# "SPORTSBET PORT AUGUSTA RACING CLUB TYRE RELAY RACE" PROMOTION

### **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to SA residents aged 18 years or over.
- 3. The promotion will be conducted at the Port Augusta Racing Club race meeting held at the Port Augusta Racing Club, South Australia on 25th August 2024.
- 4. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 5. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 6. Incomplete, indecipherable or illegible entries will be deemed invalid.

### **Relay Race Promotion**

- 7. Entries into the Tyre Run Promotion commence at 9.00am on 12th August 2024 and close at 5.00pm on 22nd August 2024 ("Tyre Run Promotional Period").
- 8. To enter, each individual in the team must complete an entry form (including their full name, mobile number, alongside their team's name) and provide it to the Port Augusta Racing Club or a Sportsbet representative. Sportsbet will then place each team's entry into a draw barrel to receive one (1) entry into the draw to participate in the Relay Race (defined below).
- 9. The draw will take place at the Port Augusta Racing Club, 207 Racecourse Road, Port Augusta SA 5700 at 11am on the 23rd August 2024. Drawn entrants will be contacted by telephone upon their entries being drawn. If any drawn entrants cannot be reached by Sunday August 25 at 11.00am, their place in the Relay Race is forfeited and an immediate redraw will take place, subject to the below. The first drawn entry per any community club will be in the race. Any additional entries drawn for the same club will be not be eligible.
- 10. The Relay Race will consist of four (4) teams, with four (4) participants in each team (two males and two females). Teams will compete in a 100-metre relay race. Teams will roll a tyre throughout

the entirety of the race and pass the tyre to the next participant following the conclusion of the 25 metre intervals. The teams that cross the line will be awarded a prize.

- 11. The Promoter may at its discretion add additional runners to each team or create an additional team or add an additional race.
- 12. Prize money will be shared equally between the teams that finish the race in first, second and third and fourth position. The cash prizes will consist of the following:

| Finishing Position | Cash Prize Amount |
|--------------------|-------------------|
| First Place        | \$2,000 per team  |
| Second Place       | \$1,000 per team  |
| Third Place        | \$600 per team    |
| Fourth Place       | \$400 per team    |

13. Entrants acknowledge that there may be inherent risks in some aspects of the Tyre Relay Race and that participation in the Tyre Relay Race may involve participating in dangerous activities. By entering this Relay Race, entrants accept that risk for themselves.

#### General

- 14. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 15. The Promoter's decision is final and no correspondence will be entered into.
- 16. As a condition of entry, entrants must sign a waiver/release form as required by the Promoter.
- 17. Cash prizes will be awarded via EFT (electronic funds transfer) within twenty-eight (28) business days of being notified. Winners are responsible for providing full and accurate bank details. The Promoter will not be responsible for a banking institution reject an EFT payment, or any costs associated with locating any lost monies.
- 18. Total prize pool value is \$4,000.
- 19. Prizes, or any unused portion of a prize, are not transferable or exchangeable, unless otherwise specified.
- 20. All participants in each team must complete their nominated 25 metre leg whilst rolling a tyre and must transfer the tyre to the next member of that team. Sportsbet reserves the right to disqualify a team should it identify a particular team has not completed a leg in its entirety while in control of the tyre or otherwise engaged in conduct which has brought the competition into disrepute.

- 21. Entrants consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.
- 22.
