Report on Race Meeting held at Balaklava Racecourse

**RACE 1: HEINIGER / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres**

**ANGASTON** (R. Hurdle) - difficult to load. Trainer, Mr J. O'Connor, was advised that a warning had been placed on the gelding. Shifted out in the vicinity of the 50 metres when insufficiently clear of MANOR KING. Rider pleaded guilty to a charge under AR131(a) and was suspended from riding in races for a period to commence midnight Wednesday, 17 April 2019 to conclude midnight Monday, 22 April 2019, a period of three meetings.

**HANKSTAR** (R. Clark) - in the vicinity of the 50 metres was contacted by THE PUGILIST, which shifted out despite the efforts of its rider.

**MANOR KING** (S. Cahill) - in the vicinity of the 50 metres had to be restrained to avoid the heels of ANGASTON, which shifted out when insufficiently clear.

**THE PUGILIST** (B. Vorster) - shifted out despite the efforts of its rider over the concluding stages contacting HANKSTAR. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.

**GLORY GAME** (J. Chau) - laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: COUNTRY LIVING HOMES / SABOIS MAIDEN PLATE - 1400 metres**

**ALLAYEZ** (S. Price) - underwent a pre-race veterinary examination as it had not raced in the past twelve months and was passed fit to start. Held up for clear running from the vicinity of the 400 metres to the 300 metres and was obliged to shift wider on the track to improve into clear running.

**OURKHANI** (J. Toeroek) - laid in throughout the event. In the vicinity of the 50 metres was contacted by HINCHPIN, which shifted out under riding.

**RACE 2: COUNTRY LIVING HOMES / SABOIS MAIDEN PLATE - 1400 metres (Cont'd)**

**ZAMERIC** (M. Lawrence) - raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

**DELUXE DESIGN** (J. Potter) - laid in under pressure in the straight.

**HINCHPIN** (B. Vorster) - in the vicinity of the 800 metres shifted in and away from LANGKAWI, which improved to its outside. In the vicinity of the 50 metres shifted out under riding contacting OURKHANI. Rider severely reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**MONETISE** (R. Clark) - laid in under pressure in the straight.

**RACE 3: ADELAIDE GALVANISING INDUSTRIES / SABOIS MAIDEN PLATE - 1200 metres**

**AL ZAFIR** (L. Goomany) - in the vicinity of the 400 metres was momentarily inconvenienced and obliged to shift wider to avoid the heels of SIGH OF USSURI, which shifted out when insufficiently clear.

**JOHN THE RODENT** (J. Potter) - over-raced in the middle stages of the event.

**SMOKE** (S. Price) - in the vicinity of the 200 metres was contacted by AMBIDAZZLE, which shifted out.

**ULTIMATE REALITY** (D. Tourneur) - over-raced in the early and middle stages of the event.

**IT'S MAGIC** (K. Lau) - laid out under pressure in the straight.

**WAN CHI WARRIOR** (T. Pannell) - laid out from the vicinity of the 700 metres until entering the straight.

**AMBIDAZZLE** (G. Lo) - in the vicinity of the 200 metres shifted out under pressure contacting SMOKE.

**SIGN OF USSURI** (B. Vorster) - in the vicinity of the 400 metres shifted out when attempting to improve momentarily inconveniencing AL ZAFIR. Rider reminded of his obligations to be clear when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: AEP HEALTH GROUP BENCHMARK 64 HANDICAP - 1200 metres**

**FRANCE'S BOY** (G. Lo) - obliged to be restrained in the vicinity of the 900 metres after improving onto the heels of COMMANDING DIVA as the pace slackened.

**CARLALUISA** (R. Clark) - in the vicinity of the 900 metres was obliged to be restrained to avoid the heels of CRYSTAL MOMENT after the pace slackened. When questioned regarding her riding in the straight R. Clark stated that on entering the straight she had attempted to improve into a run between COMMANDING DIVA and CRYSTAL MOMENT. She added that CARLALUISA was reluctant to improve into that run and as a result she elected to shift to the outside of the heels of COMMANDING DIVA, whereby her mount responded to her riding and finished off the event strongly. A post-race veterinary examination revealed no visible abnormalities.

**UNSCOPEABLE** (M. Lawrence) - raced greenly over the concluding stages of the event.

**CRYSTAL MOMENT** (K. Lau) - jumped away awkwardly. Over-raced in the early and middle stages of the event. In the vicinity of the 900 metres raced fiercely for a number of strides.

**RACE 5: T.P.I. TROPHY BENCHMARK 64 HANDICAP - 2200 metres**

**AMERISSA** (B. Vorster) - over-raced in the early and middle stages of the event.

**LORD GREYSON** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 5: T.P.I. TROPHY BENCHMARK 64 HANDICAP - 2200 metres (cont'd)**

**ANOTHER MARTINI** (K. Bishop) – when questioned regarding the improved performance of the gelding. Trainer, Mr B. Jones, advised that ANOTHER MARTINI had pleased in its work leading up to today's event and he was of the opinion that the gelding was better suited racing over longer distances than its previous start at Streaky Bay and appreciated the better track surface.

**RACE 6: SELAH HOMES PTY LTD BENCHMARK 60 HANDICAP - 1050 metres**

**AKKACAN** (M. Lawrence) – laid in under pressure in the straight.

**REAL EASY** (S. Price) – a post-race veterinary examination revealed no visible abnormalities.

**SWEET VARDEN** (K. Lau) – slow to begin.

**QUIVERS** (G. Lo) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**EXALTED MAXINE** (R. Clark) – jumped away awkwardly and shifted in. Laid out throughout the event.

**RUSHWA** (S. Fawke) – trainer, Mr R. Balfour, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to find cover in today's event. Settled back with cover.

**RACE 7: GILLES PLAINS & HAMPSTEAD RSL BENCHMARK 60 HANDICAP - 1600 metres**

The start of this event was delayed approximately two minutes.

**WICKED RHYTHM** (J. Holder) – in the vicinity of the 800 metres had to be restrained after improving onto the heels of IRON MAX.

**IRON MAX** (R. Clark) – slow to begin. Over-raced in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty, Stewards took into account R. Clark's good record.

**JUST LIVE ON** (J. Maund) – shifted out under pressure over the concluding stages of the event taking WYUNA and KINGSGROVE wider on the track. Rider severely reprimanded under AR131(a).

**WYUNA** (T. Pannell) – in the vicinity of the 100 metres was obliged to shift wider on the track when JUST LIVE ON shifted out under pressure.

**COBBERS MATE** (J. Toeroek) – over-raced in the early and middle stages of the event.

**KINGSGROVE** (D. Tourneur) – over-raced in the early and middle stages of the event. In the vicinity of the 100 metres was taken wider on the track by JUST LIVE ON, which shifted out under pressure. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: HENSON LLOYD ACCOUNTANT'S BENCHMARK HANDICAP - 1400 metres**

**EXALTED TRAVELLER** (S. Logan) - slow to begin. Laid in under pressure in the straight. In the vicinity of the 100 metres laid in momentarily inconveniencing STAGHORN. Rider reminded of her obligations to stop and straighten her mounts when she shifts ground in future. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$500. In determining penalty Stewards took into account S. Logan's numerous breaches of the whip rule. A post-race veterinary examination revealed no visible abnormalities.

**SYLVAN CREST** ( G. Lo) - laid in under pressure in the straight.

**RACE 8: HENSON LLOYD ACCOUNTANT'S BENCHMARK HANDICAP - 1400 metres (Cont'd)**

**CANIDAE** (S. Fawke) - over-raced in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards took into account S. Fawke's numerous recent breaches of the whip rule.

**BEL STREAK** (J. Toeroek) - rider reported his mount felt awkward in its action rounding the home turn and in the straight, as a result elected not to place the gelding under pressure over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr M. McClean was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. First aid administered.

**MADNESS INVALENCIA** (E. Boyd) - laid out under pressure in the straight.

**PERFEK** (D. Tourneur) - over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**MABEL JOSEPHINE** (J. Maund) - slow to begin.
