Report on Race Meeting held at Clare Racecourse

RACE 1: TAB / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately four minutes.

WALLAMAN (S. Logan) - became fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was passed fit to start. Trainer, Mr S. Whittle, was advised that a warning had been placed on the gelding in relation to its barrier manners. Raced wide without cover throughout the event.

CRIMSON TYCOON (P. Gatt) - fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and passed fit to start. Trainer, Mr W. Clarcken, was advised that a warning had been placed on the gelding in relation to its barrier manners. When questioned, rider explained that his instructions were to lead in today's event and not to hold the gelding up due to its breathing issues. He added that the gelding jumped okay but he was obliged to encourage the gelding early to obtain the lead and maintain his position on the rail. He felt that he was travelling at a fair tempo; however, was mindful of his instructions not to restrain CRIMSON TYCOON. He stated that he would have preferred to restrain the gelding more than he did during the event. He further added that from in the vicinity of the 200 metres CRIMSON TYCOON had come to the end of its run and he therefore looked around on a number of occasion to see where other runners were. He added that despite his efforts the gelding failed to respond to his riding as he had anticipated and was disappointing to the finish. Trainer, Mr W. Clarcken, confirmed the instructions and advised that CRIMSON TYCOON will likely undergo a throat operation prior to its next start. A post-race veterinary examination revealed no visible abnormalities.

SPIRIT OF CHARM (A. Jordsjo) - rider explained that the gelding never travelled during the event, didn't respond to her riding and was very disappointing in its efforts. Trainer, Mr J. Hyam, advised that the gelding will now be spelled. A post-race veterinary examination revealed no visible abnormalities.

RACE 1: TAB / SABOIS MAIDEN PLATE - 1100 metres (cont'd)

DELLA STREET (M. Henderson) - in the vicinity of the 50 metres became awkward in its action for a short distance.

CADELLE (G. Lo) - approaching the 100 metres was obliged to be eased as DIXON STREET, which was racing greenly, shifted out abruptly.

DIXON STREET (L. Goomany) - jumped away awkwardly. Approaching the 100 metres when racing greenly shifted out abruptly onto CADELLE, which was obliged to be eased. Rider severely reprimanded under AR131(a) and advised to take greater care in future.

RACE 2: TAYLORS BENCHMARK 64 HANDICAP - 1200 metres

COMMANDING DIVA (S. Price) - in the vicinity of the 600 metres raced tight for a short distance and was obliged to be restrained when racing to the inside of SON OF CITY and ARTISTIC FOCUS.

PARTY SET (C. Lions) - jumped away awkwardly.

SHE'S RENELDASGIRL (S. Logan) - raced wide without cover throughout the event.

RACE 3: ALAN HEINJUS MEMORIAL / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres

DEXTINY (G. Lo) - in the vicinity of the 300 metres rolled out onto LITTLE RED FOX, which was obliged to be eased. Rider reprimanded under AR131(a) and advised to take greater care in future.

LITTLE RED FOX (M. Lawrence) - jumped away awkwardly. Raced wide without cover throughout the event. In the vicinity of the 300 metres was obliged to be eased as DEXTINY rolled out.

MISS FORBIDDEN (S. Logan) - hung out rounding the home turn.

RITZY DIVA (A. Jordsjo) - hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DOUBLE BLUE (L. Goomany) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: MAGICFM/5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

RUN FOR SUCCESS (T. Farrugia) - jumped away awkwardly.

SANDHILL HUSTLE (S. Price) - contacted on jumping away by TICKET TO TEXAS, which jumped away awkwardly and shifted out, and AUSTRALIEN, which jumped away awkwardly and shifted in. A post-race veterinary examination revealed no visible abnormalities.

TICKET TO TEXAS (K. Lau) - jumped away awkwardly, shifted out and contacted SANDHILL HUSTLE. Made the turn in the vicinity of the 1000 metres awkwardly taking AUSTRALIEN wider. In the vicinity of the 400 metres raced in restricted room for a short distance between ZAMERIC and GOOD TIME MADAM, which was weakening.

BARRYMORE (G. Lo) - hung in under pressure in the straight. When questioned rider explained that the gelding travelled well during the event until the 1000 metres where it raced off the bridle. Thereafter, despite his urging it failed to respond to his riding, was inclined to hang in, in the straight, and was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

ZAMERIC (M. Lawrence) - bumped on jumping away by KIMMIE QUICK SHOES, which shifted out.

RACE 4: MAGICFM/5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres (cont'd)

AUSTRALIEN (C. Lions) - jumped away awkwardly, shifted in and contacted SANDHILL HUSTLE. In the vicinity of the 1000 metres was taken wider by TICKET TO TEXAS, which made the turn awkwardly.

GOOD TIME MADAM (A. Jordsjo) - weakened from in the vicinity of the 400 metres. Rider reported that the filly may have choked down in today's event. A post-race veterinary examination revealed no visible abnormalities.

KIMMIE QUICK SHOES (L. Goomany) - jumped away awkwardly, shifted out and bumped ZAMERIC.

NORMAN PRINCESS (M. Henderson) - jumped away awkwardly, shifted out and contacted ON FIRE.

ON FIRE (S. Logan) - contacted on jumping away by NORMAN PRINCESS, which shifted out.

RACE 5: HILL LIVESTOCK BENCHMARK 64 HANDICAP - 1800 metres

KAZOOM (NZ) (A. Jordsjo) - slow to begin.

TOMMY GUN (C. Lions) - from in the vicinity of the 1000 metres improved around the field to settle outside the leader.

GRAND ARMADA (G. Lo) - on jumping away was hampered when tightened onto PEARL BANDIT as DOWNUNDER PRINCE jumped away awkwardly and shifted out

DOWNUNDER PRINCE (L. Goomany) - jumped away awkwardly and shifted out onto GRAND ARMADA, which was hampered.

MAHEERA (NZ) (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: JIM BARRY BENCHMARK 54 HANDICAP - 1800 metres

ZAALADD (L. Goomany) - in the vicinity of the 50 metres rolled out onto BETTERTHANYOUTHINK, which was obliged to be eased. Rider reminded of his obligations when shifting ground in future.

SEPTANGO (M. Lawrence) - in the vicinity of the 1600 metres shifted in onto CHUMPUNYA, which was obliged to be eased. Rider reminded of her obligations when shifting ground in future. Rider explained that the gelding did not travel well during the event, felt uncomfortable in its action and when asked for an effort from in the vicinity of the 600 metres failed to respond to her riding and therefore she did not ride the gelding out in her normal manner. SEPTANGO failed to finish the event. A post-race veterinary examination revealed a lower than expected heart rate. Trainer, Mr D. Bonetti, was advised that the gelding would now be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race.

CHUMPUNYA (K. Lau) - slow to begin. Approaching the 1600 metres was obliged to be eased as SEPTANGO shifted in.

ALDOLPHIN (J. Chau) - in the vicinity of the 50 metres rolled in onto BETTERTHANYOUTHINK.

BETTERTHANYOUTHINK (C. Lions) - in the vicinity of the 50 metres was obliged to be eased as ALDOLPHIN rolled in and ZAALADD rolled out.

BROOKTON ICE (D. McWhinney) - raced wide without cover in the middle stages of the event.

RACE 7: AIRMASTER AUSTRALIA BENCHMARK 54 HANDICAP - 1100 metres

The start of this event was delayed approximately seven minutes.

ARCHWAY TO HEAVEN (S. Logan) - reared on jumping away and as a result was slow to begin. Inside the 100 metres bumped with STRATEGIC AGENDA, which shifted out.

MAYBE THIS TIME (C. Lions) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

STOLEN TIME (M. Lawrence) - unruly when the rider attempted to mount.

THE MOSHIRE (T. Farrugia) - held up for clear running rounding the home turn when racing between ZUME FORWARD and TO BE VAIN.

STRATEGIC AGENDA (P. Gatt) - lost its near fore plate en route to the barriers and required to be re-shod on arrival at the barriers. Underwent a pre-race veterinary examination and passed fit to start. Inside the 100 metres shifted out and bumped ARCHWAY TO HEAVEN.

VEIN CHOICE (L. Goomany) - jumped away very awkwardly.

MOODY MISS (T. Farrugia) - cross-over noseband required to be adjusted on arrival at the barriers.
