

**THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Gawler Racecourse
by the Gawler and Barossa Jockey Club on Thursday, 25 April 2019**

RACE 1: PEACE DECLARED 1919 CLASS TWO HANDICAP - 1106 metres

MASIPAG (S. Price) - approaching the 800 metres shifted in and away from PERFEK onto REGALO DI GAETANO.

CAPTAIN CALIFORNIA (B. El-Issa) - shifted in, in the vicinity of the 800 metres onto PERFEK, which was taken in onto MASIPAG. Rider severely reprimanded and advised in future to ensure he was sufficiently clear prior to commencing to shift ground. Rider explained that the gelding had travelled well in the early and middle stages of the event; however, when placed under pressure in the vicinity of the 500 metres had commenced to give ground and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

REGALO DI GAETANO (J. Toeroek) - approaching the 800 metres had to be taken hold of and lost its position when tightened onto TO BE VAIN by MASIPAG.

HAHNDORF (S. Fawke) - slow to begin.

TO BE VAIN (T. Pannell) - inconvenienced in the vicinity of the 800 metres when contacted by REGALO DI GAETANO. A post-race veterinary examination revealed no visible abnormalities.

PERFEK (S. Logan) - raced keenly in the early stages of the event. In the vicinity of the 800 metres was inconvenienced when taken in onto MASIPAG by CAPTAIN CALIFORNIA.

RACE 2: RSL SOUTH AUSTRALIA - COOPERS BENCHMARK 70 HANDICAP - 1206 metres

EXTREME THRILL (G. Lo) - inclined to lay in under pressure in the straight. A post-race veterinary examination revealed the gelding to be exhibiting signs of respiratory thumps. First aid administered.

KNOTTED (R. Clark) - rider reported that the gelding commenced to weaken from the vicinity of the 500 metres and became awkward in its action approaching the 200 metres and for this reason she had not ridden her mount out in her usual manner. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

AWAKE IN GRINZING (NZ) (T. Farrugia) - raced keenly in the early and middle stages of the event and in the vicinity of the 800 metres was hampered and forced to race in restricted room when BE MY STAR laid in. Held up from the entrance to the straight until approaching the 200 metres. In the vicinity of the 200 metres shifted in when insufficiently clear onto PAMELA JOY, which was forced to be taken hold of when tightened onto KNOTTED. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 27 April 2019 to conclude midnight Friday, 10 May 2019, a period of five meetings.

PAMELA JOY (J. Toeroek) - in the vicinity of the 200 metres had to be taken hold of when tightened onto KNOTTED by AWAKE IN GRINZING (NZ). A post-race veterinary examination revealed no visible abnormalities.

MISS CUOCO (J. Holder) - rider reported that the mare felt sore in front over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BE MY STAR (B. Vorster) - laid in, in the early stages of the event and in the vicinity of the 800 metres shifted in slightly onto AWAKE IN GRINZING (NZ).

RACE 3: THANK YOU VETERANS / SABOIS MAIDEN PLATE - 1506 metres

The start of this event was delayed approximately two minutes.

JOHN THE RODENT (C. Lions) - raced keenly in the early and middle stages of the event.

MAI CHAU (J. Huxtable) - slow to begin.

THE ULSTERMAN (C. Jones) - trainer, Ms L. Conlon, advised Stewards prior to the event of a change of tactics in that she would instruct her rider to attempt to settle more forward in today's event than the gelding had at its most recent starts. Settled in front.

CUT THE STRINGS (J. Toeroek) - reared in its stall after being loaded and became cast. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice Stewards withdrew CUT THE STRINGS at 1.52 pm. Trainer, Mr T. McEvoy, was advised that a warning had been placed on the gelding in relation to its barrier manners.

LIPPSY SHUFFLE (P. Gatt) - raced keenly in the early and middle stages of the event. In the vicinity of the 700 metres improved onto the heels of PARIS ON FIRE and had to be taken hold of and in doing so shifted out contacting RACY ROSIE. A post-race veterinary examination revealed a poor recovery.

GARIFULLINA (NZ) (R. Hurdle) - inside the 100 metres became held up when disappointed attempting a tight run between THE ULSTERMAN and HEZ A WOLF.

ANJAH (K. Bishop) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: THANK YOU VETERANS / SABOIS MAIDEN PLATE - 1506 metres (cont'd)

HINCHPIN (B. Vorster) - raced keenly in the early and middle stages of the event.

PEARL MUNCHKIN (A. Jordsjo) - rider reported that the filly was reluctant to race in today's event despite her efforts and had been disappointing. A post-race veterinary examination revealed no visible abnormalities.

RACY ROSIE (R. Clark) - in the vicinity of the 700 metres was inconvenienced when contacted by LIPPSY SHUFFLE. Laid in under pressure in the straight.

RACE 4: FRANK OWEN OAM BENCHMARK 56 HANDICAP - 1206 metres

KING'S SPIRIT (S. Cahill) - laid in under pressure in the straight.

DOCTOR DOOLITTLE (J. Toeroek) - laid in under pressure in the straight.

REAL EASY (S. Price) - shifted in on jumping away onto LORD ROSENTHAL. Raced keenly in the early and middle stages of the event and wide without cover throughout. Hung out rounding the home turn.

CURTAIN CALL (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

LORD ROSENTHAL (T. Pannell) - hampered and lost its position on jumping away when tightened onto KING'S SPIRIT by REAL EASY.

CRYSTAL MOMENT (K. Lau) - jumped away awkwardly. Laid in under pressure in the straight.

LAST ONE LAUGHING (S. Logan) - a post-race veterinary examination revealed a poor recovery with cardiac arrhythmia. Trainer, Mr G. Young, was advised that the results of an ECG were to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness were required prior to a performing to the Stewards' satisfaction in an Official Barrier Trial.

JARRVIS (T. Farrugia) - slow to begin.

RACE 5: LIGHT HORSE - SA BOOKMAKERS ASSOCIATION / SABOIS MAIDEN PLATE - 1206 metres

The start of this event was delayed approximately four minutes.

FRANK GOES BOOM (S. Price) - hampered and lost its position on jumping away when ONE MORE JACK shifted out.

ULTIMATE REALITY (S. Cahill) - became fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was ruled unfit to start. Acting on this advice Stewards withdrew ULTIMATE REALITY at 3.08 pm. Trainer, Mr S. Cahill, was advised that a warning had been placed on the gelding in relation to its barrier manners.

IT'S MAGIC (K. Lau) - raced wide without cover throughout the event. Inclined to lay in under pressure in the straight.

ONE MORE JACK (C. Lions) - shifted out on jumping away onto FRANK GOES BOOM. Lost its near fore plate during the event.

TRUE ILLUSION (C. Jones) - slow into stride.

**RACE 5: LIGHT HORSE – SA BOOKMAKERS ASSOCIATION / SABOIS MAIDEN PLATE –
1206 metres (cont'd)**

TWIN CARBS (J. Toeroek) – reared and became cast in its barrier after being loaded. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice Stewards withdrew TWIN CARBS at 3.09 pm. Trainer, Ms E. Hubbard, was advised that a warning had been placed on the gelding in relation to its barrier manners.

MINNAMOSA (NZ) (B. El-Issa) – inconvenienced on jumping away when contacted by YOU HADME AT HELLO. Raced keenly in the early and middle stages of the event. Rider reported that the mare commenced to weaken of its own accord in the vicinity of the 400 metres and for this reason he did not ride his mount out in his usual manner over the final 200 metres. Rider was advised of his obligations under AR131(b) in riding his mount out to the end of the race. A post-race veterinary examination revealed no visible abnormalities.

MOVANDI (G. Lo) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

GLORY GAME (J. Chau) – inclined to lay out in the early and middle stages of the event.

YOU HADME AT HELLO (B. Vorster) – jumped away awkwardly and shifted in onto MINNAMOSA.

REGAL DOMAIN (K. Bishop) – which was in an adjoining barrier stall to TWIN CARBS, underwent a pre-race veterinary examination and was passed fit to start. Raced keenly in the early and middle stages of the event.

RACE 6: ANZAC APPEAL - HOLDFAST INSURANCE BENCHMARK 60 HANDICAP - 1506 metres

RED DAZZLE (C. Lions) – which injured itself en route to the course underwent a pre-race veterinary examination on arrival on course and ruled unfit to start. Acting on this advice Stewards withdrew RED DAZZLE at 3.02 pm.

IRON MAX (C. Jones) – stood flat-footed and was slow to begin. Trainer, Mr M. Vassallo, was advised that the gelding would be required to jump away with the field in an Approval Jump-out or Official Barrier Trial prior to a future race.

INDRABEEL (NZ) (B. Vorster) – jumped away awkwardly. Rider accidentally dropped his whip approaching the 100 metres.

COBBERS MATE (S. Fawke) – shifted in slightly in the vicinity of the 1200 metres onto BALLILSTIC MISSILE.

BALLISTIC MISSILE (E. Boyd) – jumped away awkwardly. Inconvenienced in the vicinity of the 1200 metres when COBBERS MATE shifted in slightly.

**RACE 7: OPERATION K9 - GOLDIN FARMS / SABOIS FILLIES & MARES BENCHMARK 64
HANDICAP - 1206 metres**

UNSCOPEABLE (S. Logan) – jumped away awkwardly and shifted out contacting ORBOST.

BAYOU (J. Toeroek) – rider reported that the filly never travelled throughout the event and failed to respond when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

CONTAINMENT (J. Holder) – inclined to lay in, in the straight.

ORBOST (T. Pannell) – contacted on jumping away. Raced keenly for a number of strides in the vicinity of the 800 metres when awkwardly placed on the heels of AL NAIFA.

RACE 8: GALLIPOLI MEMORIAL TROPHY BENCHMARK 64 HANDICAP - 1706 metres

CAMPOBASSO (NZ) (B. El-Issa) - in the vicinity of the 1600 metres shifted in and away from IGITUR onto WYUNA.

IGITUR (C. Jones) - shifted in slightly in the vicinity of the 1600 metres onto CAMPOBASSO (NZ).

JUST LIVE ON (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

LA LA LUCHIE (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

SEATTLE SOUND (B. Vorster) - rider explained that the gelding had travelled well in the early stages of the event; however, in the vicinity of the 1400 metres it had felt like it had been galloped on behind and the horse became awkward for a short distance. He added that shortly afterwards the gelding commenced to travel well again; however, when placed under pressure in the vicinity of the 600 metres failed to respond to his riding and had weakened from the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

WYUNA (A. Jordsjo) - hampered in the vicinity of the 1600 metres when tightened onto JUST LIVE ON by CAMPOBASSO (NZ).

AMBISHOP (K. Bishop) - slow to begin.
