STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse
by the Gawler and Barossa Jockey Club on Wednesday, 22 May 2019

TRACK: Soft 5 (Track with a reasonable amount of give in it)

RAIL: Out 5 metres 800 metres to 400 metres, 2 metres remainder. Sectional 606 metres

WEATHER: Fine

RACE 1: HOLDFAST INSURANCE BENCHMARK 120 HURDLE - 3380 metres

All runners underwent a pre-race veterinary examination and were passed fit to start.

CASIRAGHI (T. Sadler) – struck the tenth hurdle and knuckled on landing.

DAYS GO BY (FR) (R. O'Sullivan) – jumped away awkwardly. Raced keenly in the early and middle stages of the event.

EXALTED BLOOM (W. Gordon) – eased out of the event in the vicinity of the 600 metres. A post-race veterinary examination revealed the mare had bled from both nostrils. Trainer, Mr G. Young, was advised that as this was the mare's first bi-lateral bleed it was now suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

All runners underwent a post-race veterinary examination which, with the exception of EXALTED BLOOM, revealed no visible abnormalities.

RACE 2: KINGSFORD HOTEL / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1100 metres

ISCARIOT (J. Toeroek) – laid in over the concluding 600 metres of the event and in the vicinity of the 400 metres shifted in onto EMBROILED, which was inconvenienced. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

EMBROILED (R. Hurdle) – momentarily inconvenienced in the vicinity of the 400 metres.

RACE 3: FESTIVAL HIRE / SABOIS MAIDEN PLATE - 1718 metres

ALLAYEZ (S. Price) - laid out rounding the home turn and under pressure in the straight.

CAST A SHADOW (R. Hurdle) - trainer, Mr T. Doudle, was fined \$100 under AR65 in that he failed to produce the Thoroughbred Identification Card for CAST A SHADOW. The horse was permitted to start as it was able to be identified from records held by the Stewards. Mr Doudle was advised that the Thoroughbred Identification Card was required to be presented before the gelding's next start. A post-race veterinary examination revealed no visible abnormalities.

SHIRLEY'S EAGLE (J. Maund) - laid out under pressure in the straight.

FULL TILT (B. Vorster) - rider could offer no explanation in relation to the gelding's poor performance. A post-race veterinary examination revealed no visible abnormalities.

HINDLEY STREET (S. Cahill) - raced keenly in the early and middle stages of the event. Rider reported that the gelding felt awkward in its action when placed under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr S. Cahill, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 4: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately two minutes.

MALOUFF (S. Price) - jumped away awkwardly.

LORD GILBERT (P. Gatt) - took hold of its rider on arrival at the barriers and galloped for several hundred metres. Underwent a pre-race veterinary examination on return to the barriers and passed fit to start.

TRUE ILLUSION (K. Cowan) - raced keenly in the early and middle stages of the event.

CHARADE (R. Clark) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KHANI STAR (J. Holder) - jumped away awkwardly. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPER DRY CLASS TWO HANDICAP - 1200 metres

LADY SOMA (J. Huxtable) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the mare to be lame in both forelegs. Trainer, Mrs S. Jaensch, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

PANZER PRINCESS (A. Jordsjo) - a post-race veterinary examination revealed mild tying-up in the hind-quarters.

MAORI MAGIC (NZ) (J. Holder) - jumped away awkwardly.

HAHNDORF (P. Gatt) - raced keenly in the early stages of the event.

MISTY HALO (J. Maund) - slow to begin.

RACE 6: THANK YOU GOLDIN FARMS BENCHMARK 56 HANDICAP - 1100 metres

ELLE A WALKING (T. Pannell) - laid in under pressure in the straight.

RACE 6: THANK YOU GOLDIN FARMS BENCHMARK 56 HANDICAP - 1100 metres (cont'd)

CAPTAIN CALIFORNIA (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

RUSHWA (S. Price) - laid in under pressure in the straight.

TO BE VAIN (R. Clark) - obliged to alter course in the vicinity of the 300 metres when CRYSTAL MOMENT shifted out.

WONDER IF (NZ) (J. Toeroek) - hampered on jumping away. Raced fiercely in the middle stages of the event.

CRYSTAL MOMENT (K. Lau) - laid out under pressure in the straight and in the vicinity of the 300 metres shifted out onto TO BE VAIN, which was obliged to alter course. A post-race veterinary examination revealed no visible abnormalities.

FUGITIVE (S. Fawke) - laid out under pressure in the straight.

FABULOUS FLIPPER (A. Jordsjo) - shifted out on jumping away onto WONDER IF (NZ).

RACE 7: 2019 GOLDIN FARMS BAROSSA CUP - 2118 metres

VISAO (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

CHESTNUT CHARLIE (R. Clark) - rider reported that the gelding travelled well in the early and middle stages of the event; however, failed to let down when asked for an effort. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr P. Huserot, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

EPERDUMENT (D. Tourneur) - jumped away awkwardly and shifted out onto AMBISHOP. Laid out in the straight.

KAZOOM (NZ) (J. Huxtable) - raced keenly in the middle stages of the event.

KARAOKE EXPRESS (R. Hurdle) - raced keenly in the early stages of the event.

AMBISHOP (K. Bishop) - inconvenienced on jumping away.

MAJESTIC RIDGE (S. Fawke) - inclined to lay in under pressure in the straight.

RACE 8: GBJC LIFE MEMBERS TROPHY BENCHMARK 60 HANDICAP - 1514 metres

IAMTHEKEY (J. Huxtable) - slow to begin. Shifted out at the entrance to the straight onto BEHAVE. Rider reminded of his obligations when shifting ground.

SNOWBROOK (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

SERIOUS SPENDER (J. Chau) - inside the 100 metres shifted in onto BELEAGUER. Rider reminded of his obligations when shifting ground.

SPIEGEL GROVE (J. Holder) - raced keenly in the early and middle stages of the event.

BEHAVE (S. Logan) - inconvenienced at the entrance to the straight.

SUPERVELOCE (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: GBJC LIFE MEMBERS TROPHY BENCHMARK 60 HANDICAP - 1514 metres (cont'd)

BELEAGUER (A. Jordsjo) - inconvenienced inside the 100 metres.

COBBERS MATE (S. Fawke) - raced keenly in the early and middle stages of the event.

MURRAY BRIDGE - WEDNESDAY, 15 MAY 2019

Race 8: Murray Bridge Racing Club Farewell Benchmark 60 Handicap - 1200 metres

BUCKS ROW - Trainer, Ms K Byrnes, reported on return to her stable the gelding was lame in the near fore leg. Ms Byrnes was advised a Veterinary certificate of fitness is required prior to accepting for a future trial or race.
