

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 1 June 2019

TRACK: Parks Track: Good 4 Main Track: Soft 5 (Track with some give in it) (Track with a reasonable amount of give in it)

RAIL: Parks track: Out 5 metres entire. Sectional 606 metres.

Main track: Out 4 metres 1200 metres to 600 metres, out 6 metres remainder. Sectional 608 metres.

RACE 1: THE ADELAIDE APPEALS COMMITTEE HURDLE - 3200 metres

All runners underwent a pre-race veterinary examination and were passed fit to start.

All runners underwent a post-race veterinary examination which revealed no visible abnormalities.

RACE 2: AUSTRALIAN MADE ADVANTAGE TWO-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes.

BAY WAVE (J. Toeroek) – over-raced in the early stages of the event. Held up from the entrance to the straight until near the 200 metres. Raced greenly over the concluding stages, shifted out and momentarily hampered MAGIC PHANTOM.

EIGHT OVER EIGHT (S. Fawke) – over-raced in the early stages of the event. Rider explained the colt travelled well, but failed to let down in the straight. A post-race veterinary examination revealed the colt to be lame in the near foreleg and to have a poor respiratory recovery. Trainer, Mr J. Hickmott, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.



RACE 2: AUSTRALIAN MADE ADVANTAGE TWO-YEAR-OLD MAIDEN PLATE - 1000 metres (cont'd)

MAGIC PHANTOM (R. Hurdle) – laid in, in the straight. Momentarily hampered over the concluding stages by BAY WAVE, which shifted out.

RAWLINNA (K. Cowan) – race very greenly throughout the event. Ride explained that the gelding raced very greenly throughout the event and was inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

SPENCER GULF (C. Jones) - slow to begin.

KAMALA KHAN (J. Eaton) - awkward to begin. Raced keenly in the early stages of the event.

SHEZA LITTLE POSH (G. Cartwright) – held up for clear running for a short distance shortly after the entrance to the straight.

RACE 3: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1000 metres

BURNING THE CLOCK (T. Pannell) - laid out in the straight.

PAPALET (P. Gatt) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

TRILLI (NZ) (J. Eaton) - slow to begin.

LEGGERO (K. Cowan) - raced wide without cover throughout the event.

SAPPHIRE MISS (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: MCMAHON SERVICES HANDICAP - 2400 metres

OLYMPIC ACADEMY (C. Jones) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

ROYAL RUMBLE (T. Pannell) - held up from the 450 metres until in the vicinity of the 300 metres.

MELI MELO (J. Holder) – underwent a pre-race veterinary examination on arrival on course which revealed a laceration on the right jaw sustained in the float en route to the course. First aid administered. MELI MELO was declared a late scratching at 10.13 am.

AZURITE (IRE) (J. Eaton) - raced keenly in the early and middle stages of the event.

FLOW METER (S. Fawke) - inclined to shift about under pressure in the straight.

THE WILLYBE (NZ) (D. Tourneur) – a post-race veterinary examination revealed a lower than expected heart rate.

LOSTARC (P. Gatt) - laid out under pressure in the straight.

SHAKOPEE (GB) (A. Jordsjo) - raced keenly in the early and middle stages of the event.

RACE 5: LEXUS OF ADELAIDE HANDICAP - 1250 metres

The start of this event was delayed approximately two minutes.

BEL SONIC (T. Pannell) - difficult to load. Trainer, Mr J. Warren, was advised that a warning had been placed on the gelding.

DEBT COLLECTOR (J. Toeroek) – had difficulty obtaining clear running for a short distance at the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

KABINI (D. Tourneur) – dislodged its rider en route to the barriers and galloped loose for some distance before being captured by the Clerk of the Course and returned to the mounting yard. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice Stewards withdrew KABINI at 1.50 pm. D. Tourneur was examined by the First Care Medical personnel and passed fit to fulfil his remaining engagements.

BY THE POUND (P. Gatt) - very awkward to begin.

RACE 6: RESOURCECO HANDICAP - 1550 metres

ICE GHOST (C. Jones) - laid in, in the straight.

RAPID BAY (D. Tourneur) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

LEFT HAND MAN (R. Hurdle) - rider reported that the gelding hung out rounding the home turn and in the straight.

VACANT BLOCK (G. Cartwright) – awkward to begin. Near the 400 metres became awkward on the heels of CHARMIST, which commenced to weaken and was obliged to shift in to obtain clear running. Laid out under pressure in the straight.

YULONG PATROL (IRE) (T. Pannell) - raced keenly in the early stages of the event and inside the 1200 metres got its head up and raced ungenerously for a number of strides.

CHARMIST (P. Gatt) – commenced to weaken near the 400 metres. Rider reported that the filly travelled well in the early stages of the event; however, he became concerned with its action in the vicinity of the 700 metres and for that reason he eased CHARMIST from the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: THOMAS FARMS KITCHEN HANDICAP - 1550 metres

BALF'S CHOICE (S. Price) – raced wide without cover in the early and middle stages of the event. Shifted in near the 300 metres.

WAGING WAR (J. Holder) – held up for clear running for a short distance near the entrance to the straight. Thereafter, inside the 300 metres, when improving between BALF'S CHOICE and OUR BOTTINO, raced in restricted room for a number of strides as both horses shifted ground.

STRATEGIC DEMAND (T. Pannell) - held up for clear running from inside the 500 metres until near the 300 metres.

OUR BOTTINO (P. Gatt) - laid out in the straight.

CHAPEL CITY (D. Tourneur) - laid in, in the straight.



RACE 7: THOMAS FARMS KITCHEN HANDICAP - 1550 metres (cont'd)

POLAR VORTEX (J. Eaton) – raced wide without cover in the middle stages of the event. Laid out in the straight. Approaching the 100 metres was inconvenienced and taken in by CHAPEL CITY, which laid in and shifted in under riding. Rider pleaded guilty to a charge under AR131(c) for failing to ride her mount out to the finish of the event and was severely reprimanded.

RACE 8: SEPPELTSFIELD BAROSSA HANDICAP - 1250 metres

PALE ALE (E. Boyd) - raced keenly in the early and middle stages of the event.

SKILLFUL STEPS (C. Jones) - laid out under pressure in the straight and inside the 100 metres shifted out and momentarily inconvenienced TENNESSEE RAIDER.

SAVVY SHIELDS (S. Cahill) – had difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 200 metres. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ROYAL DUTY (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

A LITTLE CHUNKY (G. Cartwright) - raced wide without cover throughout the event.

BAJAN (P. Gatt) - laid out in the straight.

TENNESSEE RAIDER (J. Holder) - momentarily inconvenienced inside the 100 metres. Rider reported that the mare travelled well but failed to let down in the straight and was disappointing. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Co-trainers, Mr L Macdonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ELLE A WALKING (J. Toeroek) - inclined to lay in, in the straight.

RACE 9: ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1400 metres

BELLOMO (G. Cartwright) – raced keenly in the early and middle stages of the event. Inside the 200 metres was obliged to be checked when tightened between SIR GARFIELD, which laid in and shifted in slightly, and FRANCE'S BOY, which shifted out under riding. As a consequence BELLOMO was unable to improve its position for several strides.

SOARING HIGH (T. Pannell) – awkward to begin. Over-raced in the middle stages of the event. Lost its off hind plate during the event.

RIKIBOBBY (C. Jones) – awkward to begin. Raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

FRANCE'S BOY (S. Fawke) – approaching the 200 metres shifted out under riding tightening DELLACQUA and taking that horse's running, resulting in DELLACQUA having to be checked and losing its position. Rider found guilty of a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Monday, 10 June 2019 to conclude midnight Wednesday, 19 June 2019, a period of four meetings. Rider reported his mount slipped behind on jumping away.

GOING GAGA (S. Cahill) - raced keenly in the early stages of the event.

RACE 9: ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1400 metres (cont'd)

SIR GARFIELD (R. Hurdle) – approaching the 900 metres was taken out by ANGEL'S WISH, which failed to negotiate the turn, and as a consequence was taken out onto the heels of MASIPAG, resulting in R. Hurdle having to check his mount. Rider reported his mount laid in under pressure in the straight.

CONTAINMENT (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

DELLACQUA (J. Toeroek) – approaching the 200 metres had to be checked to avoid the heels of FRANCE'S BOY, which shifted out to improve its position, and lost its position.

DIAMOND TYCOON (D. Tourneur) – approaching the 700 metres was obliged to race in restricted room inside the heels of RIKIBOBBY. A post-race veterinary examination revealed no visible abnormalities.

ANGEL'S WISH (G. Lo) – failed to negotiate the turn approaching the 900 metres taking SIR GARFIELD out onto the heels of MASIPAG. Approaching the 200 metres shifted taking the running of FRANCE'S BOY. G. Lo was severely reprimanded for shifting ground when insufficiently clear.

KINGSGROVE (P. Gatt) - awkward to begin.

Correct weight for this event was delayed to allow Stewards to view the vision in the straight.
