Report on Race Meeting held at Naracoorte Racecourse
by the Naracoorte Racing Club on Sunday, 2 June 2019

TRACK: Soft 7 (Rain affected track that will chop out)
Downgraded to a Heavy 8 @ 1.45 pm (Rain affected track that horses will get into)
Downgraded to a Heavy 9 @ 3.47 am (Wet track getting into a squelchy area)

RACE 1: LOCAL TRAINERS BENCHMARK 72 HANDICAP - 1430 metres

RACE 2: TAB / SABOIS MAIDEN PLATE - 2000 metres

CLASSIC OAK (C. Puls) - in the vicinity of the 1900 metres was obliged to be restrained to avoid the heels of **KALLISTE**, which shifted in when insufficiently clear, and had to shift wider on the track and in doing so momentarily inconvenienced **AZDAIA**. A post-race veterinary examination revealed no visible abnormalities.

RYZLINK (S. Fawke) - rider stated his mount began to weaken noticeably from the vicinity of the 1000 metres and ran to the finish in a disappointing manner. He added that the mare may not have handled today's soft track conditions. A post-race veterinary examination revealed no visible abnormalities.

AZDAJA (J. Maund) - raced fiercely in the early stages of the event and in the vicinity of the 1900 metres was momentarily inconvenienced by **CLASSIC OAK**, which was obliged to shift wider on the track, when inconvenienced by **KALLISTE**, which shifted in when insufficiently clear.

KALLISTE (D. Tourneur) - in the vicinity of the 1900 metres shifted in when insufficiently clear of **CLASSIC OAK**, which was obliged to be restrained. Rider severely reprimanded.

MATAS (A. Jordsjo) - raced wide without cover throughout the event.

RACE 3: BECOME A MEMBER 2019/2020 / SABOIS MAIDEN PLATE - 1200 metres

BARNSTORMING (J. Potter) - in the vicinity of the 300 metres rolled out contacting SKY LACE and as a result became awkward in its stride. Rider reported in his opinion the gelding may not have handled the heavy track conditions.

CLASSY LAD (J. Huxtable) - a late scratching at 8.20 am by order of Stewards on veterinary advice.

HARLEM LOVE (S. Fawke) - contacted on jumping away by SKY LACE, which shifted in.

SKY LACE (C. Jones) - Trainer Mr J. MacMillian advised a change of tactics to attempt to find cover. Jumped away awkwardly, shifted in and contacted HARLEM LOVE, was unable to obtain cover and raced wide without throughout. In the vicinity of the 300 metres had its hindquarters turned by BARNSTORMING, which shifted out. Rider stated after beginning awkwardly was unable to find cover at any stages and although, in her opinion the mare travelled well throughout the event, it would be better suited racing on top of the ground. A post-race veterinary examination revealed no visible abnormalities.

STAR MOOLA (D. Tourneur) - rider reported his mount laid out throughout the event and laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: ORMEROD PICS AND PIECES BENCHMARK 56 HANDICAP - 1100 metres

The start of this event was delayed approximately 15 minutes owing to remedial work to the running rail.

COUNTER SPIN (E. Boyd) - over-raced in the early stages of the event.

PHAR LINK (G. Lo) - jumped away awkwardly, shifted out and contacted LICORICE BULLET, which was taken out onto JUST MAK.

LONGMIRE (J. Maund) - jumped away awkwardly.

EQUIDAME (D. Tourneur) - over-raced in the early and middle stages of the event.

JUST MAK (P. Gatt) - hampered on jumping away.

PRIME SUSPECT (A. Jordsjo) - a late scratching by order of Stewards on veterinary advice after dislodging its rider en route to the barriers and breaking through the inside running rail. Trainer Mr J. Searle was advised the gelding would be required to trial to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A. Jordsjo was examined by First Care Medical Personnel and was stood down for the remainder of her engagements.

LICORICE BULLET (K. Bishop) - hampered on jumping away.

SHE'S ALL POWER (C. Puls) - slow to begin. over-raced in the early and middles stages of the event. Rider reported her mount hung out throughout the event. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer Ms S. Murphy was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. Lost its near fore plate during the event.

RACE 5: BEAUTY @ RIVOLI CLASS TWO HANDICAP - 1430 metres

The start of this event was delayed approximately two minutes.

DYADAMO (J. Maund) - raced wide without cover throughout the event.

REAL THINKER (S. Fawke) - over-raced in the early and middles stages of the event.

RACE 5: BEAUTY @ RIVOLI CLASS TWO HANDICAP - 1430 metres (Cont'd)

PERFECT STORM (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

STRATEGIC REIGN (J. Huxtable) - slow to begin. Over-raced in the middles stages of the event.

LANDOWNER (C. Lions) - in the vicinity of the 800 metres laid in becoming awkwardly placed on the heels of **MAYBE THIS TIME**.

ROMANZE (K. Bishop) - slow to begin.

RACE 6: GERICKE LOGISTICS BENCHMARK 64 HANDICAP - 1800 metres

JACKTHEGIANTSLAYER (G. Lo) - rider reported the gelding failed to handle the heavy track conditions. A post-race veterinary examination revealed no visible abnormalities.

GRINZINGER CHARGER (NZ) (C. Jones) - had difficulty obtaining clear running on entering the home straight for a short distance.

SOLAAZEM (J. Potter) - in the vicinity of the 1700 metres had to be restrained after improving onto the heels of **JACKTHEGIANTSLAYER** and as a result raced keenly for a considerable distance thereafter.

CHIPPAWA (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

SAN GREGORIO (S. Fawke) - rider reminded of his obligations to ride his mount out to the finish.

RACE 7: PETER LUDWIG BENCHMARK 60 HANDICAP - 1000 metres

JIMASSI (K. Bishop) - in the vicinity of the 50 metres was inconvenienced after **MAZESTIC** shifted out abruptly.

FOX ON THE RUN (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

CIRCUS DANCER (M. Julius) - began awkwardly and was slow into stride. In the vicinity of the 100 metres shifted out abruptly despite the efforts of its rider and contacted **EMMY AWARDS**. A post-race veterinary examination revealed no visible abnormalities.

MAZESTIC (E. Boyd) - in the vicinity of the 50 metres shifted out abruptly despite the efforts of its rider contacting **JIMASSI**.

EMMY AWARDS (S. Fawke) - in the vicinity of the 100 metres was hampered and became awkward in its stride after **CIRCUS DANCER** shifted out abruptly.
