STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 8 June 2019

TRACK: Good 4 (Track with some give in it)

RAIL: Out 8 metres from 1000 metres to Winning Post, 5 metres remainder.

RACE 1: ADELAIDE GALVANISING HANDICAP - 1250 metres

CELTIC REBEL (T. Pannell) - jumped away awkwardly, shifted out taking NOVEMBER DREAMING out onto EMBROILED. Rider reported his mount hung out throughout the event and when placed under pressure in the straight, shifted wider on the track. A post-race veterinary examination revealed no visible abnormalities. Trainer representative Mr C. McEvoy was advised a warning had been placed on the colt.

NOVEMBER DREAMING (D. Tourneur) - on jumping away was taken out onto EMBROILED by CELTIC REBEL, which jumped away awkwardly. Rider reported that on entering the straight, was taken wider by CELTIC REBEL, which shifted out but thereafter raced greenly under pressure and continued to shift out for the remainder of the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer representative was advised a warning had been placed on the filly.

EMBROILED (K. Cowan) - hampered on jumping away. Over-raced in the middle stages of the event.

PREDICTS (R. Hurdle) - rider dislodged from the filly behind the barriers. Rider was examined by the First Care Medical Personnel and passed fit to fulfil his riding engagement.

RACE 2: BAROSSA FINE FOOD HANDICAP - 1950 metres

ALL TOO HUIYING (J. Huxtable) - awkward to begin. Rider reported his mount hung in throughout the event. A post-race veterinary examination revealed the horse to be lame in the near foreleg. Trainer Mr P. Stokes was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

EXALTED LIGHTNING (G. Cartwright) - slow to begin. Rider accidentally dropped her whip in the vicinity of the 350 metres.

TIME ROGUE (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: DOMINANT HANDICAP - 1300 metres

REGALO DI GAETANO (C. Jones) - held up for clear running from the vicinity of the 400 metres until inside the 200 metres.

ROBE DE FETE (D. Tourneur) - in the vicinity of the 1000 metres shifted in when insufficiently clear of TOORAK SMOCK. Rider severely reprimanded. Laid out under pressure in the straight. A post-race veterinary examination revealed the colt to be lame in the near foreleg. Trainer Mr R. Griffiths was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

SPIELBERG (R. Hurdle) - when questioned regarding the performance of the colt, rider reported that he placed his mount under pressure from the vicinity of the 600 metres but when entering the home straight, failed to respond to his riding and was disappointing in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

TOORAK SMOCK (G. Cartwright) - jumped away awkwardly. In the vicinity of the 1000 metres had to be steadied to avoid the heels of ROBE DE FETE, which shifted in when insufficient clear.

Correct weight was delayed to allow T. Pannell (BLOW TORCH) and Trainer Representative Mr C. McEvoy to view the vision in the straight.

RACE 4: RED, ROCK AND RIBS AT MORPHETTVILLE - BOOK NOW HANDICAP - 1300 metres

STAR PATRIOT (K. Cowan) - over-raced in the middle stages of the event. Raced wide without cover throughout the event.

BEAUTIFUL FLYER (T. Pannell) - over-raced in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

PRETTY BLONDE (J. Potter) - laid out rounding the home turn and continued to lay out under pressure in the straight.

HELLO GORGEOUS (NZ) (J. Holder) - in the vicinity of the 1000 metres got its head up for a number of strides when attempting to be restrained to find cover.

RACE 5: JAMES BOAGS THREE-YEAR-OLD MAIDNE PLATE - 1000 metres

DEXSTRA (R. Hurdle) - slow to begin.

EQUIMOORE (P. Gatt) - in the vicinity of the 800 metres rolled in marginally tightening the running of GO BALLISTIC.

GO BALLISTIC (J. Huxtable) - in the vicinity of the 800 metres had to be restrained to avoid the heels of EQUIMOORE, which shifted in marginally. In the vicinity of the 100 metres was disappointed for a run between MIAMI FREEDOM and SHAM I AM, which laid out. Rider reported his mount laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MILLIONMOSS (C. Jones) - over-raced in the middle stages of the event. In the vicinity of the 800 metres was obliged to be restrained to avoid the heels of SHAM I AM, which shifted in abruptly despite the efforts of its rider. A post-race veterinary examination revealed no visible abnormalities.

SHAM I AM (D. Tourneur) - in the vicinity of the 800 metres shifted in abruptly despite the efforts of its rider. Laid out under pressure in the straight. In the vicinity of the 100 metres laid out momentarily inconveniencing GO BALLISTIC.

RACE 5: JAMES BOAGS THREE-YEAR-OLD MAIDNE PLATE - 1000 metres (Cont'd)

MIAMI FREEDOM (K. Cowan) - in the vicinity of the 700 metres rolled out marginally momentarily inconveniencing SOPHINA DIVA.

SHINING BRIGHTLY (K. Lau) - began awkwardly. Laid out under pressure over the concluding stages.

SOPHINA DIVA (J. Toeroek) - in the vicinity of the 700 metres was momentarily inconvenienced by MIAMI FREEDOM, which rolled out. Over-raced in the early and middles stages of the event. Rider accidentally dropped his whip in the vicinity of the 100 metres.

RACE 6: HUGHES LIMOUSINES HANDICAP - 1000 metres

BAROOD (J. Toeroek) - in the vicinity of the 200 metres had to be restrained to avoid the heels of PLEASANT, which shifted out when insufficiently clear.

TEQUILA TIME (J. Holder) - laid out under pressure in the straight and inside the 100 metres shifted out taking MYSTIFIED out across the heels of CASHED. Rider reprimanded.

MYSTIFIED (P. Gatt) - in the vicinity of the 100 metres was forced to shift out across the heels of CASHED when carried out by TEQUILA TIME, which shifted out when insufficiently clear.

PLEASANT (G. Cartwright) - in the vicinity of the 200 metres shifted out when insufficiently clear of BAROOD. Laid out under pressure in the straight. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 14 June and to conclude at midnight on Wednesday, 19 June 2019: a period of three meetings. A post-race veterinary examination revealed no visible abnormalities.

Correct weight delayed to allow P. Gatt (MYSTIFIED) and Trainer Mr R. Balfour to view the vision in the straight.

RACE 7: NAB HANDICAP - 1250 metres

VIEIRA (G. Cartwright) - slow to begin.

PALE ALE (E. Boyd) - rider reported her mount raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KABINI (D. Tourneur) - underwent a pre-race veterinary examination after being kicked behind the barriers and was passed fit to race.

ILLUMICON (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: AAMI HANDICAP - 1400 metres

CANNOT BE SERIOS (NZ) (J. Huxtable) - jumped away awkwardly, shifted in taking KINGSGROVE in onto SCOUT'S HONOUR. A post-race veterinary examination revealed no visible abnormalities.

DESIDERO (J. Holder) - in the vicinity of the 250 metres was taken out across the heels of MISTA KNOWITALL by CURTAIN CALL, which was taken out by SVETLANA'S ARROW, which shifted out when insufficiently clear and as a result had to be restrained. Rider reported after receiving interference in the vicinity of the 250 metres became concerned with the action of the gelding and elected not to place his mount under pressure over the concluding stages. A post-race veterinary examination revealed the horse to be lame in the off foreleg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 8: AAMI HANDICAP - 1400 metres (Cont'd)

KINGSGROVE (P. Gatt) - hampered on jumping away. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$100.

SCOUT'S HONOUR (W. Kerford) - hampered on jumping away.

CURTAIN CALL (K. Cowan) - rider dislodged from the gelding behind the barriers. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her riding engagement. Had difficulty obtaining clear running on entering the home straight. In the vicinity of the 200 metres was taken out onto DESIDERO by SVETLANA'S ARROW and as a result was hampered. Held up for clear running for the remainder of the straight until inside the 50 metres.

SVETLANA'S ARROW (G. Lo) - over-raced in the early and middle stages of the event. In the vicinity of the 250 metres shifted out when insufficiently clear of CURTAIN CALL, which was taken out onto DESIDERO. Rider severely reprimanded.

GENERAL:

Following a routine car and float inspection on course prior to the race meeting on Saturday, 8 June 2019 at Morphettville, Stewards found two syringes and hypodermic needles in the motor vehicle of Trainer G. Young. Mr Young pleaded guilty to the charge under AR251(1)(b)(i) in that he had in his possession two syringes and needles that could have been used to administer prohibitive substances to a horse and was fined \$200.
