STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Balaklava Racecourse  
by the Balaklava Racing Club on Monday, 10 June 2019

**TRACK:** Good 4 (Track with some give in it)

**RAIL:** Out 4 metres from 1000 metres to 400 metres, true remainder.

**WEATHER:** Fine

**RACE 1: ADELAIDE GALVANISING INDUSTRIES / SABOIS MAIDEN PLATE - 1000 metres**

**ARTIE STOKER** (P. Gatt) – slow into stride. Shifted in over a number strides over the concluding stages of the event.

**MONET** (L. Goomany) – jumped away awkwardly. In the vicinity of the 700 metres shifted out abruptly. Was inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**LA PETITE ROUSSE** (D. Tourneur) – a post-race veterinary examination revealed a small laceration to the off hind fetlock. First aid administered.

**PAM'S JOURNEY** (K. Cowan) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**SWIFTY** (T. Pannell) – laid out over the concluding stages of the event.

**RACE 2: HAULMARK TRAILERS / SABOIS PLUS BENCHMARK 60 HANDICAP - 2200 metres**

**SHAKOPEE (GB)** (R. Hurdle) – hung out under pressure in the straight.

**ZAALADD** (L. Goomany) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence midnight Wednesday, 12 June 2019 to expire midnight Sunday, 23 June 2019, a period of five race meetings. In assessing penalty Stewards noted that L. Goomany used his whip 28 times prior to the 100 metres, 23 times more than the allotted amount, his clean record and guilty plea.

**MAJESTIC RIDGE** (S. Fawke) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**PERCY KIWA** (D. Tourneur) – slow to begin.

**RACE 2: HAULMARK TRAILERS / SABOIS PLUS BENCHMARK 60 HANDICAP – 2200 metres**  
**(cont'd)**

**ALDOLPHIN** (C. Lions) – Over-raced in the middle stages of the event. In the vicinity of the 1300 metres shifted and strode forward to lead. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. Lost its off hind plate during the event.

**RACE 3: MY BUTCHER BENCHMARK 80 HANDICAP – 1400 metres**

**CAPTAIN DUFFY** (P. Gatt) – jumped away awkwardly, shifted out and contacted ADATTO (NZ). Raced keenly in the early and middle stages of the event. Rider reported that he had concerns with the gelding's action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**ADATTO (NZ)** (A. Jordsjo) – on jumping away contacted with CAPTAIN DUFFY, which shifted out.

**FRANCE'S BOY** (S. Fawke) – held up for clear running from the entrance to the straight until the 300 metres.

**A LITTLE CHUNKY** (D. Tourneur) – laid in under pressure in the straight.

**RACE 4: TAYLORS WINES BENCHMARK 64 HANDICAP – 1000 metres**

**THAT'S TWO SLABS** (J. Maund) – a post-race veterinary examination revealed the gelding to be lame in the off hind leg. First aid administered. Trainer, Mr D. Shepherd, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**GOOD LUCK CHUCK** (K. Lau) – dislodged its rider en route to the start. K. Lau was examined by the First Care Medical personnel and passed fit to fulfil his engagements. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**EXALTED MAXINE** (J. Holder) – raced keenly in the early and middle stages of the event.

**RACE 5: SAGLE CONSTRUCTIONS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE**  
**- 1400 metres**

**ALWAYS THE KING** (K. Lau) – jumped away awkwardly and was slow to begin. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400.

**I WON'T DO THAT** (D. Tourneur) – trainer, Mr S. Burford, was fined \$100 under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.

**ISATMULAA** (K. Cowan) – raced keenly in the early and middle stages of the event and got its head up on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

**LORD GILBERT** (P. Gatt) – jumped away awkwardly and shifted in. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

**RACE 5: SAGLE CONSTRUCTIONS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE**  
**- 1400 metres (cont'd)**

**YIN AND YANG** (T. Pannell) - jumped away awkwardly. Rider reported that the gelding raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**LAP IT UP** - acting on confirmed advice from trainer, Mr M. Seyers, that the filly was showing signs of a fungal infection and would be unfit to race Stewards withdrew LAP IT UP up at 8.35 am. Mr Seyers was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**THE PUBLIKIN** (J. Holder) - rider explained that the filly travelled well during the event, but when asked for an effort in the vicinity of the 200 metres failed to let down as he had expected and was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

**VENGEFUL LADY** (G. Lo) - laid in under pressure in the straight.

**CALYPSO STORM** (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$600. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: COOPERS BENCHMARK 60 HANDICAP - 1200 metres**

**ARCHWAY TO HEAVEN** (S. Logan) - hung out from approaching the 800 metres for the remainder of the event.

**BUCK'S ROW** (D. Tourneur) - rider reported that the gelding travelled well during the event; however when asked for an effort failed to let down as he had expected and was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**EXALTED TRAVELLER** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**OUTINTHESTREET** (K. Cowan) - slow to begin. Hung in under pressure in the straight.

**PORT TRIANO** (R. Hurdle) - slow to begin. Held up for clear running from the entrance to the straight until inside the 400 metres.

**RACE 7: HEINIGER CLASS TWO HANDICAP - 1400 metres**

**COLESBERG** (S. Cahill) - in the vicinity of the 100 metres was obliged to be checked as MOVANDI shifted in when insufficiently clear.

**MOVANDI** (J. Holder) - hung in under pressure in the straight and in the vicinity of the 100 metres shifted in onto COLESBERG, which was obliged to be checked and lost its position when tightened onto FUGITIVE. Continued to hang in under pressure for the remainder of the event. Rider was found guilty of a charge of careless riding under AR131(a) in that he shifted in when insufficiently clear of COLESBERG and was suspended from riding in races for a period to commence midnight Saturday, 15 June 2019 to conclude midnight Saturday, 22 June 2019, a period of 3 meetings. In assessing penalty Stewards took into account a number of mitigating factors. A post-race veterinary examination revealed superficial abrasions to the near hind leg. First aid administered. Assistant trainer, Mr T. Stokes, was advised that MOVANDI was now required to complete an Official Barrier Trial to the Stewards' satisfaction prior to a future race start.

**RACE 7: HEINIGER CLASS TWO HANDICAP - 1400 metres (cont'd)**

**OUTLAW** (D. McWhinney) - over-raced in the early and middle stages of the event.

**DAREBEN HALARO** (K. Lau) - a post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Ms D. Wilson, was advised that as this was the gelding's first bi-lateral bleed DAREBEN HALARO would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

**FUGITIVE** (S. Fawke) - jumped away very awkwardly and as a result was slow to begin. Crowded for room over the concluding stages by MOVANDI, which hung in and shifted in.

Correct weight for this event was delayed to allow S. Cahill (COLESBERG), placed fifth, to view the vision in the straight. Correct weight was further delayed to allow S. Fawke (FUGITIVE), placed second, to view the vision in the straight. After doing so both S. Cahill and S. Fawke lodged an objection against MOVANDI (J. Holder) being declared the winner on the grounds of alleged interference over the concluding 200 metres of the event. After considering the evidence, viewing the vision and acting on their own observations Stewards *dismissed* both objections.

Logan (CALYPSO STORM) - Fined \$600 - AR132(7)(a)(ii)[+7] - Whip offence.

<b>SUSPENSIONS</b>	Race 2 - L. Goomany (ZAALADD) - AR132(7)(a)(ii)[+23] - From midnight 12/06/19 to midnight 23/06/19 - 5 meetings - Whip offence. Race 7 - J. Holder (MOVANDI) - AR131(a) - Careless riding - from midnight 15/06/19 to midnight 22/06/19 - 3 meetings.

Race 7 - MOVANDI - Suspended - Must complete an Official Barrier Trial to the Stewards' satisfaction prior to a future race - Hung in. Race 7 - DAREBEN HALARO - Suspended 3 months - AR79(4) - Bilateral bleed first time - Required to gallop 1000 metres in the presence of a Steward prior to a future race start.
