RACE 1: ROSS BRAYLEY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres

AIR MARSHAL (C. Jones) - shifted out and away from BLESS IT BE on jumping away losing ground.

GENERAL MINT (J. Potter) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BLESS IT BE (J. Chau) - jumped away awkwardly and shifted out.

EXALTED QUEEN (D. Tourneur) - shifted in, in the vicinity of the 600 metres onto KAMALA KHAN, which was racing keenly. Rider reminded of his obligations when shifting ground.

KAMALA KHAN (C. Lions) - shifted in on jumping away. Raced keenly from the vicinity of the 800 metres and in the vicinity of the 600 metres had to be steadied for a number of strides when it improved on to the heels of EXALTED QUEEN.

WESTPORT (B. Vorster) - jumped away awkwardly and shortly after shifted in and away from KAMALA KHAN and lost ground.

RACE 2: PHYLLIS O'DEA CLASS TWO HANDICAP - 1050 metres

THE RAVEN (J. Potter) – raced greenly in the early and middle stages of the event and was inclined to shift about. In the vicinity of the 750 metres shifted in onto GREEN TEA ICE.

MARTINIQUE (A. Jordsjo) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

WHITE LINE FEVER (S. Logan) – underwent a pre-race veterinary examination on arrival on course as it had not raced since February 2017 and was passed fit to start.

GREEN TEA ICE (K. Bishop) – dipped in the vicinity of the 750 metres when awkwardly placed inside THE RAVEN. Continued to race in restricted room until approaching the 600 metres.

RACE 3: RON BAUM / SABOIS MAIDEN PLATE - 1050 metres

EQUIMOORE (C. Jones) – knuckled on jumping away.

GO BALLISTIC (S. Cahill) – inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ALL THINGS NICE (J. Maund) – hampered in the vicinity of the 700 metres when tightened onto SIRIUS JOURNEY by SOPHINA DIVA.

SIRIUS JOURNEY (S. Logan) – inconvenienced in the vicinity of the 700 metres when taken wider by ALL THINGS NICE.

SO INTELLIGENT (K. Crowther) – slow to begin.

SOPHINA DIVA (L. Neindorf) – shifted out abruptly in the vicinity of the 700 metres onto ALL THINGS NICE. Laid out under pressure in the straight. Rider reported that his saddle had shifted forward in the vicinity of the 50 metres placing him at a disadvantage until the finish.

RACE 4: IAN BARTON / SABOIS MAIDEN PLATE - 1600 metres

The start of this event was delayed approximately two minutes.

ALWAYS THE KING (G. Lo) – tightened on jumping away between DALAKANSHE, which shifted in, and WHEN STARS ALIGN, which shifted out. Laid in under pressure in the straight.

NEAR MAGIC (R. Clark) – in the vicinity of the 400 metres had to be steadied momentarily when it improved onto the heels of ISSARA.

RISING THUNDER (S. Price) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

JAGUARY (NZ) (D. Tourneur) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

KEN'S THUNDER (S. Cahill) – raced keenly in the early and middle stages and was wide without cover throughout the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

WHEN STARS ALIGN (B. Vorster) – lost its off fore plate en route to the barrier and required farrier attention. Underwent a pre-race veterinary examination and passed fit to start. Dipped shortly after jumping away and shifted out onto ALWAYS THE KING.

DALAKANSHE (K. Bishop) – jumped away awkwardly and shifted in onto ALWAYS THE KING.

RACE 4: IAN BARTON / SABOIS MAIDEN PLATE - 1600 metres (cont'd)

ISSARA (R. Hurdle) – a post-race veterinary examination revealed no visible abnormalities.

RACE 5: WINK HALL / SABOIS MAIDEN PLATE - 1300 metres

CIROC (S. Cahill) – hampered and lost its position on jumping away when tightened between RACY ROSIE and TOFF HEART. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FIRST THREE LEGS (E. Boyd) – in the vicinity of the 800 metres rolled out slightly onto TOFF HEART. Held up momentarily at the entrance to the straight.

INDIAN MO (P. Gatt) – raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) and was reprimanded.

TOFF HEART (D. Tourneur) – shifted out on jumping away onto CIROC. In the vicinity of the 800 metres had to be taken hold of and lost its position when tightened between FIRST THREE LEGS, which rolled out slightly at the same time as RACY ROSIE laid in slightly.

WOODCROFT (S. Price) – underwent a pre-race veterinary examination on arrival at the barriers and found to have blood present in its near side nostril and would be unfit to start. Acting on this advice Stewards withdrew WOODCROFT at 2.27 pm. The TRSA Veterinary surgeon determined that the blood was attributable to external trauma.

MEADOWS KID (K. Bishop) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

WAIKATO EXPRESS (J. Huxtable) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

HELPENY (K. Cowan) – jumped away awkwardly. Inclined to lay in under pressure in the straight.

RACY ROSIE (R. Clark) – shifted in on jumping away onto CIROC. Inclined to lay in throughout the event and in the vicinity of the 800 metres shifted in slightly onto TOFF HEART. Momentarily held up at the entrance to the straight. Lost its off hind plate during the running of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6: DES ROSS BENCHMARK 60 HANDICAP - 1300 metres

THANASI (C. Jones) – shifted out in the vicinity of the 400 metres, in an attempt to improve, onto MISTY HALO.

TENNESSEE RAIDER (J. Chau) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

SWIPE ME RIGHT (D. Tourneur) – in the vicinity of the 200 metres had to be steadied when tightened onto COOL MAVERICK by VENTRILOQUISM.

MISSCINO (P. Gatt) – jumped away awkwardly and was slow to begin.

VENTRILOQUISM (R. Clark) – shifted out slightly in the vicinity of the 200 metres onto SWIPE ME RIGHT. Rider reminded of her obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

FUTAGO (K. Bishop) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6: DES ROSS BENCHMARK 60 HANDICAP - 1300 metres (cont'd)

TOORAK ROAD (J. Potter) - contacted on jumping away.

MISTY HALO (S. Logan) - slow to begin.

TURF TAPPER (J. Maund) - jumped away awkwardly and shifted out onto TOORAK ROAD. Momentarily inconvenienced in the vicinity of the 400 metres when THANASI shifted out.

RACE 7: AUSTIN CONDON BENCHMARK 60 HANDICAP - 1600 metres

BUSKER'S BALLAD (S. Price) - trainer advised Stewards of a change of tactics prior to the event in that he would instruct his rider to attempt to settle more forward if possible in today's event. Settled midfield. Shifted out in the vicinity of the 400 metres contacting JUST A GIGOLO, which was hampered when tightened onto STORM FOX. Rider reprimanded.

A LITTLE CHUNKY (K. Crowther) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

BLINKY O'REILLY (S. Logan) - raced keenly in the early and middle stages of the event. Rider reported that the gelding failed to respond to her riding when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

SCOUT'S HONOUR (D. Tourneur) - slow to begin.

TIME ROGUE (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

STORM FOX (W. Cave) - raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

BARSHONTI (R. Clark) - raced keenly in the early and middle stages of the event. Held up from the entrance to the straight until approaching the 300 metres. Laid in under pressure in the straight.

MOLLY THE SNIP (K. Lau) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

JUST A GIGOLO (G. Lo) - hampered in the vicinity of the 400 metres when contacted by BUSKER'S BALLAD, which shifted out.

RACE 8: STAN EVANS BENCHMARK 60 HANDICAP - 1400 metres

KINGSGROVE (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

HAHNDORF (C. Jones) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres had to be taken hold of and was obliged to alter course to avoid the heels of EMMY AWARDS.

CURTAIN CALL (T. Pannell) - slow to begin.

HARLEM LOVE (K. Crowther) - laid in under pressure in the straight.

ANGEL'S WISH (K. Lau) - laid in under pressure in the straight.

RACE 8: STAN EVANS BENCHMARK 60 HANDICAP - 1400 metres (cont'd)

CROWN HARMONIUM (R. Clark) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

WONDER IF (NZ) (K. Bishop) - in the vicinity of the 1000 metres had to be steadied momentarily when racing behind HAHNDORF, which was forced to be taken hold of.

EMMY AWARDS (G. Lo) - in the vicinity of the 1000 metres shifted in when insufficiently clear of HAHNDORF resulting in C. Jones having to take hold of her mount and alter course to avoid the heels of EMMY AWARDS. As a consequence WONDER IF (NZ), which was racing behind HAHNDORF was obliged to be steadied and DAL ROMMEL (NZ), which was racing to the outside was hampered when taken wider on the track. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for period to commence midnight Sunday, 23 June 2019 and to conclude midnight Sunday, 30 June 2019, a period of three race meetings.

FREE THE WIND (D. Tourneur) - trainer advised Stewards of a change of tactics prior to the event in that he would instruct his rider to attempt to settle more forward in this event than the gelding had at its most recent starts. Settled midfield. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200

DAL ROMMEL (NZ) (J. Potter) - underwent a pre-race veterinary examination on arrival on course as it had not raced since September 2017 and was passed fit to start. In the vicinity of the 1000 metres was hampered when taken wider by HAHNDORF. A post-race veterinary examination revealed no visible abnormalities.
