RACE 1: THETERRACEFUNCTIONCENTRE.COM.AU BENCHMARK 120 HURDLE - 3340 metres

All runners underwent a pre-race veterinary examination and passed fit to start.

EXALTED LIGHTNING (T. Ryan) - jumped the ninth hurdle awkwardly.

All runners underwent a post-race veterinary examination which revealed no visible abnormalities.

RACE 2: GOLDIN FARMS BENCHMARK 60 HANDICAP - 2100 metres

SHAKOPEE (GB) (R. Hurdle) - approaching the home turn was momentarily inconvenienced when BARSHONTI laid in.

SLIPPERY JOURNEY (C. Lions) - raced three wide during the middle stages of the event.

DANOULI (S. Fawke) - performed below expectations. Underwent a post-race veterinary examination which revealed no visible abnormalities.

SPIEGEL GROVE (J. Holder) - held up for clear running from the vicinity of the 600 metres to the entrance to the home straight.

DIAMOND GEYSER (IRE) (D. Tourneur) - stood flat-footed and was slow to begin.



RACE 2: GOLDIN FARMS BENCHMARK 60 HANDICAP - 2100 metres (cont'd)

BARSHONTI (R. Clark) - inclined to lay in throughout the event. Approaching the home turn laid in inconveniencing SHAKOPEE (GB) for a short distance. Underwent a post-race veterinary examination which revealed no visible abnormalities.

RACE 3: GAWLER CUP - 'TWILIGHT' FRIDAY OCT 25TH / SABOIS MAIDEN PLATE - 1500 metres

INDIAN MO (P. Gatt) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: HOLDFAST INSURANCE / SABOIS MAIDEN PLATE - 1100 metres

KNAVESMIRE (T. Pannell) - jumped away awkwardly and shifted out bumping SHINING BRIGHTLY. Lost its off hind plate during the event.

MISS HARMONIUM (S. Fawke) - racing inside the 800 metres was awkwardly placed on heels for a short distance.

SHINING BRIGHTLY (R. Clark) - bumped on jumping away when KNAVESMIRE jumped away awkwardly and shifted out.

RACE 5: SANDERS FODDER BENCHMARK 60 HANDICAP - 1700 metres

I'M BULLETPROOF (K. Lau) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

BLINKY O'REILLY (R. Hurdle) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SASUN (K. Bishop) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

EXALTED JENNI (R. Clark) - slow to begin.

RED RAIDER (J. Maund) - a post-race veterinary examination revealed abnormal upper respiratory noise. Trainer, Ms K. Mooney, was advised that the results of a laryngoscopic exam were to be forwarded to the TRSA veterinary surgeon and a Veterinary Certificate of Fitness were required prior to a future trial or race.

RACE 6: COOPERS XPA BENCHMARK 64 HANDICAP - 1100 metres

HE IS GOLDEN (S. Price) - knuckled on jumping away and as a result was slow into stride. Performed below expectations. A post-race veterinary examination revealed lacerations on to both fore heels. First aid applied.

GEORDIE'S SECOND (K. Bishop) – refused to proceed to the start. Declared a late scratching at 3.38 pm by order of Stewards. Trainer, Mr D. Halliday, was advised that gelding was now required to proceed to the barriers without delay in two consecutive Official Barrier Trials prior to a future race.

WITH HOPE (G. Lo) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

QUIVERS (D. Tourneur) - inclined to lay in under pressure in the straight.



RACE 6: COOPERS XPA BENCHMARK 64 HANDICAP - 1100 metres (cont'd)

FUGITIVE (S. Fawke) - from the entrance to the straight until the vicinity of the 200 metres was unable to obtain clear running.

COOLIDGE (K. Lau) - jumped away awkwardly.

RACE 7: GBJC THANKS TERRY MCAULIFFE BENCHMARK 56 HANDICAP - 1500 metres

HASTA LA BULLET (S. Fawke) - rider explained that in his opinion the gelding felt awkward in its action and for that reason he did not fully test HASTA LA BULLET over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

A LITTLE CHUNKY (K. Lau) - very slow to begin. Co-trainers, Mr K. and Mrs H. Frew, were advised that a warning had been placed on the mare in relation to its starting manner.

JOCKS GLEN (R. Clark) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

UNRELATED (J. Potter) - slow to begin.

REIGNING IN PARIS (T. Voorham) - trainer, Mr J. Dunn, was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.
