

## THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Wednesday, 10 July 2019

#### RACE 1: EVRIGHT.COM / SABOIS MAIDEN PLATE - 1550 metres

The start of this event was delayed approximately two minutes.

**INDIAN MO** (P. Gatt) - jumped away awkwardly, shifted out and made heavy contact with EXALTED RUTH. A post-race veterinary examination revealed no visible abnormalities.

I WON'T DO THAT (D. Tourneur) - difficult to load. Trainer, Mr S. Burford, was advised that a warning had been placed on the gelding in relation to its loading manners. Jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**DALAKHANI GIRL** (T. Pannell) – as there was no other rider available on course permission was granted for T. Pannell to replace apprentice C. Jones. Jumped away very awkwardly and shortly afterwards was contacted by SUNNY GREEN. A post-race veterinary examination revealed no visible abnormalities.

**EXALTED RUTH** (K. Bishop) – contacted on jumping away by INDIAN MO, which shifted out. As a result K. Bishop became unbalanced. Shortly after the entrance to the straight was inconvenienced as SUNNY GREEN rolled in. From thereafter was held up for clear running when racing behind INDIAN MO, which was weakening, until approaching the 100 metres.

**PORTAMAGGIORE** (J. Toeroek) - jumped away awkwardly, shifted out and contacted SUNNY GREEN, which was taken out.



#### RACE 1: EVRIGHT.COM / SABOIS MAIDEN PLATE - 1550 metres (cont'd)

**SUNNY GREEN** (E. Boyd) - taken out on jumping away onto DALAKHANI GIRL. Hung in throughout the event. Hung out from in the vicinity of the 150 metres for the remainder of the event.

## RACE 2: DOMINANT CLASS TWO HANDICAP -1550 metres

**BLOW TORCH** (B. Vorster) – jumped away awkwardly. When racing keenly in the vicinity of the 1200 metres became awkwardly placed on the heels of TIME ROGUE and got its head up. Lost its near fore plate during the running of the event. A post-race veterinary examination revealed the colt to be lame in the near foreleg as a result of losing that plate.

**TERRITORY TITAN** (R. Clark) - hung out rounding the home turn for the remainder of the event. Lost its near hind plate during the running of the event.

FIRST THREE LEGS (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

**GO STRAIGHTANDHARD** (T. Pannell) - slow into stride. Shortly after the start shifted in behind runners to obtain cover. Inclined to hang in under pressure in the straight.

MISS MELLAINEOUS (K. Bishop) - raced wide without cover throughout the event.

**TIME ROGUE** (D. Tourneur) - awkward to begin.

#### RACE 3: SCHWEPPES BENCHMARK 60 HANDICAP - 2250 metres

**SANIMA STAR** (T. Voorham) - lost its position on jumping away when tightened between SHIRLEY'S EAGLE and LORD GREYSON.

SHIRLEY'S EAGLE (J. Maund) - jumped away awkwardly and shifted in onto SANIMA STAR. Over-raced throughout the event. In the vicinity of the 600 metres rolled out. Trainer, Mr J. Smith, advised that the gelding will now be spelled. A post-race veterinary examination revealed no visible abnormalities.

DISCO REBEL (C. Jones) - raced keenly in the early and middle stages of the event.

**MR STEAL (NZ)** (E. Boyd) - shortly after the start was obliged to be restrained off the heels of ZAALADD, which was taken out.

**DANOULI** (R. Clark) - jumped away awkwardly and shifted out taking ZAALADD wider. Held up for clear running from in the vicinity of the 500 metres until shortly after the entrance to the straight.

**BLINKY O'REILLY** (T. Pannell) – in the vicinity of the 900 metres quickened to take up a position in the lead. Inclined to lay out under pressure in the straight.

**ZAALADD** (L. Goomany) - on jumping away was taken out onto MR STEAL (NZ) by DANOULI, which jumped away awkwardly.

**BEHAVE** (D. Tourneur) – raced wide without cover throughout the event. In the vicinity of the 600 metres raced in restricted room and was hampered when tightened onto DISCO REBEL as SHIRLEY'S EAGLE rolled out.

BARSHONTI (J. Holder) - inclined to lay in under pressure in the straight.

LORD GREYSON (J. Potter) - jumped away awkwardly and shifted out onto SANIMA STAR.



#### RACE 4: AAMI / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1300 metres

The start of this event was delayed approximately one minute.

IT'S A MYTH (K. Crowther) - inclined to lay in, in the straight.

**ARCTIC BLAZE** (J. Holder) - had difficulty obtaining clear ground from approaching the 400 metres until in the vicinity of the 300 metres.

UNSCOPEABLE (J. Toeroek) - jumped away awkwardly. Laid in, in the straight.

**CALYPSO STORM** (P. Gatt) - fractious in the barriers after being loaded. Underwent a pre-race veterinary examination and was passed fit to start.

**WESTPORT** (B. Vorster) - jumped away awkwardly and was slow into stride. Raced wide without cover throughout the event.

# RACE 5: ELTON JOHN EXPERIENCE AT MORPHETTVILLE - BOOK NOW / SABOIS MAIDEN PLATE - 1250 metres

The start of this event was delayed approximately four minutes.

ALIRIS (T. Voorham) - made the turn in the vicinity of the 900 metres awkwardly.

**ISATMULAA** (K. Bishop) - raced keenly throughout the event.

SIDESTREET (S. Price) - a post-race veterinary examination revealed no visible abnormalities.

**TRUE ILLUSION** (K. Crowther) - slow into stride.

**ISSARA** (R. Hurdle) - in the vicinity of the 1000 metres shifted in abruptly onto PALI DE LYS, which was obliged to be steadied, contacted the running rail and lost its position. Had difficulty obtaining clear ground from rounding the home turn until approaching the 200 metres.

IT'S ALL GOSSIP (E. Boyd) - refused to load. Stewards withdrew IT'S ALL GOSSIP at 2.34 pm. Trainer, Mr J. Macmillan, was advised that the filly was now required to load without delay in an Official Barrier Trial prior to a future race.

**PALI DE LYS** (S. Fawke) - in the vicinity of the 1000 metres was obliged to be steadied, contacted the running rail and lost its position when ISSARA shifted in abruptly.

**ROYAL RING** (R. Clark) - contacted the outside partition of the barrier on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**ULTIMATE VIEW** (J. Potter) - underwent a pre-race veterinary examination on arrival at the barriers and was ruled unfit to start. Acting on this advice Stewards withdrew ULTIMATE VIEW at 2.29 pm.

## RACE 6: TERRY HOWE PRINTING CLASS TWO HANDICAP - 1000 metres

LIFE'S REWARD (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

THOMPSON'S REWARD (T. Pannell) - raced keenly in the early stages of the event.

**EXALTED GLORY** (J. Potter) - contacted on jumping away. Weakened from the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.



#### RACE 6: TERRY HOWE PRINTING CLASS TWO HANDICAP - 1000 metres (cont'd)

**HUSSLIN HUMPH** (D. Tourneur) - raced keenly in the middle stages of the event and approaching the 600 metres rolled out and was inconvenienced when awkwardly placed on the heels of GOODGEE.

**CHEVITE** (G. Lo) – permission was granted for G. Lo to only claim two kilograms of his allowance. G. Lo pleaded guilty to a charge under AR143(14)(a) and was fined \$100. On jumping away shifted in and contacted EXALTED GLORY. Hung in, in the straight.

#### RACE 7: TAB BENCHMARK 64 HANDICAP - 1400 metres

**CLASSY JOE** (S. Fawke) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**EXALTED TRAVELLER** (J. Holder) - jumped away awkwardly. Laid in under pressure in the straight.

**FLORID** (E. Boyd) - slow to begin. Approaching the 600 metres was taken wider and contacted OUTINTHESTREET.

**COUNTER SPIN** (D. Tootell) - over-raced throughout the event. When making the turn approaching the 600 metres, whilst over-racing, shifted out taking FLORID wider.

MISTY HALO (K. Bishop) - in the vicinity of the 700 metres, when racing keenly and being restrained, got its head up. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

**BRAKEFOOT BLING** (J. Potter) - the nasal strip fitted to the mare became unstuck prior to it being loaded and it therefore raced without the gear as declared.

## RACE 8: THANK YOU TERRY MCAULIFFE BENCHMARK 60 HANDICAP - 1250 metres

**HEROES QUEST** (S. Price) - in the vicinity of the 100 metres rolled in onto SIR JOHNSON, which was obliged to be checked and lost its position when tightened onto SYLVAN CREST, which was taken out. Rider reprimanded and advised to take greater care in future.

**COOL MAVERICK** (G. Lo) - approaching the 100 metres rolled out onto RAHEEBA, which was taken out and bumped with SYLVAN CREST. Rider was reprimanded and advised to take greater care in future.

**GROOVE WITH ME** (R. Clark) - jumped away awkwardly, shifted out and bumped STRYKER FORTUNE on a number of occasions.

**RAHEEBA** (T. Voorham) – jumped away awkwardly. Held up for clear running from near the 400 metres until approaching the 100 metres where it attempted a tight run between SYLVAN CREST and COOL MAVERICK, which rolled out, shifted out and contacted SYLVAN CREST.

**SIR JOHNSON** (J. Holder) – held up for clear running from in the vicinity of the 500 metres until the 300 metres. Had difficulty obtaining clear ground from the vicinity of the 200 metres until approaching the 100 metres, when it was obliged to be checked and lost its position when tightened onto SYLVAN CREST, which was taken out, and HEROES QUEST, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

SWIPE ME RIGHT (D. Tourneur) - jumped away awkwardly.

LET'S TANGO (K. Bishop) - made the turn in the vicinity of the 900 metres awkwardly.



## RACE 8: THANK YOU TERRY MCAULIFFE BENCHMARK 60 HANDICAP - 1250 metres (cont'd)

**SYLVAN CREST** (P. Gatt) - approaching the 100 metres bumped with RAHEEBA and was taken out onto SIR JOHNSON.

**JETTABEL** (K. Crowther) - slow into stride.

TOORAK ROAD (S. Fawke) - made the turn in the vicinity of the 900 metres awkwardly.

**STRYKER FORTUNE** (A. Jordsjo) - permission was granted for A Jordsjo to only claim one kilogram of her allowance. Having regards for all the circumstances Stewards issued no penalty. Bumped at the start.
