Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Saturday, 13 July 2019

RACE 1: - PROPER CLEAN STEEPLECHASE - 3340 metres

All runners underwent a pre-race veterinary examination and was passed fit to start.

LUCQUES (S. Jackson) - very awkward to begin.

PENTOMATIC (NZ) (W. Gordon) - very awkward to begin, threw its head up in the air after jumping away and struck its rider in the face. Rider returned to scale with blood from his nose, was examined by the First Care Medical personnel and passed fit to ride. A post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Mr E. Musgrove, was advised that as this was the gelding's second bi-lateral bleed it was now ineligible to start in a race in accordance with AR79(6).

All runners underwent a post-race veterinary examination, which, with the exception of PENTOMATIC (NZ), revealed no visible abnormalities.

RACE 2: GAWLER CUP - "TWILIGHT" FRIDAY 25TH OCT HURDLE - 3340 metres

All runners underwent a pre-race veterinary examination and was passed fit to start.

ANDREA MANTEGNA (USA) (R. Cully) - raced keenly in the early and middle stages of the event.

RACE 2: GAWLER CUP - "TWILIGHT" FRIDAY 25TH OCT HURDLE - 3340 metres (cont'd)

TANGARA (W. Gordon) – fell after jumping the first hurdle and dislodged its rider. Trainer, Mr E. Musgrove, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race. Rider was examined by the First Care Medical personnel and cleared of injury.

HERO'S HONOR (R. Short) – struck the last hurdle and fell on landing dislodging its rider. Rider was examined by the First Care Medical personnel and cleared of injury. HERO'S HONOR was examined by the veterinary surgeon, who administered first aid. The gelding was subsequently moved to a nearby stable location for further observation and assessment.

CABLE BAY (NZ) (B. Thomas-Rantall) – slow to begin.

JUMBO PRINCE (S. Jackson) – made the seventh hurdle awkwardly.

All runners underwent a post-race veterinary examination, which, with the exception of HERO'S HONOR, revealed no visible abnormalities.

RACE 3: GOLDIN FARMS HANDICAP - 1100 metres

KEMALPASA (K. Lau) – jumped away awkwardly.

EXALTED MAXINE (G. Cartwright) – laid out rounding the home turn.

WANAASA (K. Crowther) – inclined to lay out under pressure in the straight. Rider could offer no explanation for the horse's performance today. A post-race veterinary examination revealed no visible abnormalities.

THE PUBLIKIN (J. Holder) – laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: ONKA VALLEY FOOTBALL CLUB HANDICAP - 1100 metres

GRINZINGER EXPRESS (NZ) (J. Toeroek) – fractious after being loaded into its barrier stall. Inside the 900 metres shifted in taking the running of VALENTINA STAR, which was inconvenienced. Rider reprimanded for shifting ground when insufficiently clear. Rider explained that in his opinion the filly did not handle today's track conditions.

VALENTINA STAR (T. Pannell) – raced keenly in the early and middle stages of the event. Inside the 900 metres was inconvenienced by GRINZINGER EXPRESS (NZ), which shifted in. Rider explained that the filly failed to let down when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

AUTUMN SPLENDOUR (K. Crowther) – lost its off fore plate during the event. Laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

HATEECH (R. Clark) – jumped away awkwardly.

WICKED SCANDAL (K. Bishop) – raced wide without cover throughout the event.

RACE 5: HOLDFAST INSURANCE HANDICAP - 2100 metres

LORESHO (FR) (J. Huxtable) – near the 500 metres was tightened by DANCE OF HEROES (GB), which shifted out, and as a consequence was taken out onto the hindquarters of SAMSTAG making contact with that horse. As a further consequence, LORESHO (FR) was obliged to be steadied and lost its position.

RACE 5: HOLDFAST INSURANCE HANDICAP - 2100 metres (cont'd)

ECKHART (NZ) (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

DANCE OF HEROES (GB) (K. Crowther) - near the 500 metres shifted out to improve and tightened LORESHO (FR) onto SAMSTAG. Rider pleaded guilty to a charge of careless riding under AR131(a) for shifting ground when insufficiently clear, and was suspended from riding in races for a period to commence midnight Sunday, 21 July 2019, at the conclusion of her current suspension, and to expire midnight Wednesday, 31 July 2019, a period of four race meetings. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

WAR LEGEND (NZ) (S. Fawke) - raced a little keenly in the early stages of the event.

SAMSTAG (R. Clark) - raced keenly in the early stages of the event. Near the 500 metres was contacted by LORESHO (FR), which was taken out by DANCE OF HEROES (GB), and as a consequence had its hindquarters turned.

RACE 6: MARX REAL ESTATE HANDICAP - 1500 metres

CHAROSSA (J. Holder) - laid in under pressure in the straight.

MAXSAMIA (K. Bishop) - raced wide without cover throughout the event.

DOUBLE POCKETS (K. Crowther) - raced fiercely in the early and middle stages of the event. Laid out under pressure in the straight.

RACE 7: COOPERS XPA HANDICAP - 1200 metres

LOPE DE CAPIO (R. Hurdle) - raced keenly in the early and middle stages of the event.

TATOOSH (K. Crowther) - approaching the entrance to the straight was held up for clear running for a short distance and was obliged to shift to the outside of the field to obtain clear ground.

AMBERDI (J. Huxtable) - rounding the home turn was held up for a number of strides when racing in restricted room.

VIEIRA (G. Cartwright) - awkward and slow to begin.

NIPPERKIN (K. Bishop) - raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

ARROW LANE (S. Fawke) - laid out under pressure over the concluding 100 metres of the event.

RACE 8: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1100 metres

KNOTTED (J. Holder) - raced wide without cover throughout the event.

MUM'S MY HERO (G. Lo) - raced wide without cover throughout the event. Laid in, in the straight.

BOLT I AM (K. Crowther) - approaching the 800 metres became very awkward in its action, shifted in and contacted the running rail placing its rider at a disadvantage for a short distance.

HELLO GORGEOUS (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1100 metres (cont'd)

GOOD LUCK CHUCK (R. Clark) - had difficulty obtaining clear running from near the 400 metres until inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

QUIVERS (D. Tourneur) - held up for clear running from near the 400 metres until near the entrance to the straight.

BAJAN (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

GENERAL: RACE 2: GAWLER CUP - "TWILIGHT" FRIDAY 25TH OCT HURDLE - 3340 metres

On Sunday, 14 July 2019, the TRSA Veterinary Surgeon advised that following further examination and assessment and having regard for a neck injury sustained by the gelding in the fall, HERO'S HONOR was humanely euthanased.
