Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Wednesday, 21 August 2019

TRACK: Soft 6 (Moist but not a badly affected track)

Downgraded to Soft 7 at 1.28 pm retrospective to Race 2

(More rain affected track that will chop

out)

RAIL: Out 2 metres entire. Sectional 604 metres.

RACE 1: TAB BENCHMARK 120 HURDLE - about 3380 metres

All runners underwent a pre-race veterinary examination and were passed fit to start.

UNDERCOVER POET (W. Gordon) – struck the eleventh hurdle and fell. A post-race veterinary examination revealed no visible abnormalities. Rider was examined by the First Care Medical personnel and cleared of injury.

OUT OF KILTER (R. O'Sullivan) – rider's luggage did not arrive in Adelaide. As there was no helmet that was of the correct standard and size on course for that rider OUT OF KILTER was a late scratching by order of Stewards at 12.37 pm.

All runners underwent a post-race veterinary examination which revealed no visible abnormalities.

RACE 2: ADELAIDE PLAINS BLOODSTOCK / SABOIS MAIDEN PLATE - 1718 metres

AMERICAN HIPSTER (E. Boyd) - had to be taken hold of in the vicinity of the 200 metres when SMILING ASSASSIN shifted out.

INDIAN MO (P. Gatt) - trainer advised Stewards of a change of tactics prior to the event that he would instruct his rider to attempt to settle midfield with cover if possible in today's event. Settled behind midfield with cover. Raced keenly in the early and middle stages of the event. Held up from the vicinity of the 500 metres until inside the 300 metres.

GRABBING GLORY (R. Clark) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SMILING ASSASSIN (J. Chau) - laid out under pressure in the straight. In the vicinity of the 200 metres shifted out under riding into the running line of AMERICAN HIPSTER when insufficiently clear, resulting in E. Boyd having to take hold of her mount. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 24 August 2019 and to conclude midnight Saturday, 31 August 2019, a period of three meetings.

THEE QUEEN BEE (NZ) (J. Maund) - slow into stride.

ENOOD (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: GAWLER CUP 'TWILIGHT' FRIDAY OCT 25TH BENCHMARK 56 HANDICAP - 1718 metres

DIAMONDS ARE (L. Neindorf) - rolled in slightly in the vicinity of the 300 metres and then had its hindquarters turned resulting in the gelding shifting further in onto COMFORT MAN.

COMFORT MAN (J. Toeroek) - slow to begin. In the vicinity of the 300 metres had to be taken hold of and lost its position when tightened between DOWNUNDER PRINCE, which shifted out at the same time as DIAMONDS ARE rolled in slightly.

GO ONE MORE (T. Pannell) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr J. Croucher, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SAMSTAG (S. Price) - raced wide without cover throughout the event.

DOWNUNDER PRINCE (P. Gatt) - hung out throughout the event and in the vicinity of the 300 metres shifted out onto COMFORT MAN. Rider severely reprimanded and advised that in future he would be required to make a greater effort to keep his mounts straight when they commence to shift ground.

TIME ROGUE (R. Hurdle) - raced keenly in the early and middle stages of the event.

RACE 4: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1200 metres

BLUE TABLE (K. Lau) - shifted out on jumping away contacting KOSTYA.

BRUNETTE DOWNS (T. Voorham) - slow into stride.

KOSTYA (G. Lo) - contacted on jumping away.

VICTORY SPOILS (S. Fawke) - laid out under pressure over the concluding 600 metres.

BEACHLANE (P. Gatt) - rolled out in the vicinity of the 1100 metres onto TINNY BAR BLUE. Laid in under pressure in the straight.



RACE 4: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

LADIES GLASS (J. Toeroek) - lost its position shortly after the start when tightened onto BEACHLANE by JIVE BABY. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RUSTLE UP (D. Tourneur) - lost its off fore plate during the event.

SACRED WALK (NZ) (J. Holder) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

JIVE BABY (K. Crowther) - taken out on jumping away onto LADIES GLASS.

TINNY BAR BLUE (K. Bishop) - in the vicinity of the 1100 metres was hampered when BEACHLANE rolled out slightly.

VOSOTA (J. Maund) - shifted out shortly after jumping away onto JIVE BABY.

GREY FROG (R. Clark) - trainer, Mr J. Hyam, put a submission to Stewards that the gelding be a late scratching due to the track downgrade. Stewards acceded to this request and withdrew GREY FROG at 2.03 pm.

RACE 5: CORNERSTONE STUD CLASS ONE HANDICAP - 1100 metres

DAMASCUS MOMENT (T. Pannell) - jumped away awkwardly.

THANASI (R. Clark) - jumped away awkwardly.

THE TROOPER (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

CIBACHROME (R. Hurdle) - inclined to lay out under pressure in the straight.

ENOUGH SWAGGER (E. Boyd) - laid out under pressure in the straight.

PANZER PRINCESS (A. Jordsjo) - Stewards questioned the rider in relation to her riding of this mare in the straight. She explained that the mare was inclined to lay out under pressure rounding the home turn, then became awkward in its action approaching the 200 metres and she had become concerned and for this reason had not ridden her mount out to the finish. Stewards accepted her explanation; however, she was reprimanded under AR114(2)(a) in relation to reporting as soon as practicable after a race anything which might have affected the running of the horse. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: THANK YOU GOLDIN FARMS BENCHMARK 60 HANDICAP - 1500 metres

LAST WITNESS (A. Lindsay) - jumped away awkwardly and was slow into stride.

RIKIBOBBY (J. Chau) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

REDEEM BOUNTY (G. Lo) - inclined to shift about under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DOUBLE POCKETS (R. Clark) - raced keenly in the early and middle stages of the event.

SHINING BRIGHTLY (T. Pannell) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

SYLVAN CREST (K. Crowther) - raced keenly in the early and middle stages of the event.



RACE 6: THANK YOU GOLDIN FARMS BENCHMARK 60 HANDICAP - 1500 metres (cont'd)

GORILLE (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

THRONES (S. Fawke) - lost its near fore plate during the event.

RACE 7: COOPERS XPA BENCHMARK 60 HANDICAP - 2118 metres

LOOKING AROUND (NZ) (T. Pannell) – rider explained that the gelding travelled well in the early and middle stages of the event; however, when the pace quickened in the vicinity of the 700 metres he was unable to maintain contact with the field despite his efforts and when placed under pressure at the entrance to the straight the gelding did not respond and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

ALIRIS (J. Chau) - in the vicinity of the 1000 metres was inconvenienced by I'M BULLETPROOF and forced to ride without cover for the remainder of the event.

SPIEGEL GROVE (J. Holder) - jumped away awkwardly.

I'M BULLETPROOF (D. Tourneur) - in the vicinity of the 1000 metres shifted out contacting ALIRIS, which was taken wider on the tack. Rider reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

RACE 8: ATKINS PHOTOGRAPHY BENCHMARK 60 HANDICAP - 1200 metres

KID FLASH (E. Boyd) - shifted in on jumping away contacting KING ARTHUR. Rider reported that the gelding did not feel comfortable in its action in the straight, and in her opinion may not have handled the track conditions. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr N. Rabig, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

HAKERAK (T. Pannell) - underwent a pre-race veterinary examination and was passed fit to start. Slow to begin.

KING ARTHUR (J. Toeroek) - contacted on jumping away.

HILUMIERE (K. Bishop) - laid out under pressure in the straight.

SCARE CAMPAIGN (P. Gatt) - laid out under pressure in the straight.

FANDANGO (J. Potter) - jumped away extremely awkwardly and was slow to begin.

TOORAK ROAD (S. Fawke) - laid out under pressure in the straight.

GENERAL:

<u>Trackwork Morphettville Racecourse - Wednesday, 21 August 2019</u>

Stewards inquired into a report by the SAJC Trackwork Supervisor in relation to Jockey R. Clark using her mobile telephone whilst mounted on a horse. After considering her explanation Stewards laid a charge under AR113 in that she used her mobile telephone whilst mounted on a horse at trackwork. R. Clark pleaded guilty to the charge and was fined \$200.

All twenty-five (28) riders were breathalysed prior to taking their first ride of the day. All returned negative.
