# RACE 1: ADELAIDE GALVANISING INDUSTRIES / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1300 metres

**ANGASTON** (R. Hurdle) – held up for clear running from near the entrance to the straight until inside the 300 metres.

**GONDOLIER** (E. Boyd) – trainer, Mr J. Macmillan, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to lead in the event. Awkward to begin.

**OOLONG GAZE** (J. Holder) - laid in from near the entrance to the straight until near the 200 metres.

**DUBAI HOUSE** (B. Vorster) - raced keenly in the early stages of the event.

HOLY SANGRIA (P. Gatt) - awkward to begin.

JIVE BABY (K. Crowther) - raced wide without cover throughout the event.



# RACE 2: TAYLORS WINES / SABOIS MAIDEN PLATE - 1600 metres

**ELEVENBEE (NZ)** (D. Tourneur) – fractious in the float en route to the racecourse. Underwent a pre-race veterinary examination on arrival on course and was passed fit to start. Laid out from inside the 800 metres. Raced wide into and up the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**OUR FRANCIS** (S. Fawke) – contacted at the start. Laid out from inside the 800 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**CHAPPETTE** (T. Pannell) – laid out from near the 300 metres.

**NEW TESTAMENT** (T. Voorham) – awkward to begin, shifted out and contacted OUR FRANCIS. Laid in, in the straight. Held up for clear running from near the 400 metres until inside the 300 metres, and thereafter, approaching the 100 metres, became awkward inside the heels of SASSY RAIDER, which rolled in, and was obliged to alter course to the outside of that horse. A post-race veterinary examination revealed no visible abnormalities.

SASSY RAIDER (J. Potter) - rolled in approaching the 100 metres.

**SIRIUS JOURNEY** (J. Toeroek) - lost its off hind plate during the event.

**IRONIC SMILE** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

## RACE 3: CHEAP AS CHIPS / SABOIS MAIDEN PLATE - 1050 metres

**BARRYMORE** (T. Voorham) – laid in under pressure in the straight.

**KIROSHIMA** (S. Fawke) – awkward to begin, shifted out and contacted MAGNO. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**NIC'S SECRET** (K. Crowther) – had to have its off fore shoe replaced prior to leaving the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Rider reported that she felt that something was amiss with the gelding over the concluding stages and for that reason eased it out of the event over the final 50 metres. A post-race veterinary examination revealed no visible abnormalities.

OLIVE GROVE (J. Holder) - laid in under pressure in the straight.

**BLACK DIAMONDS** (S. Logan) – laid in, in the early part of the straight and became awkward on the heels of CADELLE for a short distance.

**CADELLE** (J. Chau) – laid out in the straight.

**MAGNO** (D. Tourneur) - contacted at the start. Rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres (7 times), and AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres (18 times). Having regard for the severity of the breach of the Rule and D. Tourneur's use of the whip over the final 100 metres of the event, and also D. Tourneur's record for whip breaches, Stewards determined that in relation to the breach for the consecutive use of the whip D. Tourneur be fined the sum of \$200, and in relation to the breach for using his whip on more than five occasions prior to the 100 metres that his licence to ride in races be suspended for a period of four (4) race dates to commence midnight Saturday 14 September 2019 and to conclude at midnight Wednesday 25 September 2019.



## RACE 3: CHEAP AS CHIPS / SABOIS MAIDEN PLATE - 1050 metres

**STAR PARFAIT** (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

#### RACE 4: ATLAS EVENT & PARTY HIRE FOUR-YEAR-OLD & OVER BENCHMARK 60 HANDICAP - 1200 metres

APPALACHIAN (K. Crowther) - contacted at the start. Over-raced in the early stages of the event.

**CENTRE SCOOTA** (L. Neindorf) – awkward to begin, shifted out and contacted APPALACHIAN.

**EXALTED HONEY** (S. Logan) - raced wide without cover throughout the event.

ALWAYS BE TRUE (K. Lau) – examined by the Club's Veterinary Surgeon on arrival at the barriers and was found to be lame in the near foreleg. Acting on this advice Stewards declared ALWAYS BE TRUE to be a late scratching at 1.17 pm.

**PERFEK** (D. Tourneur) – rider dropped his whip near the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

## RACE 5: AGFERT BENCHMARK 60 HANDICAP - 2200 metres

**SAGAAB** (T. Pannell) – laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ALIRIS** (J. Chau) – late scratching by Order of Stewards at 10.05 am acting on confirmed advice from co-trainer, Mr A. Gluyas, who advised that the gelding was lame in the near hind leg. Mr Gluyas was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**PAT THE WEAPON** (G. Lo) - inclined to shift about under pressure in the straight.

## RACE 6: HAULMARK BENCHMARK 56 HANDICAP - 1400 metres

**SYLVAN CREST** (K. Crowther) – rolled in shortly prior to the entrance to the straight and inconvenienced FANDANGO.

MABEL JOSEPHINE (E. Boyd) - laid out over the concluding stages of the event.

**MISS BRIXTON** (B. Vorster) – shifted about and contacted HAHNDORF on several occasions shortly after the start and thereafter raced keenly for a short distance.

**HAHNDORF** (T. Pannell) – shifted about and contacted MISS BRIXTON on several occasions shortly after the start and became unbalanced. A post-race veterinary examination revealed no visible abnormalities.

**FANDANGO** (J. Potter) – shortly prior to the entrance to the straight became awkward and was inconvenienced when racing inside the heels of SYLVAN CREST, which rolled in.

WILLOCHRA (J. Todd) - a -post-race veterinary examination revealed no visible abnormalities.

# RACE 7: COOPERS XPA FLYING HANDICAP - 1050 metres

**HUSSYBAY** (J. Holder) – laid out rounding the home turn and shortly after the entrance to the straight shifted out tightening COLUMBIA onto TEQUILA TIME, resulting in COLUMBIA being momentarily inconvenienced. Thereafter HUSSYBAY continued to lay out for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

**ALL OVER BOSANOVA** (G. Lo) - shifted out at the start onto DOMINATION, which shifted out and away from this horse onto SEVEN YEAR REWARD, making contact with SEVEN YEAR REWARD.

**COLUMBIA** (T. Pannell) – shortly after the entrance to the straight was inconvenienced when tightened onto TEQUILA TIME by HUSSYBAY.

**BAROOD** (D. Tourneur) – inclined to lay out in the straight.

**TEQUILA TIME** (R. Clark) – dipped shortly after the start. Rider reported that the gelding dipped on several occasions during the event. A post-race veterinary examination revealed no visible abnormalities.

**SEVEN YEAR REWARD** (J. Toeroek) – contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

**DOMINATION** (S. Logan) - trainer, Mr G. Young, was granted permission to add blinkers to the gear for this gelding after acceptance time and was fined \$200 under AR206. Shifted out and away from ALL OVER BOSANOVA at the start.

# RACE 8: HEINIGER BALAKLAVA CUP - 1600 metres

**WAGING WAR** (R. Clark) – rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres. Having regard for R. Clark's limited use of her whip over the final 100 metres of the event and her record Stewards fined R. Clark \$200.

**WASABI BOB** (J. Chau) – contacted at the start. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**BROWN BEN** (C. Parish) – inconvenienced at the start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**CHAROSSA** (J. Holder) – shifted out at the start and contacted WASABI BOB. Near the 1000 metres shifted in slightly and inconvenienced WHITE JADE. Rider reminded of his obligations when shifting ground. Laid in, in the straight. Rider explained that in his opinion CHAROSSA was left flatfooted in the straight and would be better suited to racing over more ground. A post-race veterinary examination revealed no visible abnormalities.

HANDSOME RETURN (NZ) (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

**DAWN RAID** (J. Todd) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres. Having regard for J. Todd's use of the whip over the final 100 metres of the event and his record Stewards imposed a fine of \$100.

**DOLLAR DOLLAR BILL** (D. Tourneur) – shifted out and away from WHITE JADE at the start and inconvenienced BROWN BEN.

# RACE 8: HEINIGER BALAKLAVA CUP - 1600 metres (Cont'd)

WHITE JADE (A. Lindsay) - contacted a fence in the mounting yard prior to proceeding to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Raced keenly in the early stages of the event and near the 1000 metres was inconvenienced by CHAROSSA, which shifted in slightly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres. Having regard for her limited use of her whip over the final 100 meters of the event and her record Stewards fined A. Lindsay \$200.

# RACE 9: TAB BENCHMARK 60 HANDICAP - 1600 metres

**DON'T DISMISS** (T. Voorham) - slow to begin. Shortly thereafter commenced to race keenly and was hampered for several strides by LEONARDA, which shifted in and thereafter continued to race keenly and near the 1200 metres was obliged to race wide without cover for some distance.

**ZOUNAMI** (B. Vorster) - inconvenienced at the start.

**REDEEM BOUNTY** (R. Hurdle) - contacted at the start by LEONARDA, which shifted out.

**SASUN** (J. Toeroek) - contacted at the start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**BALLAST** (J. Chau) - awkward to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Laid out in the straight.

**HE'S GOT SKILLS** (P. Gatt) - awkward to begin. Shifted out, contacted SASUN, which was taken out onto ZOUNAMI, which was inconvenienced. A post-race veterinary examination revealed no visible abnormalities.

**LEONARDA** (J. Potter) - awkward to begin. Shifted out and contacted REDEEM BOUNTY. Shortly thereafter shifted in and hampered DON'T DIMISS for several strides. Rider severely reprimanded and advised to take greater care when shifting ground. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**I'M BULLETPROOF** (J. Holder) - raced keenly in the early stages of the event. Mr. Grant Kluske the trainer of the gelding was questioned regarding comments he made in a post-race interview. After considering the matter, Stewards were satisfied with his explanation and took no action.

**REIGNING IN PARIS** (K. Bishop) - slow to begin.

## MURRAY BRIDGE (SUNDAY 8 SEPTEMBER 2019) RACE 7: DUTTONS ST GEORGE CLASS ONE HANDICAP - 1400 metres

On Tuesday 10 September 2019, Stewards concluded the inquiry which commenced on Sunday 8 September 2019, into the circumstances which led to a charge being laid against Apprentice T. Voorham under AR131(a) – (careless riding rule). At the inquiry on 10/9/19, Apprentice Voorham was assisted by Mr Darren Murphy. After considering further evidence and submissions by Apprentice Voorham and Mr Murphy, Stewards found Apprentice Voorham guilty of the charge and suspended her licence to ride in races for a period to commence at midnight on Saturday, 14 September and to conclude at midnight on Wednesday, 25 September 2019: a period of four meetings.
