Report on Race Meeting held at Gawler Racecourse  
by the Gawler & Barossa Jockey Club on Wednesday, 18 September 2019

**RACE 1: ATKINS PHOTOGRAPHY BENCHMARK 60 HANDICAP - 2132 metres**

**RED VALENTINE (NZ)** (S. Price) - approaching the 100 metres shifted in onto COBBERS MATE, which was tightened onto ZAALADD. Rider severely reprimanded and advised to make a greater effort in future when his mounts commence to shift ground.

**HAKERAK** (R. Hurdle) - stood flat-footed and was slow to begin.

**COBBERS MATE** (J. Potter) - raced keenly in the early and middle stages of the event. Approaching the 100 metres had to be checked and lost its position when tightened between ZAALADD, which shifted out at the same time as RED VALENTINE (NZ) shifted in.

**ZAALADD** (L. Goomany) - approaching the 100 metres shifted out onto COBBERS MATE, which was tightened onto RED VALENTINE (NZ). As a result of the interference the hindquarters of ZAALADD were turned in, turning that gelding out further into the running line of COBBERS MATE. Rider severely reprimanded and advised to make a greater effort in future when his mounts commence to shift ground. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**ISATMULAA** (C. Lions) - rider reported that her mount was inclined to lay out throughout the event.

Correct weight for this event was delayed to allow J. Potter (COBBERS MATE), placed fifth, and trainer, Mr R. Balfour, to view the official vision in the straight. After doing so J. Potter lodged an objection against RED VALENTINE (NZ) (S. Price) being declared the fourth placegetter, and ZAALADD (L. Goomany) being declared the third placegetter, on the grounds of alleged interference in the vicinity of the 150 metres. After considering the evidence, viewing the films and acting on their own observations Stewards *dismissed* both objections.

### **RACE 2: TAB / SABOIS MAIDEN PLATE – 1732 metres**

**MANILOW** (S. Price) – raced keenly in the early and middle stages of the event. Rider explained that the gelding had travelled keenly in the middle stages and as a result he found himself three wide and after being placed under pressure in the vicinity of the 500 metres had failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

**QUEEN'S SONG** (P. Gatt) – slow to begin.

**REGAL DOMAIN** (K. Bishop) – laid out under pressure in the straight.

**ROYAL RING** (J. Chau) – rider explained that the mare had travelled well in the early and middle stages of the event; however, when placed under pressure had only responded for a short distance and then had been one paced to the line. A post-race veterinary examination revealed no visible abnormalities.

**SMILING ASSASSIN** (J. Toeroek) – slow to begin. Rider explained that the gelding had travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight had failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 3: KINGSFORD HOTEL / SABOIS MAIDEN PLATE – 1200 metres**

The start of this event was delayed approximately one minute.

**FIGHT FOR FREEDOM** (J. Toeroek) – raced keenly in the early and middle stages of the event. Raced wide without cover throughout.

**THE ULSTERMAN** (S. Fawke) – jumped away awkwardly.

**GOOD TIME MADAM** (J. Potter) – a post-race veterinary examination revealed minor lacerations to the off hind legs. First aid applied.

**LIVERPOOL LANE** (T. Pannell) – laid out under pressure in the straight. Lost its off fore plate during the event.

**NATURE BOY (NZ)** (R. Clark) – required to be resaddled on arrival at the start. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground in the straight.

**RASUMADOLE** (J. Maund) – slow to begin. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**LONG GRASS** (G. Lo) – jumped away awkwardly. Rider reported that the filly raced greenly throughout the event.

### **RACE 4: PIRAHNA MEDIA / SABOIS MAIDEN PLATE – 1200 metres**

**HIGH STATUS** (A. Lindsay) – hampered on jumping away when tightened onto NEWBAY FLYER (NZ) by CRY OUT LOAD. Raced keenly in the early and middle stages of the event. Raced greenly when placed under pressure in the straight and had difficulty obtaining clear ground.

**CRY OUT LOUD** (S. Fawke) – jumped away awkwardly and shifted in onto HIGH STATUS. Inclined to lay in throughout the event.

#### **RACE 4: PIRAHNA MEDIA / SABOIS MAIDEN PLATE - 1200 metres (cont'd)**

**ISSARA** (T. Pannell) – rider explained that the mare had travelled well in the early stages of the event; however, when placed under pressure in the vicinity of the 600 metres had failed to respond to his riding and was disappointing in the straight. A post-race veterinary examination revealed the filly to be lame in the near hind leg. Trainer, Mr J. O'Connor, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**NONAME LANE** (R. Hurdle) – inclined to lay out under pressure in the straight.

**STAR GAIS** (C. Lions) – was examined by the Club's Veterinary Surgeon on arrival on course who reported that the mare was sore in the region of its withers and was unfit to race. Acting on this advice Stewards withdrew STAR GAIS at 12.55 pm.

**VALI ROSE** (G. Lo) – laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 5: COOPERS XPA CLASS TWO HANDICAP - 1732 metres**

The start of this event was delayed approximately two minutes.

**GWENT** (J. Potter) – rider reported that the mare had travelled well in the early and middle stages of the event; however, when placed under pressure had failed to let down and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

**NORTHSET** (L. Neindorf) – fractious in the mounting yard and required to be resaddled. Required to be resaddled again on arrival at the barriers. Slow to begin. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout.

**BARSHONTI** (R. Clark) – Stewards permitted R. Clark to ride the gelding 0.5kg over its declared weight of 54.0kg. Slow to begin. Inclined to lay in under pressure in the straight.

**TEMPERS FLARE** (J. Maund) – Stewards permitted J. Maund to ride the gelding 0.5kg over its declared weight of 54.0kg. Inclined to lay out under pressure in the straight.

#### **RACE 6: SANDERS FODDER BENCHMARK 60 HANDICAP - 1522 metres**

**BIG CALL** (C. Lions) – jumped away awkwardly. Hung out over the concluding 600 metres of the event.

**ABBI FEDE** (R. Clark) – raced keenly in the early and middle stages of the event. Inclined to shift about under pressure in the straight.

**TEXAS LIL** (P. Gatt) – co-trainer, Mr G. Kent, advised Stewards of a change of tactics prior to the event in that he would instruct his rider to attempt to settle in a more forward position in today's event if possible. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout.

**WICKED SCANDAL** (K. Bishop) – raced keenly in the early and middle stages of the event.

**COOL FONZY** (T. Pannell) – laid out under pressure in the straight.

**MAGLEV** (S. Logan) – slow to begin.

**RACE 7: CORNERSTONE STUD HEAT 2 - SIR PRANCEALOT SERIES MARES BM 60 HANDICAP - 1200 metres**

The start of this event was delayed by approximately three minutes.

**ZAGATO STAR** (J. Chau) – slow to begin.

**ENOUGH SWAGGER** (E. Boyd) – laid out in the early stages of the event. Laid in under pressure on straightening and in the vicinity of the 200 metres shifted in taking SAND CAT in. Rider reminded of her obligations and advised in future to make a greater effort to keep her mounts straight when they commence to shift ground.

**SAND CAT** (S. Fawke) – in the vicinity of the 200 metres was taken in onto HILUMIERE by ENOUGH SWAGGER.

**MISS MOSH** (R. Clark) – was obliged to alter course in the vicinity of the 200 metres to obtain clear ground.

**ARCTIC BLAZE** (K. Lau) – contacted on jumping away. Had to be momentarily steadied in the vicinity of the 800 metres when PARTY SET shifted in.

**SNOWBROOK** (A. Lindsay) – rider reported that the mare was inclined to lay out under pressure in the straight.

**HILUMIERE** (K. Bishop) – had to be taken hold of in the vicinity of the 200 metres when tightened between SAND CAT, which had been taken in, and LIBERTY'S GIFT, which had been taken out, and then became awkward in its action and laid out for the remainder of the event.

**LIBERTY'S GIFT** (J. Toeroek) – taken out by NITRO MAGIC from the entrance to the straight until the vicinity of the 200 metres when it was tightened onto HILUMIERE.

**NITRO MAGIC** (S. Logan) – fractious behind the barrier, broke free and was quickly captured by the Clerk of the Course. Underwent a pre-race veterinary examination on return to the barriers and passed fit to start. Trainer, Mr A. Justice, was advised that a warning had been placed on the mare in relation to its barrier manners.

**PARTY SET** (C. Lions) – shifted in on jumping away contacting ARCTIC BLAZE. In the vicinity of the 800 metres shifted in slightly onto ARCTIC BLAZE. Rider reminded of her obligations when shifting ground. Rider dismounted on pulling up and was examined by the First Care Medical personnel who reported an injury to her left foot. Rider was advised that a medical clearance was required prior to riding again.

**RACE 8: 2019 JERICHO CUP - 2019 SA HEAT FRI OCT 25 CLASS TWO HANDICAP - 1100 metres**

En route to the barrier LIFE'S REWARD shifted out abruptly dislodging A. Lindsay, resulting in that rider requiring medical attention. A. Lindsay was examined by the First Care Medical personnel and ruled unfit to fulfil this engagement. LIFE'S REWARD, which galloped riderless for a short distance prior to being recaptured was examined by the Club's Veterinary Surgeon and passed fit to race. As A. Lindsay was unfit to ride she was replaced by apprentice K. Lau. As a result Race 8 was rescheduled to run at 4.50 pm and Race 9 rescheduled to run at 5.15 pm.

**HE WILL BOOM** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**LIFE'S REWARD** (K. Lau) – shifted out abruptly en route to the barrier dislodging its rider A. Lindsay., and as a result was replaced by apprentice K. Lau.

**TURNPIKE** (A. Jordsjo) – a post-race veterinary examination revealed no visible abnormalities.

**HANKSTAR** (R. Clark) – shifted out abruptly inside the 200 metres to obtain clear ground.

**RACE 8: 2019 JERICHO CUP - 2019 SA HEAT FRI OCT 25 CLASS TWO HANDICAP - 1100 metres (cont'd)**

ICE HUNT (J. Maund) - jumped away awkwardly.

TOFFEE BELL (K. Bishop) - raced keenly in the early and middle stages of the event.

GRAVITY (S. Logan) - raced wide without cover throughout the event.

**RACE 9: PROPER CLEAN ENTIRES & GELDINGS BENCHMARK 60 HANDICAP - 1200 metres**

This event was rescheduled to run at 5.15 pm.

KNOTTED (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

WHITE HEATH (R. Clark) - jumped away awkwardly.

PEARL BANDIT (J. Chau) - had difficulty obtaining clear ground from the entrance to the straight until the 100 metres.

SCARE CAMPAIGN (P. Gatt) - laid out under pressure in the straight.

RUSHWA (J. Potter) - raced wide without cover throughout the event.

TOORAK ROAD (S. Fawke) - raced keenly in the early stages of the event. Inclined to lay out under pressure in the straight.

GONE TO PRINT (K. Lau) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.
