## RACE 1: AAMI SPRING CARNIVAL AT MORPHETTVILLE OCT 12-NOV 5 THREE YEAR OLD MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately seven minutes owing to a number of horses proving fractious during the loading process.

**CLEARY ADONIS** (G. Cartwright) - reshod prior to its entry to the mounting yard. Underwent a pre-race veterinary examination prior to proceeding to the barriers and was passed fit to race. Inclined to lay in, in the straight.

FLOREAT PICA (M. Harley) - laid in, in the straight.

MILITARY ROAD (R. Hurdle) - over-raced in the early stages. Thereafter was held up for clear running from the entrance to the straight until approaching the 100 metres.

**OUTPOST** (T. Pannell) - awkward to begin. Raced ungenerously for a short distance inside the 600 metres and thereafter was held up for clear running from the entrance to the straight and was unable to obtain clear running for the remainder of the event, and was untested to the finish. Rider reported that after being award to begin he was obliged to settle further back than intended.

**SEVEN LETTERS** (L. German) - as a consequence of JUST ZERENE being fractious in its barrier stall and kicking out, after becoming cast, this gelding was kicked and underwent a pre-race veterinary examination and was ruled unfit to race. Declared a late scratching at 12. 56 pm by order of Stewards on veterinary advice.

**DARK SENTRY** (R. Clark) - very difficult to load. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr G. Richards was advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

HANEDA (P. Gatt) - hung out under pressure in the straight.



# RACE 1: AAMI SPRING CARNIVAL AT MORPHETTVILLE OCT 12-NOV 5 THREE YEAR OLD MAIDEN PLATE - 1100 metres (Cont'd)

JUST ZERENE (B. Vorster) - became very fractious in its barrier stall, reared and thereafter became cast and had to be removed by the barrier staff. Underwent a pre-race veterinary examination and ruled unfit to start. A late scratching by order of Stewards at 12. 54 pm on veterinary advice. Trainer Mr T. McEvoy was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race as the filly was found to be lame in both hindquarters, with minor lacerations to its mouth and near hind leg. First aid administered. Rider examined by the First Care Medical Personnel and declared fit to fulfil his remaining engagements. Trainer Mr T. McEvoy advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**TERELLI** (K. Bishop) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 2: HAPPY 21ST BIRTHDAY ISABELLE TASSONE HANDICAP - 1100 metres

BEAUTY (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

**ALASKAN JADE** (K. Lau) - near the 700 metres was momentarily inconvenienced by YANKEE EYES, which shifted in across its running and thereafter near the 300 metres was contacted by LADY BETHANY (NZ), which shifted out to improve.

YANKEE EYES (E. Boyd) - raced wide without cover throughout the event. Shifted in near the 700 metres and inconvenienced ALASKAN JADE. Rider was reminded of her obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

**CARLALUISA** (R. Clark) - raced keenly and became awkwardly placed on the heels of TIARA STAR for a short distance between the 700 metres and 500 metres.

LADY BETHANY (NZ) (A. Jordsjo) - raced keenly in middle stages of the event. Held up for clear running from near the 500 metres until near the 300 metres, shifted out in an attempt to obtain clear running and contacted ALASKAN JADE for several strides taking this horse wider on the track. Rider was reprimanded and advised to take greater care when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

### RACE 3: FLEURIEU MILK COMPANY HANDICAP - 2014 metres

OCEAN WALZER (GER) (D. Holland) - laid out and shifted out over the concluding stages.

**DR DEPENDABLE** (J. Chau) - awkward to begin, shifted out contacted FRANKED (GB) inconveniencing and taking that horse our onto SAGAAB, which was inconvenienced. Inside the 600 metres became awkward on the heels of SAGAAB for a short distance as that horse weakened and shortly thereafter when improving its position between SAGAAB and FRANKED (GB), raced in restricted room between these two runners for a short distance.

SET TO CRUISE (T. Pannell) - laid out over the concluding stages.

SHOP TIL I DROP (NZ) (B. Vorster) - slow to begin. Held up for clear running from inside the 600 metres until approaching the 200 metres and was obliged to shift to the inside of DR DEPENDABLE to obtain clear running and shortly thereafter when improving into a run between DR DEPENDABLE and OCEAN WALZER (GER), raced in restricted room for a number of strides as OCEAN WALZER (GER), which laid out, shifted out.

DOCKER PAV (G. Cartwright) - laid out in the straight.

FIRST THREE LEGS (J. Potter) - hung in near the 800 metres.



## RACE 3: FLEURIEU MILK COMPANY HANDICAP - 2014 metres (Cont'd)

**SAGAAB** (J. holder) - inconvenienced at the start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

Following the running of this event B. Vorster was examined by the First Care Medical Personnel and declared unfit to fulfil his remaining engagements. B. Vorster was transported to hospital for further assessment.

#### RACE: 4 PATRICK JARRETT HANDICAP - 1200 metres

PRAIRIE FIRE (L. German) - a post-race veterinary examination revealed no visible abnormalities.

MAGNA BELLA (T. Pannell) - near the 200 metres was obliged to alter course to the outside of PRAIRIE FIRE to obtain clear ground. Rider reported it was his intention to settle in the first two however, after beginning only fairly he was obliged to settle a pair further back. A post-race veterinary examination revealed no visible abnormalities.

STRAGUN (G. Cartwright) - inconvenienced near the 800 metres and had to be steadied.

**STREET LIFE** (R. Clark) - Approaching the 800 metres shifted in to obtain cover and in doing so inconvenienced STRAGUN, which had to be steadied. Rider severely reprimanded for shifting ground when insufficiently clear. Laid in, in the straight.

**LUCKY CAT** (C. Hall) - slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 5: TOKYO CITY CUP - 1800 metres

VALAC (IRE) (L. German) - a post-race veterinary examination revealed no visible abnormalities.

WASABI BOB (R. Clark) - raced wide without cover in the early stages of the event.

**MUNTAHAA (IRE)** (M. Harley) - over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

TATOOSH (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

CHAROSSA (J. Holder) - laid in, in the straight.

**PIERROCITY** (D. Holland) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded,

#### RACE 6: TAB / ATA TRAINERS' TRUST HANDICAP - 1100 metres

DR DAPPER (L. German) - began awkwardly, shifted out and contacted WONDER IF (NZ).

**ZARACE** (A. Jordsjo) - shifted in on jumping away contacted THE DIFFERENCE, which was tightened onto ATOMIC LOKADE resulting in that horse's hindquarters being turned.

**THE DIFFERENCE** (C. Parish) - contacted at the start. Over-raced in the early and middle stages of the event. Laid in, in the straight. Was unable to obtain clear running over the final 100 metres of the event and as a consequence, was untested to the finish. Rider explained after receiving interference at the start he was obliged to settle a pair further back than he intended. A post-race veterinary examination revealed no visible abnormalities. Lost both fore plates during the event.



## RACE 6: TAB / ATA TRAINERS' TRUST HANDICAP - 1100 metres (Cont'd)

**ATOMIC LOKADE** (E. Boyd) - contacted by THE DIFFERENCE at the start and had its hindquarter's turned.

WONDER IF (NZ) (P. Gatt) - contacted at the start. Laid out rounding the home turn.

#### RACE 7: W H WYLIE HANDICAP - 1100 metres

**CASINO WIZARD** (J. Holder) - rider reported the gelding was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

MYSTYKO (NZ) (C. Hall) - over-raced in the early stages of the event. Inconvenienced near the 800 metres and again thereafter near the 600 metres. Near the 200 metres was obliged to alter course to the outside of ARROW LANE to obtain clear running. Laid in, in the straight.

**GIFT OF POWER (NZ)** (D. Thornton) - raced wide without cover from in the vicinity of the 800 metres.

**ALL OVER BOSANOVA** (G. Lo) - hampered for several strides shortly after the start. Laid out in the straight.

**KARLOVASI** (P. Gatt) - shifted in near the 800 metres and momentarily inconvenienced MYSTYKO (NZ). Rider reminded of his obligations when shifting ground.

**BENZ** (G. Cartwright) - awkward to begin, shifted in and hampered ALL OVER BOSANOVA for several strides.

BELLA VELLA (D. Holland) - a post-race veterinary examination revealed no visible abnormalities.

FANCY RUMBLE (J. Chau) - near the 600 metres rolled out and inconvenienced MYSTYKO (NZ).

SCHILLDORA (J. Toeroek) - over-raced in the early stages of the event.

#### RACE 8: ADELAIDE GALVANISING HANDICAP - 1600 metres

**LADY CONQUISTADOR** (L. German) - raced wide without cover from in the vicinity of the 1100 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**DEXTER YOU DEVIL** (S. Cahill) - over-raced in the early stages of the event.

WYLIE OL' COYOTE (J. Chau) - near the 1200 metres raced keenly and when being restrained as ESCALATOR (NZ) got into its running line, got its head up and raced ungenerous for a number of strides. Continued to race keenly and in the vicinity of the 500 metres raced in restricted room and was awkwardly placed between the heels of ESCALATOR (NZ) and DIAPASON (NZ) for a short distance.

**DOLLAR DOLLAR BILL** (C. Parish) - rider was restricted in his use of the whip over the concluding stages when it became entangled with the whip of G. Cartwright, the rider of DON'T DISMISS.

**DIAPASON (NZ)** (D. Thornton) - began awkwardly, shifted in and tightened ESCALATOR (NZ) onto WYLIE OL' COYOTE and as a consequence ESCALATOR (NZ) was hampered. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer Mr W. Clarken was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.



## RACE 8: ADELAIDE GALVANISING HANDICAP - 1600 metres (Cont'd)

**DON'T DISMISS** (G. Cartwright) - rider was restricted in her use of the whip over the concluding stages when it became entangled with the whip of C. Parish, the rider of DOLLAR DOLLAR BILL.

**ESCALATOR (NZ)** (J. Toeroek) - tightened and hampered at the start and thereafter over-raced for a short distance. Near the 1200 metres shifted in and hampered WYLIE OL' COYOTE, which had raced keenly in the lead up to the incident and when being restrained got its head up and raced ungenerous for a number of strides. Rider was severely reprimanded for shifting ground when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**ALLUSION** (R. Clark) - over-raced in the early stages of the event. Rider could offer no explanation in relation to the performance of the gelding in today's event other than it was disappointing. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to all J. Holder (ROTHMOORE) placed fourth and Trainer Mr R. Moore to view the vision in the straight.
