Report on Race Meeting held at Jamestown Racecourse  
by the Jamestown Racing Club on Sunday, 5 October 2019

**Stewards:** K. Lemay-Robbins (A/Chairman), C. Deakin (HT), & A. Milne (F) (Stewards), A. Deakin & C. Edson (Deputy Steward), Dr G. Warren (Veterinary Surgeon).

**TRACK:** Good 3 (Track with good grass coverage and cushion)  
(Upgraded to a Firm 2 @11.30 am) (Firm track with reasonable grass coverage)

**RAIL:** True

**WEATHER:** Overcast

**RACE 1: JAMESTOWN CONTAINER DEPOT/JAMESTOWN CONCRETE/SWAN  
PHARMACIES/WEBBS TYRE SERVICE BM64 HANDICAP - 1000 metres**

**KNOTTED** (L. Neindorf) - in the vicinity of the 700 metres shifted in tightening **REACT**, which was obliged to be steadied. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

**SHE'S OUR GIFT** (L. Goomany) - slow to begin. Approaching the 300 metres shifted out onto **SHE'S GOT THE GOODS**. Rider reminded of his obligations to take greater care when shifting ground in future.

**SHES GOT THE GOODS** (P. Crich) - slow to begin. Approaching the 300 metres was obliged to ease and alter course to avoid the heels of **SHE'S OUR GIFT**, which shifted out.

**REACT** (D. McWhinney) - in the vicinity of the 700 metres was obliged to be steadied when tightened for room by **KNOTTED**, which shifted in.

**RACE 2: KELLY TOYOTA/KERIN LANDMARK/JAMESTOWN ENGINEERING &  
MANUFACTURING/FINANCIAL SERVICE SA/SABOIS MAIDEN - 1000 metres**

**GO HERBIE** (C. Lions) - raced greenly throughout the event. Rider reported that her horse was disappointing in the straight and failed to finish off the event as expected. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer Mrs S. Ratsch was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**DRAW SHOT** (D. Tootell) - laid in, in the straight.

**RACE 3: REDDEN BROS PTY LTD/RYNNE'S HARDWARE AND SPORTS STOREE/JAMESTOWN  
COUNTRY RETREAT CARAVAN PARK/SABOIS MAIDN PLATE- 1340 metres**

**LANGKAWI** (C. Lions) - laid in, in the straight.

**MAGIC BUDDY** (D. Tootell) - laid in, in the straight.

**AUSTIN RAIDER** (L. Neindorf) - slow to begin. Laid in, in the straight.

**MISS DONCH** (K. Bishop) - laid in under pressure in the straight.

**RACE 3: REDDEN BROS PTY LTD/RYNNE'S HARDWARE AND SPORTS STOREE/JAMESTOWN COUNTRY RETREAT CARAVAN PARK/SABOIS MAIDN PLATE- 1340 metres (Cont'd)**

**RYZLINK** (E. Annells) raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: COMPLETE CHIROPRACTIC/MURRAY PEST CONTROL JAMESTOWN/QUALITY LIVESTOCK BENCHMARK 60 HANDICAP - 1340 metres**

**JUST A BIGGER DASH** (E. Annells) - hung in, in the straight. In the vicinity of the 100 metres shifted in under riding inconveniencing and taking **STRYKER FORTUNE** in. Rider was severely reprimanded and advised to stop riding and straighten her mount in future.

**BEL MOSHE** (P. Crich) - very awkward to begin and slow into stide. Trainer Mr Frew was advised a warning had been placed on the mare in regards to its barrier manners.

**STRYKER FORTUNE** (L. Goomany) - hung out throughout. In the vicinity of the 100 metres was taken in and inconvenienced by **JUST A BIGGER DASH**, which shifted in.

**RACE 5: RAILWAY HOTEL / COOPERS JAMESTOWN CUP - 1800 metres**

**IT'S HUMPHREY** (L. Neindorf) - shifted out on jumping away contacting **CITY BEATS**.

**CITY BEATS** (E. Annells) - was contacted on jumping away by **IT'S HUMPHREY**, which shifted out. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**FIRST THREE LEGS** (K. Bishop) - laid in, in the straight. On the finish line, the gelding knuckled dislodging its rider. A post-race veterinary examination revealed the gelding had fractured its off fore canon bone and was humanely euthanased. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

Correct weight for this event was given on the numbers semaphored by the judge being:

First - 5 - OH SO UNFAIR  
Second - 6 - FANTASTIC MAGIC  
Third - 2 - DON'T' DISMISS  
Fourth - 4 - FIRST THREE LEGS

Prior to the running of Race 6, Stewards were approached by an owner of **DON'T DISMISS** believing that his horse should have been placed second in this event. Stewards took evidence from the judge Mr C. Kutcher who advised that he had inadvertently semaphored the incorrect placings and after viewing the official photo image of the race, Stewards were satisfied on the available evidence that the judge had made an error with the semaphoring of the finishing order and altered the official placings to be:

First - 5 - OH SO UNFAIR  
Second - 2 - DON'T' DISMISS  
Third - 6 - FANTASTIC MAGIC  
Fourth - 4 - FIRST THREE LEGS

**RACE 6: MICHAEL NOONAN MEMORIAL CUP BENCHMARK 54 HANDICAP - 1200 metres**

The start of this event was delayed approximately 10 minutes due to the fall in Race 5.

**SWANKYTOFF** (K. Bishop) - laid in, in the straight.

**DESERT DUEL** (E. Annells) - rider reported the gelding did not travel in today's event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. First aid administered. Trainer Ms J. Virgin was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**JARRVIS** (D. McWhinney) -. In the vicinity of the 1000 metres became awkward in its action and was eased out of the event. Rider reported his horse resented the kickback. A post-race veterinary examination revealed the gelding to be sore in its lower back. Trainer Mr G. Kluske was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.
