

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 12 October 2019

RACE 1: ROMEO'S FOODHALL IGA HANDICAP - 2500 metres

AAGAS (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

FRANKED (GB) (T. Pannell) – awkward to begin, shifted out and contacted GOLDEN FLAG (NZ). Raced keenly in the early stages of the event. Laid out in the straight.

GOLDEN FLAG (NZ) (G. Cartwright) - contacted at the start.

RACE 2: ROMEO'S RUNDLE MALL THREE-YEAR-OLD MAIDEN PLATE - 1200 metres

JIMMY WITHA DASH (T. Pannell) – awkward to begin. Laid out in the straight. Rider reported that as a consequence of being awkward to begin he was unable to lead as intended and added that having regard for the manner in which the gelding raced it may benefit from today's run. A postrace veterinary examination revealed no visible abnormalities.

PARTY HACK (J. Potter) - laid out over the concluding stages of the event.

RACE 2: ROMEO'S RUNDLE MALL THREE-YEAR-OLD MAIDEN PLATE - 1200 metres (cont'd)

SEVEN LETTERS (L. Riordan) – approaching the 1100 metres was inconvenienced and had to be momentarily steadied when MISS CON DELAGO shifted in. Over-raced in the early stages of the event. Laid out rounding the home turn. Rider explained that owing to the racing manners of this gelding he did not persevere with his riding from inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

MISS CON DELAGO (P. Gatt) – awkward to begin. Approaching the 1100 metres shifted in and inconvenienced SEVEN LETTERS, which was obliged to be momentarily steadied. Rider was reprimanded under AR131(a) for careless riding. Laid in, in the straight.

VALI ROSE (J. Chau) – held up for clear running from approaching the 400 metres until near the 300 metres.

RACE 3: ROMEO'S FOODLAND HANDICAP - 1600 metres

The start of this event was delayed approximately three minutes.

REIBY THE RED (A. Jordsjo) - raced wide without cover throughout the event. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

JACKTHEGIANTSLAYER (G. Lo) – in adjacent stall to fractious horse. Underwent a pre-race veterinary examination and was passed fit to start. Rider examined by the First Care Medical personnel and passed fit to fulfil his riding engagements. Inclined to lay out over the concluding stages of the event.

STAR STATUS (J. Chau) - fractious in the barriers after being loaded, reared and got its off foreleg over the barrier partition. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice Stewards withdrew START STATUS at 2.18 pm. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that gelding was now required to prove tractable and perform satisfactorily in an Official Trial or an Approval to Race jump-out prior to a future race start.

SHAKOPEE (GB) (R. Hurdle) – late scratching by order of Stewards at 8.00 am acting on advice from Trainer, Mr G. Young, that he had missed the scratching deadline owing to circumstances involving an injured stable employee at the track this morning.

CONCONI (K. Crowther) – rider reported that the mare failed to let down as expected in the straight and was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

PIERRO'S PROMISE (G. Cartwright) - rider explained that the gelding made breathing noises on pulling up. A post-race veterinary examination revealed no visible abnormalities.

DESIDERO (D. Tourneur) - shifted out under pressure over the concluding 100 metres.

RACE 4: ROMEO NEW SUPA VALU HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes.

MORE THAN EXCEED (NZ) (K. Crowther) - over-raced in the early and middle stages of the event.

STREET LIFE (A. Jordsjo) - near the 1000 metres shifted in slightly. Obliged to be steadied near the winning post when EXTREME THRILL rolled in. A post-race veterinary examination revealed no visible abnormalities.

EXTREME THRILL (G. Cartwright) – near the winning post rolled in and inconvenienced STREET LIFE, which was obliged to be steadied.



RACE 4: ROMEO NEW SUPA VALU HANDICAP - 1200 metres (cont'd)

CHAPEL CITY (D. Tourneur) - near the 1000 metres shifted out slightly and contacted KAMIEN, which was hampered for a number of strides.

KAMIEN (L. Riordan) – near the 1000 metres shifted in slightly and shortly thereafter was contacted by CHAPEL CITY, which shifted out slightly. Shortly thereafter was hampered for several strides when obliged to race in restricted room inside the heels of STREET LIFE, which shifted in slightly.

ATEN (B. Vorster) – rider explained that the filly began awkwardly, was inclined to lay in over the first 200 metres of the event; thereafter it settled in running, however, from near the 600 metres was under pressure and failed to finish the event off as expected. A post-race veterinary examination revealed no visible abnormalities.

EXALTED TRAIL (J. Holder) – held up for clear running from approaching the entrance to the straight until approaching the 100 metres.

RACE 5: HILL SMITH STAKES - 1800 metres

EXALTED AMBITION (R. Hurdle) - shortly after the start was inconvenienced when awkward on the heels of PISCEAN after being taken out by RAABEEHA, which shifted out.

PISCEAN (M. Aitken) – trainer, Mr D. Williams, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle forward of midfield.

SILENT SOVEREIGN (J. Maund) - awkward to begin, shifted out and contacted SOWPODS. Overraced in the early stages of the event.

MARNDARRA (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

MAGAZINE (NZ) (J. Toeroek) – inclined to lay out over the concluding stages of the event. A postrace veterinary examination revealed no visible abnormalities.

RAPTURES (T. Pannell) – Mr M. Seyers, acting on behalf of co-trainers, Messrs D. & B. Hayes and Mr T. Dabernig, advised Stewards prior to the event of a change of tactics in that he would instruct the rider to settle more forward in today's event. Commenced to weaken from in the vicinity of the 600 metres, failed to raise a gallop thereafter and was eased from the event. A post-race veterinary examination revealed the filly to have atrial fibrillation. Mr D. Hayes was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the colt performing satisfactorily in an Official Barrier Trial.

RAABEEHA (P. Gatt) - shifted out at the start.

RACE 6: COMMUNITY CO HANDICAP - 1050 metres

THOMPSON'S REWARD (J. Toeroek) – rider reported that his mount over-raced in the early stages of the event.

SHAMINO (K. Crowther) – over-raced in the early stages of the event. Held up from the entrance to the straight until the 200 metres.

HELLO GORGEOUS (NZ) (J. Maund) – Stewards acceded to a request from Trainer, Mr G. Searle, for a late gear change being the removal of the bar plates from the front feet. Mr Searle was fined \$200 under AR206(3). Near the 300 metres, when improving its position, became awkward on the heels of MUSICAL QUERY for a number of strides and was obliged to shift to the outside of that horse to obtain clear running.

RACE 6: COMMUNITY CO HANDICAP - 1050 metres (cont'd)

GOODGEE (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

I AM (B. Vorster) - raced keenly in the early stages of the event.

ALWAYS SACRED (S. Fawke) - late scratching by order of Stewards at 8.00 am acting on advice from Trainer, Mr G. Young, that he had missed the scratching deadline owing to circumstances involving an injured stable employee at the track this morning.

RACE 7: ANTONIO & ELISABETH ROMEO HANDICAP - 1200 metres

BAYOU (K. Lau) - underwent a pre-race veterinary examination on arrival on course and was passed fit to start. Raced fiercely for a short distance in the early stages of the event.

MY DIVAS (L. Riordan) – raced fiercely for a short distance in the early stages of the event. Held up for clear running from the entrance to the straight until approaching the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

CARLALUISA (J. Chau) - laid out over the concluding stages of the event.

RAINMOTH (J. Toeroek) - inclined to lay in, in the straight.

KENYAN WONDER (S. Fawke) – kicked a fence leaving the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Slow to begin. Raced fiercely for a short distance in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: ROMEO'S DURBRIDGE STAKES - 1200 metres

The start of this event was delayed approximately three minutes.

CASINO WIZARD (J. Holder) - began awkwardly, shifted in and contacted SCHILLDORA. Near the 1000 metres shifted in when insufficiently clear tightening KEMALPASA onto PETRELLE, which in turn was tightened onto EVERYDAY LADY, resulting in these three horses being severely hampered for several strides. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight Saturday, 19 October 2019 to conclude midnight Sunday, 27 October 2019, a period of four race dates.

KEMALPASA (J. Toeroek) – near the 1000 metres was tightened for galloping room when inside the heels of CASINO WIZARD, which shifted in. As a consequence had to be restrained and after making contact with PETRELLE to its inside was taken out by PETRELLE, which shifted out when being restrained. As a consequence KEMALPASA shifted out taking SCHILLDORA a little wider.

KARLOVASI (J. Maund) – inside the 200 metres shifted in when insufficiently clear, taking the running of MARCEL FROM MADRID, which had commenced to improve to its inside resulting in MARCEL FROM MADRID having to be steadied to avoid the heels of KARLOVASI and alter course to the outside of that horse. Rider pleaded guilty to a charge of careless riding under AR131 and was suspended from riding in races for a period to commence midnight Sunday, 13 October 2019 and to expire midnight Saturday, 19 October 2019, a period of three meetings.

BENZ (R. Hurdle) – dislodged its rider en route to the barriers and galloped freely for some distance before being captured. Stewards ordered BENZ a late scratching at 5.26 pm.



RACE 8: ROMEO'S DURBRIDGE STAKES - 1200 metres (cont'd)

MARCEL FROM MADRID (B. Vorster) - began awkwardly, shifted out and contacted SCHILLDORA. Near the 200 metres, when improving into a run to the inside of KARLOVASI, was obliged to be restrained as KARLOVASI shifted in under riding, and as a consequence MARCEL FROM MADRID was obliged to alter course to that horse's outside, and thereafter was unable to improve its position over the concluding stages when in restricted room between the heels of KARLOVASI and ARROW LANE.

EVERYDAY LADY (T. Pannell) – near the 1000 metres was severely hampered when tightened and making contact with the inside running rail when in restricted room inside PETRELLE as that horse was taken in by KEMALPASA. Held up for clear running from the entrance to the straight until inside the 200 metres.

PETRELLE (D. Tourneur) – near the 1000 metres was hampered by KEMALPASA, which shifted in after being tightened by CASINO WIZARD. A post-race veterinary examination revealed no visible abnormalities.

SCHILLDORA (P. Gatt) - hampered at the start when tightened between runners. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow S. Fawke (ARROW LANE), placed third, and trainer, Mr J. Hickmott, to view the official vision in the straight.
