Report on Race Meeting held at Port Lincoln Racecourse
by the Port Lincoln Racing Club on Wednesday, 16 October 2019

RACE 1: MITTYS / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately four minutes.

ARTFULABEERS (S. Logan) - slow to begin.

DIAL (T. Voorham) - slow to begin.

RASHYATHERE (G. Lo) - jumped away awkwardly. Laid in, under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SEA HOFFA (B. Sweeney) - reared in its barrier after being loaded. Underwent a pre-race veterinary examination and was passed fit to start. Rider was examined by the First Care Medical personnel and ruled unfit to ride in this event. Acting on that advice Stewards withdrew SEA HOFFA at 1.48 pm. Trainer, Mr T. Montgomerie, was advised that a warning had been placed on the gelding in relation to its barrier manners. Rider was re-examined by the First Care Medical personnel following the event and was passed fit to fulfil his remaining engagements.

THE MASTER (K. Crowther) - raced wide without cover throughout the event. Laid in, in the straight.

RACE 2: BRIAN HARVEY AGENCIES / SABOIS MAIDEN PLATE - 1210 metres

The start of this event was delayed approximately five minutes.

RACE 2: BRIAN HARVEY AGENCIES / SABOIS MAIDEN PLATE - 1210 metres (cont'd)

ICE TRAIN (A. Jordsjo) - reared on arrival at the barriers dislodging its rider. A. Jordsjo was examined by the First Care Medical personnel and ruled unfit to fulfil her remaining engagements. A. Jordsjo was transferred to hospital for x-rays. Trainer, Mr T. Haddy, was advised that a warning had been placed on the gelding in relation to its pre-race manners.

KOODA MISCHIEF (J. Chau) - in the vicinity of the 600 metres was inconvenienced when taken wider by PUT DEBEERS ON BAR. Hung out rounding the home turn.

TAJAVEDO (B. Sweeney) - raced keenly in the middle stages of the event, and in the vicinity of the 600 metres shifted in and contacted the running rail, became awkward in its action and lost ground. Trainer, Mr B. Lear, was advised that a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

PUT DEBEERS ON BAR (K. Crowther) - slow to begin. In the vicinity of the 600 metres was severely hampered in avoiding TAJAVEDO, and shifted out onto KOODA MISCHIEF.

SMARTFUL (T. Voorham) - inconvenienced in the vicinity of the 600 metres when taken wider by STURT'S PRIDE.

STURT'S PRIDE (S. Fawke) - attempted to buck for a short distance shortly after the start. Trainer, Mr B. J. Cozamanis, was advised that a warning had been placed on the mare in relation to its racing manners. Severely hampered in the vicinity of the 600 metres when avoiding TAJAVEDO, and shifted out onto SMARTFUL.

RACE 3: JP CABINETS BENCHMARK 80 HANDICAP - 1210 metres

ARTFUL RAMBLER (S. Logan) - approaching the 100 metres was disappointed when attempting a tight run between the heels of NEVA DOUBT US and TOLSTOY, and as a result was obliged to alter course to obtain clear ground. Rider, S. Logan, returned to scale approximately 1.5 kgs below the weight she was required to carry in the race. Stewards were able to establish that a lead bag which the rider had weighed out with had not been added to the saddle and Stewards were able to locate it at the stall where the mare had been saddled. Trainer, Mr R. King, was charged under AR209(2)(b) in that he was the person at fault in relation to ARTFUL RAMBLER failing to carry the correct weight. Mr King pleaded guilty and was fined \$1000. In arriving at this penalty Stewards took into account Mr King's plea of guilt and that he had held a trainer's licence for fifty years without a similar incident. As a result, ARTFUL RAMBLER, which placed third, was disqualified from the event under AR209(2)(a) and Stewards declared the new numbers to be:

EYE THE WORLD (E. Boyd) - shifted in on jumping away contacting STAR MOVER.

NEVA DOUBT US (K. Crowther) - raced wide without cover throughout the event.

STAR MOVER (S. Fawke) - shifted out on jumping away and contacted EYE THE WORLD. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TUNARAMA COACHLINES CLASS ONE HANDICAP - 1210 metres

FEARLESS AL (K. Crowther) - raced wide without cover throughout the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ARTFUL AMBITION (J. Chau) - hung out rounding the home turn.

RACE 4: TUNARAMA COACHLINES CLASS ONE HANDICAP - 1210 metres (cont'd)

GOURMELIN (S. Fawke) – inconvenienced shortly after the start and had to be steadied when MR TRUMAN was taken out into its running line. Raced keenly in the early and middle stages of the event.

TOFFEE BELL (T. Voorham) – a post-race veterinary examination revealed no visible abnormalities.

AUGUSTER RUSH (B. Sweeney) – jumped away awkwardly.

JUSTICA (J. Toeroek) – taken out shortly after the start onto MR TRUMAN.

CALL ME CRACKERS – late scratching at 3.08 pm as there was no available rider on course.

MR TRUMAN (S. Logan) – taken out shortly after the start into the running line of GOURMELIN.

DERR PHONZ (C. Lions) – taken out shortly after the start onto JUSTICA. Raced keenly in the middle stages of the event.

LASANTA (L. Neindorf) – shifted out shortly after the start onto DERR PHONZ.

RAYLEIGH (E. Boyd) – jumped away awkwardly.

RACE 5: LEADER DISTRIBUTORS BENCHMARK 64 HANDICAP - 1390 metres

The start of this event was delayed approximately two minutes.

STONECAST (J. Chau) – jumped away awkwardly.

BEAU'S MY BOY (B. Sweeney) – a post-race veterinary examination revealed no visible abnormalities.

IT'S HUMPHREY (T. Pannell) – required to have its tongue tie refitted after being loaded.

HETUKA ZARSHO (J. Toeroek) – rider reported that the gelding laid in, in the straight.

OBLIQUE LINE (S. Logan) – jumped away awkwardly. Held up from the vicinity of the 150 metres until the concluding stages of the event.

SAINT VALENTINE (E. Boyd) – raced wide without cover throughout the event.

REDEEM BOUNTY (K. Crowther) – held up from the vicinity of the 200 metres and was untested to the finish.

REIGNING IN PARIS (T. Voorham) – raced in restricted room rounding the home turn when awkwardly placed inside the heels of BEAU'S MY BOY. Had difficulty obtaining clear ground for a number of strides in the vicinity of the 200 metres.

RACE 6: LOCAL LIQUID BENCHMARK 60 HANDICAP - 1000 metres

TINTAGEL ROCKER (J. Chau) – raced keenly in the early and middle stages of the event.

MY LESSON (L. Neindorf) – raced fiercely in the early and middle stages of the event and was inclined to shift about. A post-race veterinary examination revealed no visible abnormalities.

MIRTHDALE (T. Pannell) – slow to begin.

RACE 6: LOCAL LIQUID BENCHMARK 60 HANDICAP - 1000 metres (cont'd)

SOCIAL MEDIA (G. Lo) – jumped away awkwardly. In the vicinity of the 100 metres was taken out onto BEDLOE’S ISLAND.

NIPPY LIPPY (S. Fawke) – in the vicinity of the 100 metres shifted out under pressure onto SOCIAL MEDIA, which was taken wider. Rider reprimanded and advised in future to make a greater effort to keep his mounts straight when they commence to shift ground.

BEDLOE’S ISLAND (K. Crowther) – taken out in the vicinity of the 100 metres contacting WILANDER PRINCESS, and then was unable to obtain clear ground for the remainder of the event.

SERIOUS MOONLIGHT (E. Boyd) – slow to begin.

WILANDER PRINCESS (S. Logan) – contacted and became unbalanced in the vicinity of the 100 metres when BEDLOE’S ISLAND was taken out.

ROCKET LYLES – late scratching at 3.22 pm as there was no available rider on course.

RACE 7: LIBERTY RURAL PORT LINCOLN BENCHMARK 60 HANDICAP - 1210 metres

GOTTABITON (J. Toeroek) – taken out in the vicinity of the 300 metres into the running line of CHASE SOPRANO.

CHASE SOPRANO (S. Logan) – inconvenienced momentarily in the vicinity of the 300 metres when GOTTABITON was taken out into the mare’s running line, and as a result was taken wider on the track.

CRAZY CULPRIT (B. Sweeney) – jumped away awkwardly.

DOWN’S AFTER DARK (S. Fawke) – shifted out in the vicinity of the 300 metres onto GOTTABITON. Rider reminded of his obligations when shifting ground.

ARTFUL MONTY (C. Lions) – raced wide without cover throughout the event. Raced keenly in the early and middle stages.

LICORICE BULLET (G. Lo) – inconvenienced in the vicinity of the 200 metres when S. Logan was taken out. A post-race veterinary examination revealed a laceration to the left fore pastern. First aid administered.
