STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 5 October 2019

TRACK: Soft 5 (Track with a reasonable amount of give in it)

RAIL: Out 7 metres 1000 to winning post, 5 metres remainder. Sectional 609 metres.

WEATHER: Overcast

RACE 1: HOLDFAST INSURANCE HANDICAP - 1250 metres

GRINZINGER EXPRESS (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

SIGN OF USSURI (B. Vorster) - over-raced in the early stages of the event. Near the 700 metres rolled out and contacted NEWBAY FLYER (NZ).

JACOBITE PRINCE (G. Lo) - contacted at the start by NEWBAY FLYER (NZ).

NEWBAY FLYER (NZ) (S. Logan) - awkward to begin, shifted out and contacted JACOBITE PRINCE. Contacted near the 700 metres.

TUBBY TWO TRACKS (T. Voorham) - slow to begin. Over-raced in the early stages of the event.

HOLY DANCER (NZ) (K. Crowther) - raced keenly in the early stages of the event. Inclined to lay out in the straight.

RACE 2: MEDALLION HOMES HANDICAP - 1400 metres

SNOANO (GB) (J. Holder) - rider reported the gelding travelled well in the early stages but when asked for an effort was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

TERBIUM (G. Lo) - near the 800 metres rolled out and brushed with DEXELATION taking that horse a little wider and thereafter near the 700 metres again rolled out, brushed with and inconvenienced DEXELATION.

DEXELATION (K. Lau) - raced keenly in the early stages of the event. Inconvenienced near the 800 metres and 700 metres.

RACE 2: MEDALLION HOMES HANDICAP - 1400 metres (Cont'd)

WINNING PARTNER (B. Vorster) - raced keenly in the early stages of the event. In the vicinity of the 900 metres became awkward in its action for several strides momentarily unbalancing its rider.

**RACE 3: ROMEO'S FAMILY RACE DAY AT MORPHETTVILLE - OCT 12 MAIDEN PLATE
- 1400 metres**

FRANK GOES BOOM (G. Lo) - over-raced in the early stages of the event. Held up for clear running from approaching the 400 metres until approaching the 200 metres.

HIGH STATUS (R. Hurdle) - rider reported the gelding made abnormal respiratory noises. A post-race veterinary examination revealed no visible abnormalities.

JOURNICA (T. Voorham) - held up for clear running from near the 500 metres until approaching the 100 metres.

LADY DRAKE (NZ) (P. Gatt) - Stewards approved a late gear change of Blinkers and a Tongue Tie to the mares gear, Trainer Mrs S Jaensch was fined \$200 under AR206(2) for the late application of gear. Raced keenly in the early stages of the event. Inclined to lay out in the straight.

NATURE BOY (NZ) (J. Chau) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RITRATTO (T. Pannell) - awkward to begin. Raced greenly in the middle stages of the event.

DUBAI HOUSE (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: AAMI SPRING CARNIVAL AT MORPHETTVILLE OCT 19 - NOV 5 HANDICAP
BENCHMARK 75 - 1550 metres**

POLAR VORTEX (J. Chau) - a late scratching at 2.03 am by order of Stewards on veterinary advice that the gelding had an injury to its off hind fetlock. When questioned about the horse's injury, Mr Doudle advised that on Wednesday evening, 2 October, the gelding had kicked a fence at the stables and sustained a laceration to its off hind fetlock. When asked why he did not report the injury to Stewards he advised that he did not consider it would have any bearing on the horse's engagement today and that he had bandaged the wound in the lead up to the race. Stewards also questioned the Club's veterinary surgeon who advised that it was likely that the bandage applied and the horse cantering to the start may have exacerbated the condition of the wound. Following the horse's scratching from the event, it was again examined by the veterinary surgeon in the tie up stalls area and found to be lame in the off hind leg. Mr T. Doudle was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. Mr Doudle was also reprimanded under AR105(1)(d) for failing to report the occurrence and condition of the horse to Stewards.

CLASSIC WEIWEI (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

WYLIE OL' COYOTE (T. Pannell) - laid out in the straight, shifted out slightly approaching the 200 metres and contacted CLASSIC WEIWEI taking that horse wider on the track. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: AAMI SPRING CARNIVAL AT MORPHETTVILLE OCT 19 - NOV 5 HANDICAP
BENCHMARK 75 - 1550 metres (Cont'd)

BLUE MORPHO (J. Toeroek) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

CANNOT BE SERIOUS (NZ) (A Jordsjo) - underwent a pre-race veterinary examination as the gelding was injured in the float en route to the course and was ruled unfit to race. A late scratching at 12.13 pm by order of Stewards acting on veterinary advice. Trainer Mr M. Hickmott was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

EXALTED RUTH (S. Logan) - raced keenly in the early stages of the event.

RACE 5: AAMI HANDICAP - 2250 metres

DR DEPENDABLE (J. Chau) - laid out under pressure in the straight.

GRABBING GLORY (G. Cartwright) - raced keenly in the early stages of the event. Lost its near fore plate during the event.

COMFORT MAN (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

SAGAAB (J. Toeroek) - rider reported the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: LYN GRANTHAM'S 60TH BIRTHDAY HANDICAP - 1000 metres

ITZ INVINCIBLE (L. German) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr M. Seyers was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

BENZ (J. Holder) - reared on jumping away, awkward to begin and shortly thereafter was tightened between **CELTIC BLAST**, which began awkwardly and shifted out and **BAROOD**, which began awkwardly and shifted in and as a consequence was unable to maintain his position. Rider explained that as a consequence of the incident at the start he was unable to take up a more forward position in running as intended.

BAROOD (S. Fawke) - began awkwardly and shifted in at the start.

CELTIC BLAST (G. Cartwright) - began awkwardly and shifted out at the start. Laid out in the straight.

I AM INCREDIBLE (P. Gatt) - over-raced in the early and middle stages of the event.

BELLA SUCCESS (J. Toeroek) - in the vicinity of the 900 metres commenced to buck, dislodged it's rider. Rider examined by the First Care Medical Personnel who reported no obvious serious injury. A post-race veterinary examination of the mare revealed no visible abnormalities. Trainer Mr W. Clarken advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

EXALTED TRAIL (S. Logan) - raced keenly in the early and middle stages of the event.

Correct weight was delayed to allow J. Holder (**BENZ**) placed third, to view the vision of the start.

RACE 7: DOMINANT HANDICAP - 1950 metres

AAGAS (L. Gerrman) - a post-race veterinary examination revealed no visible abnormalities.

LADY CONQUISTADOR (T. Pannell) - Stewards permitted T. Pannell to ride the mare at 0.5 kg over its declared weight of 54 kg. Near the 1800 metres was momentarily tightened and obliged to race in restricted room inside SWEET MISCHIEF, which was taken in slightly by JAGUARY (NZ), which shifted in slightly. Obligated to race in restricted room for a number of strides near the entrance to the straight. A post-race veterinary examination revealed heat stress. First aid administered.

SWEET MISCHIEF (B. Vorster) - taken in slightly by JAGUARY (NZ) near the 1800 metres. A post-race veterinary examination revealed no visible abnormalities.

DOWNHEARTED (G. Cartwright) - over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

JAGUARY (NZ) (J. Holder) - shifted in slightly near the 1800 metres.

RACE 8: PHIL WRIGHT HANDICAP - 1300 metres

TONGSAI BOSS (G. Cartwright) - reared as the start was affected, began very awkwardly and as a consequence was slow to begin losing two to three lengths. Rider explained that as a consequence of the incident at the start, she was unable to take up a position outside the leader as intended.

ADATTO (NZ) (L. German) - awkward to begin. Laid out in the straight.

MASTERATI (S. Logan) - over-raced in the early and middle stages of the event.

CORONEL (T. Pannell) - near the 900 metres got its head up when awkward on the heels of ADATTO (NZ) and raced ungenerously for a short distance. A post-race veterinary examination revealed no visible abnormalities.

HE WILL BOOM (P. Gatt) - near the 900 metres became awkward on the heels of MIA GEORGIA and when being restrained rolled out onto CORONEL taking that horse wider on the track. Near the entrance to the straight when shifting out to improve inconvenienced TONGSAI BOSS, which was taken a little wider on the track.

Correct weight was delayed to allow G. Cartwright (TONGSAI BOSS), placed second and Ms S. Clayfield, Stable Representative for Mr J. Hyam to view the vision of the start.

RACE 9: ADELAIDE GALVANISING HANDICAP - 1300 metres

SO WE ARE (G. Lo) - laid in, in the straight. Rider reported that the mare travelled well in the early and middle stages however, when placed under pressure at the entrance to the straight, failed to respond to his riding until the vicinity of the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

LOCKDOWN JACK (G. Cartwright) - over-raced from in the vicinity of the 1000 metres for a short distance.

GOING GAGA (T. Pannell) - inside the 1100 metres was hampered when tightened between SHIR, which rolled out slightly and BORRIS IN OSSORY, which shifted in and away from AMBERTONE, which laid in.

RACE 9: ADELAIDE GALVANISING HANDICAP - 1300 metres (Cont'd)

SHIR (J. Holder) - rolled out slightly near the 1100 metres.

BORRIS IN OSSORY (S. Logan) - inside the 1100 metres shifted in and away from **AMBERTONE** and tightened **GOING GAGA**. Rider was reminded of her obligations when her mounts commence to shift ground. Thereafter approaching the 200 metres shifted out under riding and tightened **RUSSIAN ROMEO** onto **LOCKDOWN JACK**. Rider was severely reprimanded for allowing her mount to shift ground. Thereafter the gelding laid out for the remainder of the event. Having regard for both incidents and S. Logan's lack of immediate corrective action, she was advised that she would be required to attend the Riders Advisory Panel and may only accept rides in the metro area following a satisfactory report from the Riders Advisory Panel.

ENOUGH SWAGGER (E. Boyd) - over-raced from in the vicinity of the 1000 metres for a short distance.

AMBERTONE (K. Crowther) - laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RUSSIAN ROMEO (J. Toeroek) - rider examined by the First Care Medical Personnel prior to this event and declared fit to fulfil his engagement. Rider over-raced from in the vicinity of the 1000 metres for a short distance. Approaching the 200 metres was obliged to be steadied when tightened by **BORRIS IN OSSORY**, which shifted out under riding.
