Report on Race Meeting held at Morphettville Racecourse  
by the South Australian Jockey Club on Saturday, 19 October 2019

**TRACK:** Soft 5 (Track with a reasonable amount of give in it)

**RAIL:** Out 9 metres 1200 metres to winning post, 8 metres remainder. Sectional 612 metres

**RACE 1: CAUDO VINYARD MAIDEN PLATE - 1200 metres**

The start of this event was delayed approximately two minutes.

**LOFTY TYCOON** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**WICKED ALIBI** (J. Toeroek) - raced greenly throughout the event.

**AUSTIN RAIDER** (R. Clark) - slow to begin.

**MISS HEDY** (A. Jordsjo) - jumped away awkwardly. Laid out under pressure in the straight.

**JUST ZERENE** (B. Vorster) - refused to load. A late scratching by order of Stewards at 1.08 pm. Co-Trainer Mr C. McEvoy was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**RACE 2: ROADSIDE SERVICES THREE-YEAR-OLD MAIDEN PLATE - 1050 metres**

The start of this event was delayed approximately three minutes.

**BRAY STREET BOSS** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**PEARL DRAGON** (J. Chau) - laid in severely from the entrance to the straight until inside the 200 metres where it commenced to weaken of its own accord. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**STREETCAR STRANGER** (K. Crowther) - shifted out on jumping away and contacted TROODLES. Laid out rounding the home turn.

**DOUBLE BLUE** (D. Tourneur) - laid in slightly in the vicinity of the 100 metres. Raced wide without cover throughout the event.

**RACE 2: ROADSIDE SERVICES THREE-YEAR-OLD MAIDEN PLATE - 1050 metres (Cont'd)**

**KISHSTAR** (J. Holder) - shifted out in the vicinity of the 200 metres onto PEARL DRAGON, which was laying in. Rider was reprimanded.

**LA RICHESSE** (J. Toeroek) - had to be steadied momentarily in the vicinity of the 100 metres when DOUBLE BLUE laid in slightly. Over-raced in the early and middle stages of the event. Laid in under pressure in the straight.

**TROODLES** (B. Vorster)- lost its near fore plate en route to the barriers and required farrier attention. Underwent a pre-race veterinary examination and passed fit to race. Shifted in on jumping away and contacted STREETCAR STRANGER.

**RACE 3: AAMI HANDICAP - 2040 metres**

**WASABI BOB** (J. Chau) - shifted out shortly after the start taking THE GATTING BALL wider. Made a celebratory gesture prior to passing the winning post and was reprimanded under AR131(c). Rider was further advised of the direction in South Australia in relation to celebratory gestures after passing the winning post.

**JAGUARY (NZ)** (J. Holder) - in the vicinity of the 1900 metres was forced to take hold and altered course to avoid the heels of FLOW METER, which shifted in. Laid in under pressure in the straight and inside the 200 metres shifted in onto SWEET MISCHIEF, which had to be steadied and altered course. Rider was severely reprimanded and advised to take greater care when shifting ground in future.

**FLOW METER** (S. Fawke) - in the vicinity of the 1900 metres shifted in when insufficiently clear of JAGUARY (NZ) forcing that rider to take hold and alter course to avoid the heels of FLOW METER. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 26 October and to conclude at midnight on Saturday, 2 November 2019: a period of three meetings. Forced to race in restricted room for a number of strides, in the vicinity of the 100 metres when JAGUARY (NZ) laid in.

**LADY CONQUISTADOR** (T. Pannell) - Shortly after the start lost its position when taken out onto the heels of SWEET MISCHIEF by THE GATTING BALL.

**THE GATTING BALL** (M. Aitken) - taken out shortly after the start.

**SWEET MISCHIEF** (B. Vorster) - inside the 200 metres had to be steadied and altered course when JAGUARY (NZ) shifted in.

**SASUN** (P. Gatt) - Stewards permitted P. Gatt to ride the gelding at 0.5kg over its declared weight of 54.5 kg.

**RACE 4: AAMI REBEL RAIDER SERIES FINAL - 1200 metres**

**GARNER** (J. Holder) - approaching the 800 metres was hampered when taken wider by JACOBITE PRICE.

**JACOBITE PRINCE** (G. Lo) - approaching the 800 metres shifted out and hampered GARNER. Rider reminded of his obligations when shifting ground. Laid in under pressure in the straight.

**XILONG** (B. Vorster) - shifted out on jumping away onto MILITARY ROAD, which was hampered and lost its position when tightened onto GARNER.

**RACE 4: AAMI REBEL RAIDER SERIES FINAL - 1200 metres (Cont'd)**

**MILITARY ROAD** (R. Hurdle) - Stewards permitted R. Hurdle to ride the gelding at 0.5kg over its declared weight of 54.5 kg. hampered and lost its position on jumping away. Rider was dislodged on pulling up. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

**PARTY HACK** (J. Potter) - raced wide without cover throughout the event.

**SIGN OF USSURI** (J. Toeroek) - hampered and lost its position on jumping away.

**HOLY DANCER (NZ)** (G. Cartwright) - shifted in on jumping away onto SIGN OF USSURI, which was hampered and lost its position when tightened onto PARTY HACK.

**OUTPOST** (K. Crowther) - inside the 800 metres became awkwardly placed on the heels of GARNER, which had been taken out.

**OLONG GAZE** (R. Clark) - underwent a pre-race veterinary examination on arrival at the barriers and ruled the gelding lame in the off foreleg. A late scratching by order of Stewards at 2.51 pm. Trainer Mr K. Sweeney was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 5: WESLO SECURITY HANDICAP - 1600 metres**

**TONGSAI BOSS** (G. Cartwright) - lost its off hind plate during the event.

**MARINA** (S. Fawke) - jumped away awkwardly. Laid out under pressure in the straight.

**PICTURE ME ROLLING** (P. Gatt) - rider reported the mare felt awkward in its action when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

**OURKHANI** (T. Pannell) - raced wide without cover throughout the event.

**RACE 6: PETER ELBERG FUNERALS HANDICAP - 1800 metres**

**SET TO CRUISE** (T. Pannell) - inside the 100 metres was hampered when GRABBING GLORY shifted in.

**DON'T DISMISS** (J. Holder) - shifted out on jumping away onto SVETLANA'S ARROW. Raced keenly in the early and middle stages of the event. Lost its off hind late during the event.

**OH SO UNFAIR** (S. Cahill) - jumped away awkwardly.

**SUNMATE** (P. Gatt) - hampered and lost its position on jumping away when SVETLANA'S ARROW was taken out.

**SHAKOPEE (GB)** (R. Hurdle) - raced wide without cover throughout the event.

**DIAMONDS ARE** (D. Tourneur) - slow to begin

**GRABBING GLORY** (J. Chau) raced keenly in the early and middle stages of the event. Inside the 100 metres shifted in onto SET TO CRUISE. Rider advised to make a greater effort to keep his mounts straight in future.

**SPLASH SOME CASH** (S. Logan) raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**DIAMOND ARROW** (T. Voorham) - raced keenly in the early and middle stages of the event.

**RACE 6: PETER ELBERG FUNERALS HANDICAP - 1800 metres (Cont'd)**

**SVETLANA'S ARROW** (K. Lau) - taken out on jumping away onto SUNMATE. A post-race veterinary examination revealed cardiac arrhythmia. Trainer Mr K. Sweeney advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing satisfactorily in an Official Barrier Trial.

**CLIPAHOLIC** (J. Potter) - raced wide without cover throughout the event.

**RACE 7: PETER ELBERG FUNERALS HANDICAP - 1050 metres**

**I AM INCREDIBLE** (M. Aitken) - jumped away awkwardly and was slow into stride. Raced keenly in the early and middle stages of the event. Inside the 300 metres was obliged to alter course when disappointed attempting a tight run to the inside of HEAVEN'S DEAL, which rolled in marginally.

**CALL ME CURTIS** (D. Tourneur) - at the entrance to the straight shifted out to improve onto MASTERATI, which had to momentarily steady when tightened onto MISS LABELLE. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**LOVE MAGIC** (S. Price) - difficulty obtaining clear ground from the entrance to the straight until the 200 metres.

**STAR HILLS** (R. Clark) - difficulty obtaining clear ground from the entrance to the straight until the 150 metres.

**MASTERATI** (R. Hurdle) - raced wide without cover throughout the event. At the entrance to the straight had to momentarily steady when tightened onto MISS LABELLE.

**ZARACE** (A. Jordsjo) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr K. Sweeney was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**MISS LABELLE** (T. Voorham) - raced wide without cover throughout the event.

**HEAVEN'S DEAL** (J. Toeroek) - inside the 300 metres rolled in marginally onto I AM INCREDIBLE.

**RACE 8: SO BRAVE HANDICAP - 1200 metres**

**BY THE POUND** (R. Clark) - jumped away extremely awkwardly and shifted in contacting STRYKE IN STYLE. Inclined to lay in under pressure in the straight.

**FINAL HEARING** (J. Holder) - laid out under pressure over the concluding 200 metres.

**MIHANY** (K. Lau) - jumped away awkwardly and was slow into stride. Raced keenly in the early and middle stages of the event.

**STRYKE IN STYLE** (K. Crowther) - hampered on jumping away.

**TASTE OF DIAMONDS** (D. Tourneur) - raced keenly in the early and middle stages of the event.

**CORONEL** (T. Pannell) Stewards permitted T. Pannell to ride the gelding at 0.5kg over its declared weight of 54.5 kg. Jumped away awkwardly. Raced wide without cover throughout the event.

Race 7 - ZARACE - Not to race - Vet Cert of Fitness required prior to future trial or race - Lameness near foreleg.
