Report on Race Meeting held at Port Lincoln Racecourse

RACE 1: BRIAN HARVEY AGENCIES / SABOIS FOUR-YEAR-OLD & OVER MAIDEN PLATE
- 1210 metres

ARTFUL TEEPA (C. Lions) - laid in, in the straight.

BARB WIRE (R. Hurdle) - approaching the 100 metres was inconvenienced by CHINESIS, which shifted in. Rider explained that the gelding travelled well in the early and middle stages of the event, however when placed under pressure in the straight, failed to respond to his riding and in his opinion, BARB WIRE would benefit from the run. A post-race veterinary examination revealed no visible abnormalities.

KIROSHIMA (S. Fawke) - approaching the 800 metres shifted in and tightened WICKED KID onto TAJAVEDO. Rider reprimanded and advised to only shift ground when entitled to do so in future. Laid in, in the straight.

MANDALA (S. Logan) - raced fiercely in the early and middle stages of the event. Laid in, in the straight.

TAJAVEDO (B. Sweeney) - slow to begin. Approaching the 800 metres, when attempting a run between STURT'S PRIDE and WICKED KID, was tightened for room by WICKED KID, which was taken in, and obliged to be steadied for a number of strides.

WICKED KID (A. Jordsjo) - approaching the 800 metres was taken in onto TAJAVEDO by KIROSHIMA, which shifted in.

CHINESIS (J. Chau) - laid in, in the straight and approaching the 100 metres shifted in inconveniencing BARB WIRE. Rider severely reprimanded and advised to have greater awareness of horses around him when shifting ground in future. A post-race veterinary examination revealed small laceration to near fore pastern.

RACE 1: BRIAN HARVEY AGENCIES / SABOIS FOUR-YEAR-OLD & OVER MAIDEN PLATE
- 1210 metres (Cont'd)

INKERI (T. Pannell) - underwent a pre-race veterinary examination and found the mare to have blood in one nostril. Acting on this advice Stewards withdrew INKERI at 1.19 pm. Trainer, Ms J. Stoetzer was advised INKERI would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race in accordance with AR79(8).

SMARTFUL (K. Lau) - shortly after the start shifted out and away from ARTFUL TEEPA, resulting in SMARTFUL being slow into stride.

STURT'S PRIDE (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

KOODA MISCHIEF (E. Annells) - jumped away awkwardly.

RACE 2: JOHN'S QUICK CLEAN / SABOIS THREE-YEAR-OLD BENCHMARK 60 HANDICAP
- 1210 metres

KALAMON (K. Lau) - jumped away awkwardly and as a result was slow into stride.

WOTUWANT (T. Pannell) - laid out under pressure in the straight and approaching the 100 metres shifted out and inconvenienced ARTFUL AMBITION. Rider reminded of his obligations to straighten his mounts sooner when they commence to shift ground.

ARTFUL AMBITION (J. Chau) - on jumping away was tightened onto TIME GENTLEMAN by HOBO BOB, which shifted out.

TIME GENTLEMAN (G. Lo) - on jumping away was tightened onto JUSTICA by ARTFUL AMBITION, and as a result lost its position. A post-race veterinary examination revealed no visible abnormalities.

ARTFULABEERS (S. Logan) - laid in, in the straight.

DERR PHONZ (C. Lions) - jumped away awkwardly. Laid in, in the straight.

HOBO BOB (S. Fawke) - jumped away awkwardly, shifted out and tightened ARTFUL AMBITION onto TIME GENTLEMAN.

RACE 3: AVIS PORT LINCOLN BENCHMARK 56 HANDICAP - 1390 metres

SPENCER GULF (K. Crowther) - bumped on jumping away by GRAND BARBA, which shifted out. As a result SPENCER GULF lost its position. Laid in, in the straight.

BALTIC PRINCE (K. Lau) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Laid in, in the straight.

HOW JAMMY'S THAT (E. Boyd) - laid out in the straight.

GRAND BARBA (S. Logan) - jumped away awkwardly, shifted out and bumped SPENCER GULF.

BEL MOSHE (J. Chau) - a post-race veterinary examination revealed the mare to have atrial fibrillation. Trainer, Ms J. Stoetzer, was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness was required prior to the mare performing satisfactorily in an Official Barrier Trial.

OBLIQUE LINE (S. Logan) - jumped away awkwardly and in the vicinity of the 400 metres laid in tightening the running of CALL ME CRACKERS.

RACE 4: LOWE & REDDING DESIGN BENCHMARK 56 HANDICAP - 1390 metres

GEANDGE (R. Hurdle) - laid out throughout the event.

LACE AND WHISKEY (T. Pannell) - rider explained that the filly travelled well throughout the event; however, it was unable to quicken with the leaders in the straight.

CALL ME CRACKERS (C. Lions) - jumped away awkwardly. Inside the 400 metres became awkward in its action for a short distance when tightened for running by **OBLIQUE LINE**, which rolled in. Rider explained that the mare never travelled throughout the event and she became concerned with its action inside the 200 metres and for that reason she did not ride **CALL ME CRACKERS** out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

CLAREFELILLI (J. Chau) - had difficulty obtaining clear running between the 400 metres and the entrance to the straight. Laid in, in the straight.

RACE 5: TUNARAMA COACHLINES CLASS ONE HANDICAP - 1000 metres

HE'S ABEL (R. Hurdle) - approaching the 600 metres had to be checked to avoid the heels of **BEDLOE'S ISLAND** and in doing so shifted out hampering **EQUIDAME** taking that mare wider.

SHEZA PROPHET (S. Fawke) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

EQUIDAME (K. Lau) - jumped away awkwardly and as a result was slow into stride. Approaching the 600 metres was hampered and taken wider by **HE'S ABEL**.

BEDLOE'S ISLAND (J. Chau) - raced keenly in the early and middle stages of the event. Inside the 700 metres became awkwardly placed for a number of strides on the heels of **ROCKEY LYLES**, which was unable to quicken with the field and approaching the 600 metres had to be checked to avoid that gelding's heels.

RACE 6: JP CABINETS BENCHMARK 80 HANDICAP - 1390 metres

BRAMFIELD (T. Pannell) - raced keenly in the middle stages of the event.

PERESSINI (G. Lo) - laid in, in the straight. Inside the 200 metres shifted in. Rider was reminded of his obligations and advised to straighten his mounts sooner when they commence to shift ground.

ROOBOY (R. Hurdle) - underwent a pre-race veterinary examination as it had not raced in over 12 months and passed fit to race.

NEVA DOUBT US (K. Crowther) - inside the 200 metres was disappointed when attempting a run between **PERESSINI**, which shifted in and **DEBEERSONUS** and was unable to obtain clear running for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

BANRI DE HERO (S. Fawke) - slow to begin.

RACE 7: LEADER DISTRIBUTORS BENCHMARK 60 HANDICAP - 1750 metres

CRAZY CULPRIT (S. Fawke) - reared on jumping away.

SLIPPERY JOURNEY (K. Crowther) - approaching the 1500 metres was inconvenienced by **HAND TO HAND** (NZ), which shifted in. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: LEADER DISTRIBUTORS BENCHMARK 60 HANDICAP - 1750 metres (Cont'd)

HAND TO HAND (NZ) (K. Lau) - approaching the 1500 metres shifted in and inconvenienced SLIPPERY JOURNEY. Rider reminded of his obligations and to only shift ground when entitled to do so.

RAYLEIGH (S. Logan) - jumped away awkwardly.

RACE 8: HYGAIN - FEEDING CHAMPIONS BENCHMARK 64 HANDICAP - 1210 metres

SAVANERO (NZ) (A. Jordsjo) - underwent a pre-race veterinary examination as it had not raced in the last 12 months and passed fit to race.

STONECAST (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

GALAXY FALLS (R. Hurdle) - inclined to lay in, in the straight.

STORM VOYAGER (K. Crowther) - laid in, in the straight and contacted SOCIAL MEDIA on several occasions. A post-race veterinary examination revealed no visible abnormalities.

ROCKETTA (S. Logan) - a late scratching by order of Stewards at 4.20 pm on veterinary advice as the gelding had knocked its head in the race day stall. First aid administered.

SON OF CITY (S. Fawke) - approaching the 400 metres raced in restricted room between SAVANERO (NZ), which rolled in and MIRTHDALE for a short distance.
