Report on Race Meeting held at Gawler Racecourse

**RACE 1: LITTLE HEROES FOUNDATION / SABOIS DISTANCE MAIDEN PLATE - 2122 metres**

**HEZ A WOLF** (J. Maund) - approaching the 200 metres was bumped and crowded between LISETTE, which shifted out, and HIERO, which shifted in under pressure.

**HIERO** (D. Tourneur) - shifted in under pressure near the 200 metres. Laid in over the concluding stages. Rider reported that his mount lost its near fore plate on pulling up.

**MANILOW** (J. Potter) - approaching the 200 metres was bumped outwards slightly by VOSOTA.

**VOSOTA** (R. Clark) - began awkwardly. Shifted out near the 400 metres and made contact with ANOTHER WHISPER. Shifted out near the 200 metres and bumped the hindquarters of MANILOW. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer, Mr J. Hyam, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**AZZUREOUS** (P. Gatt) - awkward to begin. In the vicinity of the 400 metres had to be eased for a number of strides to avoid the heels of ANOTHER WHISPER, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

**ANOTHER WHISPER** (S. Logan) - near the 400 metres commenced to give ground and when doing so was bumped by VOSOTA, which shifted out. Thereafter shifted in and crowded AZZUREOUS.

**LISETTE** (J. Holder) - held up for clear running from the 600 metres and was disappointed when attempting a run where there was barely sufficient room between MANILOW, which had been bumped out slightly by VOSOTA, and HEZ A WOLF, which was taken in slightly by HIERO. As a result, it became unbalanced after bumping with HEZ A WOLF and consequently changed course inwards to obtain clear running over the concluding stages.

**RACE 2: HOLDFAST INSURANCE / SABOIS MARES MAIDEN PLATE - 1200 metres**

**ARCTIC FLORA** (E. Boyd) - awkward to begin.

**RACE 2: HOLDFAST INSURANCE / SABOIS MARES MAIDEN PLATE - 1200 metres (cont'd)**

**DELUXE DESIGN** (K. Crowther) - laid in under pressure over the concluding stages.

**IT'S WHAT YOU KNOW** (C. Lions) - lost ground at the start after jumping away awkwardly.

**JOMMADOSH** (R. Hurdle) - underwent a pre-race veterinary examination as it has not raced in 12 months and was passed fit to race. Difficulty obtaining clear running from near the 400 metres until approaching the 200 metres.

**LOMON TEMBY** (T. Pannell) - bumped at the start by TAKE IT UP A GIA. Raced keenly in the early and middle stages of the event.

**TAKE IT UP A GIA** (J. Potter) - jumped outwards at the start and bumped LOMON TEMBY. Held up for clear running from the 500 metres until approaching the 100 metres.

**RACE 3: G&J CIVIL / SABOIS MAIDEN PLATE - 1100 metres**

**COMMANDING DRAGON** (S. Price) - bumped with NIC'S SECRET on jumping away.

**KANZO** (T. Pannell) - jumped out at the start and inconvenienced MISS FLATLEY. Lost its off fore plate during the event.

**NIC'S SECRET** (L. Neindorf) - bumped with COMMANDING DRAGON on jumping away.

**OLIVE GROVE** (J. Holder) - began awkwardly. Raced keenly in the early and middle stages of the event. Laid in for the majority of the straight.

**OUR FRANCIS** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**RADIO ROOM** (J. Maund) - bumped MISS FLATLEY at the start and became unbalanced. Was obliged to be eased when momentarily tightened between MISS FLATLEY and CHASE THE THRILLS.

**MISS FLATLEY** (J. Chau) - taken out shortly after the start by KANZO, resulting in the mare bumping RADIO ROOM.

**RACE 4: SAROA BENCHMARK 60 HANDICAP - 2122 metres**

**OLYMPIC ACADEMY** (R. Hurdle) - inside the 400 metres was contacted by CLASSY JOE, resulting in the gelding becoming unbalanced.

**AMMO LOCO** (S. Fawke) - rider dropped his whip at the entrance to the straight.

**COMFORT MAN** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**CLASSY JOE** (R. Clark) - inside the 400 metres shifted out contacting OLYMPIC ACADEMY, momentarily unbalancing that gelding. Rider was reminded of her obligations under AR132(6)(e) regarding her use of the whip past the finishing post.

**ANTIPAS** (E. Boyd) - trainer, Mr D. Koch, advised Stewards of a change of tactics prior to the event in that he would instruct his rider to attempt to settle further back from the wide draw in today's event. Settled towards the rear of the field.

**RACE 4: SAROA BENCHMARK 60 HANDICAP - 2122 metres (cont'd)**

Correct weight was delayed to allow R. Hurdle (OLYMPIC ACADEMY), placed second, and trainer, Mr G. Young, to view the Official Vision in the vicinity of the 400 metres. After doing so Mr Young lodged an objection against CLASSY JOE (R. Clark) being declared the winner on the grounds of alleged interference in the vicinity of the 400 metres. After considering the evidence, viewing the vision and acting on their own observations, Stewards *dismissed* the objection.

**RACE 5: VIEW CLUB BOOT SALE - 10TH NOVEMBER CLASS ONE HANDICAP - 1200 metres**

**FREE HAND** (P. Gatt) – rider reported that his mount laid out throughout the event.

**CARBONE** (C. Lions) – trainer, Mr P. Moody, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle midfield in today's event. Underwent a pre-race veterinary examination and passed fit to race. Settled toward the rear of the field. Raced keenly in the early stages of the event.

**AMBIBELLA** (K. Crowther) – raced keenly in the early and middle stages of the event and, when proving difficult to settle after passing the 800 metres, had to be eased after becoming awkwardly placed on the heels of PANZER PRINCESS, which shifted in. Approaching the finish had to be eased to avoid the heels of PANZER PRINCESS.

**TEXAS LIL** (J. Chau) – inconvenienced on jumping away.

**PANZER PRINCESS** (G. Lo) – shifted in inside the 800 metres.

**LE DEZALEY** (L. Neindorf) – began awkwardly losing ground at the start.

**BLUE TABLE** (A. Jordsjo) – jumped in at the start inconveniencing TEXAS LIL.

**RACE 6: COOPERS XPA CLASS TWO HANDICAP - 1516 metres**

**ELEVENBEE (NZ)** (J. Holder) – fractious in the barrier and when the start was effected reared and lost ground. A post-race veterinary examination revealed no visible abnormalities.

**GRINZINGER CHARGER (NZ)** (D. Tourneur) – laid in, in the straight.

**GETOUTTHEWAY** (R. Hurdle) – raced keenly in the early stages of the event. Held up for clear running from approaching the 400 metres until near the 200 metres.

**LANGKAWI** (C. Lions) – raced keenly in the early stages of the event.

**ZUME FORWARD** (S. Fawke) – rider reported that his mount hung out from rounding the home turn until the finish, and as a result he was not able to ride the gelding out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow J. Holder (ELEVENBEE (NZ)), and trainer, Mr T. Doudle, to view the vision of the start. After doing so J. Holder made a submission that ELEVENBEE (NZ) be declared a non-starter on the grounds that it was denied a fair start. After considering J. Holder's submission, evidence taken from the starter, Mr S. Dinunzio, viewing the vision of the start and acting on their own observations Stewards declared ELEVENBEE (NZ) to be a runner under AR204(1)(c).

**RACE 7: CORNERSTONE STUD HEAT 5 - SIR PRANCEALOT SERIES BENCHMARK 60  
HANDICAP - 1100 metres**

**PLAYFELLOW** (L. Neindorf) - underwent a pre-race veterinary examination as it has not raced in twelve months and passed fit to race. Laid in, in the straight and for this reason L. Neindorf was unable to ride PLAYFELLOW out in his normal manner.

**TRIPLE DEEZ** (D. Tootell) - slow to begin. Had difficulty obtaining clear running from near the 300 metres until inside the 100 metres.

**SEE ME ROLLIN'** (J. Potter) - raced keenly in the early and middle stages of the event.

**GRAVITY** (S. Logan) - rider dropped her nearside rein near the 150 metres and was unable to regain it for the remainder of the race.

**TURF TAPPER** (R. Clark) - rider reported that her mount changed stride in the early part of the straight and then hung in for the remainder of the race, resulting in her being unable to ride her mount out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**RUSHWA** (S. Fawke) - had difficulty obtaining clear running from the entrance to the straight until near the 200 metres. RUSHWA was further held up for clear running from inside the 200 metres for the remainder of the race and therefore was not able to be fully tested over the concluding stages of the event.

**HE'S GOT SKILLS** (K. Crowther) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.
