Report on Race Meeting held at Morphettville Parks Racecourse  
by the South Australian Jockey Club on Saturday, 9 November 2019

RACE 1: ADELAIDE GALVANISING HANDICAP - 2250 metres

JAGUARY (NZ) (J. Chau) - when being restrained in the early stages of the event got its head up on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

LORESHO (FR) (T. Pannell) - in the vicinity of the 1000 metres improved around the field to take up a position outside the leader.

KING VALOUR (NZ) (J. Holder) - laid out under pressure in the straight.

RACE 2: CHANNEL 7 THREE-YEAR-OLD MAIDEN PLATE - 1400 metres

The start of this event was delayed approximately one minute owing to FLYING ARION.

CLEARY ADONIS (G. Cartwright) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

FLYING ARION (P. Gatt) - became fractious and got its leg up in the barrier. Underwent a pre-race veterinary examination and was passed fit to start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

MAXIMUM HUSTLE (J. Holder) - when questioned in relation to the gelding's performance rider explained that it was not his intention to lead in today's event; however, after beginning well he elected to maintain his position in the lead as there appeared to be no early pace in the race. He added that MAXIMUM HUSTLE travelled well and when asked for an effort in the vicinity of the 400 metres commenced to weaken and he was disappointed in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

PETROVSKI (D. Tourneur) - shortly after the start was restrained and shifted in to obtain cover to take up a position at the rear of the field.

RACE 2: CHANNEL 7 THREE-YEAR-OLD MAIDEN PLATE - 1400 metres (cont'd)

PRINCE OF CELEBES (NZ) (K. Lau) - trainer, Ms M. Payne, was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. First aid administered. Trainer was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

THE PUGILIST (T. Pannell) - on jumping away had its hindquarters contacted by SHALFAH, which shifted out.

SHALFAH (B. Vorster) - on jumping away shifted out and made contact with the hindquarters of THE PUGILIST. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: NOVA 919 MAIDEN PLATE - 1250 metres

BACK POCKET (R. Hurdle) - shortly after the start was restrained and shifted in to obtain a position at the rear of the field.

ECLAIR FLAME (GB) (J. Holder) - raced wide without cover throughout the event. Hung out from in the vicinity of the 600 metres for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

SPUDSTA (K. Crowther) - jumped away awkwardly, shifted out and contacted THE NATURAL. Raced erratically in the early and middle stages of the event. Rider reported that her mount raced erratically during the event and in her opinion it may have gotten its tongue over the bit in running.

THE BULL MCCABE (S. Cahill) - underwent a pre-race veterinary examination after breaking loose in the pre-parade ring and was passed fit to start. Over-raced in the early and middle stages of the event.

HYPERCANE (P. Gatt) - underwent a pre-race veterinary examination after breaking loose in the pre-parade ring and was passed fit to start.

THE NATURAL (B. Vorster) - underwent a pre-race veterinary examination after breaking loose in the pre-parade ring and was passed fit to start. Raced fiercely in the early and middle stages of the event.

RACE 4: HOLDFAST INSURANCE TWO-YEAR-OLD PLATE - 1000 metres

FLINDERS RIVER (P. Gatt) - approaching the 600 metres was inconvenienced when racing in restricted room between ICHIBANSAN and STENMARK, which rolled out.

ICHIBANSAN (R. Clark) - jumped away awkwardly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

SCOTCH ON THE ROCK (E. Boyd) - hung out from inside the 600 metres for the remainder of the event. Rider reported that the colt hung out during the event and felt shin sore. A post-race veterinary examination revealed the colt to be shin sore.

STENMARK (B. Vorster) - rolled out approaching the 600 metres onto FLINDERS RIVER.

YULE MY HERO (J. Toeroek) - taken in on jumping away.

RACE 4: HOLDFAST INSURANCE TWO-YEAR-OLD PLATE - 1000 metres (cont'd)

CARALUE (J. Holder) - jumped away awkwardly and shifted in onto YULE MY HERO, which was taken in.

SHEBRINGZIT (T. Pannell) - Stewards permitted T. Pannell to ride the filly 0.5 kg over its declared weight of 54.5 kg. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: PIKE & JOYCE HANDICAP - 1400 metres

EPERDUMENT (G. Cartwright) - hung out under pressure in the straight.

MELLORS (NZ) (B. Vorster) - inclined to hang out throughout the event.

BOHEMIAN FOREST (J. Holder) - rider reported that the gelding travelled well, but did not respond to his riding and was disappointing when placed under pressure. A post-race veterinary examination revealed the mare to have tied up.

RAGING QUEEN (K. Crowther) - assistant trainer, Mr T. Stokes, advised Steward of a change of tactics prior to the event in that he would instruct his rider to attempt to settle more forward in today's event. Settled outside the leader. Inclined to lay in under pressure in the straight.

CONCONI (T. Pannell) Stewards permitted T. Pannell to ride the mare 0.5 kg over its declared weight of 54.5 kg. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

NEWBAY FLYER (NZ) (R. Clark) - held up for a number of strides at the entrance to the straight.

RACE 6: DAVID FAZAKERLEY FREEDOM FINALE CUP - 1550 metres

BALCAZAR (K. Crowther) - slow to begin. Laid in under pressure in the early part of the straight.

WANTED BY ALL (J. Toeroek) - held up for clear running from approaching the 400 metres until in the vicinity of the 200 metres.

YANKEE EYES (A. Jordsjo) - inconvenienced on jumping away when tightened between HAHNDORF, which shifted in, and KING RED, which shifted out. Raced wide without cover from the middle stages of the event. Weakened from inside the 200 metres. Rider reported that the mare felt short in its action under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SO ASTOUNDING (D. Tourneur) - trainer, Ms M. Payne, was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimand.

BWUVA (B. Vorster) - held up for clear running from shortly after the entrance to the straight until approaching the 200 metres. Had difficulty obtaining clear ground over the concluding stages of the event and was not fully tested to the line.

HAHNDORF (J. Chau) - inclined to lay out under pressure in the straight.

RACE 7: MEDALLION HOMES HANDICAP - 1000 metres

ZALMONA (P. Gatt) - jumped away awkwardly and then shifted in behind runners to obtain cover. A post-race veterinary examination revealed no visible abnormalities.

IRISH MINT (J. Toeroek) Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54.5 kg. Shortly after the entrance to the straight was disappointed when attempting a tight run between GOODGEE and LADY NATURALISTE. From in the vicinity of the 50 metres raced in restricted room between GOODGEE, which rolled in, and I AM INCREDIBLE, and as a result was untested to the line.

DOMINATION (J. Holder) - hung out under pressure in the straight.

I AM INCREDIBLE (K. Crowther) - jumped away awkwardly, shifted out and contacted GOODGEE. Raced keenly in the early and middle stages of the event.

LADY NATURALISTE (J. Chau) - in the vicinity of the 800 metres raced in restricted room between DOMINATION and IRISH MINT, which was taken out slightly by GOODGEE, and was hampered for a number of strides. Rider reported that his saddle slipped during the event.

BRIMARVI VEHERO (D. Tourneur) - hung out rounding the home turn.

GOODGEE (R. Clark) - on jumping away was contacted by I AM INCREDIBLE, which shifted out. Rider was dislodged on pulling up. A post-race veterinary examination revealed the mare to be lame in the off fore leg. R. Clark was examined by the First Care Medical personnel and transported to hospital for further observations. Stewards will enquire into the circumstances in relation to R. Clark being dislodged at a date to be fixed.

RACE 8: DOMINANT HAPPY TRAILS SERIES FINAL - 1400 metres

The start of this event was rescheduled to start at 5.50 pm owing to the fall after the previous event.

BORRIS IN OSSORY (S. Logan) - raced keenly in the early and middle stages of the event.

ENKI (D. Tourneur) - Stewards questioned trainer Mr G. Richards into the circumstances that ENKI was presented late on course. After considering the evidence Stewards charged Mr Richards under AR165(1) and imposed a fine of \$500.

I AM IMPINGE (NZ) (S. Cahill) - in the vicinity of the 200 metres was obliged to be steadied as ENOUGH SWAGGER rolled out when improving and EQUUS D'ORO, which was tiring, rolled in marginally. Rider reported that it was his intention to settle further forward in today's event; however, the gelding began slower than he had anticipated and therefore he was obliged to settle further back.

GOING GAGA (T. Pannell) - in the vicinity of the 700 metres got its head up whilst being restrained.

FINAL HEARING (J. Holder) - at the entrance to the straight became awkwardly placed on the heels of PICTURE ME ROLLING, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

PICTURE ME ROLLING (P. Gatt) - Stewards permitted P. Gatt to ride the mare 0.5 kg over its declared weight of 54 kg. Rolled in at the entrance to the straight.

ENOUGH SWAGGER (E. Boyd) - bumped by ENOUGH SWAGGER, which shifted out on jumping away. At the entrance to the straight was obliged to be steadied when attempting a tight run to the inside of MISS MOSH. From thereafter was held up for clear running until approaching the 200 metres.

RACE 8: DOMINANT HAPPY TRAILS SERIES FINAL - 1400 metres (cont'd)

EQUUS D'ORO (S. Fawke) - in the vicinity of the 200 metres rolled in marginally.

MISS MOSH (J. Potter) - jumped away awkwardly, shifted out and bumped ENOUGH SWAGGER.
