**RACE 1: SOUTHERN CROSS AUSTEREO / SABOIS MAIDEN PLATE - 1750 metres**

**KOODA MISCHIEF** (S. Logan) - inside the 1500 metres allowed her mount to shift in tightening the running of ARTFULABEERS. Rider was severely reprimanded and advised to only shift ground in future when entitled to do so.

**WICKED KID** (B. Sweeney) - in the vicinity of the 150 metres was inconvenienced by ARTFULABEERS, which was taken wider.

**ARTFULABEERS** (J. Toeroek) - jumped away awkwardly, shifted in and bumped HOBBO BOB. Inside the 1500 metres was tightened and obliged to be eased to avoid the heels of KOODA MISCHIEF, which shifted in. In the vicinity of the 150 metres was inconvenienced and taken wider by RASHYATHERE, which shifted out.

**HOBBO BOB** (S. Fawke) - laid out under pressure over the concluding stages.

**RACE 1: SOUTHERN CROSS AUSTEREO / SABOIS MAIDEN PLATE - 1750 metres (cont'd)**

**RASHYATHERE** (G. Lo) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. In the vicinity of the 150 metres shifted out and inconvenienced ARTFULABEERS. Rider reprimanded under AR131(a) and advised to straighten his mounts sooner when they commence to shift ground.

**RACE 2: TUNARAMA COACHLINES / SABOIS MAIDEN PLATE - 1390 metres**

**BARB WIRE** (R. Hurdle) - in the vicinity of the 1100 metres was taken in by TAJAVEDO into the running of OUR RHYTHM.

**TAJAVEDO** (B. Sweeney) - in the vicinity of the 1100 metres shifted in taking BARB WIRE in across the running of OUR RHYTHM. Rider severely reprimanded and advised to only shift ground when entitled to do so in future. Laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**THE MASTER** (K. Crowther) - raced keenly in the early and middle stages of the event.

**ANJAH** (G. Lo) - a post-race veterinary examination revealed the mare had bled from both nostrils. Trainer, Mr A. Justice, was advised that as this was the mare's first bi-lateral bleed ANJAH would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

**OUR RHYTHM** (S. Logan) - jumped away awkwardly. In the vicinity of the 1100 metres was obliged to be taken hold of to avoid the heels of BARB WIRE, which was taken in by TAJAVEDO.

**RACE 3: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1000 metres**

The start of this event was delayed approximately three minutes.

**NEED THE YEN** (T. Pannell) - required to be resaddled on arrival at the barriers.

**BLUE GRANITE** (G. Lo) - inclined to lay out in the straight.

**PEACE CLOUD** (J. Toeroek) - shortly after the start shifted in and bumped IMBOSSIBLE.

**SEA HOFFA** (S. Fawke) - late scratching at 3.08 pm as the gelding refused to load. Trainer, Mr T. Montgomerie, was advised that SEA HOFFA was now required to load without delay in an Official Barrier Trial prior to a future race start.

**FREE MOMENT** (B. Sweeney) - jumped away awkwardly and as a result was slow to begin.

**TUNGKETTA** (E. Boyd) - approaching the 600 metres dipped and became awkward in its action for a short distance.

**IMBOSSIBLE** (K. Crowther) - shortly after the start bumped by PEACE CLOUD. Laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: LEADER DISTRIBUTORS BENCHMARK 80 HANDICAP - 1210 metres**

**TOLSTOY** (L. Neindorf) - had difficulty obtaining clear ground for a short distance entering the straight.

**VICTOR VICTOR** (S. Fawke) - laid out in the straight.

#### **RACE 5: LINCOLN ESTATE WINES BENCHMARK 56 HANDICAP - 1000 metres**

**KINGSON** (K. Crowther) – inside the 600 metres was obliged to shift out to avoid the heels of MY LESSON, which hung in.

**MY LESSON** (E. Annells) – laid in from the 800 metres and inside the 600 metres shifted in and across the running of KINGSON despite the efforts of its rider. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr T. Montgomerie, was advised that a warning had been placed on the gelding in relation to its racing manners.

**ARTFUL AMBITION** (B. Sweeney) – jumped away awkwardly, shifted in and across the heels of BEDLOE'S ISLAND and was obliged to be steadied. Laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**MACKIE** (K. Lau) – jumped away awkwardly.

**CHOUX BACQUAT (NZ)** (S. Fawke) – slow into stride.

**MAIDEN GRACE** (C. Lions) – raced greenly throughout the event.

#### **RACE 6: LOWE AND REDDING DESIGN BENCHMARK 56 HANDICAP - 1000 metres**

The start of this event was delayed approximately two minutes.

**RODNEY** (L. Neindorf) – on jumping away was tightened onto TOFFEE BELL by LA PETITE ROUSSE. A post-race veterinary examination revealed an abrasion to the left hind cannon. First aid administered.

**LA PETITE ROUSSE** (S. Logan) – jumped away awkwardly and shifted out tightening RODNEY onto TOFFEE BELL.

**FEARLESS AL** (K. Crowther) – raced wide throughout the event. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**TOFFEE BELL** (G. Lo) – dipped on jumping away then tightened onto KAILUA by RODNEY, which was taken wider, and as a result lost its position. A post-race veterinary examination revealed no visible abnormalities.

**SERIOUS MOONLIGHT** (E. Boyd) – laid out in the straight.

**KAILUA** (S. Fawke) – on jumping away had its hindquarters turned by TOFFEE BELL.

**BOTTLE AND BIRD** (E. Annells) – required the reins to be replaced on arrival at the barriers.

**KAAPOW** (K. Lau) – laid in, in the straight. Raced in restricted room over the concluding stages and for this reason was not fully tested to the finish.

**ROCKET LYLES** – late scratching at 3.29 pm as there was no rider available.

#### **RACE 7: DEMPSEY'S SADDLERY & FEED SUPPLIES BENCHMARK 64 HANDICAP - 1750 metres**

**ROOBOY** (K. Crowther) – approaching the 1200 metres raced in restricted room inside REIGNING IN PARIS, which rolled in, and was obliged to be steadied.

**EYE THE WORLD** (E. Annells) – hampered on jumping away by GOTTABITON, which shifted out. Approaching the 1200 metres improved onto the heels of ROOBOY, which was racing in restricted room, and was obliged to be steadied.

**RACE 7: DEMPSEY'S SADDLERY & FEED SUPPLIES BENCHMARK 64 HANDICAP - 1750 metres**  
(cont'd)

**GOTTABITON** (T. Pannell) - jumped away awkwardly, shifted out and hampered EYE THE WORLD.

**FORAOISE** (K. Lau) - a post-race veterinary examination revealed no visible abnormalities.

**REIGNING IN PARIS** (L. Neindorf) - approaching the 1200 metres laid in and away from BEAU'S MY BOY, tightening the running of ROOBOY.

**RACE 8: MCDONALD'S PORT LINCOLN BENCHMARK 60 HANDICAP - 1210 metres**

**STORM VOYAGER** (T. Pannell) - laid in under pressure approaching the finish.

**KIROSHIMA** (S. Fawke) - laid out under pressure in the straight.

**AVORA SUN** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**JAAMINT** (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 1kg above its allotted weight as there was no other rider available to ride the mare at its allotted weight.

**KEEP DIGGING** (E. Boyd) - had difficulty obtaining clear ground in the straight. Inside the 100 metres became awkwardly placed outside the heels of KIROSHIMA, which rolled out. Approaching the finish was obliged to be steadied when tightened between STORM VOYAGER, which rolled in, and KIROSHIMA, which laid out marginally.

**SPIRITOS** (E. Annells) - jumped away awkwardly and shifted out. Laid out in the straight. Approaching the finish became awkwardly placed on the heels of KIROSHIMA.

**RACE 9: GREAT NORTHERN BENCHMARK 64 HANDICAP - 1390**

**DANCE OF HEROES (GB)** (R. Hurdle) - in the vicinity of the 100 metres was inconvenienced by STONECAST, which shifted in.

**STONECAST** (S. Fawke) - bumped on jumping away by OBLIQUE LINE. In the vicinity of the 100 metres shifted in and away from OBLIQUE LINE and inconvenienced DANCE OF HEROES (GB).

**EMOJI** (B. Sweeney) - a post-race veterinary examination revealed no visible abnormalities.

**ABBI FEDE** (E. Boyd) - inconvenienced on jumping away. Approaching the 50 metres tightened for room between ANGEL'S WISH, which shifted in, and MIRTHDALE, which rolled out marginally, and was obliged to be taken hold of to avoid heels. A post-race veterinary examination revealed no visible abnormalities.

**ANGEL'S WISH** (L. Neindorf) - jumped away awkwardly, shifted out and inconvenienced ABBI FEDE. Laid in, in the straight. Approaching the 50 metres shifted in tightening the running of ABBI FEDE. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 17 November 2019 to conclude midnight Saturday, 23 November 2019, a period of three meetings.

**MIRTHDALE** (T. Pannell) - laid out in the straight.

**SWING IT SISTER** (C. Lions) - jumped away awkwardly.

**OBLIQUE LINE** (S. Logan) - jumped away awkwardly, shifted out and bumped STONECAST. Laid in, in the straight.
