

## THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

## Report on Race Meeting held at Port Lincoln Racecourse by the Port Lincoln Racing Club on Friday, 29 November 2019

Stewards: M. Santoro (A/Chairman), & A. Milne (MT) (Stewards), P. Dearman (F), J. Perry (HT),

TRACK: Good 4 (Track with a some give in it)

RAIL: Out 1 metre 1050 metres to 900 metres, out 1.5 metres 450 metres to 300 metres, true

**WEATHER: Overcast** 

RACE 1: AVIS PORT LINCOLN / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

GRAND BARBA (R. Hurdle) - raced wide without cover throughout the event.

PEACE CLOUD (L. Neindorf) - inclined to lay in under pressure in the straight.

RASHYATHERE (S. Fawke) - raced greenly throughout the event.

**TIME GENTLEMAN** (T. Voorham) - Stewards questioned T. Voorham in relation to her riding of the gelding during the event, and in particular in the straight. She explained that she had been given no firm instructions; however, on rounding the home turn the gelding commenced to hang out severely and for this reason she had elected not to use her whip or ride with her normal vigour as she was of the opinion that the gelding may shift out and impact on other runners. Stewards noted her explanation; however, advised her of her obligations under AR114(2) in reporting any matter as soon as practicable after a race that may have affected the running of the rider's horse. She was further advised in future to ride in a manner that did not invite question. A post-race veterinary examination revealed minor abrasions to the left side of the mouth.

# RACE 2: LINCOLN SAND SUPPLIES - NT & DA DICKSON BENCHMARK 80 HANDICAP - 1390 metres

BRAMFIELD (T. Pannell) - raced keenly in the early stages of the event.

LADY CONQUISTADOR (J. Chau) - at the entrance to the straight was disappointed and was obliged to alter course in the vicinity of the 200 metres when attempting a tight run between the heels of DEBEERSONUS, which rolled our marginally at the same time as BRAMFIELD rolled in slightly.

STONECAST (L. Neindorf) - lost its off fore plate during the event.

TASKMASTER (E. Boyd) - raced keenly in the early and middle stages of the event.



## RACE 3: MISS FINESSE FINANCE, VARIETY SA CHILDREN'S CHARITY BENCHMARK 64 HANDICAP - 1000 metres

**RODNEY** (L. Neindorf) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TINTAGEL ROCKER (J. Chau) - contacted on jumping away.

**STORM VOYAGER** (T. Pannell) - raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

KIROSHIMA (S. Fawke) - jumped away awkwardly.

**MAIDEN GRACE** (C. Lions) - jumped away awkwardly and shifted out bumping TINTAGEL ROCKER. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr T. Jolly, was advised that a Veterinary Certificate of Fitness was require prior to a future trial or race start.

#### RACE 4: RSM / SABOIS MAIDEN PLATE - 1210 metres

BARB WIRE (R. Hurdle) - inconvenienced when taken wider in the vicinity of the 1000 metres.

COMMANDING DRAGON (S. Logan) - taken out on jumping away onto FREE MOMENT.

**TAJAVEDO** (B. Sweeney) - shifted in shortly after the start bumping FREE MOMENT. In the vicinity of the 1100 metres was hampered and lost its position when contacted by FREE MOMENT and approaching the 1000 metres was again inconvenienced when taken wider by FREE MOMENT. Inside the 200 metres was hampered and became unbalanced when its hindquarters were turned out by FREE MOMENT.

**TEXAS JACK (NZ)** (G. Lo) – inconvenienced in the vicinity of the 1000 metres when BARB WIRE was taken out into its running line.

**WICKED KID** (E. Annells) - hampered in the vicinity of the 1100 metres when tightened onto INKERI by LADANES.

CHINESIS (J. Chau) - laid in throughout the event.

**FREE MOMENT** (S. Fawke) – contacted on jumping away. Raced greenly throughout the event and in the vicinity of the 1100 metres shifted out onto TAJAVEDO, and shortly after shifted out again contacting that runner. Inside the 200 metres shifted in and contacted JETTA JAE, which shifted out, resulting in FREE MOMENT being tightened onto TAJAVEDO. A post-race veterinary examination revealed lacerations to both hind pasterns. Trainer, Mr White, was advised that a warning had been placed on the mare in relation to its racing manners.

**IMBOSSIBLE** (K. Crowther) - shifted out on jumping away onto COMMANDING DRAGON. Hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms A. Cornell, was advised that a warning had been placed on the mare in relation to its racing manners.

**INKERI** (T. Pannell) – became unbalanced and lost its position in the vicinity of the 1100 metres when contacted by WICKED KID.

**JETTA JAE** (T. Voorham) - shifted out inside the 200 metres and contacted FREE MOMENT, which shifted in at the same time.

**LADANES** (C. Lions) - jumped away awkwardly. Shifted out in the vicinity of the 1100 metres onto WICKED KID. Rider advised to make a greater effort to keep her mounts straight when they commence to shift ground.



## RACE 5: JONES ELECTRICAL BENCHMARK 60 HANDICAP - 1390 metres

**GALAXY FALLS** (R. Hurdle) - momentarily inconvenienced inside the 100 metres when taken in by CRAZY CULPRIT.

**ABBI FEDE** (S. Fawke) - rider reported that it was his intention to settle outside the leader in this event; however, after being a touch slow to begin and encouraged early the gelding commenced to race fiercely and took up the lead of its own accord.

**CRAZY CULPRIT** (C. Lions) - inclined to shift about under pressure in the straight and inside the 100 metres shifted in onto GALAXY FALLS.

**KEEP DIGGING** (T. Voorham) - kicked by another in the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start.

**QUEEN'S PALACE** (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 6: CARLTON DRAUGHT BENCHMARK 49 HANDICAP - 1210 metres

**SPIRIT FORCE** (L. Neindorf) - shifted out shortly after the start onto HOW JAMMY'S THAT. A post-race veterinary examination revealed no visible abnormalities.

SERIOUS MOONLIGHT (E. Boyd) - slow into stride.

DERR PHONZ (C. Lions) - laid out under pressure in the straight.

**HOW JAMMY'S THAT** (T. Pannell) – jumped away awkwardly and shortly after lost its position when tightened onto LICORICE BULLET by SPIRIT FORCE.

MR TRUMAN (J. Chau) - raced fiercely in the early and middle stages of the event.

**WILANDER PRINCESS** (T. Voorham) - held up from the entrance to the straight until inside the 200 metres, when it was obliged to shift in to obtain clear ground.

**LICORICE BULLET** (G. Lo) – after obtaining the lead approaching the 100 metres was inclined to shift about under pressure until the finish.

## RACE 7: M & M GROUP OF COMPANIES BENCHMARK 56 HANDICAP - 1210 metres

SOCIAL MEDIA (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

**DOWNS AFTER DARK** (K. Crowther) - shifted in on jumping away contacting HE'S ABEL and shortly after was hampered when its hindquarters were turned by HE'S ABEL, which was taken back out. Raced wide without cover throughout the event.

**TUNGKETTA** (E. Boyd) - unbalanced on jumping away when its hindquarters were turned in by TOFFEE BELL. Rider explained that the mare was uncomfortable in its action throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**GEANDGE** (T. Pannell) – had difficulty obtaining clear ground approaching the 100 metres and then raced in restricted room over the concluding stages of the event. Rider explained that he was given no firm instructions; however, he anticipated that the mare would settle on pace or forward of midfield. He added that after jumping away GEANDGE had shown no real speed and due to the formation of the field he elected to restrain the mare and obtain cover rather than being caught wide. He further added that GEANDGE hung out rounding both turns and his a flat spot on straightening prior to it responding to his riding and finishing the race off well.



#### RACE 7: M & M GROUP OF COMPANIES BENCHMARK 56 HANDICAP - 1210 metres (cont'd)

**HE'S ABEL** (J. Chau) - taken in on jumping away contacting TOFFEE BELL, and then shortly after lost its position when TOFFEE BELL shifted out.

**TOFFEE BELL** (L. Neindorf) - jumped away awkwardly and shortly after was taken in onto TUNGKETTA, which shifted back out taking the mare out onto HE'S ABEL.

KAILUA (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

#### RACE 8: Q MECHANICAL CLASS TWO HANDICAP - 1750 metres

**HOBO BOB** (S. Fawke) – rider reported that the gelding travelled well in the early stages of the event; however, in the vicinity of the 800 metres was under pressure and had been one-paced to the finish of the event.

LANGKAWI (R. Hurdle) - shifted out on jumping away contacting BURGUNDEE MISS.

**NORTHSET** (T. Pannell) - raced fiercely in the early and middle stages of the event. Hung out rounding the home turn.

**SPIRITOS** (T. Voorham) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start.

**BURGUNDEE MISS** (E. Boyd) - contacted on jumping away. Raced wide without cover throughout the event. Hung in under pressure in the straight.

**CLAREFELILLI** (J. Chau) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the 400 metres until inside the 200 metres.

### RACE 9: VETS ON EYRE BENCHMARK 72 HANDICAP - 1750 metres

ROOBOY (T. Pannell) - raced wide without cover throughout the event.

**NEVA DOUBT US** (K. Crowther) - shortly after the start attempted to savage BALTIC PRINCE. Momentarily held up inside the 400 metres when it improved onto the heels of DANCE OF HEROES (GB).

DANCE OF HEROES (GB) (E. Annells) - raced wide without cover throughout the event.

EYE THE WORLD (G. Lo) - race keenly in the middle stages of the event.

**SAVANERO (NZ)** - was a late scratching at 8.30 am as there was no rider available at the required weight.

**GOTTABITON** (C. Lions) - had difficulty obtaining clear ground from the vicinity of the 300 metres until near the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

EMOJI - was a late scratching at 8.30 am as there was no rider available at the required weight.

**BANRI DE HERO** (S. Fawke) - slow to begin. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.
