STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 4 December 2019

TRACK: Good 4 (Track with some give in it)
Upgraded to a Good 3 at 3.20 pm (Track with good grass coverage and cushion)

RAIL: Out 5 metres entire. Sectional 610 metres.

WEATHER: Fine

RACE 1: 4 WAY FRESH PRODUCE / SABOIS MAIDEN PLATE - 1200 metres

CALL ME DEXTER (T. Voorham) - raced greenly throughout the event. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 100 metres when it shifted wider on the track to obtain clear ground. A post-race veterinary examination revealed no visible abnormalities.

WINTER HARBOUR (J. Maund) - inside the 800 metres rolled out into the running of STATELY STAR. Approaching the 600 metres improved onto the heels of KANZO and was obliged to be steadied.

CHARADE (J. Toeroek) - approaching the 100 metres rider became concerned with the mare's action and for this reason he did not ride CHARADE out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

RACY ROSIE (J. Chau) - shortly after the start raced in restricted room for a short distance between ETHICAL SOLUTION and FOUR OF A KIND.

SASSY RAIDER (J. Potter) - slow to begin.

ETHICAL SOLUTION (J. Holder) - trainer, Mr T. Doudle, was reprimanded under AR65(1) for failing to produce the Thoroughbred Identification Card (TIC). The horse was permitted to start as it was able to be identified from records held by the Stewards. Mr Doudle was advised that the TIC was required to be produced prior to a future race start.

RACE 1: 4 WAY FRESH PRODUCE / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

FOUR OF A KIND (G. Lo) - jumped away awkwardly. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

STATELY STAR (T. Pannell) - jumped away awkwardly. Inside the 800 metres was tightened for room between WINTER HARBOUR, which rolled out, and FOUR OF A KIND.

RACE 2: ULTRA-TUNE / KINGSFORD HOTEL CLASS TWO HANDICAP - 1200 metres

WOULDA THOUGHT SO (T. Pannell) - underwent a pre-race veterinary examination on arrival on course as it had not raced in over twelve months and was passed fit to start. Jumped away awkwardly and shifted in contacting TRIP.

STOLEN AWAY (NZ) (J. Holder) - reared over in the mounting yard. Underwent a pre-race veterinary examination and was ruled unfit to start. Acting on this advice Stewards withdrew STOLEN AWAY (NZ) at 1.55 pm. Trainer, Mr T. Doudle, was advised that a warning had been placed on the mare in relation to its pre-race manners.

GUEST LIST (J. Chau) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

TRIP (K. Crowther) - jumped away awkwardly, shifted out and contacted WOULDA THOUGHT SO. Raced keenly in the early and middle stages of the event. Laid out at the entrance to the straight.

SHALL WE HOPE (S. Logan) - laid out from the 400 metres until the entrance to the straight.

EMINENT SON (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: CORNERSTONE STUD / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1200 metres

CARLALUISA (J. Chau) - raced wide without cover throughout the event.

MAGNUS MAGIC (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

LAKHANI ROSE (K. Crowther) - slow to begin. Laid in under pressure in the straight.

AMBIBELLA (T. Voorham) - had difficulty obtaining clear ground at the entrance to the straight and inside the 200 metres was disappointed for a run between CARLALUISA, which rolled in slightly, and MAGESTIC DIVA and was unable to obtain clear ground until approaching the 50 metres.

RACE 4: DARE & JOHNSON BENCHMARK 60 HANDICAP - 1719 metres

EXALTED DEE (J. Holder) - in the vicinity of the 1500 metres raced in restricted room for a short distance between ANTIPAS and BANTEUX, which rolled in marginally. Thereafter raced keenly in the middle stages of the event.

RACE 4: DARE & JOHNSON BENCHMARK 60 HANDICAP - 1719 metres (cont'd)

BANTEUX (L. Neindorf) - in the vicinity of the 900 metres shifted in and inconvenienced COBBERS MATE. Rider reminded of his obligations and advised to only shift ground when entitled to do so. Rider explained that his instructions were, that given the gelding was one-paced, he was to attempt to settle outside the leader. After jumping away, given the formation of the field, he elected to find cover. Inside the 1200 metres, as the leaders drew away from the field, he elected to allow the gelding to roll forward to get closer to the leading pair. He added that BANTEUX was only one paced to the finish. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-trainers, Mr R. Jolly and Miss C. Jolly, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

ANTIPAS (J. Potter) - raced keenly in the early stages.

TATTIES (D. Tourneur) - a post-race veterinary examination revealed a laceration to the near hind leg. First aid administered.

RACE 5: MEMBERS OF BUNG FRITZ APPRECIATION SOCIETY BENCHMARK 60 HANDICAP - 1100 metres

COMMANDING DIVA (T. Pannell) - held up for clear running from the 400 metres until the 100 metres.

DR DAPPER (T. Voorham) - slow to begin.

IN THE FAST LANE (R. Hurdle) - raced wide throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RUSHWA (S. Fawke) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: HI-BEAM GAWLER CAR WASH BUNG FRITZ CUP BENCHMARK 60 HANDICAP - 2121 metres

CLASSY JOE (S. Fawke) - in the vicinity of the 600 metres was obliged to be taken hold of when racing tight between LINE DANCER and KING VALOUR (NZ).

LINE DANCER (K. Crowther) - jumped away awkwardly. Rider explained that after jumping away awkwardly the mare settled well, but did not let down as expected. A post-race veterinary examination revealed an abnormal upper respiratory noise. Trainer, Mr W. Clarken, was advised that the results of a laryngoscopic exam and a Veterinary Certificate of Fitness were required prior to a future trial or race start.

RUN BY NIGHT (J. Maund) - inside the 600 metres raced keenly and had to be restrained away from the heels of ANNAMAN.

SHAKOPEE (GB) (S. Logan) - got its head up whilst being restrained in the early stages of the event. Raced keenly in the early and middle stages of the event. In the vicinity of the 600 metres was obliged to be eased away from the heels of CLASSY JOE, and thereafter raced in restricted room until the 500 metres.

RACE 7: COOPERS BENCHMARK 64 HANDICAP - 1516 metres

DYNASTIC (T. Pannell) - raced wide without cover throughout the event.

RACE 7: COOPERS BENCHMARK 64 HANDICAP - 1516 metres (cont'd)

MIHANY (T. Voorham) - rider explained that the gelding raced flat throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr D. Saxon, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

HULME (NZ) (K. Crowther) - slow into stride.

BWUVA (J. Chau) - late scratching at 3.55 pm due to the track upgrade.

CITY BEATS (D. Tourneur) - laid out in the straight and in the vicinity of the 100 metres shifted out.

DIAMOND TYCOON (J. Holder) - in the vicinity of the 400 metres shifted out and inconvenienced **HULME (NZ)**. Rider reprimanded and advised in future to only shift ground when he is entitled to do so.

SECRET REWARD (E. Boyd) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

Race 7 - J. Holder (DIAMOND TYCOON) - AR131(a) - Careless riding.
