RACE 1: CEDUNA MEAT SERVICE TROPHY BM 54 HANDICAP - 1000 metres

ZOFFAY MAGIC - a late scratching by order of Stewards at 12.35 pm as there was no rider available.

SERIOUS MOONLIGHT (M. Henderson) - laid in under pressure over the concluding stages.

KAILUA (C. Lions) - laid in, in the straight.

BOTTLE AND BIRD (E. Annells) - rider accidentally dropped her whip in the vicinity of the 200 metres.

ALPHA MINT (P. Crich) - awkward to begin.

ROCKET LYLES (M. Collett) - rider reported that her mount resented the kick-back in today's event.

**RACE 2: TERRY WHITE CHEMMART CEDUNA / MGA INSURANCE / SABOIS MAIDEN PLATE
- 1200 metres**

FLYING LOCO (P. Crich) - tailed the field and was uncompetitive throughout. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr T. Haddy was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

STREETS AFTER DARK (K. Bishop) - in the vicinity of the 1000 metres raced keenly and had to be restrained off heels for a short distance.

TEXAS JACK (NZ) (M. Henderson) - reared on jumping away and as a result was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

FREE MOMENT (B. Sweeney) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

PLACID RED (NZ) (D. McWhinney) - laid in, in the straight.

RACE 3: CEDUNA FOODLAND CHRISTMAS HANDICAP - 1300 metres

VICTORY RED (M. Henderson) - in the vicinity of the 400 metres shifted in momentarily onto **SHE'S RENELDASGIRL**.

SHE'S RENELDASGIRL (K. Bishop) - in the vicinity of the 400 metres was inconvenienced momentarily when **VICTORY RED** shifted in.

RACE 4: VITERRA AUSTRALIA THEVENARD CUP - 1600 metres

ROOBOY (K. Bishop) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

BALTIC PRINCE (C. Lions) - laid out in the straight.

RACE 5: GYPSUM RESOURCES AUSTRALIA BENCHMARK 54 TROPHY HANDICAP- 1600 metres

THE LEPRECHAUN (M. Henderson) - a post-race veterinary examination revealed no visible abnormalities.

KEEP DIGGING (K. Bishop) - laid in over the concluding stages of the event.

SMARTFUL (L. Annells) - a post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow C. Lions (**SAINT VALENTINE**) placed second, to view the official footage of the finish.
