Report on Race Meeting held at Gawler Racecourse

RACE 1: HOLDFAST INSURANCE HANDICAP - 1200 metres

IT'S A SHAME (J. Bowditch) - Shortly after the start bumped with NEWBAY FLYER (NZ) which shifted out. Raced wide without cover in the early stages of the event and was allowed to stride forward to settle outside the leader. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

AIR MARSHAL (T. Pannell) - Slow to begin.

NEWBAY FLYER (NZ) (S. Logan) - Jumped away awkwardly, shifted out and bumped IT'S A SHAME. Raced keenly in the early and middle stages of the event.

RACE 2: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1500 metres

SUPER SWOOP (J. Chau) - Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

LOSTARC (J. Bowditch) - Slow to begin. Laid in under pressure in the straight.

PICKELHAUBE (T. Voorham) - Approaching the 100 metres rider dropped her off side rein for a short distance.

ANALYTICA (NZ) (T. Pannell) - Slow to begin. Rider could offer no explanation in relation to the gelding's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

YANKEE EYES (K. Crowther) - Inclined to lay in throughout the event.

RACE 3: BRONWEN DARRALL / JOHN DUNCAN MEMORIAL HANDICAP - 2100 metres

STAR STATUS (J. Holder) - Hung in under pressure in the straight and approaching the 200 metres shifted in onto COBBERS MATE which was inconvenienced and obliged to be eased. Rider was severely reprimanded under AR131(a) and advised to make a greater effort when his mounts commence to shift ground.

SPIEGEL GROVE (K. Bishop) - Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

KARAOKE EXPRESS (K. Crowther) - A post-race veterinary examination revealed no visible abnormalities.

RUN BY NIGHT (C. Lions) - Shortly after the start shifted in behind runners. Hung in from in the vicinity of the 700 metres.

COBBERS MATE (J. Potter) - Jumped away awkwardly. Approaching the 200 metres was inconvenienced and obliged to be eased as STAR STATUS which was hanging in, shifted in.

SHAKOPEE (GB) (S. Logan) - Over-raced in the early and middle stages of the event. Held up for clear running from rounding the home turn until shortly after the entrance to the straight.

RACE 4: WILLIAMSTOWN HOTEL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 metres

COPPERFIELDS (J. Toeroek) - On jumping away was inconvenienced by MY MISTER BROOKS which shifted out and shortly after bumped with that gelding which was shifting about. A post-race veterinary examination revealed no visible abnormalities.

MY MISTER BROOKS (E. Boyd) - Jumped away awkwardly shifted out and inconvenienced COPPERFIELDS and shortly after when shifting about, shifted out and bumped that gelding. In the vicinity of the 200 metres shifted out abruptly and as a result became awkwardly placed on the heels of SILVER LINING for a number of strides. Trainer Mr. J. Macmillan was advised a warning had been placed on the gelding in relation to its racing manners.

RIOT SQUAD (J. Bowditch) - Shortly after the start was restrained from its wide barrier and shifted in behind runners. Rider reported the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed the gelding to be lame in the near fore leg. Trainer, Mr. B. Borgarts, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

STAR CENTRAL (J. Holder) - Laid out under pressure in the straight.

PREDICTS (T. Voorham) - In the vicinity of the 800 metres became awkwardly placed on the heels of GENERAL MINT for a short distance. Held up for clear running from the entrance to the straight until near the 200 meters when racing between GENERAL MINT and RIOT SQUAD. A post-race veterinary examination revealed minor skin laceration to the upper lip.

RACE 5: CORNERSTONE STUD - SIR PRANCEALOT SERIES FINAL - 1200 metres

ALASKAN JADE (T. Pannell) - Held up for clear running from rounding the home turn until near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

CARLALUISA (J. Chau) - Raced keenly in the early stages of the event. A post-race veterinary examination revealed xxx

LAKHANI ROSE (K. Crowther) - Shortly after the start shifted in behind runners.

MAGESTIC DIVA (T. Voorham) - Jumped away awkwardly and as a result was slow into stride. Held up for a short distance at the entrance to the straight.

RACE 5: CORNERSTONE STUD - SIR PRANCEALOT SERIES FINAL - 1200 metres (Cont'd.)

SAND CAT (C. Lions) - Hung out under pressure in the straight.

RACE 6: TERRACE FUNCTION CENTRE HANDICAP - 1200 metres

MISS JANE (J. Holder) - In the vicinity of the 300 metres was inconvenienced when tightened onto KARLOVASI as ENOUGH SWAGGER shifted in abruptly.

EXTREME THRILL (R. Pearson) - Hung in under pressure in the straight.

DOMINATION (S. Logan) - Laid out under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the off hind leg.. Trainer, Mr. G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ENOUGH SWAGGER (K. Crowther) - In the vicinity of the 300 metres shifted in abruptly and inconvenienced MISS JANE when tightened onto KARLOVASI. Rider was reminded of her obligations to make a greater effort when her mounts commence to shift ground in future.

NASIFA (D. Tourneur) - Held up for clear running from approaching the 400 metres until approaching the 200 metres.

GRAND ARMADA (L. Goomany) - Slow to begin. Weakend from inside the 600 metres. A post-race veterinary examination revealed the gelding to have a hindquarter incoordination (a neurological condition). Trainer, Mr. A. Webster, was advised that a detailed Veterinary Certificate of Fitness was required to be submitted and approved by the TRSA Veterinary prior to the gelding completed a satisfactory Official Barrier Trial prior to starting in a race.

RACE 7: COOPERS HANDICAP - 1100 metres

GO THE JOURNEY (T. Voorham) - Rider could offer not explanation in relation to the gelding's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

I AM INCREDIBLE (T. Pannell) - Hung out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities. Stewards questioned Trainer Mr. W. Clarken in relation to the tactics adopted in today's event. He advised that he instructed T. Pannell to take up a forward position and these instructions are consistent to what was provided at the gelding's most recent start. He added that I AM INCREDIBLE has a history of over-racing, the gelding is best suited to not racing on the inside of other runners, being allowed to stride freely and that he has a limited turn of foot. Mr. Clarken added that barrier one (1) in today's event was a disadvantage to the gelding in particular after the scratching of OAMARU OWL, the likely leader in the race, as it had taken some pace out of the race. Rider T. Pannell confirmed the instructions provide at both starts and added the pace of the race did not suit I AM INCREDIBLE.

FANCY RUMBLE (R. Pearson) - Hung out under pressure in the straight.

BELLOMO (J. Holder) - Stewards permitted J. Holder to ride the gelding 0.5 kg over its declared weight of 54kg. Slow into stride.

WHITE KAPS (K. Crowther) - Race wide without cover throughout the event.

DEVONTE (J. Chau) - Slow to begin.

RACE 8: PROPER CLEAN HANDICAP - 1700 metres

CAPE RICHARDS (R. Pearson) - A post-race veterinary examination revealed no visible abnormalities. Stewards questioned Apprentice R. Pearson in relation to the gelding's performance in today's event. She explained that her instructions were to be neutral. She added after the gelding jumped slightly slow and from a wide barrier rather than being caught wide without cover she elected to restrain and settle at the rear of the field. She stated CAPE RICHARDS travelled well during the event, was comfortable in its action and finished the race off strongly. When further questioned in relation to her riding of the gelding from in the vicinity of the 600 metres and if she should have begun to encourage her mount along at this stage she explained the speed of the race had quickened and her mount had been left slightly flat footed. She added DOWNUNDER PRINCE which was racing to her inside was attempting to shift out brushing her mount on a number of occasions and she acknowledged, after viewing the footage, she should have been encouraging her mount along. Stewards noted R. Pearson's comments and didn't disagree with her in that she should have attempted to encourage her mount along from in the vicinity of the 600 metres and in doing so she may have been closer to the eventual winner COFFEE AMOUR which was racing approximately 2 lengths directly in front of her mount and she also may have had the ability to keep DOWNUNDER PRINCE to her inside.

ADATTO (NZ) (T. Pannell) - Hung out from in the vicinity of the 500 metres for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

EXALTED DEE (J. Holder) - Raced keenly in the early and middle stages of the event.

COFFEE AMOUR (T. Voorham) - Raced wide without cover during the event.

SUPERVELOCE (NZ) (J. Potter) - Shortly after the start when being restrained got its head up on a number of occasions. Raced keenly in the early and middle stages of the event.

CENTRE SCOOTA (D. Tourneur) - Shortly after the start shifted in to obtain cover.

RACE 9: GBJC - MERRY CHRISTMAS EVERYONE HANDICAP - 1500 metres

MY MOTHER SAYS (K. Crowther) - In the vicinity of the 1300 metres rolled out onto JACK'S SISTER.

AUSSIE JACK (S. Cahill) - In the vicinity of the 1300 metres rolled in on JACK'S SISTER. A post-race veterinary examination revealed no visible abnormalities.

SEABABE (T. Pannell) - Race wide without cover throughout the event.

BWUVA (D. Tourneur) - Inclined to lay in under pressure in the straight.

MAORI MAGIC (NZ) (J. Potter) - Raced wide without cover throughout the event.

JACK'S SISTER (E. Boyd) - In the vicinity of the 300 metres was obliged to be steadied when tightened between MY MOTHER SAYS which rolled out and AUSSIE JACK which rolled in. Raced keenly in the early and middle stages of the event. Hung out under pressure in the straight and proved difficult to ride out.

FANTASTIC MAGIC (C. Lions) - Raced keenly in the early and middle stages of the event.

CHUCKLES (J. Holder) - Stewards permitted J. Holder to ride the gelding 0.5 kg over its declared weight of 54kg. Raced keenly in the early and middle stages of the event.

RACE 10: AUSBIA ELECTRICAL HANDICAP - 1100 metres

SHAMINO (K. Crowther) - Held up for clear running from the 500 metres until the entrance to the straight when racing between MYSTICANO and CALL ME CURTIS. Laid out under pressure in the straight.

MYSTICANO (G. Lo) - A post-race veterinary examination revealed no visible abnormalities.

EMINENT SON (D. Tourneur) - laid out under pressure in the straight.
