Report on Race Meeting held at Morphettville Racecourse

**RACE 1: DELNORTH HANDICAP - 2000 metres**

**WICKED ACADEMY** (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2: ACTION LINE MARKING TWO-YEAR-OLD PLATE - 1050 metres**

**STRIKES AGAIN** (D. Tourneur) - rolled in approaching the 600 metres and inconvenienced UNSTOPPABELLE, which was obliged to be restrained to avoid the heels of STRIKES AGAIN. Rider severely reprimanded and to ensure that when his mounts commence to shift ground he takes corrective action. Was inclined to lay out rounding the home turn. A post-race veterinary examination revealed the colt to be shin sore in both forelegs. Trainer, Mr R. Moore, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**QUIETLY DISCREET** (K. Crowther) - proved fractious after being loaded into its barrier stall. Underwent a pre-race veterinary examination and was passed fit to start. Raced greenly during the event and near the 600 metres commenced to lay out and as a consequence raced wide into the straight and laid out for the remainder of the event. Rider reported that QUIETLY DISCREET's racing manners today were not consistent with its preparation and in her opinion the filly may be shin sore. A post-race veterinary examination revealed no visible abnormalities.

**UNSTOPPABELLE** (T. Pannell) - approaching the 600 metres commenced to race keenly and was obliged to be restrained off the heels of STRIKES AGAIN, which rolled in. Held up for clear running from near the 500 metres until inside the 400 metres.

### **RACE 3: PLUMBING AND PIPELINE SOLUTIONS 3YO BENCHMARK 64 HANDICAP - 1600 metres**

**JOURNICA** (T. Voorham) - struck a rail in the mounting yard en route to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Over-raced in the early and middle stages of the event. Laid in, in the straight.

**DEFEND** (K. Crowther) - raced keenly in the early stages of the event and near the 1400 metres became awkwardly placed on the heels of **HOLY DANCER** (NZ) for a short distance as the pace slackened. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities. Rider reported that she was inconvenienced in the early stages after being crossed by **HOLY DANCER** (NZ) and the placed slackened. As a consequences she went from travelling off the bridle to racing more keenly. She added that the gelding was disappointing in its performance.

**HOLY DANCER (NZ)** (G. Lo) - laid out in the straight.

**CLEARY ADONIS** (T. Pannell) - shifted in at the start and contacted **FOLLOW THE PROMPTS**. Rider explained that the filly jumped well and as a consequence he settled closer than intended due to **SUNSTONE** (NZ) to his inside not taking up a more forward position. He stated that his options were to be trapped wide without cover or take up a more forward position with cover.

**SPENCER GULF** (J. Toeroek) - laid in, in the straight.

**FOLLOW THE PROMPTS** (J. Potter) - shifted in at the start and contacted **CLEARY ADONIS**. Raced keenly in the early stages of the event.

### **RACE 4: ATR REFRIGERATED RENTALS THREE-YEAR-OLD MAIDEN PLATE - 1200 metres**

**BAD MOON RISING** (S. Fawke) - had difficulty obtaining clear running from near the entrance to the straight and inside the 200 metres shifted out and brushed with **LADY PAVLI CHENKO** when attempting the same run as that horse, thereafter was unable to improve its position fully and consequently was only able to obtain clear running approaching the 100 metres.

**IT'S A SHAME** (J. Toeroek) - laid in over the concluding stages of the event.

**JACK'S A CRACKER** (S. Logan) - awkward and slow to begin. Rider explained that as a consequence of the manner in which the gelding began she was unable to take up a more forward position as intended. Held up from near the 400 metres until inside the 200 metres.

**OOLONG GAZE** (J. Holder) - awkward to begin.

**LADY PAVLI CHENKO** (J. Potter) - raced keenly in the early stages of the event. Held up from near the 400 metres and inside the 200 metres was hampered when brushed by **BAD MOON RISING**, which shifted out to attempt the same run. As a consequence was unable to improve its position and was only able to obtain clear running approaching the 100 metres. A post-race veterinary examination revealed no visible abnormalities. When questioned about his instructions rider explained that he was instructed to make use of his inside barrier and he anticipated he may settle forward of mid-field, but was unable to obtain that position in the early stages and was obliged to settle slightly further back than intended.

**SARNIA** (K. Crowther) - raced keenly in the early stages of the event.

**ZIP AKEED** (T. Voorham) - over-raced in the early stages of the event. In the straight was obliged to shift from an inside position to the outside of the field in an attempt to improve its position. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 5: APEX STEEL PRODUCTS HANDICAP - 1800 metres**

**ADATTO (NZ)** (E. Brown) - inclined to shift out slightly over the concluding stages.

**EPERDUMENT** (T. Voorham) - held up for clear running when racing between the heels of RAABEEHA and VINACEOUS (NZ) from near the 500 metres until inside the 200 metres, and was obliged to shift to the inside of VINACEOUS (NZ) to obtain clear running. Thereafter was able to improve its position; however, inside the 100 metres rider was unable to ride her mount out fully for several strides owing to the positioning of ADATTO (NZ), which had shifted out slightly, before being able to return to her normal riding to the finish. Rider explained that her instructions were to attempt to settle forward of mid-field, but owing to the early pace and the formation of the field she was unable to do so and was obliged to settle a little further back. She added that after the entrance to the straight she was unable to improve into a run between VINACEOUS (NZ) and RAABEEHA, where she considered there was insufficient room to improve into owing to her position to the outside of the heels of VINACEOUS (NZ) and was obliged to maintain that position for a short distance and be held up before being able to shift to the inside of the heels of VINACEOUS (NZ). She added that thereafter over the concluding stages she was hampered by ADATTO (NZ) as that horse shifted out over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**MABEL JOSEPHINE** (S. Logan) - laid in, in the straight and as a consequence hampered EXALTED DEE over the concluding stages.

**EXALTED DEE** (J. Holder) - awkward to begin, shifted out and contacted GOLD MAESTRO. Raced keenly in the early stages of the event. Approaching the 150 metres was obliged to race in restricted room between FLORIANO to its inside and MABEL JOSEPHINE to its outside, which laid in under pressure, resulting in J. Holder being unable to fully test his mount to the finish.

**VINACEOUS (NZ)** (T. Pannell) - proved fractious after being loaded into its barrier stall and was removed from the barriers owing to the mare getting its tongue over the bit. After being attended to by the Veterinarian and barrier staff VINACEOUS was reloaded. A post-race veterinary examination revealed no visible abnormalities.

**HAHNDORF** (J. Chau) - laid in, in the straight.

**RAABEEHA** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities. Rider explained that he began well, travelled well in the early stages but from inside the 600 metres when asked for an effort the filly was flat and was disappointing in its performance and failed to finish the event off as expected.

**FLORIANO** (J. Toeroek) - required to be resaddled on arrival at the barriers.

**GOLD MAESTRO** (J. Maund) - contacted at the start.

### **RACE 6: BRADLEY PAINTING SERVICES HANDICAP - 1200 metres**

**DANGER DEAL** (J. Chau) - raced wide without cover throughout the event. Near the 500 metres rolled in slightly onto STREET STYLE, which was taken in onto SEABABE, which was inconvenienced.

**PALE ALE** (E. Boyd) - over the concluding stages had to be checked to avoid the heels of NASIFA, which shifted in and away from EXALTED TRAIL as that horse shifted in under riding and made slight contact with NASIFA. As a consequence PALE ALE was unable to maintain its position and E. Boyd was unable to fully test her mount to the finish.

**BELLA SUCCESS** (E. Brown) - raced wide without cover in the early stages of the event. Inside the 1000 metres became awkwardly placed on the heels of STREET STYLE for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: BRADLEY PAINTING SERVICES HANDICAP - 1200 metres (cont'd)**

**EXALTED TRAIL** (J. Holder) - shifted in at the start and contacted LEFT HAND MAN.

**LEFT HAND MAN** (R. Hurdle) - contacted at the start.

**NASIFA** (D. Tourneur) - near the 100 metres shifted in and away from EXALTED TRAIL as that horse shifted in slightly. After shifting in D. Tourneur put both hands on the reins and corrected his mount. Thereafter, over the concluding stages, after being contacted by EXALTED TRAIL, which shifted in, shifted in across the running of PALE ALE, resulting in that horse having to be checked to avoid its heels.

**SEABABE** (T. Pannell) - Stewards permitted T. Pannell to ride the mare 0.5 kg over its declared weight of 54kg. Near the 500 metres raced in restricted room between the heels of KENYAN WONDER and STREET STYLE, and was unable to maintain its position as STREET STYLE was taken in slightly by DANGER DEAL, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

**SHIFT THE RISK** (P. Gatt) - rider reported that the gelding slipped behind on jumping away and as a consequence the saddle shifted back on this horse resulting in him being placed at a disadvantage in the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Co-trainers, Messrs T. and C. McEvoy, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**KENYAN WONDER** (J. Potter) - slow to begin losing one to two lengths. Had difficulty obtaining clear running from near the 200 metres.

**RACE 7: ROADSIDE SERVICES AND SOLUTIONS CITY OF MARION STAKES - 1200 metres**

**CAPTAIN PUNCH** (B. Davis) - a post-race veterinary examination revealed no visible abnormalities.

**ZALMONA** (P. Gatt) - approaching the 200 metres had difficulty obtaining clear running for a short distance.

**GO THE JOURNEY** (G. Lo) - raced keenly in the early stages of the event.

**NIPPERKIN** (J. Holder) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ARROW LANE** (S. Fawke) - inside the 100 metres shifted out under riding and inconvenienced COLUMBIA. Rider reminded of his obligations when his mounts commence to shift ground.

**COLUMBIA** (T. Pannell) - Stewards permitted T. Pannell to ride the gelding 0.5 kg over its declared weight of 54kg. Obligated to race in restricted room to the outside of ARROW LANE inside the 100 metres as that horse continued to shift ground outwards. Rider explained that after the entrance to the straight, when attempting to improve his position between ARROW LANE to his inside and BENZ to his outside he was unable to do so as his horse did not respond in the manner he expected and whilst the run that he attempted was restricted he nevertheless thought that his horse was not inclined to improve into the position. He added that thereafter inside the 100 metres when maintaining his position he was inconvenienced by ARROW LANE, which shifted out. As a result he had to be conscious of that horse's heels for a number of strides.

**AIGUILLETTE** (E. Boyd) - a post-race veterinary examination revealed that the gelding lost its near fore plate during the event.

**AMBLEVE** (N. Farley) - knuckled at the start and was awkward to begin.

**RACE 8: NORTH EAST ISUZU HANDICAP - 1600 metres**

**SEE THE MASTER (IRE)** (S. Logan) - no Thoroughbred Identification Card was available for inspection. The horse was permitted to start as it was able to be identified from records held by the Stewards. A post-race veterinary examination revealed no visible abnormalities.

**SHROUDED IN MIST** (E. Brown) - raced keenly in the early and middle stages of the event. Held up for a short distance near the entrance to the straight.

**PASS THE GLASS** (J. Maund) - held up from the entrance to the straight until near the 200 metres.

**CANNOT BE SERIOS (NZ)** (A. Jordsjo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

**JACKTHEGIANTSLAYER** (J. Chau) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**STRYKE IN STYLE** (E. Boyd) - raced keenly in the early and middle stages of the event.
