RACE 1: MITAVITE - LEADERS IN EQUINE NUTRITION / SABOIS MADIEN PLATE THREE
- 1390 metres

FULL TILT (K. Bishop) - taken wider on the home turn by TAJAVEDO. Raced greenly in the straight. Laid in under pressure over the concluding stages. Rider was reminded of her obligations to straighten her mount sooner when beginning to shift ground.

TAJAVEDO (J. Chau) - hung out rounding the home turn. A post race veterinary examination revealed quartering of the medial heel in the right fore leg. First aid administered.

THE FOUR CEES (J. Potter) - raced keenly in the early and middle stages of the event. Rider was required to take a hold over the concluding stages when racing in tight room between the rail and TAJAVEDO to the outside, who had shifted in and away from FULL TILT, which was laying in.

Correct weight was delayed to allow J. Potter (THE FOUR CEES) placed third, to view the official vision. After doing so lodged an objection against FULL TILT (K. Bishop) placed first and TAJAVEDO (J. Chau) placed second, alleging interference over the final 150 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards dismissed both protests.

RACE 2: PORT LINCOLN REAL ESTATE / SABOIS MAIDEN PLATE - 1000 metres

ULTIMATE VIEW (K. Bishop) - laid in under pressure in the straight.

RACE 2: PORT LINCOLN REAL ESTATE / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)

LORAINÉ'S FLOWJO (B. Sweeney) - late scratching at 2.55pm as the gelding refused to load. Trainer, Mr M. White, was advised that LORAINÉ'S FLOW JO was now required to load without delay in an Official Barrier Trial prior to a future race start.

PEACE CLOUD (J. Potter) - approaching the 800 metres shifted in. Rider reminded of his obligations to only shift ground when entitled to do so.

TIME GENTLEMAN (R. Hurdle) - slow to begin. Raced keenly in the early stages of the event. Approaching the 800 metres rider was obliged to momentarily ease off the heels of PEACE CLOUD.

ALL THINGS NICE (T. Voorham) - raced wide without cover throughout the event.

ANASTASIA SKILL (S. Logan) - underwent a pre-race veterinary examination as the mare had not started in over twelve months and passed fit to start. Inconvenienced in the vicinity of 200 metres by UTIMATE VIEW, which was laying in. Had difficulty obtaining clear ground for the remainder of the event.

CRY OUT LOUD (C. Lions) - laid in under pressure in the straight.

LOVE ME HARDER (K. Lau) - underwent a pre-race veterinary examination as the mare had not started in over twelve months and passed fit to start. Raced keenly in the early stages of the event.

MAM'MOSHELLE (L. Neindorf) - Over-raced in the early stages of the event.

RACE 3: VINNIES SA BUSHFIRE APPEAL BENCHMARK 50 HANDICAP - 1210 metres

THE LEPRECHAUN (T. Voorham) - hampered shortly after the start by HARDASHIAN, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

SERIOUS MOONLIGHT (E. Boyd) - slow to begin.

HARDASHIAN (B. Sweeney) - shifted in shortly after the start hampering THE LEPRECHAUN. Laid in under pressure in the straight.

BOTTLE AND BIRD (M. Collett) - hung out rounding the home turn. Laid in under pressure in the straight.

SHEZA PROPHET (K. Bishop) - hung out rounding the home turn.

TILBURY (C. Lions) - inclined to lay in under pressure. Inconvenienced in the vicinity of 100 metres when racing between BEDLOE'S ISLAND to the inside and HARDASHIAN to the outside, which was laying in.

RACE 4: SHIELDS SECUIRTIY BENCHMARK 54 HANDICAP -1390 metres

CALL ME HERBIE (K Crowther) - over the concluding stages of the event shifted in when insufficiently clear of TUNGKETTA (E. Boyd), who was obliged to steady her mount and lose its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she permitted her mount to shift in when insufficiently clear and was suspended from riding in races from midnight 5th January 2020 and to conclude at midnight 15th January 2020: a period of three meetings.

TURFONIC (T. Voorham) - held up for clear running from the vicinity of 400 metres to the entrance of the home straight. Inclined to lay in, in the straight.

KEEP DIGGING (K. Bishop) - raced wide without cover throughout the event.

RACE 4: SHIELDS SECURTIY BENCHMARK 54 HANDICAP (Cont'd) - 1390 metres

TUNGKETTA (E. Boyd) - raced keenly in the early stages of the event. Steadied and lost its position over the concluding stages by CALL ME HERBIE, which had shifted in.

HOBO BOB (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: AVIS PORT LINCOLN BENCHMARK 56 HANDICAP - 1210 metres

MONTRE (S. Logan) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start.

CHINESIS (J. Chau) - hung in, in the straight.

CHASE SOPRANO (E. Boyd) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Rider reported the mare did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: SOUTHERN CROSS AUSTERO BENCHMARK 60 HANDICAP - 1000 metres

TINTAGEL ROCKER (J. Chau) - laid in under pressure in the straight.

APPOLO HOPE (R. Hurdle) - reared on jumping away.

LA PETITE ROUSSE (K. Bishop) - shortly after the start shifted out and away from KIROSHIMA, which had been taken out.

KIROSHIMA (S. Fawke) - taken out on jumping by ARTISTIC ESCAPE, which was taken out by MAIDEN GRACE. Difficulty obtaining clear running from the entrance of the home straight to the vicinity of 200 metres.

ARTISTIC ESCAPE (J. Potter) - held up for clear running from the entrance to the straight until inside 200 metres.

MAIDEN GRACE (C. Lions) - laid in under pressure over the concluding stages. Rider reported the mare had a tendency to hang out throughout the event. A post race veterinary examination revealed no visible abnormalities.

RACE 7: LINCOLN SAND SUPPLIES - NT & DA DICKSON BENCHMARK 64 HANDICAP - 1390 metres

AHIGA (K. Bishop) - jumped awkwardly, shifting out onto RELAXED.

RELAXED (K. Crowther) - bumped at the start by AHIGA, which shifted out.

SON OF CITY (C. Lions) - raced wide without cover throughout the event.

TASKMASTER (L. Neindorf) - raced keenly in the early stages of the event.

RACE 8 FOURIER TECHNOLOGIES BENCHMARK 80 HANDICAP - 1210 metres

ARTFUL RAMBLER (S. Logan) - Inclined to lay in under pressure in the straight. Taken wider over the concluding stages by VICTOR VICTOR, which had shifted out off the heels of TOLSTOY.

RACE 8: FOURIER TECHNOLOGIES BENCHMARK 80 HANDICAP - 1210 metres (Cont'd)

TOLSTOY (L. Neindorf) - tightened on jumping away between ITS HUMPHREY, which shifted out slightly, and RUBY'S REWARD, which shifted in slightly. Lain in under pressure in the straight.

RUBY'S REVENGE (K. Bishop) - rider was severely reprimanded for permitting her mount to shift in onto IT'S HUMPHREY over the concluding stages.

KINGSON (K. Crowther) - raced keenly in the early stages of the event.

VICTOR VICTOR (J. Potter) - rider reported the gelding laid in in the straight. Shifted out from the heels of TOLSTOY over the concluding stages, taking ARTFUL RAMBLER wider.

IT'S HUMPHREY (T. Voorham) - rider was obliged to take a hold of her mount over the concluding stages to avoid the heels of RUBY'S REVENGE, which shifted in.

WHAT A SHOCK (NZ) (E. Boyd) - slow to begin. A post race veterinary examination revealed no visible abnormalities.

RACE 9: HAPPY MACCAS NEW YEAR BENCHMARK 64 HANDICAP - 1750 metres

EYE THE WORLD (E. Boyd) - rider reported the gelding did not feel comfortable in its action throughout the event. A post race veterinary examination revealed no visible abnormalities.

DON'T DISMISS (J. Potter) - held up for clear running from the vicinity of 400 metres until approaching the 200 metres.

ARTFUL MONTY (C. Lions) - raced keenly in the middle stages of the event.
