RACE 1: ZEMA ESTATE / SABOIS MAIDEN PLATE - 1700 metres

EKALNED (S. Logan) - approaching the 1400 metres rolled in and inconvenienced **PEER OF BLUE**.

PEER OF BLUE (K. Crowther) - approaching the 1400 metres was inconvenienced by **EKALNED**, which rolled in.

THE GREAT MARTINI (S. Fawke) - slow to begin. Raced keenly in the middle stages of the event.

YOUNG LUCAS (L. Williams) - laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: LADBROKE GROVE WINES / SABOIS MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately 5 minutes

RACE 2: LADBROKE GROVE WINES / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)

CAPTAINZWAYZE (K. Lau) - jumped away awkwardly. Shortly after the start was obliged to be steadied to avoid the heels **JACQUI ANN**. In the vicinity of the 700 metres was inconvenienced by **ZEGRESTO**. Laid in, in the straight.

HOST OF IDEAS (K. Bishop) - jumped away awkwardly.

KONIGSBERG (S. Fawke) - in the vicinity of the 800 metres rolled out taking **TONS OF FUN** wider.

UNCLE BOB (S. Logan) - in the vicinity of the 600 metres improved onto the heels of **TONS OF FUN** and was obliged to be steadied. In the vicinity of the 400 metres was obliged to be steadied to avoid the heels of **WONAEAMIRRI**, which rolled in.

WONAEAMIRRI (L. Neindorf) - in the vicinity of the 800 metres inconvenienced by **ATOMIC WINGS**, which was taken wider. Laid in, in the straight placing its rider at a disadvantage for the remainder of the event.

ATOMIC WINGS (T. Voorham) - in the vicinity of the 800 metres was taken wider by **TONS OF FUN**, which shifted out inconveniencing **WONAEAMIRRI**.

DE LA BOSSANOVA (L. Halliday) - a late scratching by order of Stewards at 1.53 pm as the mare refused to proceed to the start. Trainer Mr J. Kenny was advised the gelding would be required to proceed to the gates to the Stewards satisfaction in an Official Barrier Trial and prior to accepting for a future race.

TONS OF FUN (J. Chau) - in the vicinity of the 800 metres shifted out and away from **KONIGSBERG** and inconvenienced **ATOMIC WINGS**. Inside the 600 metres was obliged to be steadied when it improved onto the heels of **KONIGSBERG**.

JACQUI ANN (E. Boyd) - shifted out on jumping away.

ZEGRESTO (D. Tootell) - jumped away awkwardly got its head up while being restrained and raced greenly throughout. Trainer Mr D. Magro was advised a warning had been placed on the filly. In the vicinity of the 700 metres laid out and inconvenienced **CAPTAINZWAYZE**. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: PETER THOMPSON WINES / SABOIS MAIDEN PLATE - 1400 metres

HENRY'S REWARD (T. Voorham) - jumped away awkwardly, shifted out and hampered **YOUNG LARS**.

WATCH DAT STINGER (E. Boyd) - bumped on jumping away with **COOL DESERT**.

YIN AND YANG (S. Cahill) - raced keenly in the early and middle stages of the event.

YOUNG LARS (L. Neindorf) - hampered on jumping away by **HENRY'S REWARD**, which shifted out.

CHARADE (S. Logan) - raced keenly in the middle stages of the event.

COOL DESERT (G. Lo) - jumped away awkwardly and bumped **WATCH DAT STINGER**.

SNAPTOF (P. Gatt) - laid in, in the straight.

RACE 4: PATRICK OF COONAWARRA BENCHMARK 72 HANDICAP - 1300 metres

RHYTHMATIC (D. Tourneur) - got its head up on jumping away and shortly thereafter was hampered by **BULLET KID**, which shifted out.

RACE 4: PATRICK OF COONAWARRA BENCHMARK 72 HANDICAP - 1300 metres (Cont'd)

REDEEKA (M. Collett) - raced ungenerously in the middle stages of the event.

BULLET KID (T. Voorham) - jumped away awkwardly, shifted out and bumped RHYTHMATIC.

RACE 5: KATNOOK ESTATE BENCHMARK 54 HANDICAP - 1400 metres

MASHAHEER (J. Chau) - held up momentarily in the vicinity of the 300 metres.

MULGA LIL (D.Tourneur) - in the vicinity of the 1100 metres was obliged to be steadied to avoid the heels of SASSY MANEUVER, which shifted in.

SASSY MANEUVER (S. Cahill) - in the vicinity of the 1100 metres shifted in and inconvenienced MULGA LIL. Rider was reprimanded and advised in future to only shift ground when sufficiently clear.

BUNUMBURT (C. MacFarlane) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

BIG CALL (M. Collett) - jumped away awkwardly. Rider explained her instruction were to attempt to lead and from the 600 metres to lift the tempo as the mare was one paced. She stated that after only beginning fairly the mare did not improve as anticipated in the early part of the event and never travelled throughout. A post-race veterinary examination revealed no visible abnormalities.

TEMEYEZ (T.Voorham) - slow into stride.

RACE 6: WYNNS COONAWARRA ESTATE BENCHMARK 58 HANDICAP - 1100 metres

The start of this race was delayed approximately nine minutes.

DEFORCE (J. Maund) - laid out under pressure in the straight.

DESERT SPIRIT (D. Tourneur) - jumped away awkwardly, shifted in taking CRYPTO CURRENCY in.

OLIVER TALE (G.Lo) - hampered shortly after the start.

CRYPTO CURRENCY (L. Niendorf) -taken in on jumping away hampering OLIVER TALE.

RUBY QUE (R. Hurdle) - reared up dislodging the rider, making contact with a perimeter fence en route to the barriers and galloping riderless. Stewards declared RUBY QUE a late scratching at 4.10pm acting on veterinary advice. Trainer Mr R. Wilson was advised the mare would be required to proceed to the barrier without delay in an Official Barrier Trial prior to accepting for a future race.

TEATRO (K. Crowther) - slow into stride.

DABAY (J. Chau) - shifted out under riding in the vicinity of 150 metres when insufficiently clear of CREATIVE VISION, which was forced to be steadied to avoid the heels of DABAY. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday 25 January and to conclude at midnight on Wednesday, 29 January 2020: a period of three meetings.

CREATIVE VISION (S. Logan) - in the vicinity of the 150 metres was forced to be steadied to avoid the heels of DEBAY, obliged to shift to inside of that gelding to obtain clear running.

RACE 7: 36° SOUTH COONAWARRA VIGNERONS CUP - 1700 metres

DYAGILEV (J. Maund) - jumped away awkwardly. Laid out under pressure from the 100 metres.

JUMBO PRINCE (K. Bishop) - raced keenly in the early and middle stages of the event.

MISS COOLANGATTA (S. Fawke) - rider explained, the mare travelled well throughout, however when placed under pressure inside the 400 metres did not respond as expected to his riding and was disappointing to the finish. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr P. Preusker was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

PERSIAN EMPIRE (NZ) (K. Crowther) - jumped away awkwardly.

DISCO REBEL (P. Gatt) - Stewards declared DISCO REBLE a late scratching on veterinary advise at 12.55pm.

SANDHILL STAR (D. Tourneur) - Laid out from in the 400 metres.

RACE 8: WHISTLE POST WINES BENCHMARK 58 HANDICAP - 1700 metres

TOUGH VIC (L. Williams) - laid in under pressure from the 100 metres.

BOSSY BRITCHES (S. Cahill) - rider explained that the mare travel well in the early and middle stages, however when placed under pressure from the 400 was one paced to the finish.

TZAREVNA (L. Halliday) - rolled in at the entrance to the home straight, tightening the running of JENEFACOR.

ILLOWA (R. Hurdle) - stood flat footed and as result was slow to begin (3 lengths). Laid in approaching the finish and was obliged to shift out to obtain clear running over the concluding stages.

JENEFACOR (C. MacFarlane) - raced in restricted room at the entrance to the home straight between ILLOWA and TZAREVNA, which rolled in, and was obliged to steadied.

LONGMIRE (L. Neindorf) - inside the 400 metres laid in and away from BUBBLERAP, tightening the running of NOBLE ROCKS.

HASTA LA SPEC (T. Voorham) - jumped away awkwardly. Held up for clear running from the 400 metres until the entrance to the straight.

NOBLE ROCKS (J. Chau) - taken in, inside the 400 metres tightening the running of DERONIMO by LONGMIRE, which laid in.

DERONIMO (S. Fawke) - inside the 400 metres tightened between JENEFACOR and NOBLE ROCKS, which was taken in, and was obliged to be steadied and lost it position.
