**RACE 1: TAB/WEST END DRAUGHT/THEVENARD SHIPPING/SABOIS MAIDEN PLATE**  
- 1000 metres

**STREETS AFTER DARK** (M. Collett) - prior to the event became fractious in the mounting yard and dislodged its rider. M. Collet was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements and was sent to hospital for further observations. STREETS AFTER DARK was declared a late scratching by order of Stewards at 1.10 pm. Stewards ordered that all monies invested on STREETS AFTER DARK prior to the time of withdrawal be subject to deductions of 20 cents in the dollar for a win and 20 cents for a place.

**TIME GENTLEMAN** (B. Sweeney) - appeared to resent the kickback in the event.

**RACE 2: LETCHER MORONEY CHARTERED ACCOUNTANTS/ MIDSEC SECURITIES BENCHMARK 58**  
**HANDICAP – 1000 metres**

**ZOFFAY MAGIC** (M. Henderson) - slow to begin. Laid in, in the straight.

**MARIANNE RUBY** (D. McWhinney) - slow to begin. Laid in, in the straight.

**MAIDEN GRACE** (C. Lions) - rider reported that her mount may have gotten it's tongue over the bit during the event. A post-race veterinary examination revealed no visible abnormalities.

**SHEZA PROPHET** (J. Keating) - held up for clear running from inside the 400 metres until inside the 200 metres and shortly after shifted out to obtain clear running and thereafter laid out.

**BOTTLE AND BIRD** (B. Sweeney) - as there was no other rider available on course Stewards permitted B. Sweeney to ride the mare 4kg over its declared weight.

**RACE 3: TOYOTA AUSTRALIA FEATURE SPRINT – 1200 metres**

**KAILUA** (K. Lau) - inclined to lay in, in the straight.

**RACE 3: TOYOTA AUSTRALIA FEATURE SPRINT - 1200 metres (Cont'd)**

**THE LEPRECHAUN** (J. Keating) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 4: CEDUNA HOME TIMBER & HARDWARE/ HAHN SUPER DRY BENCHMARK 52 TROPHY RACE - 1300 metres**

**SERIOUS MOONLIGHT** (K. Lau) - rider reported his mount never felt comfortable in its action during the event.

Correct weight for this event was delayed to allow Trainer Mr B. Jones (PARTY TIGER) to view the photo finish for second place.

**RACE 5: CEDUNA FORESHORE HOTEL CEDUNA CUP - 1600 metres**

**TYCOON FLUTTER (NZ)** (M. Collett) - as there was no available rider on course Stewards ordered the late scratching of the gelding at 1. 42 pm.

**RACE 6: WCT RURAL/ WILKINSON PLUMBING BENCHMARK 52 TROPHY RACE - 1600 metres**

**SAINT VALENTINE** (E. Annells) - reared as the start was affected and as a result did not take part in the event.

**KAAPOW** (K. Lau) - examined on arrival on course by the Clubs Veterinary Surgeon who reported the gelding had an abrasion under its jaw, and as a result would not be able to race with a cross over noseband as declared on its gear. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race.

Correct weight was delayed to allow Stewards to hear evidence from the E. Annells (SAINT VALENTINE) and the official Starter. After hearing their submissions and acting under AR204(1)(c), Stewards declared SAINT VALENTINE a non-starter as the barrier attendant still had a hold of the gelding as the start was affected. Stewards ordered that all monies invested in SANT VALENTINE prior to the starting time to be subject to deductions of 40 cents in the dollar for a win and 40 cents for a place.
