STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 15 February 2020

TRACK: Good 4

(Track with some give in it)

RAIL: Out 12 metres 1200 metres to winning post, 6 metres 2000 metres to 1800 metres, 8 metres remainder sectional 616 metres

WEATHER: Fine

RACE 1: AAMI TWO-YEAR-OLD PLATE - 1100 metres

BRIBERY (J. Holder) - a post-race veterinary examination revealed low grade tying up. First aid administered.

MY RUBY (J. Potter) - raced keenly in the early and middle stages of the event. Inclined to lay out under pressure in the straight.

AQAAREB (T. Pannell) - jumped away awkwardly and was slow into stride. Rolled out slightly in the vicinity of the 400 metres onto STRIP CLUB. Inconvenienced in the vicinity of the 350 metres when its hindquarters were turned by OPHELIA BLUES.

OPHELIA BLUES (J. Chau) - made the turn in the vicinity of the 350 metres awkwardly and shifted out contacting AQAAREB. A post-race veterinary examination revealed no visible abnormalities.

STRIP CLUB (C. Lions) - raced keenly in the early stages of the event. Inconvenienced in the vicinity of the 400 metres when taken wider onto the heels of BRIBERY by AQAAREB. Inclined to lay in under pressure in the straight.

RACE 2: TAB ADELAIDE CUP DAY, MONDAY MARCH 9 HANDICAP - 1200 metres

ATLANTIC LAD (S. Price) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SOWPODS (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

SEEMINGLY DISCREET (J. Holder) - slow to begin.

CLASSY JAYBEE (S. Fawke) - jumped away awkwardly and shifted out contacting EXALTED ZOE. Laid out under pressure over the concluding 500 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

JUSTEDEE (T. Pannell) - slow to begin.

EXALTED QUEEN (C. Lions) - raced wide without cover throughout the event.

EXALTED ZOE (S. Logan) - contacted on jumping away. Laid out rounding the home turn.

RACE 3: TERRY HOWE PRINTING HANDICAP - 1600 metres

AURMAN ZOU (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

BACK POCKET (R. Hurdle) - inside the 1200 metres rolled out slightly onto ANTIPAS.

BALLAST (S. Logan) - raced keenly in the middle stages of the event.

BWUVA (J. Chau) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

SIRIUS DEAL (G. Lo) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

GETOUTTHEWAY (J. Toeroek) - jumped away awkwardly.

JIVE BABY (J. Cartwright) - shifted about under pressure in the straight.

ANTIPAS (J. Potter) - inside the 1200 metres had to be steadied momentarily when it shifted in slightly at the same time as BACK POCKET shifted out.

ARTFUL TEEPA (C. Lions) - raced wide without cover throughout the event.

RACE 4: SCHWEPES HANDICAP - 2043 metres

AZURITE (IRE) (A. Jordsjo) - slow to begin. In the vicinity of the 150 metres was tightened when attempting a run between ALLUSION and FRANKED (GB) and was obliged to alter course to obtain clear ground.

SUPER SWOOP (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

BLUE BEAR (C. Caserta) - raced keenly in the early and middle stages of the event.

ALLUSION (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

SIR GARFIELD (S. Fawke) - a post-race veterinary examination revealed the gelding was showing signs of the thumps.

RACE 5: TAB HANDICAP - 1100 metres

NIPPERKIN (L. Neindorf) - shifted out on jumping away bumping STAR OF MONSOON.

ENOUGH SWAGGER (D. Bates) - shifted in on jumping away onto SHAMINO. Rider explained the mare had never really travelled and when asked for an effort at the entrance to the straight had not let down as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

FAVONSKI (K. Julius) - a post-race veterinary examination revealed no visible abnormalities.

SHAMINO (G. Lo) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

STAR OF MONSOON (S. Logan) - contacted on jumping away.

CAZABILLIE (T. Pannell) - Stewards permitted T. Pannell to ride the mare 0.5 kg over its declared weight of 54kg.

OH MO (D. Tourneur) - laid out over the concluding 500 metres.

RACE 6: FURPHY HANDICAP - 1600 metres

TABLE OF WISDOM (M. Julius) - rolled in towards FAROOQ inside the 200 metres. Inside the 100 metres shifted out slightly onto SERIOUS SPENDER.

REGALO DI GAETANO (L. Neindorf) - inclined to shift about under pressure in the straight.

BLOW TORCH (J. Holder) - raced keenly in the early and middle stages of the event. Held up from approaching the 400 metres until in the vicinity of the 200 metres.

FAROOQ (R. Hurdle) - laid out under pressure over the concluding stages.

ICE GHOST (T. Pannell) - inside the 100 metres rolled in slightly onto SERIOUS SPENDER.

DREAMED (D. Tourneur) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SERIOUS SPENDER (J. Chau) - in the vicinity of the 100 metres was disappointed when it laid out slightly when attempting a tight run between TABLE OF WISDOM and ICE GHOST. Shortly thereafter was accidentally struck across the head by the whip of M. Julius and then had to be steadied when TABLE OF WISDOM rolled out slightly at the same time as ICE GHOST rolled in slightly.

Correct weight was delayed to allow R. Hurdle (FAROOQ) placed fourth, to view the vision in the straight. After doing so R. Hurdle lodged an objection against TABLE OF WISDOM (M. Julius) placed third, alleging interference in the straight. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the protest.

RACE 7: HOLDFAST INSURANCE HANDICAP - 1200 metres

DANGER DEAL (J. Chau) - jumped away awkwardly. In the vicinity of the 800 metres was inconvenienced for a number of strides when COTILLION rolled in slightly. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

EXCELTARA (G. Lo) - laid in under pressure in the straight.

BELLOMO (T. Voorham) - jumped away extremely awkwardly, got its head up and missed the start by several lengths. Trainer Mr B. Jones was advised that a warning had been placed on the gelding. A post-race veterinary examination revealed no visible abnormalities.

TROGIR (T. Pannell) - in the vicinity of the 1100 metres shifted out slightly contacting COTILLION. Wide without cover throughout the event.

ORLEANS ROCK (NZ) (D. Bates) - jumped away awkwardly and shifted out contacting BROADWAY AND FIRST. Held up from the vicinity of the 300 metres until approaching the 100 metres.

ROHLON DRUNK (M. Julius) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

BROADWAY AND FIRST (K. Bishop) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

COTILLION (A. Jordsjo) - taken out in the vicinity of the 1100 metres by TROJIR onto SUNRISE DANCER. In the vicinity of the 800 metres rolled in onto DANGER DEAL. Rider reminded of her obligations when shifting ground.

RACE 7: HOLDFAST INSURANCE HANDICAP - 1200 metres (Cont'd)

SUNRISE DANCER (P. Gatt) - hampered in the vicinity of the 1100 metres when COTILLION was taken out into its running line.

Correct weight was delayed to allow Stewards to view the vision of the start.

RACE 8: HOLDFAST INSURANCE BIRTHDAY CUP - 2043 metres

WETAKEMANHATTAN (S. Fawke) - hampered on jumping away when contacted by ROCKARRAL. Laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

MELI MELO (J. Toeroek) - Stewards permitted J. Toeroek to ride the mare 0.5 kg over its declared weight of 54kg. Taken out in the vicinity of the 100 metres by MASTER CHUM.

DR DEPENDABLE (J. Chau) - contacted for a number of strides in the vicinity of the 900 metres when LOSTARC attempted to shift out.

HASTA LA WAR (T. Voorham) - raced keenly in the early and middle stages of the event. Held up from the vicinity of the 500 metres until near the 400 metres. Shifted in slightly in the vicinity of the 50 metres onto ROCKARRAL.

ROCKARRAL (T. Pannell) - Stewards permitted T. Pannell to ride the gelding 0.5 kg over its declared weight of 54kg. Taken out on jumping away onto WETAKEMANHATTAN. In the vicinity of the 500 metres shifted out slightly onto LIGHT THE WAVES. Inconvenienced in the vicinity of the 50 metres when taken out by MELI MELO at the same time as HASTA LA WAR shifted in slightly.

LIGHT THE WAVES (J. Holder) - momentarily inconvenienced in the vicinity of the 500 metres when ROCKARRAL shifted out slightly. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Co-Trainer Mr C. McEvoy was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

LOSTARC (P. Gatt) - raced keenly in the early stages of the event. Shifted out in the vicinity of the 900 metres in an attempt to improve, contacting DR DEPENDABLE, which held its line.

MASTER CHUM (E. Boyd) - jumped away awkwardly and shifted out onto ROCKARRAL. Laid out under pressure in the straight. In the vicinity of the 100 metres shifted out onto MELI MELO. Rider reminded of her obligations when shifting ground.

JACKTHEGIANTSLAYER (L. Neindorf) - had difficulty obtaining clear ground from the vicinity of the 300 metres until near the 150 metres.

RACE 9: ADELAIDE GALVANISING HANDICAP - 1050 metres

VALLIANO (R. Hurdle) - slow into stride.

LOVE MAGIC (S. Price) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

ALASKAN JADE (J. Chau) - shifted in on jumping away onto DEVONTE.

FRENCH ROCK (L. Neindorf) - inconvenienced on jumping away when contacted by DEVONTE, which had been taken in.

RACE 9: ADELAIDE GALVANISING HANDICAP - 1050 metres (Cont'd)

READY SUNSHINE (K. Zechner) - A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer Mr R. Balfour was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

WAR MISTRESS (P. Gatt) - slow to begin. Raced keenly in the early and middle stages of the event.

DEVONTE (A. Jordsjo) - hampered on jumping away when tightened onto **FRENCH ROCK** by **ALASKAN JADE**. Raced wide without cover throughout the event. Rider reported the gelding raced keenly in the early and middle stages of the event.
