Report on Race Meeting held at Port Lincoln Racecourse

**RACE 1: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1210 metres**

**FLYING LOCO** (C. Lions) - jumped away awkwardly and as a result was slow into stride. Shortly thereafter was awkwardly placed on the heels of IMBOSSIBLE, which was taken out. Raced keenly in the early and middle stages of the event. Inside the 100 metres rider accidentally dropped her whip.

**COPPERFIELDS** (S. Fawke) - jumped away awkwardly, shifted out and bumped IMBOSSIBLE.

**THE MASTER** (T. Pannell) - jumped away awkwardly, shifted in and bumped OUR RHYTHM. Inclined to lay in under pressure in the straight. Near the 200 metres laid in and was obliged to be eased when awkwardly placed on the heels of IMBOSSIBLE. Rider explained in relation to the gelding's disappointing performance that THE MASTER travelled well during the run, and when presented at the top of the straight, failed to let down as he had expected. He added the gelding was inclined to lay in when placed under pressure, raced flat in today's event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

**ANASTASIA SKILL** (J. Toeroek) - jumped away awkwardly and shortly after was unable to improve its position, due to the positioning of OUR JOURNEYMAN and LADY HUNTSMEN.

**IMBOSSIBLE** (K. Bishop) - raced keenly in the vicinity of the 700 metres for several strides.

**RACE 2: LINCOLN ESTATE WINES RATING 0-56 HANDICAP - 1390 metres**

**ARTFULABEERS** (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

**KEEP DIGGING** (T. Voorham) - hung out rounding the home turn.

**CRAZY CULPRIT** (C. Lions) - jumped away awkwardly. Raced wide without cover throughout the event. In the vicinity of the 200 metres, rider accidentally dropped her off side rein for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: LINCOLN ESTATE WINES RATING 0-56 HANDICAP - 1390 metres (Cont'd)**

**CALL ME HERBIE** (K. Crowther) - inclined to lay in under pressure in the straight.

**TURFONIC** (T. Pannell) - slow to begin. Held up for clear running from in the vicinity of the 400 metres until approaching the 200 metres. Laid out under pressure in the straight.

**GEANDGE** (S. Logan) - difficulty obtaining clear ground from shortly after the entrance to the straight until in the vicinity of the 150 metres.

**HE'S ABEL** (J. Toeroek) - shortly after the start shifted in to obtain cover.

**BURNING HARD** (K. Bishop) - slow into stride. In the vicinity of the 600 metres dipped for no apparent reason.

**RACE 3: FESTIVAL HIRE RATING 0-56 HANDICAP - 1390 metres**

**OLIVER'S TALE** (M. Collett) - held up for a short distance shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**RELAXED** (S. Fawke) - over raced in the early and middle stages of the event. Hung out rounding the home turn. Hung in under pressure in the straight.

**SWING IT SISTER** (E. Annels) - raced keenly in the middle stages of the event.

**LOVES EDGE** (T. Voorham) - slow to begin approximately three lengths. Trainer Mr S. Drewitt was advised a warning had been placed on the mare in relation to its barrier manners.

**ROSIE LOUISE** (D. Caboche) - shortly after the start restrained in an attempt to gain cover.

**AIR MAIL** (J. Chau) - laid out under pressure in the straight.

**STURT'S PRIDE** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 4: RIVIERA MARINE BENCHMARK 62 HANDICAP 1390 metres**

**HIGH MIST** (T. Pannell) - shortly after the start shifted in to obtain cover. Inclined to lay out under pressure in the straight.

**JAAMINT** (J. Potter) - at the entrance to the straight was obliged to alter course to the inside of ANGEL'S WISH, which shifted out when tightened onto SERIOUS MOONLIGHT.

**WHAT A SHOCK (NZ)** (A. Tomita) - in the vicinity of the 1000 metres was awkwardly placed and was obliged to be restrained when racing between SASSY MANEUVER, which rolled in slightly and ANGEL'S WISH, which rolled out slightly.

**SASSY MANEUVER** (S. Logan) - in the vicinity of the 1000 metres rolled in slightly. A post-race veterinary examination revealed no visible abnormalities.

**ANGEL'S WISH** (J. Chau) - in the vicinity of the 1000 metres rolled out slightly. At the entrance to the straight shifted out into the running of JAAMINT, which was obliged to alter course to the inside of that mare when tightened onto SERIOUS MOONLIGHT. Rider was severely reprimanded under AR131(a) and advised to take greater care in future.

**SERIOUS MOONLIGHT** (S. Fawke) - shortly after the start shifted in to obtain cover.

#### **RACE 5: LOWE AND REDDING DESIGN BENCHMARK 62 HANDICAP - 1000 metres**

**KNOTTED** (L. Neindorf) - approaching the 100 metres rolled out onto **KINGSON**, which was obliged to be eased when tightened onto **WILANDER PRINCESS**. Rider severely reprimanded under AR131(a) and advised to take greater care in future when his mounts commence to shift ground.

**KINGSON** (K. Crowther) - on jumping away shifted in and bumped with **HEAVENS FLIGHT**. Approaching the 100 metres was obliged to be eased when tightened onto **WILANDER PRINCESS** as **KNOTTED** rolled out.

**HEAVENS FLIGHT** (B. Sweeney) - jumped away awkwardly, shifted out and bumped **KINGSON**. Hung out throughout the event and proved difficult to ride the gelding out over the concluding stages. Trainer Ms S. Williams was advised a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

**NEED THE YEN** (A. Tomita) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**STAR PARFAIT** (S. Logan) - slow into stride. Raced keenly in the early and middle stages of the event. Held up for clear running from the entrance to the straight until in the vicinity of the 100 metres.

#### **RACE 6: THOMAS FOODS INTERNATIONAL FLYING HANDICAP - 1210 metres**

**TOLSTOY** (S. Logan) - held up for clear running from shortly after the entrance to the straight until in the vicinity of the 200 metres.

**ENIGMAN** (A. Tomita) - Stable Representative Mr L. Weekley advised Stewards prior to the running of the event that he would instruct the rider to attempt to be more forward in today's event with the addition of blinkers. Settled in the lead. Laid out under pressure in the early part of the straight. Rolled in approaching the finish onto **VICTOR VICTOR**, which was attempting to improve to the inside of the gelding. Rider reminded of his obligations under AR131(a) when his mounts weaken and commence to shift ground in future.

**DEBEERSONUS** (T. Pannell) - inclined to lay in under pressure in the straight.

**BELLOMO** (K. Bishop) - slow into stride.

**EXCELTARA** (G. Lo) - held up for clear running from shortly after the entrance to the straight until in the vicinity of the 200 metres.

**VICTOR VICTOR** (J. Potter) - approaching the finish was obliged to be steadied when attempting a tight run between **EXCELTARA** and **ENIGMAN**, which rolled in slightly.

#### **RACE 7: MGA INSURANCE BROKERS 2020 PORT LINCOLN CUP - 1960 metres**

**DEXTER YOU DEVIL** (S. Cahill) - rider pleaded guilty to a charge under AR131(c) in that he made a celebratory gesture prior to the winning post and was fined \$200.

**BRAMFIELD** (L. Neindorf) - shortly after the start shifted in to obtain cover.

**CLASSIC WEIWEI** (T. Pannell) - rounding the home turn, shifted in abruptly onto **I'M BULLETPROOF**, which was weakening and became very awkward in its action when being steadied.

**RACE 7: MGA INSURANCE BROKERS 2020 PORT LINCOLN CUP - 1960 metres (Cont'd)**

**GREYCLIFFE (NZ)** (D. Caboche) - in the vicinity of the 1300 metres was obliged to be eased and dipped when being restrained as the pace eased slightly. Approaching the 600 metres was obliged to be restrained and dipped when awkwardly placed on the heels of DANCE OF HEROES (GB). Held up for clear running rounding the home turn for a short distance.

**DON'T DISMISS** (S. Fawke) - held up for clear running from inside the 400 metres until approaching the 200 metres.

**BEACH GOD** (A. Tomita) - inside the 1300 metres became awkwardly placed on the heels of GREYCLIFFE (NZ), which was being restrained when the pace eased slightly.

**I'M BULLETPROOF** (J. Potter) - rounding the home turn, when weakening, became awkward in its action when being steadied as CLASSIC WEIWEI shifted abruptly prior to being corrected. A post-race veterinary examination revealed no visible abnormalities.

**DESERT MINTY** (M. Collett) - raced wide without cover from in the vicinity of the 1200 metres for the remainder of the event.

**RACE 8: COMPLETE BUSINESS & ACCOUNTING SERVICES BENCHMARK 62 HANDICAP - 1750 metres**

The start of this event was delayed approximately eight minutes owing to LOVE 'N' PEACE.

**GALAXY FALLS** (L. Neindorf) - approaching the 1300 metres, when being restrained from the heels of LEONARDA, rolled out slightly onto HARDASHIAN.

**LOVE 'N' PEACE** (T. Pannell) - required to be reshod on arrival at the barrier as it had lost its near fore plate. Underwent a pre-race veterinary examination and passed fit to race. In the vicinity of the 1300 metres rolled in as the pace was eased onto HARDASHIAN, which clipped the heels of that gelding.

**HARDINGTON (GB)** (T. Voorham) - jumped away awkwardly and was slow to begin.

**EYE THE WORLD** (C. Lions) - raced wide without cover from in the vicinity of the 1200 metres and in the vicinity of the 1000 metres improved its position to settle outside the leader.

**LEONARDA** (J. Toeroek) - reared on jumping away. Approaching the 1300 metres was obliged to be eased and became awkwardly placed on the heels of QUEEN'S PALACE for a number of strides as the pace was slackened.

**WITCH KID** (G. Lo) - inside the 400 metres shifted out when insufficiently clear of URBAN ARMOUR (NZ), which was obliged to be steadied when tightened onto LOVE 'N' PEACE. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 9 March and to conclude at midnight on Sunday, 15 March 2020: a period of three meetings.

**QUEEN'S PALACE** (J. Chau) - approaching the 1300 metres rider appeared to slacken the pace of the race. Stewards questioned the rider in relation to the pace of the event, with particular reference to the slackening of the pace in the vicinity of the 1300 metres. After considering the evidence of J. Chau and J. Toeroek (LEONARDA), J. Chau was severely reprimanded under AR131(d) in that he reduced the pace of the race.

**HARDASHIAN** (J. Potter) - in the vicinity of the 1300 metres clipped the heels of LOVE 'N' PEACE, which rolled in as the pace was eased and GALAXY FALLS, which rolled out slightly.

**RACE 8: COMPLETE BUSINESS & ACCOUNTING SERVICES BENCHMARK 62 HANDICAP**  
**- 1750 metres (Cont'd)**

**URBAN ARMOUR (NZ)** (D. Caboche) - shortly after the start was inconvenienced and lost its position when tightened onto **HARDASHIAN** as **LOVE 'N' PEACE** rolled out. Inside the 400 metres was obliged to be steadied when tightened onto **LOVE 'N' PEACE** as **WITCH KID** shifted out when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**RACE 9: MCDONALD'S AND PLRC 10 YEARS OF PARTNERSHIP BENCHMARK 58 HANDICAP**  
**- 1210 Metres**

The start of this event was delayed approximately four minutes.

**SOCIAL MEDIA** (M. Collett) - jumped away awkwardly. At the entrance to the straight bumped with **JUSTICA**, which rolled in. Rider reported the mare raced flat in today's event. A post-race veterinary examination revealed no visible abnormalities.

**SCENIC MINT** (D. Caboche) - taken in on jumping away by **WEDGEBROOK** and bumped **TAJAVEDO**.

**WEDGEBROOK** (B. Sweeney) - the cross-over nose band and tongue tie were readjusted on arrival at the barriers. Shortly after the start, the saddle slipped to the off side and as a result the gelding shifted in onto **SCENIC MINT**, which was taken in. From thereafter, rider had difficulty in controlling the gelding due to the positioning of his saddle. In the vicinity of the 800 metres shifted in abruptly onto **MR TRUMAN**, which was obliged to be checked and lost its position. Rider attempted to rebalance his saddle and was successful to a degree from in the vicinity of the 500 metres, and from that point on, he elected not to ride gelding out in his normal manner as the gelding had tailed off. A post-race veterinary examination revealed no visible abnormalities.

**TAJAVEDO** (T. Pannell) - shortly after the start bumped with **SCENIC MINT**, which was taken in and as a result lost its position. Hung in under pressure in the straight.

**JUSTICA** (J. Toeroek) - at the entrance to the straight rolled in and bumped **SOCIAL MEDIA**. A post-race veterinary examination revealed no visible abnormalities.

**MR TRUMAN** (S. Logan) - in the vicinity of the 800 metres was obliged to be checked and lost its position as **WEDGEBROOK** shifted in abruptly.

**AVORA SUN** (C. Lions) - near the 400 metres bumped with **BOTTLE AND BIRD**, which shifted out.

**TUNGKETTA** (L. Neindorf) - obliged to be resaddled at the start.

**BOTTLE AND BIRD** (A. Tomita) - near the 1200 metres rolled out and bumped **AVORA SUN**.
