

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Wednesday, 18 March 2020

RACE 1: SPECSAVERS GAWLER / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 Metres

ARCTIC FLORA (T. Voorham) - raced keenly in the early stages while being restrained.

BEACHLANE (K. Bishop) - kicked by another runner on arrival at the barriers. Underwent a prerace veterinary examination which ruled the mare unfit to race. Acting on this advice Stewards withdrew BEACHLANE at 1.28 pm.

JUSTA JILLAROO (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

SUGAR WITH THAT (S. Fawke) - raced keenly in the early and middle stages of the event while being restrained. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DUCK DIVE (E. Finnegan) - laid out rounding the home turn. Rider reported the filly raced greenly.

RACE 2: GBJC LIFE MEMBERS CUP / SABOIS PLUS MAIDEN/CLASS ONE PLATE - 2100 Metres

ELCANO (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

COOL DESERT (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

PAY THE MAN (J. Holder) - rider reported the mare made excessive respiratory noise on pulling up. Inclined to lay out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.

SENTRY GATE (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

GOLDIE GURU (K. Crowther) - inclined to lay in under pressure in the straight.

RACE 3: HOLDFAST INSURANCE BROKERS / SABOIS MAIDEN PLATE - 1500 Metres

AZZUREOUS (P. Gatt) - jumped away awkwardly. In the vicinity of the 500 metres became awkward in its action for a stride for no apparent reason. Obliged to alter course inside the 200 metres when EXALTED BEAST shifted out.

CLUB DOUBLE (K. Crowther) - a post-race veterinary examination revealed minor lacerations to the off fore pastern.

COCO PUNCH (A. Tomita) - jumped away awkwardly.

EXALTED BEAST (C. Jones) - raced wide without cover throughout the event. Laid out under pressure in the straight and inside the 200 metres shifted out into the running line of AZZUREOUS. Rider reminded of her obligations.

KRUPTONITE (S. Fawke) - raced keenly in the early stages of the event. Laid out under pressure in the straight.

RACE 4: TERRACE FUNCTION CENTRE / SABOIS MAIDEN HANDICAP - 1100 Metres

The start of this event was delayed approximately two minutes.

APPLIED (D. Tourneur) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

JIMMY WITHA DASH (T. Pannell) - laid in under pressure in the straight.

SPECIAL BOOM (J. Toeroek) - jumped away awkwardly.

GUCCI GUY (J. Chau) - laid out under pressure in the straight.

TIME FLIES BY (J. Holder) - hung out rounding the home turn.

BARZILAI (E.Finnegan) - required to have its bridle refitted on exiting the mounting yard and contacted a perimeter fence on a number of occasions. Underwent a pre-race veterinary examination at the barriers and passed fit to race.

HUSSY CAT (K. Bishop) - raced wide without cover throughout the event.

RACE 5: COOPERS RATING 0-58 HANDICAP - 1500 Metres

MAXSAMIA (J. Potter) - a post-race veterinary examination revealed lacerations to the off hind hoof. First aid administered.

DIAMOND TYCOON (J. Holder) - laid out under pressure in the straight.

BUJOLASS (T. Voorham) - rider explained she was given no firm instructions on the mare however, after jumping away she elected to roll forward rather than be caught wide and took up a forward position. Mr M. Smith representing Trainer Ms K. Mooney confirmed that no firm instructions were provided to T. Voorham and that the Stable had not expected the mare to settle forward.

RACE 6: 2020 BAROSSA CUP - EASTER MONDAY CLASS ONE HANDICAP - 1200 Metres

REGINA DEL DRAMMA (P. Gatt) - rider reported the mare felt uncomfortable in its action over the concluding 200 metres. A post-race veterinary examination revealed minor speedy cuts to near hind pastern.

RACE 6: 2020 BAROSSA CUP - EASTER MONDAY CLASS ONE HANDICAP 1200 Metres (Cont'd)

WITH PLEASURE (A. Jordsjo) - in the vicinity of the 1100 metres rider eased the pace resulting in AUGUSTA ROCK improving onto its heels. Rider was reminded of her obligation in relation to easing the pace in accordance with AR131(d).

CALYPSO STORM (D. Tourneur) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

AUGUSTA ROCK (K. Crowther) - raced fiercely in the early and middle stages of the event. In the vicinity of the 1100 metres improved onto and clipped the heels of WITH PLEASURE when that mare's rider eased the pace.

RACE 7: CORNERSTONE STUD BENCHMARK 56 HANDICAP - 1100 Metres

VALLIANO (L. Neindorf) - rider reported the gelding hung out during the event. A post-race veterinary examination revealed the gelding to be lame near foreleg. Trainer, Mr D. Tootell, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

SCARE CAMPAIGN (P. Gatt) - at the entrance to the straight shifted out in an attempt to improve and in doing so contacted LADY PAVLI CHENKO. Inclined to lay out under pressure in the straight.

LUCERNEFIELD (M. Collett) - jumped away awkwardly and shifted out onto ARCTIC BLAZE. Raced wide without cover throughout the event. Rider reported the gelding hung out over the concluding 600 metres. A post-race veterinary examination revealed no visible abnormalities.

LADY PAVLI CHENKO (J. Potter) - contacted at the entrance to the straight.

ARCTIC BLAZE (S. Fawke) - inconvenienced on jumping away when taken out onto LE DEZALEY by LUCERNEFIELD. Raced keenly in the early and middle stages of the event.

ISSARA (K. Zechner) - jumped away awkwardly.

LE DEZALEY (A. Jordsjo) - hampered and lost its position on jumping away when ARCTIC BLAZE was taken out.
