Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 9 May 2020

RACE 1: SCHWEPPE'S HANDICAP - 1000 Metres
(RUN ON MORPHETTVILLE PARKS TRACK)

THE GENERAL (L. Neindorf) - laid in form inside the 700 metres.

HEARTY LASS (B. Vorster) - reared badly as the gates were released and as a consequence rider became unbalanced and was dislodged, resulting in HEARTY LASS running riderless and hampering a number of horses at various stages during the event. Rider examined by the First Care Medical Personal and ruled fit to fulfil his remaining engagements. Trainer Mr J. Hyam advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Approval to Race jump out prior to accepting for a future race.

LARKHAM (C. Jones) - contacted at the start by UTAH JOE, which shifted ground slightly. Near the 700 metres was momentarily inconvenienced by THE GENERAL (NZ), which laid in and shifted in slightly. Thereafter near the 400 metres, when racing inside the heels of THE GENERAL (NZ) was held up for a short distance and elected to shift to the outside of THE GENERAL (NZ) near the 300 metres to improve its position.

DIXON STREET (G. Cartwright) - approaching the 100 metres was hampered for several strides by the riderless horse, which shifted in and as a consequence was obliged to shift to the outside of that horse to obtain clear running.

GLORY GAME (T. Voorham) - near the 400 metres was inconvenienced and taken wider by the riderless horse, which improved to its inside.

RACE 1: SCHWEPPE'S HANDICAP - 1000 Metres (Cont'd)

UTAH JOE (K. Crowther) - contacted by LARKHAM at the start which shifted ground. Rider explained that from in the vicinity of the 600 metres until near the 400 metres she was inconvenienced as a consequence of the riderless horse improving to her inside. She stated she was conscious of this horse's position and did not attempt to improve her position until she thought it was safe to do so.

RACE 2: TAB SA SIRE'S' PRODUCE STAKES - 1400 Metres (RUN ON MORPHETTVILLE PARKS TRACK)

The start of this event was delayed approximately two minutes.

CROWN MINT (T. Pannell) - was contacted at the start. Raced wide without cover from near the 1000 metres and commenced to race keenly for a short distance inside the 1000 metres. Near the 700 metres rolled in and shifted in for a number of strides. Shifted in near the 600 metres and inconvenienced BRIBERY.

THE LAST CHARGE (J. Toeroek) - awkward to begin, shifted out and brushed ECUMENICAL, which shifted in slightly, and as a consequence shifted back out and contacted DISCREPANCY (NZ), which was hampered when tightened onto RINGBOLT. Near the 900 metres got its head up and raced a little ungenerously for a number of strides when awkwardly placed on the heels of VIOLINIST, which crossed to the rail.

INDICTMENT (E. Brown) - a post-race veterinary examination revealed no visible abnormalities.

RINGBOLT (J. Allen) - near the 600 metres momentarily rolled out into the running line of BRIBERY.

ICHIBANSAN - proved very difficult to load. A late scratching by order of Stewards at 12.08 pm on advice from the starter that the colt had refused to load. Co-Trainer Mr L. Macdonald was advised the colt would be required to load without delay in an Official Barrier Trial or Approval to Race jump out prior to accepting for a future race. Mr L. Macdonald advised the colt would now be gelded and be going for a spell before being presented for a barrier certificate.

ECUMENICAL (R. Hurdle) - near the 900 metres got its head up and raced a little ungenerously for a number of strides when awkwardly placed on the heels of THE LAST CHARGE when the place slackened and as a consequence was obliged to shift to the outside of THE LAST CHARGE into a wider position. Near the 700 metres was inconvenienced by BRIBERY, which rolled in. A post-race veterinary examination revealed a minor laceration to its off hind heel.

BRIBERY (B. Vorster) - raced keenly for some distance from inside the 1000 metres. Near the 700 metres rolled in and away from CROWN MINT, which rolled in and shifted in and as a consequence inconvenienced ECUMENICAL. Shortly thereafter was inconvenienced and had to be momentarily steadied when crossed by CROWN MINT, which shifted in near the 600 metres at the same time as RINGBOLT rolled out. A post-race veterinary examination revealed no visible abnormalities.

VIOLINIST (D. Thornton) - shifted in shortly after the start and contacted CROWN MINT.

DISCREPANCY (NZ) (Z. Spain) - tightened and hampered at the start by THE LAST CHARGE, which shifted out and as a consequence lost its position.

VONDEXTER (D. Caboche) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

SHEBRINGZIT (D. Holland) - near the 1100 metres rider adjusted his near side stirrup iron.

RACE 3: AAMI AUTUMN SERIES FINAL - 1400 Metres
(RUN ON MORPHETTVILLE PARKS TRACK)

The start of this event was delayed approximately two minutes.

AIGUILLETTE (L. Neindorf) - lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

ONE MORE JACK (J. Potter) - awkward to begin, shifted out and contacted **TERRITORY TITAN**.

AWAKE IN GRINZING (NZ) (R. Hurdle) - awkward to begin.

PERFECT COMMAND (C. Jones) - brushed at the start. On entering the straight was obliged to shift out onto **JACOBITE PRINCE** to obtain clear running.

MARINA (S. Fawke) - awkward to begin, shifted in and contacted **TERRITORY TITAN**.

TERRITORY TITAN (J. Holder) - tightened and contacted at the start between **ONE MORE JACK** and **MARINA**, which both shifted ground and shortly after being tightened shifted out and hampered **MARINA** taking that horse out onto **MR RANGER**, which was hampered losing its position. Near the 1200 metres commenced to over-race and raced ungenerously for some distance and near the 1000 metres was obliged to shift out wider when becoming awkward between runners and as a consequence raced a little wider for the remainder of the event. Near the 100 metres shifted out abruptly of its own accord and inconvenienced **SHE'S NEVER LATE**.

SHE'S NEVER LATE (K. Bishop) - near the 100 metres was momentarily inconvenienced by **TERRITORY TITAN**, which shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

SEABABE (T. Pannell) - contacted shortly after the start.

AL MA BELLE (G. Cartwright) - shifted out shortly after the start and contacted **SEABABE**.

MR RANGER (D. Thornton) - tightened shortly after the start by **MARINA**, which received pressure from its inside and as a consequence lost its position.

CANIDAE (K. Zechner) - had its tongue-tie readjusted in the mounting yard. Began very awkwardly and brushed with **PERFECT COMMAND**.

RACE 4: HOLDFAST INSURANCE BROKERS HANDICAP - 1050 Metres

DOMINATION (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

HEKA EXPRESS (J. Allen) - laid in from near the 700 metres.

DASKULYA (K. Bishop) - awkward to begin.

YANKEE LOU (T. Pannell) - awkward to begin. Rider explained the gelding was hesitant when racing inside other runners, did not fully stretch out in the straight and was disappointing in its finish. A post-race veterinary examination revealed no visible abnormalities.

GOODGEE (A. Jordsjo) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Rider reported the mare never really travelled in the early part of the event and on straightening, when a run presented to the inside of **ALMADRAVA**, she attempted to improve into that position however, the mare was reluctant and beaten to the run and as a consequence she was obliged to shift out to improve to the outside of runners from near the 200 metres. She added that in her opinion, the mare may be better suited to racing over more ground.

MIHANY (E. Finnegan) - raced wide without cover throughout the event.

RACE 4: HOLDFAST INSURANCE BROKERS HANDICAP - 1050 Metres (Cont'd)

ALMADRAVA (K. Crowther) - rider explained the filly travelled well however, when placed under pressure in the straight was disappointing. A post-race veterinary examination revealed no visible abnormalities.

RUSHWA (D. Thornton) - inclined to lay in, in the straight. Lost its off fore plate during the event.

RACE 5: ADELAIDE GALVANISING PROVINCIAL SUPER SERIES FINAL - 1800 Metres

MANZALA (J. Allen) - held up for a short distance near the 400 metres.

ADATTO (NZ) (E. Brown) - a post-race veterinary examination revealed no visible abnormalities.

HASTA LA FIORENTE (T. Voorham) - shifted in at the start and contacted A KNIGHT IN PARIS. Inclined to lay in, in the straight.

BAJAN (K. Crowther) - slow to begin.

SENTRY GATE (D. Tourneur) - slow to begin.

A KNIGHT IN PARIS (T. Pannell) - contacted at the start. Laid out in the straight.

FIGHT FOR FREEDOM (G. Cartwright) - laid out throughout during the event.

SUPERVELOCE (NZ) (C. Lions) - raced wide without cover throughout the event.

HAPPY ATOM (L. Neindorf) - slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6: ADELAIDE GALVANISING ADELAIDE GUINEAS - 1600 Metres

YOURDEEL (NZ) (T. Pannell) - near the 1000 metres when being restrained as the pace slackened, shifted in, brushed the running rail and over-raced for a short distance as a consequence. A post-race veterinary examination revealed no visible abnormalities.

GAME KEEPER (J. Allen) - began awkwardly.

HYPERCANE (C. Jones) - inconvenienced shortly after the start. Inside the 1200 metres became awkwardly placed on the heels of runners for several strides as the pace slackened.

CASHIN' CHEX (NZ) (J. Potter) - approaching the 1100 metres became awkward on the heels of YOURDEEL (NZ) for a short distance as the pace slackened. Near the 100 metres was obliged to shift in to gain clear running when improving onto the heels of JOURNICA.

KOOWEERUP (E. Brown) - rider explained the filly did not travel during the event, was disappointing in its performance and may be better suited racing over shorter distances. A post-race veterinary examination revealed no visible abnormalities.

EXCELIDA (D. Holland) - Trainer Mr M. Seyers acting on behalf of Mr D. Hayes & Mr T. Dabernig advised Stewards prior to the event of a change in tactics that being that they would instruct their rider to attempt to be ridden more forward and sit outside the lead. Rider was taken out at the start. Near the 1300 metres shifted in, crossed the running of BALAABEL, which shifted in slightly onto KOOWEERUP, which shifted in and away into the running line of NIGHT PASSAGE, which was over-racing at the time, resulting in that horse being inconvenienced. In complying with his instructions and having regard for the early pace, rider was obliged to cross and lead in its own right for a short distance. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: ADELAIDE GALVANISING ADELAIDE GUINEAS - 1600 Metres (Cont'd)

DONE BY ME (D. Thornton) - approaching the 200 metres was taken in by REALLY DISCREET, which laid in and shifted in and as a consequence became momentarily awkward outside the heels of QUANTUM MECHANIC, which rolled out.

BALAAABEL (J. Toeroek) - Co-Trainer Mr T. McEvoy advised Stewards prior to the event of a change of tactics that being that he would instruct his rider to be more positive early.

REALLY DISCREET (K. Crowther) - shifted out and away from GAME KEEPER at the start as that horse began awkwardly taking EXCELIDA out onto HYPERCANE, which was inconvenienced. Laid in, in the straight. Approaching the 200 metres laid in and shifted in taking DONE BY ME in.

NIGHT PASSAGE (B. Vorster) - lost its off hind plate during the event. Slow to begin. Near the 1300 metres was inconvenienced for several strides as the pace slackened.

RACE 7: CELEBRATION OF KANGAROO ISLAND #BOOKTHEMOUT HANDICAP - 1200 Metres

TERBIUM (K. Crowther) - near the 150 metres became momentarily held up for clear running.

VICTORY DOWNS (J. Allen) - which had not raced since December 2018 underwent a pre-race veterinary examination and was passed fit to race. Rolled out slightly near the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

BEAUTIFUL FLYER (J. Potter) - shifted in near the 100 metres and tightened ARKHAM KNIGHT, which was obliged to be restrained and alter course to the outside of BEAUTIFUL FLYER'S heels and as a consequence hampered DEBT COLLECTOR. Rider was severely reprimanded and advised to take greater care when shifting ground in future. Rider explained that he had no specific instructions however, was conscious of the previous instructions provided by the managing owner and that coupled with the favourable barrier and the pace in the race as assessed by him, resulted in him encouraging the mare to obtain a more favourable position in running in the early stages.

EASY BEAST (NZ) (D. Caboche) - shortly after the start shifted out for a number of strides and as a consequence MISS JANE shifted out and away from EASY BEAST (NZ).

VIEIRA (C. Jones) - near the 800 metres became awkwardly placed on the heels of MISS MANDITO (NZ) as that horse was hampered. Near the 200 metres was contacted by MAGNA BELLA, which shifted out in an attempt to improve.

ARKHAM KNIGHT (S. Logan) - near the 100 metres was tightened by BEAUTIFUL FLYER, which shifted in, as a consequence had to be restrained and altered course to the outside of that horse's heels and in doing so, hampered DEBT COLLECTOR, which had to be restrained.

BEAUTY (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

BENZ (S. Cahill) - from near the entrance to the straight, when improving into a run between MISS MANDITO (NZ) and VICTORY DOWNS, became held up for clear running as VICTORY DOWNS rolled out and was unable to gain clear ground until near the 200 metres. Thereafter near the 100 metres was hampered by MAGNA BELLA, which shifted in and as a consequence was unable to improve its position for several strides.

DEBT COLLECTOR (L. Neindorf) - near the 200 metres was momentarily tightened between FLOP, which maintained its line and TERBIUM, which shifted out to improve and as a consequence was obliged to alter course to the inside of TERBIUM to improve its position. However, thereafter inside the 100 metres was hampered by ARKHAM KNIGHT, which was obliged to shift out after being crossed by BEAUTIFUL FLYER, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: CELEBRATION OF KANGAROO ISLAND #BOOKTHEMOUT HANDICAP
- 1200 Metres (Cont'd)

TEQUILA TIME (J. Holder) - near the 800 metres shifted out abruptly of its own accord when being restrained and hampered MISS MANDITO (NZ) for several strides. As a consequence VIEIRA, which was following became awkwardly placed on the heels of MISS MANDITO (NZ).

MAGNA BELLA (D. Tourneur) - near the 200 metres when attempting to improve, shifted out and contacted VIEIRA, which maintained its line. Over the concluding stages shifted in under riding and hampered BENZ near the winning post. Near the finish shifted in and hampered FLOP. Rider was reprimanded and advised to take greater care when his mounts commence to shift ground.

MISS MANDITO (NZ) (Z. Spain) - raced wide without cover in the early and middle stages of the event. Over-raced near the 800 metres and was hampered when taken wider by TEQUILA TIME, which shifted out when being restrained.

FLOP (J. Toeroek) - had difficulty obtaining clear running from near the 200 metres until inside the 100 metres. Near the finish was tightened by MAGNA BELLA, which shifted in under riding and as a consequence had to be steadied.

MISS JANE (T. Voorham) - shifted out and away from EASY BEAST (NZ) shortly after the start.

RACE 8: TAB SOUTH AUSTRALIAN DERBY - 2500 Metres

The start of this event was delayed approximately three minutes.

DALASAN (J. Holder) - laid in, in the straight. Shifted in abruptly inside the 200 metres.

RUSSIAN CAMELOT (IRE) (J. Allen) - approaching the 2000 metres was momentarily inconvenienced by EXALTED AMBITION to its inside which shifted out as a consequence of ROCK STEADY (NZ), which became awkward inside that horse, shifting out when being checked. In the vicinity of the 2000 metres shifted in to obtain a closer position to the field and in doing so made solid contact with EXLATED AMBTION unbalancing that horse resulting in EXALTED AMBITION being hampered for a number of strides. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 16 May and to conclude at midnight on Wednesday, 27 May 2020: a period of five meetings. Laid in, in the straight.

RISING ARCHIE (E. Brown) - a post-race veterinary examination revealed no visible abnormalities.

ROCK STEADY (NZ) (D. Caboche) - awkward and slow to begin. Approaching the 2000 metres when improving its position became awkward on the heels of ZAYYDANI (NZ) and when being checked shifted out onto EXALTED AMBITION, which was inconvenienced when taken out onto RUSSIAN CAMELOT (IRE), which was inconvenienced as a consequence when taken wider.

EXALTED AMBITION (R. Hurdle) - approaching the 2000 metres was inconvenienced by ROCK STEADY (NZ), which shifted out after being checked. In the vicinity of the 2000 metres received heavy contact from RUSSIAN CAMELOT (IRE) to its outside as that horse shifted in to take a closer position to the field was hampered and became unbalanced for a number of strides.

SOWPODS (S. Cahill) - laid in, in the straight.

ZAYYDANI (NZ) (D. Tourneur) - after being loaded into its barrier stall, became fractious reared and was removed. Underwent a pre-race veterinary examination and was passed fit to race. Slow to begin. When attempting to improve its position near the 600 metres, became awkward on the heels of DALASAN and was unable to improve its position for a number of strides.

RACE 9: ROBERT & FAY GERARD SA SPRINT SERIES FINAL - 1100 Metres

MUM'S MY HERO (T. Voorham) - held up for clear running from near the entrance to the straight until inside the 300 metres and thereafter inside the 200 metres was obliged to alter course to the outside of APPALACHIAN to obtain clear running.

ASCENDANCE (C. Jones) - raced wide without cover throughout the event.

BAYOU (L. Neindorf) - held up for a number of strides at the entrance to the straight. Approaching the 100 metres was obliged to alter course to the inside of EXALTED GOLD to obtain clear running.

SEEMINGLY DISCREET (J. Holder) - laid in, in the straight.

LAKHANI ROSE (K. Crowther) - approaching the 100 metres commenced to lay in and shifted in abruptly onto APPALACHIAN, which was tightened and taken in onto RIZSKI, which was hampered.

ATEN (B. Vorster) - contacted shortly after the start had its hindquarters turned as a consequence.

APPALACHIAN (Z. Spain) - raced keenly in the early stages of the event.

BRAY STREET BOSS (D. Holland) - taken out shortly after the start by SPACE EQUITY as that horse received pressure from its inside. Over-raced early.

WOULDA THOUGHT SO (D. Thornton) - slow to begin.

JUSTA JILLAROO (D. Tourneur) - knuckled severely on jumping away shifted out as a consequence and tightened SPACE EQUITY onto BRAY STREET BOSS, which was taken out onto ATEN resulting in that horse's hindquarters being contacted and turned.

SPACE EQUITY (S. Fawke) - inconvenienced when taken out shortly after the start by JUSTA JILLAROO.

RIZSKI (A. Jordsjo) - over-raced in the early stages for a short distance near the 700 metres when racing outside the heels of JUSTA JILLAROO as that horse rolled out. Near the 300 metres was held up for clear running for a short distance. Approaching the 100 metres was hampered when taken in by APPALACHIAN as that horse received pressure from its outside.
