Report on Race Meeting held at Balaklava Racecourse

**RACE 1: AGFERT / SABOIS+ MAIDEN / CLASS ONE PLATE - 2200 Metres**

**WHYS** (S. Fawke) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

**STAR QUEST** (P. Gatt) - laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: BTR EXCAVATIONS / SABOIS TWO & THREE YEAR-OLD CLASS ONE PLATE - 1400 Metres**

**AUSSIE SOJOURN** (P. Gatt) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**JUST TREVA** (R. Hurdle) - hung out severely from the vicinity of the 1000 metres. Rider explained that after the pace slackened in the vicinity of the 1000 metres, the gelding commenced to hang out severely and at the entrance to the straight, took itself to the outside fence of its own accord. He added the gelding was reluctant to come off the fence in the straight and for that reason he had not ridden out in his normal manner. Trainer Mr G Searle was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**MR WOLF** (B. Vorster) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres was momentarily inconvenienced when JUST TREVA hung out. In the vicinity of the 200 metres was inconvenienced when contacted on a number of occasions by GOLDEN RIPPLES.

**RACE 2: BTR EXCAVATIONS / SABOIS TWO & THREE YEAR-OLD CLASS ONE PLATE**  
**- 1400 Metres (Cont'd)**

**GOLDEN RIPPLES** (D. Caboche) - approaching the 200 metres shifted in and away from THE KRONE contacting MR WOLF on a number of occasions.

**THE KRONE** (J. Holder) - Trainer Mr T. McEvoy advised Stewards prior to the event of a change in tactics that being that he would instruct the rider to attempt to settle further back in this event if possible. Settled behind mid-field. Inclined to lay in under pressure in the straight. In the vicinity of the 200 metres shifted in towards GOLDEN RIPPLES.

**GRACIEBIRD** (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**GREY VITALITY** (T. Voorham) - raced keenly in the early and middle stages of the event.

**RACE 3: COOPERS / SABOIS TWO YEAR OLD & UP MAIDEN PLATE - 1600 Metres**

**JAY PEE BEE (NZ)** (K. Zechner) - rider reported the horse was uncomfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**KEN'S THUNDER** (J. Holder) - jumped away awkwardly. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**KUNANYI** (R. Hurdle) - raced wide without cover throughout the event.

**MANILOW** (T. Pannell) - raced keenly in the early and middle stages of the event.

**DISSOLVABLE** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**FOLLOW THE PROMPTS** (B. Vorster) - in the vicinity of the 250 metres had to steady momentarily when tightened onto MANILOW by SHOPSTER, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

**PACIFIC RIM** (J. Toeroek) - rider reported the colt hung in throughout the event.

**SHOPSTER** (J. Maund) - laid out under pressure in the straight. In the vicinity of the 250 metres shifted out onto FOLLOW THE PROMPTS. Rider was severely reprimanded and advised in future to make a greater effort to keep his mounts straight when they commence to shift ground.

**RACE 4: TAYLORS WINES / SABOIS TWO-YEAR-OLD & UP MAIDEN PLATE - 1200 Metres**

**CALL ME DEXTER** (S. Fawke) - slow to begin. Raced keenly in the early and middle stages of the event. In the vicinity of the 800 metres improved onto the heels of PARTY MAID, which lost ground and as a result shifted out abruptly onto ULTIMATE ADDICTION.

**LIONEL JOHN** (T. Pannell) - slow to begin. Rider explained it was his intention to settle further forward in today's event however, after being slow from a wide barrier, he was of the opinion he would be caught wide without cover throughout the event and for this reason elected to restrain and obtain cover.

**MONRAAJ** (D. Tourneur) - slow to begin. Inconvenienced inside the 400 metres when contacted and taken wider by PARTY MAID.

**PERUVIAN EXPRESS** (D. Caboche) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SUGAR WITH THAT** (J. Holder) - raced wide without cover throughout the event. Inconvenienced in the vicinity of the 400 metres when taken wider by MONRAAJ.

**RACE 4: TAYLORS WINES / SABOIS TWO-YEAR-OLD & UP MAIDEN PLATE**  
**- 1200 Metres (Cont'd)**

**PARTY MAID** (J. Toeroek) - dipped for no apparent reason approaching the 800 metres and lost ground. Inside the 400 metres shifted out in and attempt to improve and in doing so contacted **MONRAAJ**, which was inconvenienced when taken out onto **SUGAR WITH THAT**.

**ULTIMATE ADDICTION** (A. Jordsjo) - raced keenly in the early and middle stages of the event. Inconvenienced when forced to race in restricted room in the vicinity of the 800 metres when **CALL ME DEXTER** shifted out.

**JOMMADOSH** (A. Lindsay) - slow to begin. Attempted to buck for a short distance after the start and lost ground. Trainer Mr J. Coe was advised that a warning had been placed on the mare.

E. Finnegan was examined by the First Care Medical Personnel following the running of this race who advised that she would be unable to fulfil her remaining engagements.

**RACE 5: MY BUTCHER BENCHMARK 54 HANDICAP - 1600 Metres**

**ELEVENBEE (NZ)** (D. Caboche) - laid out under pressure in the straight.

**NORDIC PRIDE** (M. Collett) - inconvenienced on jumping away when tightened onto **ORLEANS** by **MINNAMOSA**. A post-race veterinary examination revealed no visible abnormalities.

**JAYEFFKAY** (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

**MINNAMOSA (NZ)** (E. Boyd) - shifted out on jumping away onto **NORDIC PRIDE**. Rider reported the mare laid out over the concluding 800 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

**QUICK BISCUIT** (A. Lindsay) - raced wide without cover throughout the event.

**RACE 6: HEINIGER RATING 0-58 HANDICAP - 1400 Metres**

**AURMAN ZOU** (M. Collett) - raced keenly in the early and middle stages of the event. Stewards questioned the rider in relation to her riding of the gelding over the concluding stages. After considering her explanation, she was reminded of her obligations in riding her mounts to the end of the race in accordance with AR131(b).

**AUSSIE JACK** (P. Gatt) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 100 metres. Inclined to lay out under pressure in the straight.

**HAHNDORF** (c. Jones) - a post-race veterinary examination revealed no visible abnormalities.

**WOULDA THOUGHT SO** (J. Holder) - jumped away awkwardly. Raced fiercely in the early and middle stages of the event.

**BIRD OF WAR** (K. Crowther) - raced wide without cover throughout the event.

**PIERRO'S PROMISE** (D. Tourneur) - jumped away awkwardly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

**DAREBEN HALARO** - acting on confirmed advice from Trainer Ms D. Wilson that the gelding had become fractious in its float en route to the course and would be unfit to race, Stewards withdrew the gelding at 12.32 pm.

**RACE 7: HAULMARK TRAILERS CLASS ONE HANDICAP - 1200 Metres**

**KAYSERI (NZ)** (P. Gatt) - jumped away awkwardly.

**KAHAYLAAN** (B. Vorster) - Trainer Mr T. McEvoy advised Stewards prior to the event of a change in tactics that being he would instruct the rider to attempt to settle further back in the event if possible. Settled behind mid-field. Jumped away awkwardly and shifted out contacting HELPENY.

**AQUANAUT** (R. Hurdle) - raced wide without cover throughout the event.

**JUST JILTED** (S. Logan) - underwent a pre-race veterinary examination on arrival on course which revealed the filly had injured its off foreleg on route to the course and would be unfit to race. Acting on this advice, Stewards withdrew JUST JILTED at 12.20 pm.

**CIBACHROME** (M. Collett) - a post-race veterinary examination revealed no visible abnormalities.

**VILANELLE** (K. Bishop) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Inside the 800 metres stepped a discoloured section of the track.

**STREKOZA** (K. Crowther) - rider reported the mare felt awkward in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HELPENY** (A. Jordsjo) - slow to begin and shortly after was contacted by KAHAYLAAN.

**DEXTER'S NIBBLE** (B. Panicucci) - kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and revealed the gelding was unfit to race. Acting on this advice Stewards withdrew DEXTER'S NIBBLE at 3. 38 pm.

**VEIN CHOICE** (A. Lindsay) - struck a perimeter while exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the start and passed fit to race.

**RACE 8: MID NORTH TYRE BENCHMARK 54 HANDICAP - 1200 Metres**

**WAIKATO EXPRESS** (A. Lindsay) - raced wide without cover throughout the event.

**EXALTED TRAVELLER** (K. Crowther) - jumped away awkwardly. Shortly after the start shifted out contacting MIHANY. A post-race veterinary examination revealed no visible abnormalities.

**FOUR OF A KIND** (S. Logan) - inclined to lay in under pressure in the straight.

**SONO DOLCE** (T. Pannell) - jumped away awkwardly.

**SCARE CAMPAIGN** (D. Tourneur) - slow to begin. Raced keenly in the early and middle stages of the event.

**WONDER IF (NZ)** (P. Gatt) - raced keenly in the early and middle stages of the event.

**KEYSOR** (T. Voorham) - raced wide without cover throughout the event. Rider accidentally dropped her whip in the vicinity of the 350 metres.

**ICECRUSHER** (R. Hurdle) - contacted on jumping away. Lost its position approaching the 1100 metres when tightened between SIR JOHNSON, which shifted in slightly at the same time as MIHANY was taken out by EXALTED TRAVELLER.

**KEPTA** (D. Tootell) - shifted in on jumping away and contacted ICECRUSHER.

**HILUMIERE** (K. Bishop) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**MIHANY** (J. Maund) - shifted in on jumping away contacting EXALTED TRAVELLER.

**BUSKERS BALLAD** (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$500.
