

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 18 July 2020

RACE 1: TERRY HOWE PRINTING HANDICAP - 1550 Metres

SENSITIVITY (T. Pannell) - rider explained the filly had good rhythm in the early part of the event however, when placed under pressure, did not respond and quicken in the manner he expected and failed to improve its position from near the 450 metres. A post-race veterinary examination revealed no visible abnormalities.

TUBBY TWO TRACKS (D. Caboche) - had to be re-saddled on arrival at the barriers. Raced keenly in the early stages of the event.

TUMANAKO (NZ) (K. Crowther) - raced keenly in the early stages of the event.

HONORABLE SPIRIT (D. Tourneur) - raced keenly in the early stages of the event.

RACE 2: HOLDFAST INSURANCE HANDICAP - 1400 Metres

ZALMONA (T. Voorham) - awkward to begin.

WINNING PARTNER (B. Vorster) - Stewards granted permission for a gear change in respect of this gelding, after acceptance time. The gear change being the removal of blinkers and the addition of winkers. Co-Trainer Mr C. McEvoy pleaded guilty to a charge under AR206(2) for failing to obtain Stewards permission for a gear change prior to acceptance time and was fined \$200. Co-Trainer Mr T. McEvoy advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to attempt to obtain a more forward position in running. Raced keenly in the early stages of the event.

GIGGLON (P. Gatt) - inclined to lay in, in the straight.

DEFIANT DANCER (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

FLOP (J. Holder) - inclined to lay out rounding the home turn.

SILVERHAWK (J. Eaton) - laid out in the straight. Rider reported the gelding chocked down in running in the vicinity of the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: HOLDFAST INSURANCE HANDICAP - 1400 Metres (Cont'd)

MABEL JOSEPHINE (J. Potter) - underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TAB HANDICAP - 1550 Metres

TERRITORY TITAN (K. Crowther) - raced keenly in the early and middle stages of the event.

ROGUES POINT (B. Vorster) - awkward to begin. Raced keenly in the early stages of the event.

THE SIDEKICK (NZ) (T. Pannell) - awkward to begin.

MARINA (S. Fawke) - raced keenly in the early stages of the event.

WITH PLEASURE (A. Jordsjo) - contacted at the start. Rider reported the mare laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

DON'T DISMISS (R. Hurdle) - awkward to begin, shifted out and contacted WITH PLEASURE.

RACE 4: ADELAIDE GALVANISING HANDICAP - 1950 Metres

ROSELLI STING (D. Caboche) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

BIANCO NUOVO (T. Pannell) - raced keenly in the early stages of the event. Near the 1600 metres was obliged to be steadied for several strides when crossed by MANZALA as that horse shifted in to obtain a position closer to the running rail. Thereafter BIANCO NUOVO over-raced for a short distance.

BUSKER'S BALLAD (D. Tourneur) - held up for clear running from rounding the home turn until inside the 300 metres.

PLAY ME NOW (NZ) (P. Gatt) - after passing the crossing near the 1800 metres the gelding, which had been inclined to lay out, commenced to hang out severely and failed to negotiate the turn and shifted very wide on the track for some distance before regaining a position with the field in the vicinity of the 1500 metres. Rider explained his instructions were to lead and whilst he was able to take up a forward position in the early stages, the gelding was inclined to lay out initially and then commenced to hang out and shifted out very wide on the track after passing the crossing. Trainer Mr J. O'Connor was advised the gelding would be required to race tractably and to the Stewards satisfaction in an Official Barrier Trial or Approval to Race Jump Out prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

KORODON (NZ) (J. Toeroek) - awkward and slow to begin. A post-race veterinary examination revealed no visible abnormalities.

MANZALA (J. Eaton) - inside the 1800 metres was obliged to shift to the inside of PLAY ME NOW (NZ), which laid out and shifted out. Thereafter near the 1600 metres, shifted in to obtain a position closer to the running rail and crossed the running of BIANCO NUOVO, which was obliged to be steadied for several strides to avoid this horse's heels. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday 26 July 2020 and to expire at midnight on Sunday 2 August 2020; a period of three meetings. When considering penalty Stewards took into account J Eaton's guilty plea, her good record and the degree of careless and the consequences suffered by BIANCO NUOVO including that horses racing manners leading up to the incident.

RACE 4: ADELAIDE GALVANISING HANDICAP - 1950 Metres (Cont'd)

ELUSIVE ROSE (K. Bishop) - raced wide without cover in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: SCHWEPPE OAKLANDS PLATE - 1400 Metres

FOXGOSSIP (J. Eaton) - very awkward to begin, shifted out onto ANOTHER AWARD, which was tightened onto THE KRONE resulting in ANOTHER REWARD and THE KRONE being hampered. Approaching the 200 metres became held up for clear running when racing to the inside of MAYAMEEN and behind DIAMONDS and was unable to improve its position. Approaching the 100 metres raced in restricted room owing to DIAMONDS rolling out, and shortly thereafter when attempting to improve to the inside of DIAMONDS was again unable to improve its position, owing to DIAMONDS rolling back in. A post-race veterinary examination revealed no visible abnormalities.

SUPER STRIKER (T. Pannell) - approaching the 1000 metres was tightened for several strides by MAYAMEEN, which shifted in and thereafter, after being restrained, shifted out abruptly, raced wider on the track for some distance and did not make the turn inside the 1000 metres cleanly and raced wide without cover for some distance thereafter. Rider reported his control of the gelding was compromised near the 1000 metres, as it commenced to race extremely fiercely for some distance. He added that as a consequence, owing to the manner in which the horse raced in the early and middle stages, the gelding had run its race near the entrance to the straight, failed to respond to his riding and compounded quickly and as a consequence he did not persist with his riding in his normal manner for the remainder of the straight. A post-race veterinary examination revealed atrial fibrillation. Co-Trainer Mr L. Macdonald was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

THE KRONE (P. Gatt) - proved difficult to load. Trainer Mr T. McEvoy was advised that a warning had been placed on the gelding in relation to its loading manners. Hampered at the start.

KAHAYLAAN (B. Vorster) - over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

THE BRUMBY (R. Hurdle) - awkward to begin.

MAYAMEEN (K. Zechner) - approaching the 1000 metres shifted in and tightened SUPER STRIKER for several strides before relieving the pressure and shifting out to allow SUPER STRIKER clear galloping room. Rider was severely reprimanded and advised in future to ensure he allows runners their rightful running room.

INSTANT CELEBRITY (K. Crowther) - Mr T. Stokes acting on behalf of Trainer Mr P. Stokes advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to attempt to obtain a forward position in running.

ANOTHER AWARD (J. Holder) - hampered at the start.

DIAMONDS (D. Tourneur) - inclined to lay out in the straight, shifted out approaching the 100 metres and tightened FOXGOSSIP onto MAYAMEEN for several strides. Thereafter DIAMONDS rolled in and hampered FOXGOSSIP over the concluding stages.

RACE 6: CHAPEL HILL HANDICAP - 1250 Metres

DEXELATION (T. Voorham) - Stewards opened an inquiry into the riding of this gelding by apprentice T. Voorham, particularly with reference to her riding in the straight. After taking initial evidence from T. Voorham and this horse's Trainer, Mr R. Jolly, Stewards adjourned the inquiry to a date and time to be determined to allow T. Voorham to be assisted by Mr L. Macdonald. A post-race veterinary examination revealed no visible abnormalities.

ARKHAM KNIGHT (P. Gatt) - from inside the 200 metres, when attempting to improve between VIEIRA and THIS KID ROCKS was unable to do so, as VIEIRA rolled out tightening this horse onto THIS KID ROCKS. As a consequence, ARKHAM KNIGHT was obliged to shift in to the inside of VIEIRA to obtain clear running.

THIS KID ROCKS (B. Vorster) - raced keenly in the early stages of the event and made the turn near the 1000 metres awkwardly.

VIEIRA (J. Eaton) - awkward to begin. Approaching the 1000 metres commenced to race fiercely and got its head up on several occasions when being restrained. Inside the 200 metres rolled out and tightened ARKHAM KNIGHT for a number of strides.

RACE 7: FURPHY HANDICAP - 1000 Metres

AADELAD (J. Eaton) - shifted out at the start onto EXALTED GOLD, which was taken out onto GOODGEE, which was inconvenienced when tightened onto ATOMIC WIZARD. As a consequence GOODGEE lost its position.

EXALTED GOLD (S. Logan) - taken out at the start onto GOODGEE by AADELAD, which shifted out.

GOODGEE (T. Voorham) - taken out by EXALTED GOLD at the start and was inconvenienced when tightened onto ATOMIC WIZARD and as a consequence lost its position.

ALMADRAVA (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: TAB HANDICAP - 1250 Metres

SUNMATE (J. Potter) - near the 300 metres brushed with SONO DOLCE for several strides.

KAYSERI (NZ) (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

VIVALDI'S QUEST (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

DR DEE DEE (J. Eaton) - laid out in the straight.

SONO DOLCE (T. Pannell) - raced very keenly in the early stages of the event. Near the 300 metres brushed with SUNMATE for several strides.

TEXAS LIL - proved very fractious in its barrier stall, reared and was removed. Underwent a pre-race veterinary examination and was considered unfit to race. Acting on veterinary advice Stewards declared TEXAS LIL a late scratching at 3.58 pm. Trainer Mr L. O'Connor was advised the mare would be required to prove tractable in the barriers in an Official Barrier Trial prior to accepting for a future race.

RACE 9: AAMI HANDICAP - 1400 Metres

SPLASH SOME CASH (A. Jordsjo) - raced wide without cover in the early and middle stages of the event.

BARRYMORE (K. Zechner) - raced keenly in the early stages of the event.

TABERNA (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

NO JOY (C. Jones) - raced keenly in the early stages of the event.

WURLIES LASTCHANCE (D. Caboche) - inclined to lay in, in the straight.

CARLALUISA (J. holder) - held up for clear running from near the entrance to the straight until near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

SADENTE (T. Pannell) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear running in the early part of the straight and was only able to obtain clear running inside the 200 metres.

THE ANT'S PANTS (K. Crowther) - held up for clear running from near the entrance to the straight until near the 100 metres and over the concluding stages shifted to the outside of BIG CALL, in an attempt to obtain clear running.

BIG CALL (E. Boyd) - awkward to begin. Raced keenly in the early stages of the event. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

WOULDA THOUGHT SO (B. Vorster) - very awkward and slow to begin. Held up for clear running form near the entrance to the straight until inside the 200 metres.
