Report on Race Meeting held at Gawler Racecourse
by the Gawler and Barossa Jockey Club on Friday, 23 October 2020

TRACK: Good 4 (Track with some give in it)

RAIL: Out 2 metres from 800 metres to 400 metres, true remainder.

RACE 1: G&J CIVIL - ROAD TO THE JERICHO CUP HEAT BM 75 HANDICAP - 3340 Metres

ZOURKHAN (IRE) (J. Opperman) - over-raced throughout the event. Lost its near fore plate during the event.

MATAS (J. Eaton) - slow into stride.

IRONICAL (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 1.0 kg over its declared weight of 54.0 kg. Slow into stride.

MAGUS MAN (S. Logan) - over-raced in the early and middle stages of the event. Rider accidentally dropped her whip in the vicinity of the 450 metres.

RACE 2: MATRIX SOLAR SOLUTIONS / SABOIS MAIDEN PLATE - 1100 Metres

OOLONG GAZE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

AFRICAN AWESOME (J. Holder) - hung in under pressure in the straight and near the 150 metres was inconvenienced as DISS 'N' DAT, which was inclined to lay out, rolled out. A post-race veterinary examination revealed no visible abnormalities.

ASTON RAPOVA (R. Hurdle) - jumped away awkwardly.

DISS 'N' DAT (D. Caboche) - laid out under pressure in the straight and near the 150 metres rolled out and inconvenienced AFRICAN AWESOME, which was hanging in.

MISS MOMO (P. Gatt) - raced wide without cover throughout the event.

RACE 2: MATRIX SOLAR SOLUTIONS / SABOIS MAIDEN PLATE - 1100 Metres (cont'd)

ZIPADEE (D. Tourneur) – a post-race veterinary examination revealed the mare had jarred up in both forelegs. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

EQUA (K. Zechner) – over-raced in the early and middle stages of the event. Laid out under pressure in the straight. Rider reported that the filly raced greenly throughout the event.

RACE 3: TRIMBOLI SERVICES / SABOIS MAIDEN PLATE - 1100 Metres

BURNING HARD (L. Halliday) – shortly after the start shifted out taking ZIP AKEED out.

AFTER YOU (A. Jordsjo) – jumped away awkwardly and shifted in onto KRUPTONITE. Near the 150 metres rolled out onto VONDEXTER.

CHICO FIESTRO (D. Caboche) – jumped away awkwardly. Over-raced in the early and middle stages of the event.

KRUPTONITE (P. Gatt) – on request by the rider underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Lost its position on jumping away when tightened between AFTER YOU, which shifted in, and ZIP AKEED, which was taken out. Rider reported that he was concerned with the mare's action during the event. A post-race veterinary examination revealed no visible abnormalities.

SCOTCH ON THE ROCK (E. Boyd) – hung out rounding the home turn and when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ZIP AKEED (K. Crowther) – shortly after the start was taken out by BURNING HARD onto KRUPTONITE.

BARACONI (S. Fawke) – raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. In the vicinity of the 150 metres rolled in onto VONDEXTER, which was looking to improve and became hampered when racing in restricted room to the inside of BARACONI as AFTER YOU rolled out. Near the 100 metres had its hindquarters turned out and bumped with VONDEXTER, which was looking to improve and shift out, on a number of occasions.

VONDEXTER (S. So) – jumped away awkwardly. Was held up for clear running from the entrance to the straight until near the 200 metres when racing between AFTER YOU and CHICO FIESTRO. Near the 150 metres, when looking to improve, raced in restricted room and was hampered when placed behind AFTER YOU, which rolled out, and BARACONI, which rolled in. Near the 100 metres, when looking to improve and attempting to shift out, was inconvenienced and bumped with BARACONI on a number of occasions as that fillies hindquarters were turned out.

RACE 4: GAWLER CARAVAN PARK / SABOIS MAIDEN PLATE - 1500 Metres

EAGLE'S WINGS (J. Opperman) – in the vicinity of the 1000 metres became awkwardly placed on the heels of WONGA FLYER and shifted out taking VANCOUVER VELVET wider.

TICKET TO TEXAS (D. McWhinney) – shortly after the start shifted in to obtain cover.

WONGA FLYER (L. Halliday) – inside the 100 metres was momentarily inconvenienced as DON'T BLAME DIXIE rolled out.

DON'T BLAME DIXIE (A. Jordsjo) – inclined to lay out under pressure from in the vicinity of the 200 metres and inside the 100 metres rolled out and momentarily inconvenienced WONGA FLYER.

RACE 4: GAWLER CARAVAN PARK / SABOIS MAIDEN PLATE - 1500 Metres (cont'd)

DYNAMIC BELLE (S. Fawke) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasion prior to the 100 metre and was reprimanded.

REGAL TRIUMPH (P. Gatt) – trainer, Mr S. Burford, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to settle further back in today's event in an attempt to have the gelding finish the race off. Settled at the rear.

RUPPAPUMPUM (NZ) (M. Vassallo) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasion prior to the 100 metre and was reprimanded.

VANCOUVER VELVET (J. Holder) – shortly after the start attempted to shift in to obtain cover from its wide barrier. In the vicinity of the 1000 metres was taken wider as EAGLE'S WINGS shifted out. Rider explained in relation to the gelding's performance that when placed under pressure from inside the 400 metres the gelding failed to respond to his riding and was disappointing in its effort to the finish. He added that VANCOUVER VELVET may have jarred up in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPERS BREWERY BENCHMARK 58 HANDICAP - 1700 Metres

GETOUTTHEWAY (C. Jones) – a post-race veterinary examination revealed no visible abnormalities.

RAPID RAISER (P. Gatt) – laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

DON'T DISMISS (C. Lions) – acting on advice from trainer, Mr G. Kluske, that the gelding had become injured en route to course and would be unfit to race Stewards withdrew DON'T DISMISS at 2.45 pm.

AMMO LOCO (S. Fawke) – shortly after the start shifted in to obtain cover. A post-race veterinary examination revealed no visible abnormalities.

SOSTENIDO (NZ) (J. Opperman) – held up for clear running from shortly after the entrance to the straight until approaching the 100 metres.

CITY BEATS (K. Zechner) – a post-race veterinary examination revealed no visible abnormalities.

JOCKS GLEN (J. Eaton) – slow into stride.

RACE 6: FUSE RECRUITMENT CLASS ONE HANDICAP - 1200 Metres

TULLYS GOLD (T. Pannell) – jumped away awkwardly and shifted out.

THE IRON LADY (S. Logan) – on jumping away bumped with NATURE DEEL, which shifted out.

NATURE DEEL (T. Voorham) – jumped away awkwardly, shifted out and bumped THE IRON LADY. Inclined to lay out rounding the home turn.

TOSCA ROCKS (D. Caboche) – in the vicinity of the 900 metres was awkwardly placed for a number of strides to the inside of CALYPSO STORM.

KISHSTAR (J. Holder) – on jumping away was taken out and contacted by PLAYFUL HOST. Inclined to lay out rounding the home turn.

RACE 6: FUSE RECRUITMENT CLASS ONE HANDICAP - 1200 Metres (cont'd)

CALYPSO STORM (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

PLAYFUL HOST (C. Lions) - jumped away awkwardly, shifted out and contacted KISHSTAR. Shortly after shifted in to obtain cover.

RACE 7: ADELAIDE PLAINS BLOODSTOCK EVANSTON SPRINT BM 62 HANDICAP - 1100 Metres

The start of this event was delayed approximately two minutes.

MASTERATI (S. Logan) - on jumping away bumped with GALCRUM, which shifted out. Approaching the finish rolled out and was inconvenienced when awkwardly placed on the heels of HANEDA.

WOUNDED SOLDIER (NZ) (T. Pannell) - shortly after the entrance to the straight was momentarily inconvenienced when awkwardly placed on the heels of RUSTYDUSTYSUNSHINE, which was taken out slightly.

GALCRUM (D. Caboche) - jumped away awkwardly, shifted out and bumped MASTERATI.

READY SUNSHINE (D. Tourneur) - in the vicinity of the 100 metres raced in restricted room for a stride between MASTERATI and TWO ODD SOX.

TWO ODD SOX (J. Holder) - after being loaded in its barrier and being in the adjoining stall to CRYPTO CURRENCY, which became fractious and kicked out, was examined by the Club's Veterinary Surgeon and passed fit to start. Jumped away awkwardly, shifted in and contacted THE PUBLIKIN.

CRYPTO CURRENCY (A. Jordsjo) - became fractious in its barrier after being loaded and became cast for a short time. Underwent a pre-race veterinary examination and was ruled unfit to start. Acting on this advice Stewards withdrew CRYPTO CURRENCY at 5.30 pm. Trainer, Mr M. Seyers, was advised that the gelding was now required to complete an Official Barrier Trial to the satisfaction of Stewards prior to accepting for a future race. A. Jordsjo was examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements.

TWICE FORGOTTEN (K. Zechner) - shortly after the entrance to the straight rolled out taking RUSTYDUSTYSUNSHINE out slightly.

THE PUBLIKIN (C. Lions) - underwent a pre-race veterinary examination on arrival on course and was passed fit to start. On jumping away contacted TWO ODD SOX.

ANTRIM'S SECRET (J. Eaton) - shortly after the start shifted in to obtain cover. Laid in under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer, Mr R. Campbell, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RUSTYDUSTYSUNSHINE (J. Opperman) - shortly after the entrance to the straight was taken out slightly by TWICE FORGOTTEN. Laid in under pressure over the concluding stages of the event.

RACE 8: KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1500 Metres

MAXIMUM HUSTLE (S. So) - performed poorly. Rider explained that the gelding jumped okay; however, was under hard riding from in the vicinity of the 800 metres and commenced to weaken out of the event after showing no response. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1500 Metres (cont'd)

MASTER OF ZERPRISE (R. Hurdle) – shortly after the start shifted in to obtain cover. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

HAHNDORF (J. Opperman) – jumped away awkwardly.

KEYSOR (J. Maund) – in the vicinity of the 400 metres was momentarily inconvenienced when awkwardly placed on the heels of SYLVAN CREST.

SCHERZER (C. Lions) – slow to begin.

BOOMER BEACH (T. Pannell) – raced wide without cover in the early stages of the event and near the 1100 metres was permitted to stride forward to settle outside the leader. Inclined to lay out under pressure in the straight.

SHEZA LITTLE POSH (J. Holder) – raced wide without cover throughout the event. Rider could offer no explanation in relation to the mare's performance. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Mr D. Green, Stable foreman for trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 9: 2020 HOLDFAST INSURANCE GAWLER CUP - 1500 Metres

STREET LIFE (M. Collett) – rider was questioned in relation to the tactics adopted in today's event, in particular to the gelding leading. Rider explained that her instructions were that given that the gelding was up in distance to obtain a forward position and set a good tempo during the event. She added, considering the early speed of the event was fast she felt that STREET LIFE finished the race off well. Trainer, Ms K. Byrnes, confirmed the instructions provided.

BLOW TORCH (J. Maund) – over-raced in the early and middle stages of the event. Was held up for clear running rounding the home turn. At the entrance to the straight, when looking to improve, shifted out and bumped with EXTREME THRILL on a number of occasions.

EXTREME THRILL (K. Crowther) – at the entrance to the straight bumped with BLOW TORCH on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

TUBBY TWO TRACKS (D. Caboche) – laid in under pressure in the straight.

EXALTED RUTH (S. So) – raced wide without cover throughout the event. When questioned in relation to the tactics adopted in today's event with particular reference to the mare leading trainer, Mr G. Young, advised that his instructions to S. So were to attempt to settle in the first four in running given that the mare was down in distance and there was no apparent pace in the race and the mare had drawn a wide barrier. A post-race veterinary examination revealed no visible abnormalities.

L'AMARYBELLE (J. Opperman) – shortly after the start shifted in from its wide barrier to obtain cover.
