Report on Race Meeting held at Gawler Racecourse by the Gawler and Barossa Jockey Club on Thursday, 5 November 2020

RACE 1: SANDERS FODDER / SABOIS DISTANCE MAIDEN PLATE - 2121 Metres

TICKET TO TEXAS (D. McWhinney) - on jumping away bumped with SMART VISION, which shifted out. From approaching the 1100 metres raced wide without cover for the remainder of the event.

PENONG (NZ) (P. Gatt) - jumped away awkwardly. Inclined to lay out from in the vicinity of the 800 metres for the remainder of the event.

RUPPAPUMPUM (NZ) (M. Vassallo) - jumped away awkwardly.

SMART VISION (S. Fawke) - jumped away awkwardly, shifted out and bumped TICKET TO TEXAS.

RACE 2: FABHATS / SABOIS MAIDEN PLATE - 1100 Metres

The start of this event was delayed approximately five minutes.

CARRY THE MUSKET (J. Holder) - slow to begin and shortly after shifted in, in an attempt to gain cover.

CHICO FIESTRO (D. Caboche) - inclined to lay in under pressure in the straight.

REDENZO LAD (K. Crowther) - slow to begin and shortly after shifted in, in an attempt to gain cover.



RACE 2: FABHATS / SABOIS MAIDEN PLATE - 1100 Metres (cont'd)

STRUCK BY (P. Gatt) - Shortly after exiting the mounting yard dislodged it's rider and galloped freely for a short distance before being captured by the Clerk of the Course. Underwent a prerace veterinary examination and passed fit to race. P. Gatt was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. After being loaded in its barrier, STRUCK BY became fractious and cast in its barrier stall for some time. Underwent another prerace veterinary examination and ruled unfit to race. Acting on this advice, Stewards withdrew STRUCK BY at 1.38 pm. Trainer Mr T. Doudle was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

LEANNA BELLE (J. Eaton) - Trainer P. Seater advised Stewards prior to the event in a change of tactics that being that he would advise the rider to attempt to be more forward in today's event. Settled back.

NORTHERN FACTOR (E. Boyd) - proved difficult to load. Mr M. Hickmott was advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. Hung out from rounding the home turn until the finish and proved difficult for the rider to ride out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 Metres

ALITTLEBITOFREBA (Z. White) - on jumping away bumped with GAZE GRISE, which shifted in. Inside the 1100 metres was hampered and taken in onto GLENARCH BAY by GAZE GRISE, which shifted in when insufficiently clear. Inside the 800 metres lost its position when racing in restricted room between GLENARCH BAY and GAZE GRISE, which had its hindquarters turned out and as a result shifted in.

ARCTIC FLORA (J. Holder) - on jumping away was bumped and taken in by RUBY ANGEL, which shifted in. Shortly after shifted in to obtain cover. Held up for clear running when rounding the home turn until in the vicinity of the 300 metres when racing between NANAMU and BON PEGASUS and was obliged to shift out to obtain clear running.

BON PEGASUS (T. Pannell) - jumped away awkwardly, shifted out taking WILD IMAGINATION (NZ) wider. Near the 200 metres, when looking to improve, shifted in and as a result NANAMU became tight to its inside.

GLENARCH BAY (D. Stra) - inside the 1100 metres raced in restricted room and lost its position when racing between L'IL PIPER and ALITTLEBITOFREBA, which was taken in by GAZE GRISE, which shifted in when insufficiently clear. Inclined to lay out under pressure in the straight. Approaching the finish was unable to be ridden out in its normal manner when racing tight to the inside of ALITTLEBITOFREBA. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by rider and noted that she did not use her whip over the last 100 metres.

NANAMU (A. Jordsjo) - shortly after the start was buffeted between WILD IMAGINATION (NZ), which was taken out and ARCTIC FLORA, which was taken in. Inside the 200 metres when attempting to improve into a run between ALITTLEBITOFREBA and BON PEGASUS, which rolled in marginally, was obliged to be steadied, lost its position and became awkward in its action for a number of strides thereafter.



RACE 3: KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 Metres (cont'd)

GAZE GRISE (K. Zechner) - jumped away awkwardly, shifted in and bumped ALITTLEBITOFREEBA. Inside the 1100 metres shifted in when insufficiently clear onto ALITTLEBITOFREBA, which was hampered when tightened onto GLENARCH BAY, which lost its position when tightened onto L'IL PIPER. Rider found guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 13 November 2020 and to conclude at midnight on Friday, 20 November 2020, a period of three meetings. In determining penalty Stewards took into account K. Zechner's good record in relation to this Rule. Inside the 800 metres raced in restricted room between MERVA and ALITTLEBITOFREBA for a number of strides and contacted with ALITTLEBITOFREBA as a result, had its hindquarters turned out, shifted in and as a result, ALITTLEBITOFREBA lost its position.

MERVA (B. Vorster) - rider reported the filly never travelled during the event and when asked for an effort at the top of the straight, failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

RUBY ANGEL (S. Fawke) - jumped away awkwardly, shifted in and bumped ARCTIC FLORA.

VONDEXTER (S. So) - shortly after the start shifted in to obtain cover. Lost its near hind plate during the event.

WILD IMAGINATION (NZ) (J. Toeroek) - on jumping away was taken wider by BON PEGASUS, which shifted out.

RACE 4: COOPERS BREWERY CLASS TWO HANDICAP - 1516 Metres

BOOMER BEACH (T. Pannell) - raced keenly in the early and middle stages of the event.

OUR DEEP AGENDA (K. Zechner) - shortly after the start, from its wide barrier shifted in to obtain cover.

TOSCA ROCKS (D. Caboche) - laid out from the 500 metres for the remainder of the event.

QUICK BISCUIT (Z. White) - inclined to lay out rounding the home turn and under pressure in the straight.

SCALLOP (T. Voorham) - raced wide without cover throughout the event.

RACE 5: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 58 HANDICAP - 2121 Metres

AZZUREOUS (D. Tourneur) - in the vicinity of the 500 metres rolled in slightly onto THE RED SEA. A post-race veterinary examination revealed no visible abnormalities.

THE RED SEA (C. Jones) – in the vicinity of the 500 metres was awkward for a short distance to the inside of AZZUREOUS, which rolled in slightly.

BACK POCKET (R. Hurdle) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

LINE DANCER (T. Pannell) - hung in from in the vicinity of the 1200 metres for the remainder of the event and as a result T. Pannell had difficulty riding the mare out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

HAPPY ATOM (M. Collett) - slow to begin.



RACE 5: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 58 HANDICAP - 2121 Metres (cont'd)

TUFF CAT (S. Logan) - shortly after the start shifted in to obtain cover. In the vicinity of the 500 metres became awkwardly placed for a short distance inside THE RED SEA, which was awkward and rolled in marginally.

RACE 6: HOLDFAST INSURANCE BENCHMARK 58 HANDICAP - 1100 Metres

DOCTOR DOOLITTLE (S. Cahill) - was tightened and lost its position on jumping away as TINNY BAR BLUE shifted out and JETTA JAE shifted in. Near the 200 metres was inclined to lay in and became awkwardly placed on the heels of JETTA JAE, which was inclined to lay out and shifted out, for a short distance.

MALVADO (D. Tourneur) - shifted in from its wide barrier to obtain cover.

OUR BENEVENTO (T. Pannell) - laid out under pressure in the straight.

TINNY BAR BLUE (B. Vorster) - jumped away awkwardly and shifted out onto DOCTOR DOOLITTLE. Inside the 100 metres was disappointed when attempting a tight run between OUR BENEVENTO and MY LESSON, and as a result was obliged to shift to the outside of MY LESSON, and from that point on raced in restricted room to the inside of that gelding and BRIMARVI ROOBOY. As a consequence TINNY BAR BLUE was not fully tested to the line.

JETTA JAE (K. Zechner) - jumped away awkwardly and shifted in onto DOCTOR DOOLITTLE. Near the 200 metres, when inclined to lay out, rolled out onto DOCTOR DOOLITTLE, which became awkwardly placed on the heels of that mare.

NEWBAY FLYER (NZ) (S. So) – rider reported that the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: CORNERSTONE STUD BENCHMARK 58 HANDICAP - 1100 Metres

KITTY DAMOUR (S. So) - inside the 100 metres rider dropped her whip when attempting to switch it from her right hand to her left hand.

SIDESTREET (D.Tourneur) - laid out under pressure in the straight.

CARTIER TIARA (C. Lions) - raced keenly in the early and middle stages of the event.

RUSTYDUSTYSUNSHINE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

JACKPOT JOHNNY (L. Halliday) - slow to begin.

MIHANY (M. Collett) – on request of its rider underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

SAND CAT (S. Fawke) - laid out under pressure in the straight.

RACE 8: G&J CIVIL CLASS ONE HANDICAP - 1200 Metres

QUIET CLASS (K. Zechner) - slow to begin losing approximately six to seven lengths. Trainer, Mr P. Hardacre, was advised that the gelding was now required to complete an Approval to Race Jump Out or Official Barrier Trial to the Stewards' satisfaction prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.



RACE 8: G&J CIVIL CLASS ONE HANDICAP - 1200 Metres (cont'd)

DEEVINE (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

TIME WARRIOR (R. Hurdle) – on request of its rider underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Held up for clear running from shortly after the entrance to the straight for a short distance, initially when racing between LIBERTY'S TORCH and ALL THINGS NICE, and then was obliged to shift out in an attempt to gain clear running. Approaching the 200 metres was disappointed for a tight run between ALL THINGS NICE, which rolled out slightly, and KISHSTAR.

RANGER CEE JAY (J. Maund) - underwent a pre-race veterinary examination on arrival on course and passed fit to race.

KISHSTAR (J. Holder) - jumped away awkwardly. Held up for clear running from rounding the home turn until near the 200 metres.

AUSSIE SOJOURN (D. Tourneur) - hung out from the 500 metres and when placed under pressure in the straight.

MISS HEDY (J. Eaton) - slow to begin losing approximately two to three lengths. Trainer, Mr D. Saxon, was advised that a warning had been placed on the mare in relation to the manner in which it began.

ALL THINGS NICE (E. Boyd) - approaching the 200 metres rolled out slightly.

Correct weight for this event was delayed to allow the Stewards and the Starter to view the vision of the start.
