Report on Race Meeting held at Strathalbyn Racecourse
by the Strathalbyn Racing Club on Wednesday, 18 November 2020

RACE 1: NORTHPOINT FLEURIEU / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 Metres

CHARADE (D. Tootell (Snr)) - jumped away awkwardly. Raced fiercely in the early and middle stages of the event. In the vicinity of the 1000 metres rolled in onto NANA DULCE.

PENNYWEIGHT (C. Lions) - trainer, Mr G. Lesnikowski, advised Stewards prior to the event of a change of tactics in that he would instruct the rider to attempt to settle more forward if possible. Settled outside the leader.

POLLYANNA (T. Pannell) - inclined to lay in under pressure in the straight.

HEAVY ROTATION (T. Voorham) - inclined to lay out under pressure in the straight.

LEFTRIGHTGOODNITE (P. Gatt) - raced greenly in the straight.

NANA DULCE (A. Jordsjo) - jumped away awkwardly. In the vicinity of the 1000 metres was momentarily inconvenienced when CHARADE rolled in. In the vicinity of the 600 metres had to be steadied when it improved onto the heels of CHARADE.

SEE YOU LATER NOW (D. Caboche) - jumped away awkwardly. Raced wide without cover throughout the event.

RACE 2: HYGAIN TRAINERS CHOICE / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 Metres

REDAAN (Z. White) - reared on jumping away and was slow to begin.

DISCREPANCY (NZ) (S. So) - laid in under pressure in the straight.

KILDERKIN (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: HYGAIN TRAINERS CHOICE / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 Metres
(cont'd)

MISS LANGTRY (M. Collett) - in the vicinity of the 50 metres was inconvenienced and M. Collett was obliged to stop riding when taken wider by SHADOW BOOM.

SCISSORHANDS (J. Holder) - jumped away awkwardly and shifted out bumping SHADOW BOOM. Rider explained that the filly had travelled well in the early and middle stages of the event; however, when placed under pressure had failed to respond to his riding and was disappointing over the concluding 300 metres. He added that the filly was inclined to race greenly during the event. A post-race veterinary examination revealed lacerations to the near hind pastern.

SHADOW BOOM (K. Crowther) - contacted on jumping away. Laid out under pressure over the concluding 100 metres and in the vicinity of the 50 metres shifted out onto MISS LANGTRY, resulting in M. Collett being obliged to stop riding when MISS LANGTRY was taken wider. K. Crowther was reminded of her obligations and advised in future to stop riding and straighten her mounts when they commence to shift ground.

Correct weight for this event was delayed to allow M. Collett, the rider of MISS LANGTRY, placed fourth, and that filly's trainer, Mr D. Jolly, to view the vision in the straight. After doing so M. Collett lodged an objection against SHADOW BOOM (K. Crowther) being declared the second placegetter on the grounds of alleged interference over the concluding 100 metres. After considering the evidence, viewing the vision and acting on their own observations Stewards *dismissed* the objection.

RACE 3: HYGAIN MICRSPEED / SABOIS MAIDEN PLATE - 1100 Metres

MY BOY PERCEY (T. Pannell) - jumped away awkwardly and shifted out onto NATIVE BLUE.

MY GOLDEN CHAIN (A. Jordsjo) - from the vicinity of the 600 metres until near the 400 metres shifted out on a number of occasions and bumped with SEA WITNESS, which shifted in. Inclined to lay out under pressure in the straight.

NATIVE BLUE (P. Gatt) - inconvenienced on jumping away when contacted by MY BOY PERCEY.

FIFTYSEVENTHSTREET (J. Maund) - jumped away awkwardly.

RUSTY HALO (J. Toeroek) - jumped away awkwardly. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 150 metres. Dipped for no apparent reason in the vicinity of the 150 metres.

SEA WITNESS (D. Caboche) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. From the vicinity of the 600 metres until near the 400 metres shifted in on a number of occasions and bumped with MY GOLDEN CHAIN, which shifted out.

RACE 4: HYGAIN @ DAISH / SABOIS MAIDEN PLATE - 1600 Metres

GONDOLIER (K. Crowther) - contacted on jumping away. In the vicinity of the 1400 metres was obliged to be taken hold of to avoid the heels of REGAL TRIUMPH which shifted in.

OUR JOURNEYMAN (E. Boyd) - raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

BIGNOTA (D. Caboche) - hampered on jumping away when REGAL TRIUMPH shifted out.

RACE 4: HYGAIN @ DAISH / SABOIS MAIDEN PLATE - 1600 Metres (cont'd)

REGAL TRIUMPH (D. Tourneur) - jumped away awkwardly and shifted out onto BIGNOTA. In the vicinity of the 1400 metres shifted in when insufficiently clear of GOLDOLIER, which was forced to be taken hold of to avoid its heels. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 21 November 2020 and to conclude midnight Friday, 27 November 2020, a period of three meetings. Inside the 1400 metres D. Tourneur slowed the pace on REGAL TRIUMPH resulting in SHEBRINGZIT improving onto its heels. Rider was reminded of his obligations under AR131(d) in reducing the speed of his mounts.

ALITTLEBITOFREBA (Z. White) - slow to begin and missed the start by several lengths.

DITZY DANIELLA (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

MISSALLURE (J. Holder) - jumped away awkwardly, shifted out and brushed GOLDOLIER.

SHEBRINGZIT (A. Jordsjo) - in the vicinity of the 1400 metres improved onto the heels of REGAL TRIUMPH as the pace slowed and was obliged to be taken hold of and alter course.

RACE 5: HYGAIN VICTORY BM 58 HANDICAP - 1100 Metres

GROOT (S. So) - lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

CARTIER TIARA (M. Collett) - inclined to lay out under pressure in the straight.

NIC'S SECRET (E. Annells) - raced wide without cover throughout the event. Inclined to lay out under pressure in the straight. Rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure failed to respond to her riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

EXALTED QUEEN (J. Opperman) - jumped away awkwardly.

CELINE (T. Voorham) - dipped on jumping away.

RACE 6: HYGAIN RELEASE BENCHMARK 62 HANDICAP - 1200 Metres

DOMINATION (S. So) - hampered on jumping away.

PIERRE BIZEL (D. McWhinney) - shifted out abruptly shortly after the start onto DOMINATION. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

HANEDA (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: HYGAIN TRACKTORQUE BENCHMARK 62 HANDICAP - 2060 Metres

GALAHAD GURU (J. Holder) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards took into account that J. Holder had not used his whip over the final 100 metres.

ANTIPAS (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: HYGAIN TRACKTORQUE BENCHMARK 62 HANDICAP - 2060 Metres (cont'd)

THE RED SEA (S. Logan) - raced keenly in the early and middle stages of the event.

HAPPY ATOM (M. Collett) - Slow to begin. Inclined to lay out under pressure in the straight.

STALAGMITE (J. Eaton) - jumped away awkwardly and shifted out onto CASHING UP. Rider reported that the mare became extremely awkward in its action in the vicinity of the 600 metres and she had become concerned that it may have broken down, and for that reason she had eased it from the event. A post-race veterinary examination revealed minor skin laceration to the off fore cannon. Trainer, Mr J. Hyam, was advised that a Veterinary Certificate of Fitness was required prior to a future trial. Mr Hyam was further advised that STALAGMITE was now required to complete the course in an Official Barrier Trial to the satisfaction of the Stewards prior to a future race. Mr Hyam advised that he would recommend to the owners that the mare be retired.

I'M BULLETPROOF (C. Lions) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

CASHING UP (T. Voorham) - contacted and then dipped on jumping away.

RACE 8: DAISH IRRIGATION AND FODDER BENCHMARK 52 HANDICAP - 1100 Metres

LUCERNEFIELD (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

CHEVITE (S. Fawke) - acting on confirmed advice from trainer, Mr M. McClean, that the gelding had injured itself in its yard and would be unfit to race Stewards ordered the withdrawal of CHEVITE at 8.12 am. Mr McClean was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

AMBERTONE (C. Lions) - had difficulty obtaining clear ground from the entrance to the straight and inside the 200 metres was disappointed when attempting a run between LIBERTY'S TORCH and ENVYEM, which shifted in. In the vicinity of the 150 metres dipped for no apparent reason. A post-race veterinary examination revealed no visible abnormalities.

MAGIC DEE (Z. White) - raced wide without cover throughout the event.

HOLY TORMENT (J. Toeroek) - knuckled on jumping away and was slow into stride.

LIBERTY'S TORCH (M. Collett) - was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to start. In the vicinity of the 150 metres dipped for no apparent reason.

ENVYEM (D. Tootell (Snr)) - raced keenly in the early and middle stages of the event. Inside the 200 metres shifted in onto AMBERTONE. Rider was reprimanded and advised to make a greater effort to keep his mounts straight in future.

RACE 9: HYGAIN OFF THE TRACK SUPPORT BENCHMARK 54 HANDICAP - 1350 Metres

BEAU'S MY BOY (Z. White) - contacted on jumping away. Raced wide without cover throughout the event. Hung in throughout the event. Rider reported that the gelding hung in throughout the event and in the vicinity of the 600 metres commenced to weaken despite her efforts. A post-race veterinary examination revealed no visible abnormalities.

CHONCAPE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

MANOR KING (S. Fawke) - shifted in on jumping away and contacted BEAU'S MY BOY. Raced keenly in the early and middle stages of the event.

RACE 9: HYGAIN OFF THE TRACK SUPPORT BENCHMARK 54 HANDICAP - 1350 Metres
(cont'd)

THE HAITIAN POET (J. Eaton) - inclined to lay out under pressure in the straight.

RISING THUNDER (J. Maund) - in the vicinity of the 1000 metres was forced to take hold when tightened onto CHONCAPE by GRAVITY.

AL MA BELLE (T. Pannell) - rider reported that the mare had never travelled. He added that AL MA BELLE was at its top mid race and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

UNDESIRE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

GRAVITY (D. Tootell (Snr)) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres shifted in onto RISING THUNDER when insufficiently clear. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 21 November 2020 and to expire Friday, 27 November 2020, a period of three meetings. Laid out under pressure in the straight.

SYLVAN CREST (K. Crowther) - laid out under pressure in the straight.

QUICK BISCUIT (A. Jordsjo) - jumped away awkwardly.
