RACE 1: BORDERTOWN HAULAGE MAIDEN HANDICAP - 1000 Metres

The start of this event was delayed approximately two minutes.

SANDHILL REBEL (D. Tourneur) - in the vicinity of the 100 metres was tightened to the inside of REAL VALENTIA which shifted in when insufficiently clear, and clipped the heels of that gelding.

COMRADE BILL (K. Crowther) - jumped away awkwardly. Raced keenly and wide without cover throughout the event. In the vicinity of the 100 metres shifted in abruptly onto HOPE WAITS which was obliged to be steadied when taken out by SUGAR GLIDER. Rider was severely reprimanded under AR131(a) and advised to take greater care in future. A post-race veterinary examination revealed no visible abnormalities.

REAL VALENTIA (S. Wiseman) - proved difficult to load. Trainer, Mr. L. Creek, was advised a warning had been placed on the gelding in relation to its barrier manners. In the vicinity of the 100 metres shifted in when insufficiently clear of SANDHILL REBEL and as a result SANDHILL REBEL was obliged to be checked and clipped the heels of REAL VALENTIA. Rider pleaded guilty to a charge under AR131(a) and was suspended from riding in races for a period to commence at midnight Sunday, 21 March 2021 and to conclude at midnight, Sunday 28 March 2021, a period of three meetings. In assessing penalty Stewards took into account S. Wiseman's excellent record under this rule.



JAYWICK (J. Maund) – shortly after the start shifted out and bumped SMART PROMISE.

SUGAR GLIDER (S. Logan) – in the vicinity of the 100 metres shifted out under pressure taking HOPE WAITS out onto COMRADE BILL.

HOPE WAITS (A. Jordsjo) - in the vicinity of the 100 metres was taken out by SUGAR GLIDER and was obliged to be steadied as COMRADE BILL shifted in abruptly. A post-race veterinary examination revealed no visible abnormalities.

SMART PROMISE (S. Fawke) – shortly after the start shifted in and bumped JAYWICK.

RACE 2: TASCO BENCHMARK 62 HANDICAP - 1000 Metres

LANCASTER SOUND (D. Tourneur) – in the vicinity of the 300 metres was taken in by AVID GENERAL which was inclined to hang in and shifted in abruptly.

GAMBLER'S GIRL (A. Chung) – on jumping away bumped with JAAMINT.

TRUPORTH (S. Wiseman) – jumped away awkwardly, shifted in and bumped with LANCASTER SOUND.

FIRST REWARD (K. Crowther) – Stewards received a submission from Trainer, Mrs S. Hayes, that the mare be scratched due to the earlier track upgrade. Stewards accepted this submission and declared FIRST REWARD a late scratching at 1:45 pm.

HURRICANE SONNY (M. Henderson) – jumped away awkwardly.

AVID GENERAL (T. Bull) – in the vicinity of the 300 metres was inclined to hang in shifted in abruptly taking LANCASTER SOUND in.

FLASH FREDDIE (B. Price) – in the vicinity of the 500 metres became very awkward in its action for a number of strides, unbalanced its rider and lost ground before regaining its action. From that point on the mare was eased out of the event. A post-race veterinary examination revealed no visible abnormalities.

JAAMINT (S. So) – jumped away very awkwardly, shifted out and bumped GAMBLER'S GIRL

RACE 3: BORDERTOWN PUMPS & REFRIGERATION MAIDEN PLATE - 1300 Metres

The start of this event was delayed approximately two minutes.


WONGA FLYER (K. Walters) – jumped away awkwardly.

ZAG (R. Hurdle) – approaching the finish had its hindquarters turned by MUM'S ADVICE which was taken out.


BLUEBERRY BOY (S. Wiseman) – jumped away awkwardly. Approaching the finish shifted out under riding when insufficiently clear of MUM'S ADVICE which was taken out onto ZAG and as a result MUM'S ADVICE was obliged to be steadied and lost its position when awkwardly placed on the heels of BLUEBERRY BOY. Rider was found guilty of a charge of careless riding under AR131(a) and was suspended from riding in for a period to commence at midnight Sunday, 28 March 2021 and expire at midnight Monday, 5 April 2021, a period of four meetings.

DUGGEE'S BOY (J. Opperman) – jumped away awkwardly and was slow into stride. Raced keenly in the early stages of the event.

HIS NAME IS STEVE (C. Lions) – in the vicinity of the 500 metres became awkward on the heels of MAI TIME for a short distance.



MEREWETHER BEACH (A. Jordsjo) – Stewards received a submission from Trainer, Mr. J. Dodson, that the gelding be withdrawn due to the track upgrade. Stewards accepted this submission and declared MEREWETHER BEACH a late scratching at 2:16 pm.



MILITARY PRESS (K. Crowther) – a post-race veterinary examination revealed the gelding to be lame in the near hindleg. Trainer, Mr. M. Seyers, was advised a Veterinary Certificate of Fitness was required prior to accepting for a future trial or race.

MUM'S ADVICE (D. Tourneur) – approaching the finish was obliged to be steadied and lost its position when tightened onto ZAG as BLUEBERRY BOY shifted out when insufficiently clear.

RACE 4: MCCARTHY TRANSPORT BENCHMARK 62 HANDICAP - 2000 Metres

JACK'S A CRACKER (R. Hurdle) – jumped away awkwardly. In the vicinity of the 100 metres was momentarily inconvenienced when awkwardly placed on the heels of BASSONS which was taken in marginally.

ENBARR (A. Jordsjo) – Stewards received a submission from Trainer, Mr. J. Dodson, that the gelding be withdrawn from today's event due to the track upgrade. Stewards accepted his submission and declared ENBARR a late scratching at 2:16 pm.

BRONSKI (J. Maund) – on jumping away contacted with BASSONS which shifted out. In the vicinity of the 1500 metres was tightened onto CHEEKY ATOM as ANTIPAS rolled in.

BUNGALALLY BABE (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

O'MIZZNA (J. Opperman) – in the vicinity of the 100 metres rolled in onto BASSONS which was taken in onto JACK'S A CRACKER. Rider was reminded of his obligations under AR131(a) when his mount has commenced to shift ground in future. Stewards inquired into the reasons why apprentice J. Opperman returned to scale 0.5 kg over the weight he weighed out at. After considering his explanation Stewards charged J. Opperman under AR211(1) in that his mount carried more than 0.5 kg in the race. J. Opperman pleaded guilty to the charge and was fined \$200.

ANTIPAS (D. Tourneur) – in the vicinity of the 1500 metres rolled in and tightened BRONSKI onto CHEEKY ATOM.

BASSONS (K. Walters) – jumped away awkwardly, shifted out and contacted BRONSKI. Was held up for clear running when racing between JACK'S A CRACKER and ANTIPAS from rounding the home turn until shortly after the entrance to the straight. Had difficulty obtaining clear ground from approaching the 200 metres until inside the 200 metres. In the vicinity of the 100 metres was taken in by O'MIZZNA which shifted in and was obliged to shift out in an attempt to gain clear ground.

Correct weight for this event was delayed to allow K. Walters the rider of third place-getter BASSONS and Co-trainer, Mr. K. Post to view the vision in the straight.

RACE 5: BORDERTOWN STONE SUPPLIES BENCHMARK 70 HANDICAP - 1550 Metres

JACKTHEGIANTSLAYER (R. Hurdle) – Stewards received a submission from Trainer, Mr. G. Karayannis, that the gelding be withdrawn due to the track upgrade. Stewards accepted this submission and declared JACKTHEGINATSLAYER a late scratching at 1:45 pm.

SPLASH SOME CASH (M. Henderson) – raced wide without cover throughout the event.

WILD COLONIAL BOY (S. Wiseman) – Stewards received a submission from Trainer, Mr. M. O'Leary, that the gelding be withdrawn due to the track upgrade. Stewards accepted this submission and declared WILD COLONIAL BOY a late scratching at 2:58 pm.

FAST PLAN (S. Metcalfe) – shortly after the start was restrained and shifted in to obtain cover. Inclined to lay in under pressure in the straight.

NOBLE ROCKS (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.



RACE 6: DOAN PHARMACIES BENCHMARK 54 HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes.

CAN'T BLUFF ME (A. Jordsjo) – on arrival at the barriers, at the request of its rider, was examined by the Veterinary Surgeon who ruled the gelding fit to start. Rider reported that the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr M. Seyers, was advised that a Veterinary Certificate of Fitness was required prior to accepting for a future trial or race.

EUROGEM (J. Maund) – rider reported that the mare was inclined to over-race with the step up in distance in today's event.

HAFU (S. Fawke) – raced keenly throughout the event.

HOLY SANGRIA (T. Bull) – Stewards received a submission from Trainer, Mr. J. Macmillan, that the mare be withdrawn due to the track upgrade. Stewards accepted this submission and declared HOLY SANGRIA a late scratching at 2:16 pm.

RACE 7: BORDER AG BENCHMARK 54 HANDICAP - 1200 Metres

YOU ES MARSHAL (S. Metcalfe) – Stewards received a submission from Trainer, Mr. J. Macmillan, that the gelding be withdrawn due to the track upgrade. Stewards accepted this submission and declared YOU ES MARSHAL a late scratching at 2:16 pm.

KLIPPEN (E. Finnegan) – jumped away awkwardly.

AMERICAN STORM (E. Wong) – Near the 900 metres became awkwardly placed on the heels of MISS HARMONIUM, when taken in slightly by TECOFSKY and as a result shifted in onto BAD MOON RISING.

OUT PROVEN (A. Jordsjo) – Stewards received a submission from Co-trainer, Mr. J. Jaensch, that the mare be withdrawn due to the track upgrade. Stewards accepted this submission and declared OUT PROVEN a late scratching at 2:28 pm.

VIETTI (M. Collett) – raced keenly in the early and middle stages of the event and raced wide without cover throughout the event.

BULLET KID (B. Price) – as the start was affected the barrier appeared to open slightly slower than the remaining barriers and as a result BULLET KID was awkward to begin. In the vicinity of the 900 metres became awkwardly placed on the heels of BAD MOON RISING.

TECOFSKY (S. Wiseman) – Near the 900 rolled in slightly onto AMERICAN STORM. Rider reported that the gelding may not have handled today's track conditions.

RED DAZZLE (J. Maund) – a post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow B. Price the rider of BULLET KID and Co-trainer, Mr. J. Jaensch, to view the vision of the start. As the gelding was placed third by the judge, the Stewards were unable to take any action against the gelding in relation to AR204.
