RACE 1: FLEURIEU MILK COMPANY HANDICAP - 1100 Metres

BROTHER'S SHADOW (NZ) (K. Crowther) - laid out under pressure over the concluding 100 metres of the event.

KARACASU (J. Toeroek) - jumped away awkwardly.

TAVIKAT (NZ) (C. Jones) - inclined to laid in under pressure in the straight.

MAURICE ROAD (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

AUDREY GIRL (Z. Spain) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

TAGOMAGO (D. Tourneur) - jumped away awkwardly. Laid out under pressure over the concluding 100 metres of the event. Rider could offer no explanation for the filly's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 1: FLEURIEU MILK COMPANY HANDICAP - 1100 Metres (cont'd)

STRATISFACTION (S. Metcalfe) - raced keenly in the early stages of the event.

RACE 2: TERRY HOWE PRINTING THREE-YEAR-OLD MAIDEN PLATE - 1050 Metres

BLAH BLAH (D. Tourneur) – underwent a pre-race veterinary examination and found to be lame in the off foreleg. Acting on this advice Stewards withdrew BLAH BLAH BLAH at 12.35 pm. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

JONQUEST (J. Holder) - shortly after the start was hampered and lost its position when taken out onto the heels of KUNGKA MARU by ZAKHEERA. Laid out rounding the home turn and under pressure in the straight.

ORPHAN ASH (T. Hope) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SELF SUFFICIENT (P. Gatt) - raced wide without cover throughout the event. Laid in under pressure in the straight. Rider explained that the gelding had over-raced in the early and middle stages of the event, had commenced to lay in from the 600 metres and had not finished the event off. A post-race veterinary examination revealed no visible abnormalities.

SPARKUP (J. Toeroek) - slow to begin. Held up from near the 500 metres until the entrance to the straight. Inside the 300 metres altered course to the outside of SELF SUFFICIENT, which was laying in, to obtain clear ground.

VANCOUVER VELVET (C. Jones) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres.

ARTFUL LIBBY (A. Jordsjo) - shortly after the start shifted out onto ZAKHEERA.

SO SAY ANGEL (K. Zechner) - from approaching the 400 metres until near the 200 metres had difficulty obtaining clear ground.

ZAKHEERA (J. Eaton) - inconvenienced shortly after the start when tightened onto JONQUEST by ARTFUL LIBBY.

RACE 3: AUTUMN RACING CARNIVAL AT MORPHETTVILLE MAY 1ST-15TH HANDICAP - 1600 Metres

The start of this event was delayed approximately four minutes.

CROWN MINT (C. Jones) - near the 300 metres attempted a run to the outside of MONTEPULCIANO, where in the opinion of Stewards there was insufficient room. As a result CROWN MINT made contact with the hindquarters of THE BRUMBY turning that gelding in, resulting in CROWN MINT becoming awkwardly placed on the heels of MONTEPULCIANO for a short distance prior to shifting in to obtain clear ground. Rider reprimanded under AR131(a) and advised in future to ensure there is sufficient room prior to attempting runs.

THE BRUMBY (B. Vorster) - contacted on jumping away and shortly after was taken back in onto OATH OF OMERTA by MORTY. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

ZOIST (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

BELLINGER (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

MR RAIKKONEN (P. Gatt) - fractious in the barriers after being loaded, reared and dislodged its rider. Trainer, Mr T. Doudle was advised that the gelding would now be required to prove tractable in an Official Barrier Trial prior to a future race start. P. Gatt was examined by the First Care Medical personnel and was ruled unfit to fulfil his remaining engagements. MR RAIKKONEN was declared a late scratching at 1.52 pm.

RACE 3: AUTUMN RACING CARNIVAL AT MORPHETTVILLE MAY 1ST-15TH HANDICAP – 1600 Metres (cont'd)

OATH OF OMERTA (J. Eaton) - jumped away awkwardly and shifted out contacting THE BRUMBY. Shortly after was taken back in by that gelding and lost its position when tightened onto the heels of CROWN MINT.

MORTY (Z. Spain) - shortly after the start shifted in onto THE BRUMBY.

ICHIBANSAN (J. Holder) - rider explained that it was not his intention to lead in this event; however, after jumping away well the gelding took up a forward position of its own accord.

RACE 4: HOLDFAST INSURANCE HANDICAP - 1050 Metres

MOUNT MITTY (J. Mott) - a post-race veterinary examination revealed no visible abnormalities.

KOSOWSKI (S. Logan) - near the 800 metres was forced to race in restricted room for a number of strides between the heels of MOUNT MITTY, which rolled out marginally at the same time as HUFFINGTON shifted in slightly. Had difficulty obtaining clear ground from the entrance to the straight until the 200 metres.

HUFFINGTON (A. Bryan) - near the 200 metres rolled out slightly onto LUNAR HERO, which was inconvenienced.

WRITE ENUFF (Z. Spain) - raced wide without cover throughout the event.

GLASS CEILING (D. Tourneur) - laid out under pressure in the straight. Rider reported that the mare was inclined to hang out throughout the event.

LUNAR HERO (J. Holder) – near the 200 metres was inconvenienced when HUFFINGTON shifted out slightly. Rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight it had not responded to his riding. He added that in his opinion the gelding would benefit from the run. A post-race veterinary examination revealed no visible abnormalities.

CHAMPAGNE AFFAIR (K. Crowther) - rider reported that it was her intention to settle closer in today's event; however, after jumping away well from a wide barrier she had formed the opinion that due to the formation of the field she would be caught wide, and for this reason she elected to ease and obtain cover.

OUR SUSTAR (J. Eaton) - awkward and slow to begin.

RACE 5: WHITE MARQUEE HANDICAP - 2019 Metres

FAROOQ (J. Opperman) - raced wide without cover throughout the event.

BRAMFIELD (T. Pannell) – jumped away awkwardly. Rider explained that the mare had travelled fairly and when asked for an effort had been flat footed and did not finish the event off. A post-race veterinary examination revealed no visible abnormalities.

GRINZINGER STAR (NZ) (E. Finnegan) - raced keenly in the middle stages of the event.

CANFORD (D. Tourneur) - at the entrance to the straight was beaten for a run to the outside of ANALYTICA (NZ) by DREAMED and as a result was rider was obliged to stop riding and alter course to obtain clear ground. Inclined to lay in, in the straight.

RACE 6: FURPHY HANDICAP - 1200 Metres

NORTHERNERO (A. Bryan) - hampered on jumping away when tightened between LA VITA and COTILLION.

LIKE A HEARTBEAT (J. Opperman) - had difficulty obtaining clear ground from the entrance to the straight until the 200 metres.

RACE 6: FURPHY HANDICAP - 1200 Metres (cont'd)

COTILLION (S. Metcalfe) - shifted out on jumping away onto NORTHERNERO. Held up from the entrance to the straight until inside the 200 metres.

LA VITA (T. Hope) - shifted in on jumping away onto NORTHERNERO.

CARLALUISA (S. So) - a post-race veterinary examination revealed no visible abnormalities.

MICKS NEW CHICK (M. Collett) - jumped away awkwardly and shifted in contacting MALLE HAMMER.

JAGERNAUT (T. Pannell) - rider explained that the gelding travelled well in the early and middle stages; however, got on its wrong leg rounding the home turn and did not feel comfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

LOPE DE WOLF (B. Vorster) - became awkward shortly after the start.

NARRATIVE STAR (A. Kelly) - raced wide without cover throughout the event.

GLORY GAME (J. Holder) - jumped away awkwardly.

ZERO INN (A. Jordsjo) - slow to begin. Rider reported that the filly felt awkward in its action throughout the event and was inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

LADY PAVLI CHENKO (J. Eaton) – at the entrance to the straight became awkwardly placed on the heels of GALCRUM for a short distance. Rider reported that she was beaten for a run at the entrance to the straight by GALCRUM; however, when she attempted to improve into the race on that mare's back LADY PAVLI CHENKO was unable to and had been disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: MANIHI CLASSIC - 1100 Metres

LYRE (T. Pannell) - shifted in on jumping away onto EXTRA TIME. Had difficulty obtaining clear ground from the entrance to the straight until near the 300 metres.

BOLD STAR (C. Jones) - when being restrained in the vicinity of the 800 metres rolled out inconveniencing SIZZLEFLY. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

GARNER (M. Aitken) - near the 900 metres shifted in and became awkwardly placed on the heels of ELDERFLOWER and got its head up for a short distance until able to position behind that mare. Approaching the 200 metres was inconvenienced when taken in onto LITTLE RICH BOY by HUMMA HUMMA.

SHAMINO (K. Crowther) - lost its near fore plate during the event.

HUMMA HUMMA (J. Mott) – approaching the 200 metres was inconvenienced when taken in onto GARNER by ELDERFLOWER.

SUPERHARD (M. Collett) – raced wide without cover throughout the event. Rider reported that in her opinion her mount had felt the track.

ELDERFLOWER (J. Eaton) – approaching the 200 metres shifted in under riding onto HUMMA HUMMA. Rider reprimanded under AR131(a) for careless riding and advised in future to stop riding and straighten her mounts quicker than she had on this occasion. A post-race veterinary examination revealed no visible abnormalities.

LI'L KONTRA (B. Vorster) - jumped away awkwardly.

SIZZLEFLY (J. Benbow) - slow to begin and shortly after was inconvenienced when MILEVA shifted out. Near the 800 metres was inconvenienced when taken wider by BOLD STAR.

RACE 7: MANIHI CLASSIC - 1100 Metres (cont'd)

EXTRA TIME (J. Holder) - hampered on jumping away when tightened between LITTLE RICH BOY and LYRE. Lost its near fore plate during the event.

TUBBY TWO TRACKS (K. Zechner) – near the 200 metres had to be eased for a number of strides when LITTLE RICH BOY was taken in.

LITTLE RICH BOY (S. Metcalfe) – shifted out on jumping away onto EXTRA TIME. Near the 200 metres was inconvenienced when taken in onto TUBBY TWO TRACKS by GARNER.

MILEVA (A. Jordsjo) - shifted out on jumping away onto SIZZLEFLY. Raced wide without cover throughout the event.

CALYPSO REIGN (Z. Spain) – slow to begin. Had difficulty obtaining clear ground from the entrance to the straight and then approaching the 200 metres was disappointed for a run for a short distance to the inside of GARNER and was obliged to alter course to obtain clear ground. Approaching the 100 metres had to be momentarily steadied when awkwardly placed between the heels of ELDERFLOWER and HUMMA.

RACE 8: CLARE LINDOP STAKES - 1600 Metres

VICTORIA QUAY (B. Vorster) – contacted on jumping away and became unbalanced for a number of strides when THE MARKLE SPARLE continued to shift out. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ECUMENICAL (J. Eaton) - laid out rounding the home turn and under pressure in the straight. Near the 200 metres rolled out inconveniencing PERFECT WORLD.

VALANETTI (R. Hurdle) - Stewards permitted R. Hurdle to ride the filly 0.5 kg over its declared weight of 55.0 kg. Raced keenly in the middle stages of the event. Near the 200 metres shifted in towards SPECTACLE.

ANOTHER AWARD (J. Holder) - had difficulty obtaining clear ground from the entrance to the straight until near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

SCREAM DREAM (Z. Spain) - raced keenly in the early and middle stages of the event. Near the 200 metres rolled out slightly onto ENERGY WITHIN. A post-race veterinary examination revealed no visible abnormalities.

ENERGY WITHIN (J. Opperman) - inclined to lay in under pressure in the straight and near the 200 metres had to be checked when taken in onto the heels of SCREAM DREAM by SPECTACLE, which shifted in and away from VALANETTI.

PERFECT WORLD (T. Pannell) - raced keenly in the early and middle stages of the event. Inconvenienced near the 200 metres when ECUMENICAL rolled out. Inclined to lay in over the concluding stages of the event.

BIARCHI (K. Crowther) - approaching the 400 metres had to be momentarily steadied when awkwardly placed between the heels of VICTORIA QUAY, which shifted out slightly, and HEAVY ROTATION.

HEAVY ROTATION (S. Fawke) - slow to begin.

SPECTACLE (C. Jones) - near the 200 metres shifted in and away from VALANETTI onto ENERGY WITHIN.

SO BENE (J. Benbow) - raced wide without cover throughout the event.

GLITZY GIRL (D. Tourneur) - raced fiercely in the early and middle stages of the event and was obliged to be restrained on a number of occasions when awkwardly placed on heels.

THE MARKLE SPARKLE (K. Zechner) - shifted out on jumping away onto VICTORIA QUAY and continued out for a short distance.

RACE 9: TAB HANDICAP - 1600 Metres

The start of this event was delayed approximately two minutes.

LORD BOUZERON (NZ) (A. Kelly) – raced wide without cover throughout the event. Near the 300 metres laid in and bumped MONRAAJ. Rider reported that the gelding laid out throughout the event' however, near the 300 metres shifted in abruptly. A post-race veterinary examination revealed no visible abnormalities.

OH MO (J. Opperman) - had to be checked near the 300 metres when MEADOWS YOUNG BUCK was taken out into its running line.

CALL ME SHAMUS (C. Jones) - shifted out on jumping away losing ground. A post-race veterinary examination revealed no visible abnormalities.

CHU CHU CHARLIE (M. Aitken) - inconvenienced near the 300 metres when contacted by MONRAAJ.

MEADOWS YOUNG BUCK (R. Hurdle) - near the 300 metres was taken out into the running line of OH MO by SOARING EAGLE. Shortly after was forced to be checked when tightened onto GOOD GIRL BELLA by SOARING EAGLE and in being checked shifted in onto MONRAAJ.

SOARING EAGLE (J. Toeroek) - near the 300 metres shifted out onto MEADOWS YOUNG BUCK taking that gelding out into the running line of OH MO, forcing that rider to check. Continued out when insufficiently clear onto MEADOWS YOUNG BUCK forcing that rider to check when tightened onto GOOD GIRL BELLA. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 28 March 2021 and to conclude midnight Monday, 5 April 2021, a period of 4 meetings.

GOOD GIRL BELLA (S. Logan) - shifted out shortly after the start onto HAHNDORF. Raced wide without cover throughout the event.


CROWN HARMONIUM (S. Fawke) – jumped away awkwardly. Approaching the 100 metres was inconvenienced when taken in by ROSE TIARA. Rider was reminded of his obligations in riding his mounts out to the end of the race in accordance with AR131(b).

ECHO BOOMER (D. Tourneur) - lost its near fore plate during the event.

ROSE TIARA (K. Crowther) - approaching the 100 metres shifted in and away from SOARING EAGLE onto CROWN HARMONIUM.

MONRAAJ (B. Vorster) - near the 300 metres was hampered when contacted by LORD BOUZERON (NZ) and taken in onto CHU CHU CHARLIE. Inside the 300 metres was forced to race in restricted room for a number of strides between the heels of MULLAGHMORE, which rolled out slightly at the same time as MEADOWS YOUNG BUCK shifted in after being checked.

HAHNDORF (J. Eaton) – lost its position shortly after the start when tightened onto MONRAAJ by GOOD GIRL BELLA. Laid out under pressure in the straight.



GENERAL:

Trainer, Mr J. Dodgson, advised Stewards on Monday, 29 March 2021 that CARALUISA (Race 6) and HEAVY ROTATION (Race 8) had both been off their food since returning to his stable and in his opinion were showing signs of a virus.
