Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Penola Racecourse by the Penola Racing Club on Sunday, 4 April, 2021

RACE 1: WATTLE RANGE COUNCIL MAIDEN HANDICAP - 1400 Metres

DUGGEE'S BOY (J. Opperman) - when questioned, rider explained that he was given no set instructions by the trainer, Mr. Creek, other than to have the horse racing comfortably. He added that he expected to sit just behind the leader, however, after beginning well, he found himself in the lead with his horse travelling nicely. He added that he was unaware that he was so far in front, however, he was comfortable with the pace of the event. With regards to the horse's last start where the horse raced further back, rider explained that, on that day at Bordertown, the horse drew wider and, after beginning awkwardly and being slow into stride, he elected to take a sit with the hope that horse would get home to the line.

HIS NAME IS STEVE (S. Logan) - shifted in slightly near the 300 metres and in doing so momentarily crowded WONGA FLYER on its inside.

OMYAKON (J. Maund) - laid out momentarily near the 700 metres.

NO DOUBT ABOUT HIM (A. Chung) - eased when momentarily crowded near the 300 metres on the inside of WONGA FLYER. A post-race veterinary examination revealed a small cut to its off foreleg.

WONGA FLYER (K. Walters) – near the 300 metres became awkwardly placed on the heels of HIS NAME IS STEVE and shifted in.

RACE 2: COOPERS BREWERY MAIDEN PLATE - 1100 Metres

DALE'S ROCKET (R. Hurdle) - shortly after passing the 600 metres had to be steadied when awkwardly placed between BEAUMIS and WEEKEND BANG, both of which had shifted ground.

LOCH RIVER (K. Zechner) - jumped awkwardly and was slow to begin. Shortly after passing the 600 metres shifted out away from the heels of WEEKEND BANG. A post-race veterinary examination revealed no visible abnormalities.

NANCY MAY (S. Logan) - raced keenly in the early and middle stages of the event. Shortly after passing the 600 metres was inconvenienced by LOCH RIVER which shifted out.

WEEKEND BANG (D. Tourneur) - shortly after passing the 600 metres raced keenly and was steadied away from the heels of MISS GATSBY

BEAUMIS (J. Opperman) - near the 800 metres became awkwardly placed close to the heels of SIXTYFOURTH STREET and had to be steadied.

COLORADO KID (K. Walters) hung out from the 400 metres and proved difficult to ride. Trainer, J. Gow-Whyte, was advised a warning would be placed against the horse's racing manners.

RACE 3: PRINCE OF WALES HOTEL MOTEL PENOLA BENCHMARK 62 HANDICAP - 1100 Metres

ACTION IN CAIRNS (E. Finnegan) - shifted out approaching the 900 metres and bumped PREDICATED. Rider reported that the horse was fractious in the barriers and then slow to begin. She added that the horse felt uncomfortable in the early stage of the event and, as such, she was further back than anticipated. A post-race veterinary examination revealed no visible abnormalities.

ATOMIC WIZARD (J. Opperman) - near the 200 metres put in an awkward stride when attempting to jump a shadow on the track.

PREDICATED (J. Eaton) - was slow to begin and shortly after was bumped by GOODNESS GRACIE on its outside. Bumped by ACTION IN CAIRNS approaching the 900 metres.

GOODNESS GRACIE (S. So) - jumped awkwardly, shifted in and bumped PREDICATED.

RACE 4: THE MIDFIELD GROUP BENCHMARK 54 HANDICAP - 1100 Metres

GOLDEN RIPPLES (D. Tourneur) - raced keenly in the middle stages of the event. Was held up for clear running from the 400 metres to the 300 metres and then laid in in the early part of the home straight.

IS THAT SO (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

SHALL WE HOPE (M. Henderson) - shifted out on jumping and hampered BENOVSKY.

SYLVITE (A. Chung) - a post-race veterinary examination revealed no visible abnormalities.

BENOVSKY (K. Walters) - was slow to begin and then awkwardly placed on the outside of SHALL WE HOPE. Raced keenly from the 800 metres. Held up for clear running from the home turn and, as such, was not fully tested.

BULLET KID (J. Maund) - jumped awkwardly and was slow to begin.

WILANDER PRINCESS (S. Logan) - was held up for clear running from the 300 metres to the 100 metres.

ARACHNATTACK (B. Price) - raced wide without cover throughout the event.

THANASI (J. Opperman) - hung out throughout the race.

RACE 5: TDC LIVESTOCK AND PROPERTY BENCHMARK 68 HANDICAP - 1300 Metres

MUNTHAM MISSILE (B. Price) – stood flat-footed at the start and lost approximately ten lengths. Trainer, Ms. B. O'Loughlin, was advised that MUNTHAM MISSILE would now be required to jump with the field in an Official Barrier Trial or Approval to Race Jumpout prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

OLATUNJI (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

GREETINGS NED (D. Tourneur) - rider's whip became entangled with the whip of E. Finnegan, rider of BRIGHT BELLE, near the 50 metres.

BRIGHT BELLE (E. Finnegan) - rider's whip became entangled with the whip of D. Tourneur, rider of GREETINGS NED, near the 50 metres.

WILD WILLY (S. Logan) - raced greenly and laid in near the 400 metres.

BUNUMBURT (K. Walters) - steadied near the 600 metres away from the heels of WILD WILLY. Tightened to the inside of WILD WILLY near the 400 metres.

RACE 6: DIGIORGIO FAMILY WINES PENOLA CUP - 1700 Metres

JESTER HALO (K. Crowther) - raced wide throughout the event.

HEIR OF TAVISTOCK (NZ) (D. Tourneur) - shifted in approaching the 1600 metres placing SPLASH SOME CASH in an awkward position. Rider was advised to exercise more care. A post-race veterinary examination revealed no visible abnormalities.

SPLASH SOME CASH (M. Henderson) - approaching the 1600 metres was awkwardly placed on the inside of HEIR OF TAVISTOCK. Approaching the 1400 metres was awkwardly placed on the inside of TRENCHANT and was obliged to be eased.

WILD COLONIAL BOY (S. Wiseman) - shifted in near the 1400 metres obliging TRENCHANT on its inside to shift in.

GASWORX (NZ) (J. Opperman) - rider reported that his saddle shifted backwards during the event which placed him at a disadvantage over the final 100 metres and, as such, he did not ride the horse out in his usual manner.

TRENCHANT (J. Eaton) - near the 1400 metres was tightened slightly by WILD COLONIAL BOY on its inside and had to be eased.

RACE 7: ADRIAN THOMAS INDUSTRIAL BENCHMARK 58 HANDICAP - 1700 Metres

ARTHURAS (Caitlin Jones) - when questioned with regard to the performance of the horse, rider explained the horse was fresh pre-race and it was her intention to sit behind the leaders given that it was the horse's first run from a spell. However, after beginning well, the horse worked its way to the lead with little effort. Rider further explained that the horse was first up over the 1700 metres and was up in class and, given the fact that it only commenced to weaken from the 150 metres, she was happy with its performance and added that the horse should improve with fitness. A post-race veterinary examination revealed no visible abnormalities.

AIR TIME (D. Tourneur) - shifted in near the 150 metres when insufficiently clear of SHUNSEKI resulting in that horse losing its rightful running. Rider pleaded guilty to a charge of Careless Riding under AR131(a) and was suspended from riding in races for a period to commence midnight on Friday, 9 April 2021 and to expire at midnight on Wednesday, 14 April 2021: a period of three meetings.

SHUNSEKI (K. Zechner) - was slow to begin. Tightened and checked near the 150 metres on the inside of AIR TIME resulting in the horse losing its rightful running.

BACK IN ACTION (S. Wiseman) - was slow to begin.

RACE 8: OMNIZAR BENCHMARK 54 HANDICAP- 1400 Metres

OBLIQUE LINE (S. Logan) - was fractious in the barriers and slow to begin.

POWER GLEN (S. Wiseman) - was held up for a clear run over the concluding stages of the event behind GRAND HOST.

GRAND HOST (K. Crowther) - laid in, in the home straight.



RACE 8: OMNIZAR BENCHMARK 54 HANDICAP- 1400 Metres (Cont'd)

OUTINTHESTREET (M. Collett) – as the start was affected, the horse lifted its head to the side, stood flat-footed and lost approximately ten lengths. The horse then tailed the field for the remainder of the event. Trainer, Ms Y. Black, was advised that OUTINTHESTREET would now be required to jump with the field in an Official Barrier Trial or Approval to Race Jumpout prior to a future race start.

MISTA KNOWITALL (K. Zechner) - was fractious in the barriers and slow to begin.

Correct weight was delayed to allow M. Collett (OUTINTHESTREET) to enter submissions with regard to her horse, which was very slow to begin, being declared a non-runner. After taking evidence from the rider, trainer, Ms Y Black, and the Starter, Mr S. Gebert, Stewards declared OUTINTHESTREET to be a starter.
