Report on Race Meeting held at Naracoorte
Racecourse by the Naracoorte Racing Club on
Wednesday, 14 April 2021

RACE 1: HANSEN PRINT MAIDEN PLATE - 2000 Metres

FERGO'S BOYS (J. Maund) - shifted in near the 50 metres and brushed **BRIABELLA**.

MR INTERNATIONAL (NZ) (K. Walters) - raced keenly in the early stages of the event.

MAGIC ACHIEVER (S. Wiseman) - fractious in the barriers. Hung out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

AQAAREB (A. Chung) - raced wide throughout the event.

BRIABELLA (A. Jordsjo) - was brushed by **FERGO'S BOYS** near the 50 metres.

General - Correct weight was delayed to allow A. Jordsjo rider of **BRIABELLA** and its trainer, Mr. J. Macmillan, to view the vision in the straight.

RACE 2: NARACOORTE MOTORCYCLES & MOWERS MAIDEN PLATE - 1100 Metres

JAYWICK (S. Wiseman) - horse was difficult to load in the barriers. Trainer, Mr. M. O'Leary, was advised a warning had been placed on the gelding with regard to its barrier manners.

SANDHILL REBEL (T. Pannell) - A post-race veterinary examination revealed the gelding to be lame in the near-hind leg. Trainer, Mr S. Turner, was advised that a Veterinary Certificate of Fitness is required prior to any future race or trial.



RACE 2: NARACORTE MOTORCYCLES & MOWERS MAIDEN PLATE - 1100 Metres (Cont'd)

PUNT ROAD (K. Walters) – slow to begin. Raced greenly and hung in, in the home straight. Trainer, Mr. R. Gilcrist, was advised that a warning will be placed on the gelding regarding its racing manners. A post-race veterinary examination revealed no visible abnormalities.

DEVIL WEARS PRADA (J. Maund) – laid in, in the home straight.

SIXTYFOURTH STREET (J. Eaton) – rider was reminded of her obligations to ride her mount fully to the end of the race.

NANCY MAY (S. Logan) – raced wide from the 600 metres.

HUSSHABAH (S. Fawke) – raced keenly in the early stages of the event.

RACE 3: STOCK AGENTS 2ND MAY MAIDEN PLATE - 1430 Metres

The start of the event was delayed to allow A. Jordsjo, rider of SOTERIOLOGY, to change her safety vests.

Race start was further delayed due to SMART PROMISE becoming fractious in the barriers, resulting in its rider, S. Fawke, being injured. S. Fawke was examined by a First Care Medical Attendant who passed him fit to continue duties. SMART PROMISE took its place in the field.

ALLGO (K. Walters) – raced keenly in the early and middle stages of the event. Held up entering the home straight behind SANBLAS and to the inside of DALE'S ROCKET. Eased momentarily near the 150 metres to avoid the heels of SANBLAS which shifted out slightly.

DALE'S ROCKET (R. Hurdle) – was momentarily inconvenienced when approaching the 150 metres and had to be steadied away from the heels of ALLGO which shifted out slightly.

NOVIQUE (K. Bohorun) – was slow to begin. Trainer, Mr. S. Fisher, was fined \$100 under AR206(3) for failing to use blinkers on the gelding after it was passed to race wearing blinkers.

AMERICHI (J. Maund) – was slow to begin. Tailed the field throughout the event. A post-race veterinary examination revealed the gelding to have shin soreness.

DUGGEE'S BOY (J. Opperman) – hung in, in the home straight.

SANBLAS (C. Jones) – hung out rounding the home turn and in the straight.

ELIZA'S GOLD (E. Finnegan) – slow to begin. Raced wide throughout the event.

SOTERIOLOGY (A. Jordsjo) – when questioned with regard to the reason why she was required to change her safety vest and delay the start, rider explained that she weighed out for this event in a heavy vest and then changed to a lighter vest to weigh out for the following event. When parading behind the barriers, she realised she had not changed back into her heavier vest and was concerned that she may weigh in light. After considering all circumstances Stewards, issued rider with a severe reprimand under AR185 for changing gear after weighing out.

RACE 4: ENVIRO TEC BENCHMARK 62 HANDICAP (HEAT 8 SA SPRINT SERIES) - 1000 Metres

GAMBLER'S GIRL (A. Chung) – was declared a late scratching at 2:31 pm by Stewards acting on a report from the Veterinary Surgeon that the horse was kicked in the near-fore knee while parading behind the barriers which resulted in immediate swelling to the leg.

KLIPPEN (E. Finnegan) – jumped awkwardly when slow to begin. A post-race veterinary examination revealed no visible abnormalities.



RACE 5: MARANA PARK THOROUGHBREDS BENCHMARK 64 HANDICAP (HEAT 9 AUTUMN SERIES) - 1430 Metres

PEWTER (B. Price) - was held up for clear racing from the 400 metres until approaching the 150 metres where it shifted in to obtain clear running.

STRYKE IN STYLE (T. Pannell) - when questioned with regard to the performance of the gelding, rider explained that the horse raced wide from the 600 metres and only responded moderately under pressure. He added that, in his opinion, the gelding may not have handled the shifting track conditions. A post-race veterinary examination revealed no visible abnormalities.

GREETINGS NED (T. Bull) - when questioned with regard to the performance of the gelding rider T. Bull advised that she was instructed to have the horse where comfortable in running. She added that the horse was slow to begin and then raced wide from the 700 metres and was under pressure from approaching the 200 metres. Rider further added that, in her opinion, the gelding may not have handled today's shifting track conditions. A post-race veterinary examination revealed no visible abnormalities.

MACCABEE (B. Vorster) - stable advised Stewards, prior to the event of a change of tactics in that the rider would be instructed to ride the gelding further forward (settled on-pace).

WURLIES LASTCHANCE (A. Jordsjo) - was momentarily held up for clear racing when approaching the 150 metres.

THE GREAT MARTINI (J. Opperman) - got its head down as the barriers opened and was, consequently, slow to begin. Tailed the field throughout. A post-race veterinary examination revealed no visible abnormalities.

General - R. Hurdle, who was initially engaged to ride EAGLES FOREVER and, as a result of being overweight was replaced, was issued with a severe reprimand under AR190(3).

RACE 6: ELDERS INSURANCE BENCHMARK 72 HANDICAP (HEAT 8 PROVINCIAL SUPER SERIES) - 2000 Metres

JESTER HALO (T. Bull) - stood flat-footed at the start and lost considerable ground (six lengths). Trainer, Ms V. Hutchinson, was advised a final warning would be placed on the mare with regard to its starting manners. Was held up for clear racing room approaching the 400 metres to the 300 metres and shifted wider in the home straight to obtain clear racing room.

TURF MAN (S. Fawke) - raced wide rounding the home turn.

O'MIZZNA (J. Opperman) - laid out late when under pressure.

FULMINEUS (K. Bohorun) - slow to begin.

SEARAVEN (C. Lions) - Stewards permitted rider to ride the gelding 0.5 kg over weight.

RACE 7: RACELANDS BENCHMARK 54 HANDICAP - 1430 Metres

IMPULSE DIAVOLO (E. Boyd) - raced wide from the 700 metres.

BLUE LAKE BOY (J. Opperman) - momentarily held up near the 300 metres behind the weakening AMERICAN STORM.

APPLIED (C. Lions) - slow to begin. Raced wide from the 800 metres.

BAD MOON RISING (B. Price) - when questioned with regard to the performance of the gelding, rider advised the horse raced keenly in the early stages of the event. He added that between the 600 metres and the 400 metres he was held up behind several horses, however, after shifting wider near the 400 metres into clear racing room, the gelding responded well.

BELLATOR (S. Fawke) - slow to begin.



RACE 7: RACELANDS BENCHMARK 54 HANDICAP - 1430 Metres (Cont'd)

IS THAT SO (E. Finnegan) - hung in rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

JACK IN THE DITCH (S. Wiseman) - slow to begin.

AMERICAN STORM (R. Hurdle) - when questioned with regard to the performance of the gelding rider stated the horse travelled well early, however, was under pressure from the 600 metres and, in his opinion, may not have handled the shifting track conditions. A post-race veterinary examination revealed no visible abnormalities.

DINNER LAKE (S. Logan) - jumped awkwardly.

JENEFACOR (C. Jones) - raced wide without cover throughout the event.

RACE 8: COOPERS BREWERY BENCHMARK 58 HANDICAP - 1200 Metres

MANHATTAN ARCH (A. Chung) - just prior to the start, the gelding turned its head to the side and was consequently slow to begin.

ACTION IN CAIRNS (S. So) - was fractious in the barriers and, as the start was affected, the gelding got its head down, jumped awkwardly and lost considerable ground (four lengths). Trainer, Mr. M. O'Leary, was advised that a final warning would be placed on the gelding with regard to its starting manners.

MADAM MISCHIEF (T. Bull) - when questioned with regard to the performance of and her riding of the filly, rider reported that the horse travelled well. However, shortly after entering the home straight, the filly commenced to make loud respiratory noises and, in her opinion, had choked down. Consequently, she did not ride the horse out over the final 200 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

CARLALUISA (K. Crowther) - A post-race veterinary examination revealed no visible abnormalities.

THE OLYMPIAN (B. Vorster) - stable advised Stewards prior to the event of a change of tactics in that the rider will be instructed to ride the gelding further forward (settled forward of mid-field). Dipped shortly after the start.

GOLDEN RIPPLES (B. Price) - raced keenly in the early and middle stages of the event.

NEAR MAGIC (A. Jordsjo) - slow to begin.

General - Correct weight was delayed briefly to allow the connections of ACTION IN CAIRNS to view the footage of the start
