RACE 1: ADELAIDE GALVANISING HANDICAP 2 YO - 1050 Metres

ARRAN BAY (K. Crowther) - raced very keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

AEROPORT (S. Logan) - rider reported the gelding raced greenly during the event.

DESIRED (B. Vorster) - raced greenly in the straight.

STRATISFACTION (C. Jones) - approaching the 200 metres was taken wider by BALLYNORA which shifted out.

BALLYNORA (L. King) - approaching the 200 metres shifted out to improve taking STRATISFACTION wider on the track.

RACE 2: ADELAIDE RACING CARNIVAL - MAY 1ST - 15TH HANDICAP - 2500 Metres

ANALYTICA (NZ) (B. Vorster) - A post-race veterinary examination revealed no visible abnormalities.

SANDBANKS (J. Eaton) - was awkward to begin, shifted out and contacted EXALTED FIRE.



RACE 2: ADELAIDE RACING CARNIVAL - MAY 1ST - 15TH HANDICAP - 2500 Metres (Cont'd)

LOSTARC (S. Fawke) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty, Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used his whip on six occasions over the last 100 metres.

OURKHANI (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54.5 kg. Near the 1400 metres shifted out and inconvenienced EXALTED FIRE.

MISS FIVE HUNDRED (D. Tourneur) – raced wide without cover in the early and middles stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty, Stewards had regard for the totality of the use of the whip by D. Tourneur and noted that he used his whip on two occasions over the last 100 metres.

EXALTED FIRE (K. Crowther) - was contacted at the start. Over-raced in the early stages of the event, and near the 1400 metres became awkward on the heels of OURKHANI which shifted out, had to be restrained and shifted wider on the track. A post-race veterinary examination revealed no visible abnormalities.

LIAM'S THE BOSS (L. King) – as the Thoroughbred Identification Card for this gelding was not available the horse was permitted to start as it was able to be identified from records held by Stewards. Over-raced for a short distance on the turn out of the straight.

REINVIGORATE (NZ) (J. McNeil) - A post-race veterinary examination revealed no visible abnormalities.

RACE 3: FURPHY HANDICAP (Heat 9 SA Sprint Series) - 1050 Metres

DEBT COLLECTOR (J. Opperman) - was contacted and tightened at the start.

BE MY STAR (T. Pannell) - raced wide without cover in the early stages of the event.

TOFF LOVE (H. Coffey) – approaching the 400 metres was held up for a short distance when racing behind ANITRA. Rider explained he had no specific instructions other than to allow the gelding to settle where comfortable, and settled in a position back of mid-field and was conscious not to encourage his mount to take up a more forward position in the early stages as he was advised that it does have a tendency to over-race when ridden positively early. He added that the gelding did its best work late in the race and finished the event off strongly. When questioned about his riding from near the entrance to the straight until near the 300 metres he explained that he had not commenced making his run shortly after entering the straight as he was advised by the trainer that the gelding only has a short sprint and, for that reason, he allowed it to balance up before making his run. Stewards noted his explanation.

LITTLE RICH BOY (S. Fawke) - was contacted at the start by DEBT COLLECTOR which was tightened and taken in. Was inclined to lay out rounding the home turn and near the entrance to the straight was taken a little wider by ANITRA which shifted out to improve.

SIZZLEFLY (K. Crowther) - began awkwardly shifted in contacted and tightened DEBT COLLECTOR onto LITTLE RICH BOY. Was inclined to lay in, in the straight.

HYPERSONIC - A post-race veterinary examination revealed no visible abnormalities.

ANITRA (J. McNeil) - near the entrance to the straight shifted out to improve taking LITTLE RICH BOY a little wider.

RACE 4: QUAYCLEAN HANDICAP - 1600 Metres

CANNOT BE SERIOS (NZ) (T. Stockdale) - A post-race veterinary examination revealed no visible abnormalities.

RUNBRO (J. Opperman) - was tightened at the start by NORTHERNERO which shifted in. A post-race veterinary examination revealed no visible abnormalities.

MAVETTE (S. Fawke) - raced keenly in the middle stages of the event.



RACE 4: QUAYCLEAN HANDICAP - 1600 Metres (Cont'd)

GRAFTON AVENUE (R. Hurdle) - shortly after the start was tightened between GRACIEBIRD which shifted in and the heels of MAVETTE, and shortly thereafter attempted to buck for a number of strides. Trainer, Mr. T. Doudle, was advised that a warning had been placed on the gelding in respect of its racing manners. A post-race veterinary examination revealed no visible abnormalities.

LOPE DE WOLF (J. Toeroek) - raced keenly in the early stages of the event. Raced wide without cover from near the 1100 metres.

RACE 5: HAPPY 90TH BIRTHDAY MARJ KETTAPELLAR HANDICAP - 1600 Metres

MUSHAIREB (GB) (M. Aitken) - A post-race veterinary examination revealed no visible abnormalities.

BALF'S CHOICE (L King) - raced very keenly in the early stages of the event.

SHOP TIL I DROP (NZ) (B. Vorster) - which had not raced since October 2019 underwent a prerace veterinary examination and was passed fit to race. Had difficulty obtaining clear ground from the entrance to the straight until near the 250 metres.

CASSIUS (T. Stockdale) - rider reported that the gelding was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: REDELVA STAKES 3YO - 1100 Metres

INSTANT CELEBRITY (K. Crowther) - Mr. T. Stokes, representing trainer, Mr. P. Stokes advised Stewards prior to the event of a change of tactics, that being the he would instruct his rider to attempt to take up a more forward position in running. Settled mid-field.

MINHAAJ (B. McDougall) – was held up for clear running from the entrance to the straight when racing behind INSTANT CELEBRITY and thereafter approaching the 200 metres was able to improve for a number of strides to the outside of INSTANT CELEBRITY before again becoming held up for clear running to that horse's outside and behind ECHOES IN ETERNITY and was unable to be fully tested until inside the 100 metres where it was obliged to shift to the inside of INSTANT CELEBRITY to obtain clear running.

OUTLAWS REVENGE (D. Tourneur) - near the entrance to the straight, when shifting out to improve, hampered CHAMPAGNE AFFAIR which had to be steadied. Rider was severely reprimanded under AR131(a) for shifting ground when insufficiently clear.

LITCHFIELD COUNTY (T. Pannell) - was held up for clear running from approaching the 400 metres until inside the 300 metres.

MILEVA (A Jordsjo) - rider reported that, owing to the filly proving a little fractious in its barrier stall it did not begin on terms and, as a consequence, she was unable to take up a more forward position as intended.

MUNTASEERA (J. McNeil) - was held up for clear running for a short distance near the 400 metres, and again near the 250 metres.

ECHOES IN ETERNITY (J. Eaton) - was inclined to lay out from rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

SPANISH HEIRLOOM (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SMOKIN' VAL (K. Zechner) - raced keenly in the early stages of the event.

CHAMPAGNE AFFAIR (T Stockdale) - near the entrance to the straight was hampered by OUTLAWS REVENGE which shifted out and, as a consequence, was obliged to be steadied.

RACE 7: AURARIA STAKES 3YO FILLIES - 1800 Metres

PARURE (B. McDougall) - raced keenly in the early stages.

ECUMENICAL (J. Eaton) - near the 1600 metres was inconvenienced when crossed by STAR OF EDEN which shifted in.

SIRILEO MISS (D. Tourneur) - near the 1400 metres was inconvenienced when crossed by GUNMETAL GIRL (NZ) which shifted in.

FLYING MASCOT (NZ) (J. Toeroek) - near the 1600 metres was inconvenienced by STAR OF EDEN which shifted in. Near the entrance to the straight, when improving into restricted room, was severely hampered when tightened by RAISE THE COLOURS (NZ) which was taken out slightly by STAR OF EDEN which rolled out slightly as it commenced to weaken. As a consequence, FLYING MASCOT (NZ) contacted PITCHANUN (NZ). A post-race veterinary examination revealed no visible abnormalities.

STEINEM (GB) (J. McNeil) - A post-race veterinary examination revealed no visible abnormalities.

STAR OF EDEN (B. Egan) - near the 1600 metres shifted in and crossed the running of FLYING MASCOT (NZ) and ECUMENICAL resulting in both runners being inconvenienced. Rider was severely reprimanded under AR131(a) for shifting ground when insufficiently clear.

GUNMETAL GIRL (NZ) (C. Jones) – was very awkward to begin, shifted out and hampered SPECTACLE, and then raced keenly in the early stages of the event. Near the 1400 metres shifted in and crossed the running of SIRILEO MISS which was inconvenienced. Rider was reprimanded under AR131(a) for shifting ground when insufficiently clear.

DIVINE DIOSA (J. Opperman) - raced wide without cover and keenly for a short distance inside the 1000 metres.

PITCHANUN (NZ) (F. Kersley) – was contacted near the entrance to the straight by FLYING MASCOT (NZ) and thereafter had difficulty obtaining clear running from near the 200 metres and became held up when racing between FLYING MASCOT and DIVINE DIOSA and was untested to the finish.

SPECTACLE (B. Vorster) - was hampered at the start.

RACE 8: R N IRWIN STAKES - 1100 METRES

The start of this race was delayed approximately three (3) minutes due to an interstate delay.

HEY DOC (B. Vorster) – over-raced in the early stages of the event and near the 1000 metres was tightened by SAVATOXL which shifted in slightly, and when being restrained, was hampered, shifted in and tightened EXHILARATES onto SHAMINO resulting in both these runners being severely hampered for several strides. B. Vorster explained that the gelding did not appreciate racing in restricted room in the early stages of the event. He added that the gelding was somewhat one-paced and did not finish the race off when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

GARNER (M. Aitken) - late scratching by order of Stewards at 4:09 pm acting on veterinary advice that the gelding was lame in the near foreleg. Trainer, Mr. G. Richards, was advised that a Veterinary Certificate of Fitness would be required prior to a future trial or race start.

SHAMINO (L King) - near the 1000 metres was severely hampered for several strides when tightened by EXHILARATES which was taken in.

SAVATOXL (C. Jones) - near the 1000 metres shifted in slightly and tightened HEY DOC which was hampered when being restrained and, as a consequence, was tightened onto EXHILARATES which in turn was tightened onto SHAMINO resulting in both those runners being severely hampered for several strides. Rider was reprimanded under AR131(a) and advised to ensure she only shifts ground when entitled to do so. A post-race veterinary examination revealed no visible abnormalities.

OCTANE (K. Crowther) - A post-race veterinary examination revealed no visible abnormalities.

RACE 8: R N IRWIN STAKES - 1100 METRES (Cont'd)

STREET LIFE (E. Finnegan) - near the 800 metres became awkwardly placed on the heels of SHAMINO for a short distance. Was held up for clear running from near the entrance to the straight until inside the 100 metres.

EXHILARATES (T. Pannell) – was severely hampered for several strides near the 1000 metres when tightened by HEY DOC which was taken in by SAVATOXL Rider explained that the mare did not appreciate being tightened in the early stages of the event, however, travelled well thereafter until near the entrance to the straight, however, when placed under pressure the mare did not respond in the manner he expected and failed to finish the event off and was disappointing in its run to the finish. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: TAB HANDICAP (Heat 10 Autumn Series) - 1200 Metres

The start of this race was delayed approximately two (2) minutes owing to an interstate delay.

DEEP DIVE (J. McNeil) - became fractious in its barrier stall, was removed and examined by the Veterinary Surgeon and passed fit to start.

ROCK HARD (K. Zechner) - raced keenly in the early stages of the event and wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SECRET VEGA (T. Pannell) - A post-race veterinary examination revealed no visible abnormalities.

HEARTY LASS (C. Jones) – struck a gate in the mounting yard en-route to the barriers, was examined by the Veterinary Surgeon on arrival at the barriers and passed fit to start. Rider reported that the mare failed to muster early speed and, from in the vicinity of the 600 metres was under pressure and did not finish the event off as a consequence. A post-race veterinary examination revealed the mare to be lame in both forelegs. Trainer, Mr. J. Hyam, was advised that a Veterinary Certificate of Fitness would be required prior to a future trial or race start.

WINGS OF PASTRAMI (J. Opperman) - raced keenly in the early stages of the event.

STAR STATUS (J. Eaton) - which proved fractious after being loaded into its barrier stall reared, was removed from its barrier stall, examined by the Veterinary Surgeon who declared it unfit to start. Acting on this advice STAR STATUS was declared a late scratching by order of Stewards at 5:01 pm. Co-trainer, Mr. A. Gluyas, was advised in view of the gelding's barrier manners it was now suspended and must prove tractable in an official barrier trial and to the satisfaction of Stewards prior to its next race start.
