Saturday, 15 May 2021

RACE 1: G.H. MUMM HANDICAP - 2014 Metres

DR DEPENDABLE (J. Holder) - rider reported that the gelding got its tongue over the bit during the event and may have choked down. A post-race veterinary examination revealed no visible abnormalities.

CANFORD (K. Zechner) - lost its off hind plate during the event.

MANZALA (R. Hurdle) - hampered at the start when tightened onto VON COSTA GLASS by LAUNDY (NZ), which shifted out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by R. Hurdle and noted that he used it on four occasions over the final 100 metres of the event.

LAUNDY (NZ) (D. Oliver) - shifted out at the start and tightened MANZALA onto VON COSTA GLASS, resulting in MANZALA being hampered. Raced keenly in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Oliver and noted that he used it on three occasions over the final 100 metres of the event.

RACE 2: DAVID COLES AM STAKES - 1200 Metres

KARACASU (J. Toeroek) - rider explained that it was his intention to settle further back in today's event; however, the gelding began better than expected and in his opinion it would have been detrimental to KARACASU to be restrained at that point. As a result he was obliged to race wide without cover in the early and middle stages of the event.

MAGIC MAX (J. Collett) - raced greenly in the straight. Inside the 300 metres shifted out to improve taking LEGLESS LADY wider on the track.



RACE 2: DAVID COLES AM STAKES - 1200 Metres (cont'd)

BUTTER BLONDE (C. Williams) – rider explained in relation to the filly's performance that BUTTER BLONDE travelled well in the early and middle stages of the event; however, when asked to improve failed to respond to his riding as he had anticipated and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

I AM IN THE MOOD (D. Lane) – rider reported the filly was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

HERESY (D. Oliver) – raced keenly in the early stages of the event.

LEGLISS LADY (C. Jones) – taken wider inside the 300 metres.

RACE 3: FLEURIEU MILK COMPANY HANDICAP - 1050 Metres

LARIMER STREET (J. Kah) – raced wide without cover in the early and middle stages of the event.

NOT ENOUGH EFFORT (T. Pannell) – inside the 100 metres was severely hampered for several strides when tightened onto TRYGVE by MADDOX, which shifted out under riding.

ZARACE (D. Lane) – a post-race veterinary examination revealed lacerations to the near hind leg.

MADDOX (D. Stackhouse) – inside the 100 metres shifted out under riding taking the running of NOT ENOUGH EFFORT and taking that horse out onto TRYGVE, resulting on NOT ENOUGH EFFORT being tightened and severely hampered for several strides. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 16 May 2021 and to conclude midnight Sunday, 23 May 2021, a period of three meetings.

RITORNO (K. Zechner) – began awkwardly and was slow into stride. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TAB PROUD MISS STAKES - 1200 Metres

RUBISAKI (T. Pannell) – rider could offer no explanation in relation to the mare's performance. A post-race veterinary examination revealed no visible abnormalities.

HUMMA HUMMA (J. Mott) – awkward to begin, shifted out and contacted the hindquarters of SMOKIN' VAL and was slow to begin as a consequence.

BROOKLYN HUSTLE (J. Kah) – slipped on jumping away and as a consequence was slow to begin. Raced keenly in the early stages of the event.

SMOKIN' VAL (K. Zechner) – had its hindquarters turned at the start when contacted by HUMMA HUMMA which began awkwardly and shifted out on jumping away.

RACE 5: TAB SA FILLIES CLASSIC - 2500 Metres

LLANACORD (NZ) (T. Pannell) – approaching the 500 metres shifted out to improve, into the running line of BIARCHI, which was momentarily inconvenienced as a consequence. Thereafter, inside the 500 metres shifted to the outside of HEREFORAGOODTIME (NZ), and in doing so contacted PENSO A LEI, which was taken out onto KIMMY BE COOL (NZ), resulting in that horse, after being contacted by PENSO A LEI, being taken out onto BEDFORD SQUARE (NZ), resulting in that horse's hindquarters being turned. As a consequence BEDFORD SQUARE (NZ) was taken out onto MIMI'S AWARD which was hampered.

FLEXIBLE (D. Oliver) – held up from approaching the 500 metres until inside the 400 metres, where it was obliged to shift to the outside of BEDFORD SQUARE (NZ) to obtain clear running. Was inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: TAB SA FILLIES CLASSIC - 2500 Metres (cont'd)

MIMI'S AWARD (D. Stackhouse) - shifted out on jumping away inconveniencing SHEBRINGZIT. Approaching the 500 metres was taken wider by BEDFORD SQUARE (NZ). Inside the 500 metres was hampered and taken wider by BEDFORD SQUARE (NZ) which was taken out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Stackhouse and noted that he used it on three occasions over the final 100 metres of the event.

SHEBRINGZIT (K. Zechner) - inconvenienced at the start by MIMI'S AWARD, which shifted out on jumping away.

PENSO A LEI (L. Currie) - approaching the 500 metres, when commencing to weaken, shifted out onto KIMMY BE COOL (NZ), which was taken out onto BEDFORD SQUARE (NZ), resulting in that horse being hampered and taken out onto MIMI'S AWARD, which was taken wider. As a consequence, GLAMDAM (NZ), which was following became awkwardly placed on the heels' of MIMI'S AWARD, had to be checked and clipped that filly's heels. Inside the 500 metres was contacted by LLANACORD (NZ) and taken out onto and contacted KIMMY BE COOL (NZ). A post-race veterinary examination revealed no visible abnormalities.

HEREFORAGOODTIME (NZ) (J. McNeil) - a post-race veterinary examination revealed no visible abnormalities.

GLAMDAM (NZ) (J. Collett) - approaching the 500 metres became awkwardly placed on the heels of MIMI'S AWARD, which was taken wider by BEDFORD SQUARE (NZ) which shifted out and away from KIMMY BE COOL (NZ) which rolled out and away from PENSO A LEI which shifted out slightly when weakening. As a consequence GLAMDAM (NZ) had to be checked and clipped the heels of MIMI'S AWARD.

BIARCHI (J. Kah) - approaching the 500 metres was momentarily inconvenienced when LLANACORD (NZ), shifted into its running line.

BEDFORD SQUARE (NZ) (D. Lane) - raced keenly in the early stages of the event. Approaching the 500 metres was hampered and taken out onto MIMI'S AWARD by KIMMY BE COOL (NZ), which rolled out and away from PENSO A LEI. Inside the 500 metres was contacted by KIMMY BE COOL (NZ), which was taken out, and as a result had its hindquarters turned.

BRIABELLA (R. Hurdle) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

COMFORT GIRL (K. Crowther) - held up for clear running from near the 500 metres and thereafter approaching the 400 metres became very awkwardly placed on the heels of KIMMY BE COOL (NZ), had to be restrained, and was obliged to shift to the outside of KIMMY BE COOL (NZ) to gain clear running.

KIMMY BE COOL (NZ) (D. Tourneur) - approaching the 500 metres was taken out onto BEDFORD SQUARE (NZ). Inside the 500 metres was contacted by PENSO A LEI and taken out onto BEDFORD SQUARE (NZ).

RACE 6: CENTAUREA STAKES - 2014 Metres

The start of this event was delayed approximately two minutes.

IN GOOD HEALTH (D. Oliver) - raced keenly in the early and middle stages of the event.

ZOUSONIC (K. Crowther) - awkward and slow to begin.

MAXIMAK (D. Stackhouse) - rider reported that the mare felt uncomfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

DAZZLING DAMSEL (T. Pannell) - approaching the 400 metres became held up for number of strides before being obliged to shift to the outside of ECUMENICAL to gain clear ground.

ROBE BAY (D. Bates) - slow to begin. A post-race veterinary examination revealed the mare to be exhibiting signs of the thumps.



RACE 6: CENTAUREA STAKES - 2014 Metres (cont'd)

CRIMSON ACE (J. Holder) - laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400. In determining penalty Stewards had regard for the totality of the use of the whip by J. Holder and noted that he did not use it over the final 100 metres of the event.

DREAMED (D. Tourneur) - raced keenly in the early stages of the event.

PRES DE TOI (D. Lane) - near the 500 metres became awkwardly placed on the heels of KENTUCKY TORNADO (USA), which commenced to give ground, and as a consequence was obliged to shift to that horse's inside to gain clear ground.

KENTUCKY TORNADO (USA) (C. Williams) - commenced to give ground from near the 700 metres. Rider explained that the mare travelled well in the early and middle stages of the event; however, when asked to improve from the vicinity of the 600 metres failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: R A LEE STAKES - 1600 Metres

PACODALI (IRE) (D. Lane) - inside the 100 metres, when inclined to lay in, and after being corrected, shifted out and inconvenienced MASTER CHUM, which had to be steadied.

MORVADA (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities. Trainer, Mr P. Jolly, advised that the mare would now be spelled.

REGALO DI GAETANO (C. Jones) - was held up for clear ground from approaching the 400 metres until near the 300 metres.

MASTER CHUM (E. Boyd) - inside the 100 metres was inconvenienced and had to be steadied when PACODALI (IRE) shifted out.

DEXTER YOU DEVIL (J. McNeil) - held up for clear ground from near the 600 metres until near the 400 metres.

TERRITORY TITAN (K. Crowther) - raced wide without cover in the early stages of the event.

HASTA LA WAR (D. Bates) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by D. Bates and noted that he used it on three occasions over the final 100 metres of the event.

ACE OF CLUBS (C. Lions) - a post-race veterinary examination revealed no visible abnormalities.

ALSVIOR (B. Vorster) - was held up for clear running from approaching the 400 metres until shortly after straightening.

MAGNA BELLA (C. Williams) - rider explained that from a wide barrier he elected to settle forward and was then unable to obtain cover; however, the mare travelled well, but when asked to improve rounding the home turn failed to let down and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: THE FURPHY GOODWOOD - 1200 Metres

The start of this event was delayed approximately two minutes.

BEHEMOTH (C. Williams) - near the 100 metres laid in and rolled in hampering VIRIDINE. Rider explained in relation to the gelding's performance, it travelled well in the early stages; however, when asked to quicken from near the 600 metres was unable to hold its position and was taken wider by GYTRASH and from this point on was inclined to shift away from that gelding and when asked to improve did not respond as he had anticipated and felt that the gelding did not appreciate the underfoot track conditions. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: THE FURPHY GOODWOOD - 1200 Metres (cont'd)

GYTRASH (J. Collett) – raced keenly in the early stages of the event. Laid in from inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

KEMALPASA (J. Toeroek) – knuckled at the start. Rider explained that despite the horse knuckling at the start he was unable to obtain a forward position in running in the early stages, outside SAVATOXL as anticipated. He added, however, that on straightening the gelding, despite his riding, did not respond in the manner he expected and was disappointing in its run to the finish. A post-race veterinary examination revealed the gelding to have quartered its near fore heel and to be lame in the near foreleg. Co-trainers, Mr R. Jolly & Miss C. Jolly, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

VIRIDINE (D. Oliver) – raced keenly in the early stages of the event and wide without cover for a short distance inside the 800 metres. Was momentarily held up for clear running near the 200 metres when racing behind GYTRASH, and thereafter near the 100 metres was hampered for several strides and taken in by BEHEMOTH, which laid in and rolled in.

PRETTY BRAZEN (L. Currie) – slow to begin.

BEAU ROSSA (T. Pannell) – rider explained in relation to the gelding's performance that it travelled strongly in the early and middle stages of the event; however, when asked to improve from the entrance to the straight failed to respond to his riding. He added that in his opinion BEAU ROSSA may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

DOLLAR FOR DOLLAR (J. Holder) – underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. The off side winker fitted to this horse's bridle became detached near the 400 metres.

RACE 9: CARBINE CLUB OF SOUTH AUSTRALIA INC. HANDICAP - 1200 Metres

EXTREME THRILL (A. Kelly) – shifted in on jumping away and contacted LADY DUNMORE. Shortly after the start was taken out onto BEEOKAY by LADY DUNMORE which was taken out by IDATWO which shifted out on jumping away. Inside the 200 metres was disappointed for clear running and was obliged to shift to the outside of CHILL WITH TEEJAY to obtain clear running.

BEEOKAY (C. Jones) – shortly after the start was taken out onto VAPID by EXTREME THRILL, resulting in VAPID's hindquarters being turned. Approaching the 800 metres shifted in tightening LADY DUNMORE, taking that horse in onto MUNSTER (NZ), resulting in LADY DUNMORE having to be restrained for several strides to avoid the heels of BEEOKAY. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Wednesday, 19 May 2021 to conclude midnight Wednesday, 26 May 2021, a period of three meetings.

IDATWO (J. Toeroek) – began awkwardly, shifted out shortly after the start tightening LADY DUNMORE onto EXTREME THRILL, which was taken out onto BEEOKAY, resulting in that horse being taken out onto VAPID and VAPID's hindquarters being turned. A post-race veterinary examination revealed that the gelding had bled from both nostrils. Trainer, Ms N. Storr, was advised that as this was the gelding's first bi-lateral bleed IDATWO would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

TONY'S REWARD (J. Holder) – was inclined to lay out from near the 400 metres.

LADY DUNMORE (S. Logan) – shifted out at the start and contacted EXTREME THRILL. Shortly after the start was tightened onto EXTREME THRILL by IDATWO which shifted out. Approaching the 800 metres was tightened and taken in onto MUNSTER (NZ) by BEEOKAY, and had to be restrained for several strides as a consequence when awkward on the heels of BEEOKAY.

MUNSTER (NZ) (M. Aitken) – approaching the 800 metres was tightened when obliged to race in restricted room between PERFECT COMMAND, which rolled out, and LADY DUNMORE, which was tightened and taken in by BEEOKAY and as a consequence MUNSTER (NZ) was severely hampered for a short distance thereafter. A post-race veterinary examination revealed no visible abnormalities.

MYSTICANO (B. Vorster) – raced wide without cover throughout the event.

RACE 9: CARBINE CLUB OF SOUTH AUSTRALIA INC. HANDICAP - 1200 Metres (cont'd)

PERFECT COMMAND (D. Lane) - approaching the 800 metres rolled out and tightened MUNSTER (NZ) for a number of strides. Rider was reminded of his obligations when shifting ground in future.

AMBIDAZZLE (C. Williams) - disappointed for clear running from shortly after the entrance to the straight and was obliged to shift to the outside of LADY DUNMORE inside the 200 metres to obtain clear running.

MAID IN MILAN (K. Crowther) - over-raced in the early and middle stages of the event.

VAPID (T. Pannell) - shortly after start was contacted and had its hindquarters turned by BEEOKAY, which was taken out.
