# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 12 June 2021

# RACE 1: BAROSSA FINE FOODS TWO-YEAR-OLD MAIDEN PLATE - 1000 Metres

ABIT RATTLEY (D. Tourneur) - rider reported on arrival at the barriers that the gelding had coughed on a number of occasions en route to the start. Underwent a pre-race veterinary examination on arrival at the barriers and was found to have nasal discharge and ruled unfit to start. Acting on this advice Stewards withdrew ABIT RATTLEY at 11.18 am. Trainer, Mr J. Frew, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

CHEF MILITAIRE (J. Maund) - on jumping away shifted out and contacted NIGHT CRUISER.

NIGHT CRUISER (A. Jordsjo) - contacted on jumping away.

OSIRIS REX (S. Fawke) - on jumping away shifted in and bumped NIGHT CRUISER resulting in S. Fawke becoming unbalanced.

TAUNTING (J. Eaton) - laid in under pressure in the straight. Rider reported that the colt raced greenly throughout the event and was disappointing.

JOURNEY IN TIME (C. Lions) - raced wide without cover throughout the event. Rider reported that the filly travelled well during the event; however, when asked to improve from rounding the home turn JOURNEY IN TIME felt awkward in its action and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

MISCHIEVOUS TYCOON (J. Holder) - jumped away awkwardly.

SPIRITUAL GAL (K. Zechner) - a post-race veterinary examination revealed excess upper respiratory noise. Trainer, Mr J. O'Connor, was advised that the results of a laryngoscopic examination and a Veterinary Certificate of Fitness were required prior to a future trial or race start.

#### RACE 1: BAROSSA FINE FOODS TWO-YEAR-OLD MAIDEN PLATE - 1000 Metres (cont'd)

BRAZEN BOY (K. Crowther) - jumped away awkwardly. Over-raced in the early and middle stages of the event. Rider reported that after beginning awkwardly she was obliged to settle further back than she had intended.

#### RACE 2: 36° SOUTH BEEF MAIDEN - 1000 Metres

The start of this event was delayed approximately two minutes owing to a delay with an interstate race.

KZSCZOT (J. Maund) - slow to begin approximately one to two lengths. A post-race veterinary examination revealed no visible abnormalities.

UTAH JOE (T. Pannell) - shortly after the start was restrained and shifted in, in an attempt to gain cover.

SUPER LOOKA (C. Jones) - raced wide without cover throughout the event and was inclined to lay out. Approaching the 100 metres rolled in.

MISS MOMO (E. Boyd) - approaching the finish was not fully tested when improving onto the heels of MISS SIZZLER. Rider reported that the mare raced greenly in the straight and was inclined to hang out.

SUGAR GLIDER (S. Fawke) – acting on confirmed advice from trainer, Mr S. Whittle, that he was having technical issues with his stable assist account and was unable to scratch the gelding by the prescribed time, Stewards withdrew the mare at 7.38 am.

DELTA RIVER (J. Holder) – slow to begin losing approximately three to four lengths. Trainer, Mr R. Balfour, was advised that a warning had been placed on the filly. Raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MISS LANGTRY (S. Logan) - approaching the 100 metres was obliged to alter course to the outside of SUPER LOOKA, which rolled in.

ROYAL OBSESSION (J. Opperman) - jumped away awkwardly and shifted out.

Correct weight was delayed to allow J. Holder (DELTA RIVER) and trainer, Mr R. Balfour, to view the vision of the start.

# RACE 3: FLEURIEU MILK COMPANY HANDICAP - 1550 Metres

SMOKE BOMB (J. Eaton) – jumped away awkwardly and shifted out onto MONRAAJ, which was taken out and bumped with HAHNDORF. Weakened from shortly after entering the straight. Rider explained in relation to the gelding's performance that it made abnormal respiratory noises on a number of occasions during the event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

SERIOUS SPENDER (J. Holder) – near the 500 metres became awkwardly placed on the heels of RENALOT, which was weakening, and was inconvenienced. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by J. Holder and noted that he used it on one occasion over the final 100 metres. Rider was reminded of his obligations to ride his mount out to the finish of the event in accordance with AR131(b).

RENALOT (S. Fawke) - weakened from in the vicinity of the 600 metres. Rider could offer no explanation in relation to the mare's poor performance and that it may have come to the end of its preparation. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr G. Searle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ALLACCIATO (NZ) (M. Wishart) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

# RACE 3: FLEURIEU MILK COMPANY HANDICAP - 1550 Metres (cont'd)

MONRAAJ (K. Zechner) - on jumping away was taken out by SMOKE BOMB and bumped HAHNDORF.

HAHNDORF (D. Tourneur) - trainer, Mr R. Balfour, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to be more forward in today's event. Settled back of midfield. On jumping away was bumped by MONRAAJ. Laid in under pressure in the straight.

#### RACE 4: WESLO SECURITY HANDICAP - 1300 Metres

LADY BETHANY (NZ) (M. Wishart) – approaching the 1000 metres bumped with ACROSS THE WAY. A post-race veterinary examination revealed no visible abnormalities.

AMBIDAZZLE (S. Logan) - held up for clear running from shortly after the entrance to the straight until the 200 metres when racing between SANDSATION and ENCHANTINGLY. Had difficulty obtaining clear ground approaching the finish when racing between ICECRUSHER and ENCHANTINGLY.

ACROSS THE WAY (J. Eaton) - approaching the 1000 metres, when awkwardly placed on the heels of ALL IN WAR, shifted out and bumped LADY BETHANY (NZ). A post-race veterinary examination revealed no visible abnormalities.

SANDSATION (P. Gatt) – hung out throughout the event. Rider explained that the mare hung out throughout the event and raced on its wrong lead leg. He added that SANDSATION was inclined to hang out when placed under pressure in the straight and he was disappointed in its efforts to the finish. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by P. Gatt and noted that he used it on two occasions over the final 100 metres.

# RACE 5: FURPHY HANDICAP - 1250 Metres

IMPERIAL HILTON (J. Opperman) - on jumping away was bumped by CHICO FIESTRO.

KORUTO (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

WINNING WEATHER (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

CHICO FIESTRO (J. Maund) - on jumping away shifted out and bumped IMPERIAL HILTON.

PENTIRE'S SPIRIT (NZ) (T. Pannell) - shortly after the start was restrained and shifted in to take up a position on the rail. Raced keenly in the early and middle stages of the event.

# RACE 6: CHALK HILL HANDICAP - 1000 Metres

LIDO BEACH (M. Wishart) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

CONCRETE (S. Logan) - slow to begin. Hung out under pressure in the straight. Trainer reported after the event that the gelding got its tongue over the bit in running and had choked down. He advised that he will add a tongue tie to its gear for its next start.

BEEOKAY (R. Hurdle) - prior to the running of this event Stewards clarified with trainer, Mr G. Young, regarding his instructions to his rider in this event. He stated that from today's good draw he would instruct R. Hurdle to be more forward. Settled equal lead. Shortly after the start rolled in.

# RACE 6: CHALK HILL HANDICAP - 1000 Metres (cont'd)

ARAY OF SUNSHINE (E. Boyd) - approaching the 500 metres rolled out slightly. Hung out under pressure in the straight.

MAGIC PHANTOM (K. Zechner) - approaching the 500 metres was taken out slightly by ARAY OF SUNSHINE.

HILLS (K. Crowther) - raced wide without cover throughout the event.

DEVONTE (A. Jordsjo) - approaching the 500 metres was inconvenienced as MAGIC PHANTOM, which was inclined to hang out, was taken out slightly by ARAY OF SUNSHINE, which rolled out slightly.

ANAMNESIS (J. Eaton) - required to be resaddled on arrival at the barriers. Raced wide without cover throughout the event.

GENERAL MINT (J. Maund) - shortly after the start was hampered and lost its position when tightened onto MAGIC PHANTOM as BEEOKAY rolled in.

#### RACE 7: THE JUNCTION HANDICAP - 1300 Metres

CARAK (S. So) - slow to begin. Had difficulty obtaining clear ground for a short distance near the 250 metres and again inside the 200 metres.

GREETINGS NED (J. Opperman) - inclined to hang in under pressure in the straight.

MUNSTER (J. Eaton) - jumped away awkwardly, shifted out and bumped ROTHMOORE.

ROTHMOORE (J. Holder) - on jumping away bumped with MUNSTER. Rider could offer no explanation into the gelding's poor performance. A post-race veterinary examination revealed no visible abnormalities.

GRAFTON AVENUE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

DOMINATION (C. Jones) - laid out under pressure in the straight.

SOWPODS (K. Crowther) - made the turn in the vicinity of the 900 metres awkwardly and raced ungenerously for a short distance thereafter. At the 600 metres was restrained for a number of strides when racing tight to the inside of GRAFTON AVENUE. At the entrance to the straight was obliged to shift out to obtain clear running.

# RACE 8: TAB HANDICAP - 1950 Metres

ANDREA MANTEGNA (USA) (S. Logan) - hung out rounding the home turn.

DR DEPENDABLE (C. Jones) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Jones and noted that she used it on four occasions over the final 100 metres of the event.

NOT USUAL GLORIOUS (P. Gatt) – hung in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by P. Gatt and noted that he used it on two occasions over the final 100 metres of the event, and that he was previous reprimanded earlier in the day under the same rule.



#### RACE 8: TAB HANDICAP - 1950 Metres (cont'd)

EXALTED BEAST (T. Pannell) – raced wide in the early stages of the event and was permitted to stride forward to take up a position outside the leader in the vicinity of the 1200 metres. Rider explained that the gelding travelled well in the early and middle stages of the event; however, when asked to improve from in the vicinity of the 600 metres failed to respond to his riding and for this reason he elected not to ride EXALTED BEAST out in his normal manner. He added that the gelding may not have been suited to today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

DUSK FALLS (IRE) (J. Eaton) - rider advised Stewards prior to the event that she had been instructed to attempt to settle in the first four or lead if possible. Settled wide midfield. Jumped away awkwardly. When being restrained in the middle stages raced keenly, got its head up and from the 1000 metres commenced to race wide without cover for the remainder of the event, before weakening approaching the home turn.

LOSTARC (S. Fawke) - after passing the winning post knuckled, became very awkward in its action and was dismounted by its rider. A post-race veterinary examination revealed fractures to the near fore sesamoid bones. LOSTARC was humanely euthanased.

STAR STATUS (J. Holder) - approaching the 600 metres shifted out and inconvenienced WARRIOR WOMAN. Rider was reminded of his obligations under AR131(a) and advised to ensure that he shifts ground in a safe manner.

LADY HIGHLY (J. Opperman) - from its wide barrier shifted in to take up a position on the rail.

WARRIOR WOMAN (K. Crowther) - approaching the 600 metres was inconvenienced by STAR STATUS, which shifted out.

#### RACE 9: NIGEL TIPPETT'S 60TH HANDICAP - 1250 Metres

FLYING AWARD (J. Holder) – jumped away awkwardly. In the vicinity of the 1000 metres was taken out by JUST CHIPPING AWAY. Rider explained in relation to the gelding's performance that it travelled well in the early stages of the event; however, from the 400 metres changed legs on several occasions and did not finish the race off in its usual manner and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

MIDNIGHT STORM (M. Wishart) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip and noted that she used it on five occasions over the final 100 metres of the event.

JUST CHIPPING AWAY (K. Crowther) - in the vicinity of the 1000 metres commenced to overrace and when being restrained shifted out onto FLYING AWARD, which was taken out.

STRYKE IN STYLE (P. Gatt) - shortly after the start from its wide barrier shifted in to gain cover. in the vicinity of the 1100 metres was inconvenienced by EXTRA MILE, which shifted out.

ECHOES IN ETERNITY (J. Eaton) - inclined to lay out under pressure in the straight. Rider explained in relation to the filly's performance that it races best with cover, However she was unable to gain cover in today's event. She stated that ECHOES IN ETERNITY was disappointing and may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

EXTRA MILE (J. Toeroek) - shortly after the start shifted in, in an attempt to gain cover and in the vicinity of the 1100 metres commenced to race fiercely and shifted out inconveniencing STRYKE IN STYLE. From that point on over-raced and raced wide without cover for the remainder of the event. Laid in under pressure in the straight.

LI'L HANK (D. Tourneur) - jumped away awkwardly and shifted out.

ALL HARD WOOD (A. Jordsjo) - jumped away awkwardly.

# RACE 5: JB RADIATORS & WINDSCREEN SERVICE BENCHMARK 54 HANDICAP - 1867 Metres

BAD MOON RISING (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400. In determining penalty, Stewards had regard for the totality of the whip use by S Fawke and noted that he did not use it over the final 100 metres of the event.
